## El Congreso de Guatemala elige a la nueva Corte Suprema en renovación del cuestionado poder judicial

CIUDAD DE GUATEMALA, Oct 3, 2024 (AP): El Congreso de Guatemala eligió el jueves a los nuevos 13 magistrados de la Corte Suprema de Justicia que dirigirán el sistema de justicia del país por los próximos cinco años, en un proceso muy observado ante las expectativas que levantó la renovación de un poder judicial señalado por casos de corrupción.

La elección de nuevos jueces fue vigilada nacional e internacionalmente para ver quiénes serían los nuevos integrantes y si había entre ellos candidatos señalados previamente por irregularidades. El sistema de justicia guatemalteco ha sido en los últimos años cuestionado por acciones violatorias de derechos humanos contra opositores políticos, operadores de justicia, periodistas y defensores de derechos humanos.

Una misión de la Organización de Estados Americanos y expertos internacionales denunciaron injerencias y amenazas por parte de la fiscalía, dirigida por la fiscal general Consuelo

Porras, para interferir en los listados de candidatos que fueron remitidos al Congreso para la elección final.

Porras ha sido sancionada dos veces por más de 40 países, entre ellos, Estados Unidos y la Unión Europea señalándola de obstaculizar la lucha anticorrupción y socavar la democracia en el país. Varios de sus colaboradores cercanos, también sancionados, se postularon para ser electos pero ninguno recibió apoyo.

Ana María Méndez, abogada y directora para Centro América de la organización Wola, dijo que en la elección "ganaron el pulso las mafias", al referirse a magistrados electos cuestionados, y que es importante una reforma al sistema de elección de cortes.

"Esto es una suma de varios factores, el trabajo de las comisiones de postulación fue criticado, hubo un proceso irregular con un listado de candidatos que no fue el mejor, no hubo un listado con candidatos con honorabilidad y calidades

profesionales", dijo la abogada.

Entre los integrantes del pleno de la Corte Suprema de Justicia, hay tres reelectos, entre ellos, los magistrados Gustavo Adolfo Morales Duarte y René Guillermo Girón Palacios. Los demás magistrados no habían ocupado cargo en esa corte. Ambos son miembros actuales de la cámara penal y quienes aplazaron la revisión del caso contra el reconocido periodista José Rubén Zamora, que lleva más de dos años preso sin condena, prolongando así su prisión preventiva por un año más.

Para el exfiscal anticorrupción Juan Francisco Sandoval, uno de los más de 30 operadores de justicia que vive en el exilio y que ha denunciado criminalización en su contra por investigar corrupción en el propio sistema de justicia y en su elección, la renovación no llena las expectativas de la población de una verdadera justicia.

"No todos los electos garantizan la independencia judicial ni un compromiso con la justicia, sino nuevamente

tienen compromisos con poderes fácticos", dijo Sandoval.

Méndez añadió que Guatemala cambia a todos sus magistrados de salas y cortes al mismo tiempo, por lo que hace este proceso vulnerable de ser infiltrado y sea un proceso más político que técnico.

Entre los 13 magistrados electos hay cinco mujeres y ocho hombres, que fueron juramentados el mismo jueves. Estarán en el cargo

hasta 2029. El Congreso también deberá elegir a más de 170 nuevos magistrados de Cortes de Apelaciones en los próximos días.

El presidente guatemalteco, Bernardo Arévalo, se pronunció y recordó a los magistrados que es necesario ver la vocación de justicia con hechos concretos, "nunca más cortes que no estén al servicio de la democracia, el Estado de derecho y la construcción de un mejor futuro", dijo en su cuenta oficial de "X".

"En las manos de la nueva CSJ está cumplir con el compromiso que el pueblo de Guatemala exige: recuperar la confianza en la justicia, el respeto a los derechos humanos y el combate frontal contra la impunidad", agregó el presidente.

Sobre cómo la renovación del poder judicial afectaría al gobierno de Arévalo, Méndez dijo que "todos los planes que él tenga para avanzar en una agenda en la transición democrática del país pueden verse obstaculizados por el sistema de justicia, especialmente por criminalización en su contra".

El presidente ha recibido por lo menos seis solicitudes de retirada de inmunidad impulsadas por Porras. Sus fiscales aún hoy buscan anular las elecciones presidenciales investigando un supuesto fraude.

Autoridades indígenas, que el año pasado lideraron

bloqueos de carreteras por casi 20 días exigiendo respetar los comicios, exigieron el jueves a los congresistas que no sean reelegidos jueces de anteriores cortes ni abogados señalados o vinculados con corrupción, impunidad y socavamiento de la democracia.

El exfiscal Sandoval también dijo que es necesario cambiar la dinámica de elección de magistraturas, pues por lo menos tres de los electos habían recibido diferentes acusaciones con pedidos de retirada de inmunidad "y algunos también aparecían en listados de magistrados negociados en años anteriores entre políticos", mencionó sin citar nombres.

Mientras algunos diputados celebraban con aplausos y gritos la elección de algunos magistrados, otros critican la inclusión de personas cuestionadas que según ellos no cumplen con estándares de honorabilidad.

## Corte Suprema de EEUU evaluará demanda de México contra fabricantes de armas

WASHINGTON, Oct 4, 2024 (AP): La Corte Suprema de Estados Unidos indicó el viernes que decidirá si bloquea o no una demanda de 10.000 millones de dólares presentada por México contra los principales fabricantes estadounidenses de armas, a los que acusa de que sus prácticas comerciales han contribuido a provocar gran parte del derramamiento de sangre en territorio mexicano.

Los fabricantes de armas solicitaron a los jueces que anularan un fallo del tribunal de apelaciones que permitió el avance de la demanda, a pesar de las amplias protecciones legales con las que cuenta la industria de las armas de fuego.

Desde entonces, un juez federal desestimó la mayor parte de la demanda por otros motivos legales, pero México podría apelar esa decisión. El gobierno mexicano afirma que las

empresas sabían que las armas se vendían a traficantes que las introducían de contrabando a México, y que decidieron aprovechar ese mercado. El gobierno calcula que 70% de las armas traficadas a México provienen de Estados Unidos.

Entre los acusados están grandes fabricantes como Smith & Wesson, Beretta, Colt y Glock. Afirman que México no ha demostrado que la industria haya obrado intencionadamente para permitir que las armas sean usadas por los carteles y que trata de "acosar" a los fabricantes para que adopten medidas de control de armas.

Presentada originalmente en 2021, la demanda fue rechazada inicialmente por un tribunal de distrito, que mencionó las protecciones legales de los fabricantes contra los daños resultantes del uso delictivo de las armas de fuego.

Sin embargo, la Corte de Apelaciones del 1er Circuito revivió el caso

según una excepción a esa ley. Los fabricantes de armas apelaron esa decisión ante la Corte Suprema, argumentando que han seguido prácticas legítimas y que el caso no tiene nada que hacer en los tribunales estadounidenses.

En agosto, el juez federal de distrito en Boston, F. Dennis Saylor, desestimó nuevamente el caso contra seis de las ocho empresas, argumentando que el gobierno mexicano no había proporcionado pruebas concretas de que las actividades de cualquiera de esas empresas en Massachusetts estuvieran relacionadas con algún sufrimiento causado en México por las armas.

Aun así, dado que algunas acusaciones se mantienen y que es posible apelar, los fabricantes de armas argumentan que el fallo del 1er Circuito podría cerrarse sobre industria durante años si se permite su permanencia.

## Búsqueda de víctimas de Helene se prolonga otra semana y jefe de policía dice que "no descansarán"

PENSACOLA, Carolina del Norte, EE.UU., October 4, 2024 (AP): La

búsqueda de víctimas del huracán Helene entraba en su segunda semana el viernes, mientras los agotados equipos de rescate y los voluntarios seguían trabajando durante largas jornadas sorteando carreteras devastadas, líneas eléctricas caídas y deslaves, para llegar hasta los aislados y desaparecidos.

"Sabemos que son momentos difíciles, pero por favor, separan que estamos llegando", dijo Quentin Miller, jefe de la policía del condado de Buncombe, Carolina del Norte, en una conferencia de prensa el jueves en la noche.

"Estamos yendo a buscarnos. Vamos a recoger a nuestra gente".

Con al menos 215 fallecidos, Helene es ya el huracán más letal en tocar suelo continental estadounidense desde Katrina en 2005, y docenas, o posiblemente cientos, de personas siguen en paradero desconocido. Casi la mitad de las víctimas estaban en Carolina del Norte, y docenas más perdieron la vida en Carolina del Sur y Georgia.

"Estamos empezando a recuperarnos", manifestó. "Hemos sacado a la gente que se encontraba en una situación más crítica".

Cerca de la frontera estatal con Tennessee, los equipos estaban empezando a llegar por fin a las carreteras secundarias luego de despegar las principales, pero eso le suponía nuevos retos. Las carreteras más pequeñas serpentean con curvas pronunciadas y cruzan pequeños puentes que pueden ser difíciles de transitar incluso con un clima ideal.

Solo en el condado de Buncombe, hasta el jueves por la noche había 72 decesos confirmados, apuntó Miller. Allí se encuentra la ciudad turística de Asheville, la más poblada de la región. Pese a esto, el jefe de policía mantiene la esperanza de que muchos de los desaparecidos estén vivos.

¿Su mensaje para ellos?

"Su seguridad y su bienestar son nuestra mayor prioridad. Y no descansaremos hasta que estén seguros y hayan sido atendidos".

indicó Wallin. Es difícil saber cuándo terminará la búsqueda.

"Esperas poder estar cada vez más cerca, pero es complicado saberlo", añadió.

### La electricidad regresa poco a poco

La electricidad se está restableciendo poco a poco y el número de hogares y empresas sin servicio cayó por debajo del millón por primera vez desde el fin de semana pasado, según la web poweroutage.us. La mayoría de los apagones se registraron en las Carolinas y Georgia, los estados azotados por Helene tras tocar tierra en Florida como un huracán de categoría 4 el 26 de septiembre.

El presidente de Estados Unidos, Joe Biden, sobrevoló el miércoles la devastación causada por el meteoro en las Carolinas. Su gobierno se comprometió a sufragar el costo de la retirada de los escombros y de las medidas de protección de emergencia durante seis meses en Carolina del Norte, y durante tres en Georgia.

Los fondos se utilizarán para hacer frente al impacto de los deslaves y las inundaciones, y para financiar los socorristas, equipos de búsqueda y rescate, refugios y alimentación.



## How the Michigan Supreme Court Upholds the Constitution and Will of the People

The Michigan Supreme Court is essential to our state's democracy, protecting our Constitution and making sure that partisan politics don't undermine the will of Michigan voters.

The court did exactly that with its recent ruling on "Adopt and Amend." This legislative process was a way to override a citizen-initiated ballot measure by voting to pass it so it doesn't make it to the ballot for a vote, then turning around and significantly revising the very same measure.

Ballot initiatives were introduced in 2018 to raise Michigan's minimum wage and tie the wage to inflation, while also implementing paid sick leave for workers. Voters were enthusiastic about casting their ballots to improve the lives of working people in Michigan, but Michigan legislators opposed it. So rather than letting the measure get on the ballot, the Michigan Legislature voted in favor of these measures. But after the election was over, the lame-duck Legislature gutted the initiatives, watering them down significantly.

Adopt and Amend was a sneaky legislative tactic that undercuts the democratic process. Michigan citizens were not given the chance to vote on the ballot initiatives, which may have suppressed voter turnout. Critics of Adopt and Amend consider the process a way for the Legislature to sidestep voter-driven initiatives, diluting reforms with strong public support.

In its ruling, the Michigan Supreme Court declared Adopt and Amend unconstitutional, something advocates for justice have long argued. The court recognized that Adopt and Amend violates a central tenet of direct democracy by manipulating voter-driven initiatives with no good reason.

What's more, the Michigan Supreme Court's ruling will put the provisions of the minimum wage increase and earned sick time into effect in February 2025: increasing the minimum wage as originally proposed and reinstating protections for earned sick time that were stripped away by Adopt and Amend.

This ruling is a prime example of the importance of the Michigan Supreme Court as an arbiter of democracy, and how the court serves as a check on the use of power by partisan efforts.

The Michigan Supreme Court is one of the three equal branches of our state government, along with the Legislature and the governor. And Michiganders get to vote for the people they want to sit on the Michigan Supreme Court – a privilege only available in 24 states and an important civic duty for Michigan's citizens.

This year, Michiganders will choose who fills two spots on the Michigan Supreme Court. The Adopt and Amend ruling was close, just 4-3, so choosing the candidates who will truly represent the will of the people is a vitally important task.

Do your research, so you know which candidates will best reflect the Michigan you want to live in – those who will make wise, thoughtful decisions about the important issues that come before them, from fair elections and voting rights to civil rights and gun safety, among others. Each candidate is nominated by a political party, which is something you can easily look up. But their political affiliation does not appear on the ballot because Michigan Supreme Court candidates are listed in the non-partisan section.

So don't stop at the top of your ballot. Even if you vote straight-party ticket, be sure to look for the non-partisan section and vote for the two candidates you believe belong on the Michigan Supreme Court. They'll be serving an eight-year term, so they could influence important decisions about Michigan for nearly a decade. Everyone should want a Michigan Supreme Court that will represent the best interests of every Michigander and continue serving as a watchdog for democracy and upholding the Constitution.

## Puebla: Historia, Cultura y bellezas Naturales

**U**bicada en el centro de México, Puebla es uno de los estados más emblemáticos del país, famoso por su rica historia, impresionante arquitectura colonial, deliciosa gastronomía y paisajes naturales asombrosos. Fundada en 1531, la ciudad de Puebla, conocida también como "Puebla de los Ángeles", ha sido declarada Patrimonio de la Humanidad por la UNESCO gracias a su importancia cultural y su magnífico legado arquitectónico.

**Callejón de los Sapos:** Este pintoresco callejón es conocido por sus tiendas de antigüedades y su mercado de pulgas los fines de semana. Es un lugar perfecto para pasear y descubrir artículos únicos, mientras se disfruta de la arquitectura colonial de la zona.

### 2. La gastronomía poblana: un festín de sabores

Puebla es famosa por su gastronomía, una de las más diversas y deliciosas de México. El platillo más emblemático es, sin duda, el mole poblano, una salsa compleja y exquisita hecha con una mezcla de chiles, especias, chocolate y otros ingredientes. El mole se sirve tradicionalmente con pollo o pavo y es un símbolo de la riqueza culinaria de Puebla.

Otro platillo destacado es el chile en nogada, que se prepara especialmente durante la temporada de agosto y septiembre. Este platillo consiste en un chile poblano relleno de picadillo, cubierto con una salsa de nuez y adornado con granada y perejil, representando los colores de la bandera mexicana.

Los dulces tradicionales también son una parte fundamental de la gastronomía poblana. No se puede dejar de probar las tortitas de Santa Clara, los camotes y los muéganos, delicias que reflejan la historia y el ingenio culinario de la región.

### 3. Cholula: la gran pirámide y sus alrededores

A solo unos minutos de la ciudad de Puebla se encuentra Cholula, una ciudad famosa por albergar la pirámide más grande del mundo en términos de volumen, la Gran Pirámide de Cholula. Aunque hoy en día gran parte de la pirámide está cubierta de vegetación y parece una colina, los visitantes pueden explorar los túneles interiores y aprender sobre su fascinante historia prehispánica.

En la cima de la pirámide se encuentra el Santuario de Nuestra Señora de los Remedios, una iglesia colonial construida por los españoles en el siglo XVI. Desde allí, los visitantes pueden disfrutar de una vista panorámica espectacular de los volcanes Popocatépetl e Iztaccíhuatl.

Cholula también es conocida por su vibrante vida cultural y estudiantil, ya que alberga varias universidades importantes. Su plaza principal está rodeada de bares, restaurantes y cafeterías, lo que la convierte en un lugar ideal para disfrutar de la gastronomía y el ambiente local.

### 4. Atlixco: el paraíso de las flores

A solo 30 minutos de la ciudad de Puebla se encuentra Atlixco, una pequeña ciudad conocida por su clima templado y sus hermosos viveros llenos de flores. Este lugar es un destino popular, especialmente durante la temporada de la Feria de la Flor y en Navidad, cuando la ciudad se llena de coloridos adornos y luces festivas.

Atlixco también es famoso por su Cerro de San Miguel, desde donde se puede disfrutar de una vista impresionante del valle y los volcanes. En la cima, se encuentra una pequeña capilla, y es el lugar donde cada año se celebra el tradicional Huey Atlixcóyotl, una festividad que honra las danzas y tradiciones indígenas.

### 5. Los volcanes

#### Popocatépetl e Iztaccíhuatl

Para animar a las personas a iniciar una tarea con energía y sin dilaciones.

Para dar el mensaje de que es necesario empezar una actividad o trabajo con ánimo y perseverancia.

En qué momento se dice:

Al inicio de un trabajo o actividad que requiere tiempo y esfuerzo.

Cuando es necesario tomar acción rápidamente y no seguir esperando.

Para motivar a un grupo o a una persona a comenzar una tarea larga pero importante.

## Kamala Harris promete a inmigrantes "ofrecer vías para obtener la ciudadanía"

**A**unque reconoció la necesidad de reforzar la seguridad en la frontera, la vicepresidenta Kamala Harris defendió una política migratoria "equilibrada", la cual también contempla "vías para obtener la ciudadanía" para indocumentados.

"Tenemos que cuidar de nuestros Dreamers. Si analizamos las políticas [del expresidente Donald Trump] en el pasado y en el futuro, no es así como él se siente", dijo Harris. "Tenemos que tener una política de inmigración que comprenda que podemos luchar por nuestros Dreamers, ofrecer vías para obtener la ciudadanía a quienes se la han ganado y asegurar nuestras fronteras".

La candidata presidencial demócrata dio una entrevista donde habló sobre inmigración y criticó al expresidente Trump por no ofrecer soluciones. "[Trump] quiere hacer campaña sobre el problema, en lugar de solucionarlo", dijo. "Esa no es la señal de un líder. Se supone que debes solucionar los problemas, no dejar que los problemas continúen para beneficiarte a ti mismo. Aquí está la otra cosa que es diferente entre mi posición y la de él".

Agregó que Trump busca "separar a las familias", pero el plan demócrata será mantenerlas unidas.

"En primer lugar, no permitió que se produjera la solución cuando ya había una solución al alcance

de la mano", expuso, en referencia a la ley bipartidista que quedó estancada en el Senado. "En segundo lugar, sus políticas separarían a las familias. Siempre he defendido y siempre defenderé la idea de que tenemos que mantener unidas a las familias".

Para la organización Immigration Hub, las declaraciones de la vicepresidenta Harris "contrastan marcadamente" con la postura del expresidente Trump.

"Las declaraciones de la vicepresidenta contrastan marcadamente con la retórica del expresidente Trump contra los inmigrantes y los peligrosos planes de separación familiar mediante deportaciones masivas", dijo la organización. "Harris enfatizó que, a diferencia de las políticas de Trump, que bloquean intencionalmente el progreso en el tema, la campaña de Harris-Walz está comprometida con políticas que mantengan unidas a las familias y brinden oportunidades justas para obtener la ciudadanía".

La vicepresidenta Harris apoyó el proyecto de reforma migratoria presentado por el presidente Joe Biden en 2021 que incluye camino a la ciudadanía para millones de indocumentados, pero no ha quedado claro cuál será su propio plan.

En la Convención Nacional Demócrata, cuando habló de inmigración, la candidata se refirió a la ley bipartidista y criticó a Trump por bloquearla, pero



ese proyecto no contempla un camino a la ciudadanía para indocumentados.

En la gira que realizó por varios estados a inicios de agosto, la vicepresidenta había adelantado su posición sobre inmigración.

"Sabemos que nuestro sistema de inmigración está roto y sabemos lo que se necesita para arreglarlo, una reforma integral que incluya, sí, una fuerte seguridad fronteriza y un camino ganado a la ciudadanía", dijo la candidata.



## Step Forward launches new contactless service model and improved crisis appointment scheduling

Cleveland, October 5, 2024: Step Forward is pleased to announce several significant updates to its Energy Assistance Services, including the transition to a new contactless service model and improved crisis appointment scheduling just in time for the winter heating season. These enhancements aim to streamline access to utility assistance for residents of Cuyahoga County, enhancing efficiency and aligning with the State of Ohio's application process for the *Home Energy Assistance Program (HEAP)* and the *Percentage of Income Payment Plan (PIPP)*.

HEAP provides one-time credits to help low-income households reduce energy costs, while PIPP is a budget-friendly payment plan that bases utility payments on household income. Both programs are designed to ensure that families can maintain essential utility services throughout the year.

"In response to significant statewide funding reductions, we adopted contactless services to better serve the community," Jackie Boehlein, Step Forward's Vice President of Community Services, said. "This shift mirrors trends in industries like online shopping and job applications and brings the same convenience to HEAP and PIPP services in Cuyahoga County."

The State of Ohio uses a unified application for HEAP and PIPP enrollment, as well as income reverification. These applications can be submitted online or by mail, with a processing time of up to 12 weeks. Step Forward aims to expedite the process, reducing the timeline to no more than eight weeks.

Step Forward's new

contactless approach is not applicable for households facing immediate utility disconnection. Clients in need of urgent assistance during Winter and Summer Crisis Programs will continue to be served via phone appointments.

The updates to crisis appointment scheduling are particularly impactful. Historically, balancing the needs of households without service and those at risk of disconnection has been a challenge. Step Forward's previous 28-day scheduling system was often filled within hours, leaving households already disconnected from service without adequate access to timely appointments.

To address this, Step Forward has also implemented a new scheduling system for the *Winter Crisis Program* and *Summer Cooling Program*. Appointments are now divided into two categories: "reconnection" appointments for households without active service and "disconnection notice" appointments for those with an impending shutdown notice. All crisis appointments will be conducted by phone.

**Key features of the new contactless service model include:**

- **Streamlined Application Process:** HEAP and PIPP applications will be accepted exclusively through the Ohio Department of Development's Energy Services portal at [energyhelp.ohio.gov](http://energyhelp.ohio.gov), or by mail at P.O. Box 1240, Columbus, Ohio 43216. This streamlined process ensures fair and efficient application handling on a first-come, first-served basis.

- **Automated Phone Service:** A new automated response system will manage all phone inquiries. Available 24/7, this system can be reached at (216) 480-4327 or (216) 480-



HEAP. Due to high call volume, the service will not accept messages or return calls.

- **Crisis Appointment Scheduling:** All crisis appointments for reconnections and disconnection notices will be scheduled through a single system, accessible online or by phone, to ensure fair, first-come, first-served access. No internet access is required to schedule.

- **Priority for Households Without Service:** Households without active utility service will receive priority for reconnection appointments. Appointments will be initially marked as "pending" until confirmed by the utility provider, typically within one business day. This process ensures appointments are allocated fairly and efficiently.

These updates are designed to streamline access to utility assistance and improve service for all residents of Cuyahoga County.

Step Forward will soon begin scheduling appointments for the Winter Crisis Program, which runs from November 1 through the end of March 2025. This program provides critical assistance to income-eligible Greater Cleveland residents who are facing utility disconnection, have already been disconnected, or have less than 25 percent supply of bulk fuel. Designed as a one-time emergency benefit, the program helps households maintain their utility services during the colder months.

## Wilmer Valderrama, Rosario Dawson, America Ferrera. Star-led drive aims to get Latinos to vote

Oct 1, 2024 (AP): With a star-studded cast of celebrities and influencers, the Voto Latino Foundation launched a \$5 million initiative Tuesday to encourage Latinos to vote in the upcoming election.

The "Vota Con Ganas" ("Vote with Enthusiasm") campaign will feature personal stories and messages from the Latino community, voter registration drives and workshops, social media outreach campaigns along with public service announcement-type videos from celebrities and influencers, highlighting the importance of voting and the impact the Latino vote can have in this election.

Notable celebrities participating in the campaign so far include Wilmer Valderrama, Rosario Dawson, America Ferrera, Danny Lux, Jessica Alba, Gina Torres and Xochitl Gomez.

Valderrama, who directed and produced the campaign videos, said in a statement that Latinos have been a vital part of the country and that it is time for them to have a seat at the table.

"The Ganas campaign aims to reinvigorate our Latino community to vote for their future," he said. "Every decade the Latino community continues to grow in so

many aspects of our country. We contribute in so many different ways and it's critical that we own and celebrate our contributions to what's possible for us here."

As part of the campaign, the foundation also partnered with more than 170 college campus organizations to host voter registration events and digital activations during Hispanic Heritage Month, which ends Oct. 15. The campaign's efforts will also be amplified by over 300 organizations partnering with the foundation, including the NFL, Universal Music and Sony.

As the nation's largest minority group — 19.5% of the total population, according to the 2020 census — Latinos form a key voting bloc in what's shaping up to be a tight presidential election.

Latinos have grown at the second-fastest rate, behind Asian Americans, of any major racial and ethnic group in the U.S. since the last presidential election, according to a Pew Research Center analysis, and are projected to account for 14.7%, or 36.2 million, of all eligible voters in this presidential election, a new high.

They are a growing share of the electorate in several presidential and congressional battleground states, including



Arizona, California and Nevada, and are being heavily courted by Republicans and Democrats.

Voto Latino Foundation president Maria Teresa Kumar said including everyday Latinos in the videos is a way to give them power and make their voices heard. In a statement, Kumar described the campaign as "a movement to harness the power of the Latino community."

Kumar said ensuring every Latino voter is registered is vital, as Latinos have the power to shape the future of the country only if they cast their ballot this election.

Dawson, who is a board member of the foundation, said Latinos must mobilize their community, especially youths, as there will be many first-time voters.

"We have the power to decide. We could literally change the tide," Dawson said in a statement. "'Vota con Ganas' means to register, vote, volunteer, and own this election, because it is yours to take."



## \$1.7 Million in Federal Justice Awards to address youth violence and support criminal justice reform

Toledo, OH, October 1, 2024: Congresswoman Marcy Kaptur (OH-09) announced two significant federal awards from the Department of Justice (DOJ) to the City of Toledo and the Lucas County Criminal Justice Coordinating Council to enhance local efforts aimed at combating youth violence and improving criminal justice outcomes. Together, these DOJ awards, totaling nearly \$1.7 Million, will bolster community-based initiatives to make Northwest Ohio safer, more resilient, and more equitable.

"We are on the front lines of our community's challenges, and each story — from a young student impacted by violence to an individual fighting for a second chance through rehabilitation—matters deeply," said Congresswoman Marcy Kaptur (OH-09). "These federal awards are more than just dollars and cents — they

are lifelines for Toledo and Lucas County. By working hand-in-hand with vital community organizations, we are building a future where our children can grow up safely and those battling addiction can rebuild their lives with dignity."

The first award, a \$1 Million award from the Office of Juvenile Justice and Delinquency Prevention (OJJDP) under the DOJ's Enhancing School Capacity to Address Youth Violence program, will focus on supporting Toledo Public Schools and local community organizations in preventing and responding to school- and community-based violence. The funding will be utilized in collaboration with Toledo Public Schools and two key community partners, Good Grief of Northwest Ohio and Sisters 4 Unity. The project will deliver trauma-informed care, violence prevention pro-

grams, and peer support for students and families impacted by violence at three Toledo high schools: Waite, Woodward, and Scott.

The second award, totaling \$678,332, was awarded to the Lucas County Criminal Justice Coordinating Council by the Bureau of Justice Assistance. The funds will be used to enhance the Lucas County Treatment Court, which plays a vital role in rehabilitating individuals with substance use disorders by providing them with treatment options as an alternative to incarceration. The award will improve court operations, increase access to treatment resources, and strengthen community partnerships aimed at reducing recidivism and promoting long-term recovery.

## Latina Equal Pay Day, October 3

Latinas are one of the fastest growing, most powerful groups in the United States, but are not being paid the same as white men. Latinas are paid approximately 49 percent less than their male counterparts. Latina Equal Pay Day is a symbolic day when Hispanic and Latina workers ask to close the unfair wage gap.

"Latina Equal Pay Day is a sobering reminder that the wage gap Latinas face is extreme, harmful, unacceptable — and for the first time in two decades, it is widening. Because Congress has failed to take the necessary action to address wage discrimination in our country, Latina earners overall are paid just 51 cents on the dollar paid to White, non-Hispanic men. Because our nation hasn't invested in a care infrastructure, Latina working moms are paid an even more disgraceful 41 cents for every dollar paid to White, non-Hispanic dads. This shameful discrimination

persists across occupations and education levels. It is driven by racism, sexism and xenophobia, and it must end.

"Our families, our communities, and our economy all suffer when Latinas are shortchanged on our paychecks. The lack of progress on this issue is unacceptable. Latina voters are engaged, mobilizing, and ready to vote for leaders who will address the wage gap and other pressing issues our communities face. We are working hard to get out the vote and make our voices heard. Moms of all backgrounds are energized and rising for the policies that will lift our families and our economy, and end the wage gap once and for all." — Statement of Xochitl Oseguera, Vice President, MamásConPoder


