I do not give you permission to enter my home based on my 4th Amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door.

I do not give you permission to search any of my belongings based on my 4th Amendment rights.

I choose to exercise my constitutional rights.

These cards are available to citizens and noncitizens alike.

You have constitutional rights:

- DO NOT OPEN THE DOOR if an immigration agent is knocking on the door.
- DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent.
- DO NOT SIGN ANYTHING without first speaking to a lawyer. You have the right to speak with a lawyer.
- If you are outside of your home, ask the agent if you are free to leave and if they say yes, leave calmly.
- GIVE THIS CARD TO THE AGENT. If you are inside of your home, show the card through the window or slide it under the door

History Forgotten, and Now for All to See

History Forgotten and Now for All to See, a documentary about the rural Great Migration African American Community of Braceville, Ohio, is a captivating film that unveils the rich tapestry of Braceville, a “Small Town with Big History.” This remarkable town is the birthplace of numerous notable figures, who have left an indelible mark on the world.

Colette Córdova, of Toledo, met Daniel Mason, of the Cleveland area, a film editor and technical director of the film, while working on a political campaign and began working on projects that promote advocacy, especially for people of color, including this documentary. “I was amazed at all of the work that goes on behind the scenes and the countless hours needed to perfect a film,” said Colette Córdova, Vice President of ALAS, the Escuela SMART Academy Advisory School Board. “Given the times we are in now, it’s more important than ever for oppressed populations to get our history out there. Both the Latinx and African American communities have been marginalized for too long.”

Mr. Mason feels at the core of the film is a question: “How did this community, who escaped from the Jim Crow south—some of them fleeing with nothing in the middle of the night—end up producing so many notable sons and daughters? What was it about this particular community that led them to live the American Dream, when so many other communities “set aside” for people of color were actively prevented from reaching their potential?”

How did a small community of maybe 90 families, even at its peak—sitting in a flood zone in the countryside of Ohio—improbably produce multiple millionaires, an Olympian, hall of fame boxers, a member of Jackie Robinson’s All Stars, state track and field record-holders, filmmakers, and many other notables? And, maybe even more importantly, how is it that they are all just about the nicest people you have ever met?

Mr. Mason said he knows, “some people are rightfully wary of AI in film—and elsewhere,” but he believes “when you are trying to help marginalized people’s voices be heard—and the historical record is often by the nature of said marginalization scant,” he thinks “any tool that can help is worth using.” Mr. Mason added, “As Howard Zinn’s *A People’s History of the United States*... there is so much more to learn about how people actually lived from primary sources and from a ‘bottom up’ approach, rather than a ‘top down’ history of ‘Great (usually white) Men’—history as we have traditionally been taught it.

Mr. Mason hopes that these techniques and some emerging software will allow him and others to tell stories of the wisdom that would otherwise be lost. He says, “Every neighborhood, often every generation, has multiple stories worth telling.” Because he says, “There are stories and characters everywhere. We only have to think back to our childhoods, and of all the individuals who left a mark on our memory, helped us form our values and who we are. Most of us have not gone back and inter-

viewed our parents, neighbors, friends—at least not formally. But there is so much there. Lifetimes of accumulated experience, wisdom—and often humor. I encourage everyone to take out their phone (with permission and ideally a heads up, of course), and document the stories of their elders and other interesting people they may know. Sometimes the people you want to interview are not comfortable on camera, but will often let you record a voice memo—you most certainly know people who like to tell stories, and our memories of these stories years later are often sadly lacking.”

Mr. Mason then went on to discuss implications and potentials of these new ways of storytelling: “These stories need not be one unedited shot of your *abuelo* (though that is quite important to have a copy of if possible, properly backed up in “the cloud”), but could include cutaways to photographs and even AI recreations of historical events or just be integrated with existing copyright free footage, if possible (copyright ownership may not be needed for personal or educational use, but you never know where your story may lead or how many people may want to watch it if you post it online).

According to Mason, “It’s our responsibility to document these histories before they are lost, as we know others won’t—they’ll probably aim for the opposite. It’s perhaps almost equally as important to tell our audience when and how something is manipulated (AI or otherwise), and a good practice to provide access to the original sources of everything, for historical purposes.”

I encourage everyone reading this to reach out to us at and let us know of your interest. We want to preserve these voices for future generations—and ideally preserve them in a way that inspires younger generations to not just pretend they are listening, smile and say, ‘Sí, abuelo’—and then proceed to stare back down at their phones...

History Forgotten and Now for All to See premiered at Robins Theater, 160 E Market St, Warren, Ohio on February 16, 2025. The hope is to bring it to Toledo in the coming year.

Historia olvidada y ahora para que todos lo vean

Historia olvidada y ahora para que todos lo vean es un documental sobre la gran migración rural afroamericana de la comunidad estadounidense de Braceville, Ohio.

Es una película cautivadora que presenta el rico tapiz de Braceville, la “pequeña ciudad con gran historia”. Esta notable ciudad es el lugar de nacimiento de numerosas figuras notables que han dejado una marca indeleble en el mundo.

Colette Córdova, de la ciudad de Toledo, conoció al director técnico y editor de cine de la película Daniel Mason, quien es del área de Cleveland, mientras trabajaba en una campaña política. Comenzó a laborar en proyectos que promueven la defensa, especialmente para personas de color, incluido este documental. “Me sorprendió todo el trabajo que se realiza detrás de escena y las innumerables horas necesarias para perfeccionar una película”, dijo Colette Córdova, vicepresidenta de ALAS, la Asesoría Académica de la Junta de la escuela Smart.

Dados los tiempos convulsos en los que estamos ahora,

es más importante que nunca para las poblaciones oprimidas mostrar nuestra historia. Tanto las comunidades latinas y afroamericanas han sido marginadas durante mucho tiempo”.

El sr. Mason siente que en el centro de la película hay una pregunta: “¿Cómo fue esta comunidad que escapó del sur de Jim Crow, donde algunos de ellos huyeron sin nada en medio de la noche? ¿Qué tenía esta comunidad en particular que los llevó a vivir el sueño americano, cuando muchas otras comunidades “reservadas” para las personas de color se les impidió activamente alcanzar su potencial? ¿Cómo una pequeña comunidad de quizás 90 familias, incluso en su apogeo, en una zona de inundación en el campo de Ohio, produjo múltiples millonarios, un boxeador olímpico del Salón de la Fama, un miembro de las All Stars de Jackie Robinson, State Track y State Track y State Track. Los titulares de récord de campo, los

cineastas y muchos otros notables? Y tal vez aún más importante, ¿cómo es que todas son personas de lo más agradable que hayas conocido?

El sr. Mason dice: “se que algunas personas están desconfiadas legítimamente de la inteligencia artificial en el cine, y por otro lugar, pero cuando intentas que se escuchen las voces marginadas de las personas, y el registro histórico es a menudo por la naturaleza de dicha marginación escasa, creo que vale la pena usar cualquier herramienta que pueda ayudar. El sr. Mason agregó: “Como la historia de Howard Zinn es una historia del pueblo de los Estados Unidos, y la nueva era de la investigación y el trabajo posterior que inspiró nos muestra que hay mucho más que aprender sobre como las personas realmente vivían de fuentes primarias y de un enfoque de “abajo hacia arriba”, en lugar de una historia de “de arriba hacia abajo” de “grandes hombres (generalmente blancos) como la hemos enseñado tradicionalmente.

“Ahora podemos inspirar a la próxima generación con” las épicas historias personales de su familia, sus experiencias y cómo formaron sus valores de quienes son ahora. Esto es esencial, especialmente en un mundo donde una nueva ola de historia revisionista está tratando de afianzarse en nuestro país.

Mason dice que, “Es nuestra responsabilidad documentar estas historias antes de que se pierdan, ya que sabemos que otros no lo harán, probablemente apuntarán a lo contrario. Quizás sea casi igualmente importante decirle a nuestra audiencia cuándo y cómo se manipula algo (IA o no), y una buena práctica para proporcionar acceso a las fuentes originales de todo, con fines históricos.”

Animo a todos los que leen esto a que se comuniquen con nosotros en bcf@bracevilleplatt.org y háganos saber de su interés. Queremos preservar estas voces para las generaciones futuras, e idealmente preservarlas de una manera que inspire a las generaciones más jóvenes no solo fingir que están escuchando, sonreír y decir: ‘sí, abuelo’, y luego proceder a mirar hacia atrás en sus teléfonos...

Toledo supports *Home Matters to Ohio* policy platform

TOLEDO, Ohio: The Board of Lucas County Commissioners, representatives from Toledo City Council, and several housing partners voiced support for the Home Matters to Ohio policy platform February 12, 2025 at a press conference held at One Government Center.

The Commissioners and members of Council joined representatives from Coalition on Homelessness and Housing in Ohio (COHHIO), Lucas County Land Bank, Lucas Metropolitan Housing, Area Office on Aging of Northwestern Ohio, Local Initiatives Support Corporation (LISC) Toledo, and Cherry Street Mission Ministries to offer support for the policy platform, which has 11 data-driven proposals that would increase the supply of housing across Ohio.

The Commissioners and Toledo City Council both presented resolutions in support of the platform on Tuesday to make Toledo and Lucas County the first government bodies in the state to champion the proposal.

"Communities thrive when residents can afford to drive the local economy," the Lucas County Commissioners said. "The Home Matters to Ohio platform is a data-driven policy approach that would increase the supply of affordable housing across our state, assist with workforce development, improve the quality of our housing

with local governments to tackle the affordable housing crisis that is afflicting every community throughout Ohio."

"Increasing affordable housing opportunities will take all of us, and county land banks have unique tools to help get this job done. We proudly stand with the Lucas County Commissioners, Mayor Kapszukiewicz, and Toledo City Council to support these needed investments," David Mann, president and chief executive officer of the Lucas County Land Bank said. "We're hopeful that the State of Ohio will meet this moment too."

"Home matters to Cherry Street Mission as daily, we seek to give people a hand-up to safe and affordable housing in their next step out of shelter care," Ann Ebbert, president of Cherry Street Mission Ministries said. "Without access to housing, people get stuck in the emergency shelter system. We support creating new housing, like we are doing with our partners at LMH (Lucas Metropolitan Housing), so our neighbors can find good places to call home."



Columbus Crew to host LIGA MX sides Deportivo Toluca F.C., Club Puebla, and Club León in Leagues Cup 2025

COLUMBUS, Feb. 11, 2025: The *Leagues Cup Organizing Committee* announced today Phase One opponent details for *Leagues Cup 2025*. The Columbus Crew will host *Liga MX* sides *Deportivo Toluca F.C.* on Tuesday, July 29, *Club Puebla* on Friday, Aug. 1, and *Club León* on Tuesday, Aug. 5. All matches will be hosted at *Lower.com Field*. Toluca is the third-most successful team in Mexico, having won 10 league titles. Additionally, León is an eight-time league title winner. The match against *Club Puebla* marks the first time in Club history that the *Black & Gold* will face off against Los Camoteros.

The tournament will begin on Tuesday, July 29, 2025 with the final taking place on Sunday, August 31, 2025 across the U.S. and Canada. Times for all three Phase One contests at *Lower.com Field* will be announced at a later date.

tickets. Season Ticket Members will have the match on Friday, Aug 1 against *Club Puebla* included as part of their package.

LEAGUES CUP 2025 FORMAT

New for this year, *Leagues Cup 2025* will be played in two rounds: Phase One and the Knockout Rounds. Phase One will feature three consecutive match dates per club to be played between July 29-August 7, and all 54 Phase One matches will be played between MLS and *Liga MX* clubs.

The MLS and *Liga MX* regular seasons will continue play through the month of August, with most *Leagues Cup* knockout matches played mid-week.

Regional Tiers: Clubs will be divided evenly into two regions of 18 teams each: Eastern and Western.

The *Leagues Cup Organizing Committee* determined regional assignments based on *Leagues Cup* Ranking and geographical considerations. Within each region, the

18 teams will be sorted into three tiers:

Tier 1: Teams ranked 1-3 from each league

Tier 2: Teams ranked 4-6 from each league

Tier 3: Teams ranked 7-9 from each league

Six sets will be formed to facilitate Phase One play, three sets in the East and three sets in the West. Each set will include six clubs: one MLS club and one *Liga MX* club from each of the Tiers (Tier 1, Tier 2, and Tier 3).

Phase One Matchups: Each club will play three matches against the three opponents from the opposite league within their set. *Leagues Cup* Phase One matches are determined by the *Leagues Cup* Ranking, as well as by region.

Points System: While competing on the field against teams from the opposite league, MLS and LMX teams will be competing in a league-specific table against the teams from their own league. New to this format, clubs will earn points within their league-specific tables. For example, an MLS club's win earns points in the

Leagues Cup MLS table, while a *Liga MX* win contributes to the *Leagues Cup*

Liga MX table. Further competition details, including tie-breaking criteria, will be included in the tournament regulations.

The top four (4) clubs from each *Leagues Cup* league-specific table advance to the Quarterfinals. The tables were designed to ensure more interleague matches into the Knockout Rounds.

Knockout Rounds: Following Phase One, the advancing four (4) clubs from the MLS and *Liga MX* tables will be placed in a fixed bracket to compete in the single-game elimination Knockout Rounds beginning with




the Quarterfinals (four matches), featuring only MLS vs. *Liga MX* matchups. The Quarterfinal pairings will be decided based on *Leagues Cup* Phase One performance with an inverse order of ranking among the respective league tables (MLS 1 vs. *Liga MX* 4, MLS 2 vs. *Liga MX* 3, MLS 3 vs. *Liga MX* 2, and MLS 4 vs. *Liga MX* 1).

The four (4) advancing

clubs will compete in the two Semifinal matches, as determined by the bracket. The *Leagues Cup 2025* Third Place match and Final will determine the three clubs that qualify for the 2026 Concacaf Champions Cup.



Shahzia Sikander: Collective Behavior at CMA

CLEVELAND, February 14, 2025: The Cleveland Museum of Art (CMA) is pleased to announce that its presentation of *Shahzia Sikander: Collective Behavior* is on view now. The exhibition premiered at the Palazzo Soranzo van Axel in Venice. Co-organized by the Cleveland Museum of Art (CMA) and the Cincinnati Art Museum (CAM), it was a Collateral Event in association with the 60th International Art Exhibition—La Biennale di Venezia in 2024. After *Collective Behavior* closed in Venice, iterations of the show traveled to both Ohio institutions, where they are on view concurrently.

The CMA presents Shahzia Sikander's art in relation to historical South Asian works from the museum's collection that inspire her. *Collective Behavior* includes works that span Sikander's career and the

many mediums that she has used. It comprises a series of conversations between our own time and the past that illuminate the artist's primary ideas and inquiries. This iteration of *Collective Behavior* offers a narrative that the CMA is uniquely well suited to share, carrying forward in time the rich histories that are encompassed in the museum's renowned South Asian collection. Simultaneously, it situates contemporary artistic practice in relation to the global history that precedes it.

"Shahzia Sikander's work looks back to our histories and forward to our futures," said Emily Liebert, Lauren Rich Fine Curator of Contemporary art at the CMA. "Through this expansive perspective, she proposes new and deeply relevant narratives that cross time and place, helping us to see with fresh eyes the world we inhabit."

Cuyahoga County plans for a Behavioral Health Crisis Receiving Center

CLEVELAND, Ohio, February 10, 2025: A new *Behavioral Health Crisis Receiving Center* (CRC) planned for Cuyahoga County will soon help strengthen the region's crisis continuum of care. The ADAMHS Board, The Centers and Cuyahoga County are partnering to create a facility in Cleveland's Central neighborhood that will support countless individuals experiencing a mental and/or addiction emergency. Construction is expected to begin in spring 2025.

A first-of-its kind in Cuyahoga County, the CRC will provide accessible, short-term behavioral health care for people experiencing a mental health crisis or substance use disorder. CRCs can help reduce the need for emergency department visits, jail bookings, and divert individuals from psychiatric hospitalizations by providing a community-based, home-like alternative environment.

When the CRC opens in fall 2026, The Centers will operate a comprehensive 24/7 facility that includes services such as urgent care, medication refills, de-escalation, triage, assessment, observation,

treatment, coordination, linkage to services, and the management of both voluntary and involuntary clients, in addition to other services.

The CRC will develop a robust referral network to route patients on discharge to appropriate in-patient, out-patient, or community services and will work with local hospital partners to assist them in training physicians in behavioral health crisis treatment.

As proposed, the behavioral health crisis receiving center will employ an estimated 200 caregivers and serve about 17,000 people.

Funding and Investment

The project is made possible through the ongoing collaboration of public and non-profit partners. In summer 2024, The Ohio Department of Mental Health & Addiction Services awarded a capital grant of \$6.8 million in American Rescue Plan Act funds to the ADAMHS Board. The Board - responsible for the planning, funding and monitoring of mental health services in Cuyahoga County - saw the need for a crisis center and selected The Centers to help bring the project to fruition.

In addition to the initial capital award, the ADAMHS Board is com-

mitting \$2.5 million for startup costs. The ADAMHS Board will provide oversight of the capital project and operations of the CRC while continuing to fund the facility. Cuyahoga County is supportive of the project and is currently finalizing its financial commitment from both a capital and operational perspective.

Funding will be used to renovate the first two floors of an existing building at 2322 E. 22nd St., which will become the new CRC.

"For decades, the ADAMHS Board has worked to create a seamless, integrated system of care that offers quality behavioral health services throughout Cuyahoga County. When we envisioned a new crisis receiving center, we aimed to enhance that system by implementing best practices and health models that ensure each client receives the needed care. We are pleased to partner with The Centers and Cuyahoga County to bring this vision to life and provide safe, accessible crisis care that meets the community's evolving needs." - Scott Osiecki, CEO, ADAMHS Board of Cuyahoga County.

Trump avanza velozmente en su lista de tareas, pero hay señales de advertencia

WASHINGTON, February 15, 2025 (AP) — El presidente de Estados Unidos, Donald Trump, se acerca al primer mes de su segundo mandato y ha actuado con velocidad vertiginosa y fuerza contundente para reorganizar las normas sociales y políticas y la economía estadounidense, al tiempo que redefine el papel de Estados Unidos en el mundo.

Al mismo tiempo, ha empoderado a Elon Musk, un multimillonario no electo nacido en Sudáfrica, para orquestar el despido de miles de empleados federales y, posiblemente, cerrar agencias enteras creadas por el Congreso.

Esos esfuerzos han eclipsado las medidas de Trump contra la inmigración y la frontera entre Estados Unidos y México, así como sus intentos de remodelar la política social al eliminar programas de diversidad, equidad e inclusión y dar marcha atrás a los derechos de las personas transgénero.

El presidente también ha impuesto nuevos aranceles contra los socios comerciales de Estados Unidos y ha amenazado con más, aun cuando los economistas advierten que eso trasladará los costos a los consumidores estadounidenses y aumentará la inflación.

Este es un vistazo a las primeras cuatro semanas de su gobierno:

Comienzan los despidos masivos en el gobierno federal

El gobierno de Trump despidió a miles de trabajadores que aún se encontraban en períodos de prueba, los cuales son comunes entre los nuevos empleados. Algunos tuvieron menos de una hora para abandonar sus oficinas.

Entre quienes podrían perder sus empleos hay científicos médicos, especialistas en infraestructura energética, empleados del servicio exterior, agentes del FBI, fiscales, expertos en datos educativos y agrícolas, trabajadores de ayuda en el extranjero, e incluso personal de recursos humanos que tendría que gestionar los despidos.

En la Oficina de Protección Financiera del Consumidor, creada para

proteger al público tras la crisis financiera de 2008, los empleados dicen que la administración no solo quiere despedir a casi todo el personal, sino también borrar todos sus datos de los últimos 12 años. Por órdenes de un juez, la administración acordó pausar cualquier desmantelamiento adicional de la agencia hasta el 3 de marzo.

Si bien Trump prometió revolucionar Washington, sus acciones podrían tener consecuencias de gran alcance para miles de empleados federales de todo el país y aumentar la tasa de desempleo si se producen grandes despidos a la vez.

Aumentan las impugnaciones

Las impugnaciones a las políticas de Trump comenzaron el día en que tomó posesión y han continuado a un ritmo vertiginoso desde el 20 de enero. La administración enfrenta alrededor de 70 demandas en todo el país que impugnan sus órdenes ejecutivas y sus acciones para reducir el tamaño del gobierno federal.

El Congreso, controlado por los republicanos, ofrece poca resistencia, por lo que el sistema judicial es el punto de partida para los actos de oposición. Los jueces han emitido más de una docena de órdenes que bloquean, al menos temporalmente, diversos aspectos de la agenda de Trump, que van desde una orden ejecutiva para poner fin a la ciudadanía estadounidense que se concede automáticamente a las personas nacidas en este país, hasta permitir que el equipo de Musk tenga acceso a datos federales sensibles.

Si bien muchos de esos jueces fueron nominados por presidentes demócratas, Trump también ha recibido fallos desfavorables de jueces elegidos por presidentes republicanos. El mandatario sugirió que podría atacar a la judicatura, diciendo: "Quizás tengamos que poner atención a los jueces". Mientras tanto, el gobierno ha dicho que apelará, mientras que la secretaría de prensa de la Casa Blanca, Karoline Leavitt, criticó las

órdenes que ralentizan la agenda del presidente, calificando a cada una de ellas como "un abuso del estado de derecho".

La administración también ha logrado algunas victorias, siendo la más significativa cuando un juez le permitió seguir adelante con un programa de renuncia diferida encabezado por Musk.

El panorama económico empeora

En medio de la agitación política, los datos económicos más recientes podrían generar algunas preocupaciones en la Casa Blanca.

La inflación aumentó a una tasa mensual de 0,5% en enero, según el Departamento de Trabajo.

En los últimos tres meses, el índice de precios al consumidor aumentó a una tasa anual de 4,5%, una señal de que la inflación se calienta nuevamente tras haber disminuido durante gran parte de 2024.

Trump dijo a los votantes que podría reducir la inflación, y que podía hacerlo casi inmediatamente después de asumir el cargo. Pero Leavitt, aunque culpó al predecesor de Trump, el demócrata Joe Biden, reconoció que los indicadores de inflación más recientes eran "peores de lo esperado".

Surgieron más señales de problemas cuando el Departamento de Comercio informó que las ventas minoristas cayeron 0,9% en enero en comparación con el mes anterior. Una caída de tal magnitud podría indicar que la confianza del consumidor y el crecimiento económico se han debilitado.

En el informe de la Reserva Federal sobre la producción industrial también se encontró que la producción de las fábricas disminuyó 0,1% en enero, en gran parte debido a una caída de 5,2% en la fabricación de vehículos de motor y refacciones.

Todas estas podrían ser solo fluctuaciones, lo que significa que los datos mensuales de febrero serán realmente importantes.

El "comercio justo" que Trump quiere no es necesariamente justo

Tras imponer aranceles a China y preparar impuestos a las importaciones de Canadá

y México, Trump presentó

lo que llamó "el gran día". Dijo que su administración elaboraría nuevos aranceles en las próximas semanas y meses para igualar lo que otros países cobran.

Otras naciones consideran injusto el enfoque de Trump.

Desde el punto de vista de esos países, el mandatario estadounidense incluye elementos distintos a los aranceles, como impuestos al valor agregado, que son similares a los impuestos sobre las ventas. Eso significa que las tasas podrían ser mucho más altas que un arancel estándar en Europa.

Además, Trump planea imponer aranceles adicionales a los automóviles, chips de computadora y productos farmacéuticos, además de las tarifas de 25% sobre el acero y el aluminio que anunció el lunes.

No está claro si estas sanciones comerciales son herramientas de negociación o formas de aumentar los ingresos. Hasta ahora, Trump ha sugerido que son ambas cosas.

El Congreso observa cómo se erosiona su autoridad. Pero hay señales de resistencia

El Congreso está desconcertado por la embestida, ya que su poder institucional —como la primera rama del gobierno según la Constitución, con su autoridad inigualable sobre el gasto federal— está siendo erosionado en

tiempo real.

El presidente de la Cámara de Representantes, Mike Johnson, dijo que el trabajo del equipo de Musk le parece "muy emocionante". Afirmó que Trump "emprende acciones ejecutivas legítimas".

Pero incluso entre los republicanos del Congreso surgieron pequeñas señales de protesta: se han escrito cartas y se han hecho llamadas telefónicas para proteger los intereses y al electorado de sus estados de origen mientras se desmantela la financiación de programas, servicios y contratos gubernamentales.

El representante Carlos Gimenez instó al Departamento de Seguridad Nacional a no realizar deportaciones masivas de migrantes venezolanos que huyeron de su país y ahora llaman hogar al área de Miami. "No soy impotente. Soy miembro del Congreso", dijo.

Los legisladores demócratas se han unido a los manifestantes fuera de las oficinas federales que han sido cerradas, argumentando que

Trump y Musk han ido demasiado lejos. Los demócratas sugirieron promulgar leyes para proteger distintos programas e incluso presentaron artículos de juicio político contra el presidente por sus planes de arrasar y reconstruir Gaza.

Trump quiere un nuevo

orden mundial

Con su llamada telefónica al presidente ruso Vladímir Putin la semana pasada, Trump espera haber puesto en marcha el principio del fin de la guerra del Kremlin en Ucrania.

Ambos líderes acordaron que sus equipos "comenzarían las negociaciones de inmediato". Después de colgar con Putin, Trump llamó al presidente ucraniano Volodymyr Zelenskyy para analizar cómo llevar a ambas partes a la mesa de negociaciones.

La llamada a Putin es un avance monumental en una guerra que ha provocado cientos de miles de muertos y heridos graves.

Pero el camino sigue siendo complicado.

Zelenskyy dijo que no se reunirá con Putin hasta que Trump elabore un plan de paz. El republicano recibió un contragolpe cuando los líderes europeos lo criticaron duramente a él y al secretario de Defensa estadounidense Pete Hegseth por insinuar que la incorporación de Ucrania a la OTAN no estaba en los planes.

La Casa Blanca enfrenta otro dilema, pues Zelenskyy desea que Estados Unidos y otros países proporcionen garantías de seguridad para Ucrania, y el mandatario ucraniano insiste en que él y Trump deben llegar a un acuerdo sobre los perfiles de cualquier acuerdo de paz.

Inmigrantes temerosos piden a activista de Florida que firme documentos de tutela para sus hijos

H O M E S T E A D , Florida, EE.UU., Feb 15, 2025 (AP) — El día antes de la toma de posesión del presidente Donald Trump, una docena de familias de inmigrantes llegaron al rancho de Nora Sandigo para pedirle que fuera la tutora legal de sus hijos. Ahora insisten en que vaya a sus casas para firmar la documentación necesaria.

Es la consecuencia de las muchas formas en que los inmigrantes que se encuentran en situación irregular en Estados Unidos han cambiado sus patrones de viaje, ya que muchos intentan quedarse en casa tanto como les es posible y evitan ir a los hogares y oficinas de activistas como Sandigo. Muchos temen verse atrapados en una operación del Servicio de Control de Inmigración y Aduanas (ICE, por sus siglas en inglés) después de que Trump prometiera deportaciones masivas durante la campaña electoral y haya eliminado programas que habían dado a los inmigrantes una vía legal de entrada al país.

En las últimas semanas, Sandigo ha recibido cientos de llamadas de padres migrantes de todo

Estados Unidos. Contó que ha estado en al menos 15 casas donde los progenitores han llenado los formularios para que ella pueda firmar documentos en nombre de sus hijos en escuelas, hospitales y tribunales si son deportados. El poder notarial también le permite ayudar a los niños a viajar para reunirse con sus familias.

"Ahora nos están diciendo que tienen miedo de salir a la calle, que tienen miedo conducir, que tienen miedo que en la calle los detengan", dijo Sandigo, una madre de dos hijas de 59 años que vive en Homestead, una ciudad de unos 80.000 habitantes al sur de Miami. "Me han pedido que, en lugar de ellos llegar a donde yo me encuentre, yo vaya a donde ellos".

Arrestos de inmigrantes con Trump

La Casa Blanca afirmó que más de 8.000 inmigrantes que estaban en el país sin la documentación pertinente han sido arrestados desde el regreso de Trump a la presidencia el 20 de enero. ICE promedió 787 detenciones al día entre

el 23 y el 31 de enero, frente a la media diaria de 311 del período de 12 meses que terminó el 30 de septiembre durante el mandato de Joe Biden. La agencia ha dejado de publicar el total diario de arrestos.

En Homestead, donde muchos inmigrantes de México y Centroamérica viven y trabajan en viveros y campos de frutas y verduras, algunos evitan los supermercados y en su lugar le piden a los vecinos que les hagan la compra. Ya no hay hombres buscando trabajo frente a tiendas como Home Depot. Otros han dejado incluso de ir a la Iglesia del Sagrado Corazón los domingos.

"La gente ha dejado de venir y cuando viene pregunta si por aquí vino la migración o no", apuntó Elisaul Velasco, dueño de una tienda de ropa en el centro, refiriéndose a los funcionarios del ICE. "Todo está paralizado. Las ventas han bajado un 60%".

Los padres temen que los separen de sus hijos

Durante años, Sandigo ha preparado a los padres inmigrantes para el peor de los escenarios: ser

separados de sus hijos.

Ahora es ella quien acude a esos padres, en lugar de al contrario.

Un domingo reciente, visitó cuatro casas y recibió documentación que afectaba a más de 20 niños. En algunos casos, los menores nacieron en Estados Unidos y tienen la ciudadanía. Los documentos no le otorgan la tutela legal completa ni le transfieren los derechos parentales, sino que simplemente le permiten tomar decisiones en su nombre.

La mayoría de los padres temen que, si no nombran a un tutor legal, sus hijos entrarán al sistema de acogida temporal, perderán sus derechos parentales y alguien los adoptará.

Visitando los hogares de padres inmigrantes

Julia, una guatemalteca de 36 años que insistió en identificarse únicamente con su primer nombre por miedo a la deportación, esperó unos minutos antes de abrir la puerta a Sandigo mientras un grupo de personas salía corriendo por la puerta trasera.

"Soy yo, Nora, la señora que llamaste por teléfono para que venga", le dijo Sandigo.

Julia abrió la puerta un poco, vio a Sandigo y salió. Explicó que su

esposo había sido detenido días antes mientras iba con camino a una obra en una furgoneta con otros migrantes.

Después de una breve conversación, Julia invitó a Sandigo, a un notario y a un voluntario a su pequeña casa.

Julia recordó que hace ocho años, su primer esposo, también guatemalteco, fue deportado y se quedó sola en el país con sus dos hijos estadounidenses, que ahora tienen 18 y 11 años.

"Nosotros tenemos miedo. Me siento muy triste con la vida por todo lo que estoy pasando", dijo Julia, con la voz quebrada y los ojos llorosos.

El notario le pidió que le mostrara el certificado de nacimiento de su hija y le explicó que su hijo es ya un adulto y no necesita un tutor.

"No quiero que me quiten a mis hijos. Si me pasa algo, los quiero a mi lado", añadió antes de firmar el poder notarial que nombraba a Sandigo como la tutora legal de la pequeña.

En el patio trasero de otra casa, Albertina, una madre mexicana de 36 años, sostén a su bebé de dos meses en brazos mientras explicaba lo que quiere para sus seis hijos

si es deportada. Albertina también insistió en que solo se usara su primer nombre.

"Tengo mucho miedo que me agarren en el camino y me lleven. ¿Qué va a pasar con ellos?", se preguntó acerca de sus hijos.

Si eso ocurre, le pidió a Sandigo que cuide de las dos hijas mayores, de 15 y 17 años, porque no quieren ir a México, pero que mande a los cuatro a su país de origen.

Sandigo ha sido tutora de 2.000 menores

Sandigo se identifica con las familias a las que ayuda. Católica devota, huyó de Nicaragua cuando tenía 16 años dejando atrás a sus padres luego de que el gobierno sandinista confiscara la granja de su familia. Ahora es ciudadana de Estados Unidos.

Comenzó a ofrecerse como tutora legal para niños migrantes hace unos 15 años. Desde entonces, unos 22 hijos de padres deportados han vivido temporalmente en su casa. Más de 2.000 han estado bajo su tutela, aunque algunos son ya adultos. Sandigo dijo que ha asistido a cientos de esos niños.

"Siento empatía por ellos, solidaridad, amor por Dios. Quiero hacer algo", aseveró.
