## TPS Student, Tyreese Blue II, named 2025 Youth of the Year by the Ohio Alliance of the Boys & Girls Clubs

Local Latinx & Toledo Public School (TPS) student, Tyreese Blue II, was named 2025 Youth of the Year by the Ohio Alliance of the Boys & Girls Clubs. Tyreese is a 17-year-old student who will be graduating this spring from TPS's Toledo Early College and receiving an associate's degree, at the same time, from the University of Toledo (UToledo). He has also committed himself to attending UToledo in construction engineering technology.

To receive this recognition and a \$15,000 scholarship, Tyreese had to compete against numerous other contestants. He had to submit three (3) essays, two (2) letters of recommendation, give a speech to the scholarship committee at a luncheon at The Ath-

letic Club in Columbus (OH), maintain a 2.5 Grade Point Average (GPA) or above, and be an active member of the Boys & Girls Club. Next, Tyreese will travel to Chicago, Illinois, in June to compete for the Midwest Youth of the Year competition.

According to TPS's website, during his speech, Tyreese talked about how he could have been a statistic because he was born to a teenage mother, and he said he was "proud to represent a culture that values resilience and hard work." He said, "My culture has shaped who I am, and this achievement is as much the community's as it is mine."

He also shared, according to the TPS website, how important it is for programs and adults to encourage and be there for our youth.

## Daniel Noboa is reelected Ecuador's president by voters weary of crime

QUITO, Ecuador, April 14, 2025 (AP): Ecuadorian voters weary of crime reelected President Daniel Noboa, a conservative young millionaire with a divisive no-holds-barred crimefighting record, by a wide margin Sunday, but his opponent vowed to seek a recount over what she described as "grotesque" electoral fraud.

Figures released by Ecuador's National Electoral Council showed Noboa receiving 55.8% of the vote with more than 92% of ballots counted, while leftist lawyer Luisa González earned 44%. Council president Diana Atamaint said those results showed an "irreversible trend" in favor of Noboa.

The win gives Noboa four years to fulfill the promises he first made in 2023, when he stunned voters by winning a snap election and a 16-month presidency despite his limited political experience.

"Ecuador is changing... and that path will mean our children will live better lives than we did," Noboa told supporters during a brief speech in which he also criticized his opponent's fraud allegations.

"I find it embarrassing that with an 11- or 12-point difference, they come out to question the will of the Ecuadorians," Noboa added. "Ecuadorians have already spoken, now we have to get to work."

Noboa, heir to a fortune built on the banana trade, is expected to continue applying some of his no-holds-barred crimefighting strategies that part of the electorate finds appealing but which have tested the limits of laws and norms of governing.

González's defeat marks the third consecutive time that the party of Rafael Correa, the country's most influential president this century, failed to return to the presidency. She told sup-

porters that her campaign "does not recognize the results presented by the '(National Electoral Council)," arguing among other issues that pre-election polls showed her ahead of Noboa.

The candidates advanced to Sunday's contest after getting the most votes in February's first-round election. Noboa led González by about 17,000 votes that time.

### No. 1 concern among voters was violence

Voters were primarily worried about the violence that transformed the country, starting in 2021 — a spike in crime tied to the trafficking of cocaine produced in neighboring Colombia and Peru.

Both candidates promised tough-on-crime policies, better equipment for law enforcement and international help to fight drug cartels and local criminal groups.

"My vote is clear," said Irene Valdez, a retiree who voted for Noboa. "I want to continue living in freedom."

College student Martín Constante had a different view.

"I think Luisa is going to change things because Noboa has been very authoritarian," Constante, 19, said near a voting center in Quito, the capital. "Our country needs a lot of changes."

Much of González's support comes from people who long for the low crime and unemployment rates of Correa's presidency but gloss over his authoritarian tendencies, the huge debt he ran up and the corruption-related sentence handed down to him in absentia in 2020.

More than 13 million people were eligible to vote, which is mandatory for adults up to the age of 65. It is optional for people aged 16 and 17 and over 65. Failure to vote results in a \$46 fine.

Electoral authorities reported voter participation of more than 80%.

"The most important thing is that a comfortable result gives peace of mind to the country because it avoids a political confrontation, or even worse, a violent one due to accusations of fraud," said Grace Jaramillo, an Andean region expert and professor at the University of British Columbia. "Noboa's victory is clear, and that also reassures the international community in the face of a wave of uncertainty."

### Several arrests over ballot anomalies

Atamaint said several people, including voters and poll workers, were arrested over ballot anomalies. She said some cases involved double voting and others stemmed from reports of counterfeit, pre-marked ballots.

Atamaint added that 17 people were caught taking photos of their ballots, which the National Electoral Council banned for this election citing reports of voter coercion by criminal groups. The violation comes with a maximum fine of \$32,000.

Many Ecuadorians used their vote to express rejection of a candidate and not necessarily to endorse the candidate they voted for.

Ecuador is polarized, which is a sign of rejection of the past, but also of the recent policies of the Noboa administration," political analyst Oswaldo Landáuri said, adding that the expected tight result "could become a major problem for the country" if one candidate does not recognize the other as the winner.

In 2023, Noboa and González were largely unknown to most voters as they sought the presidency for the first time.

They were first-term lawmakers in May 2023, when then-President Guillermo Lasso dissolved the National Assembly, shortening his own mandate as a result and triggering that year's snap election.

### Noboa heir to a fortune built on bananas

Noboa's first foray into politics was his stint as a lawmaker. An heir to a fortune built on the banana trade, Noboa opened an event organizing company when he was 18 and then joined his father's Noboa Corp., where he held management positions in the shipping, logistics and commercial areas.

González, 47, held various government jobs during the presidency of Correa, who led Ecuador from 2007 through 2017 with free-spending socially conservative policies and grew increasingly authoritarian in his last years as president.

Noboa, 37, declared Ecuador to be in a state of "internal armed conflict" in January 2024,

allowing him to deploy thousands of soldiers to the streets to combat gangs and to charge people with terrorism counts for alleged ties to organized crime groups.

Under his watch, the homicide rate dropped from 46.18 per 100,000 people in 2023, to 38.76 per 100,000 people in 2024. But despite the decrease, the rate remained far higher than the 6.85 homicides per 100,000 people seen in 2019.

Some of Noboa's heavy-handed crime-fighting tactics have come under scrutiny for testing the limits of laws and norms of governing. He has also been criticized for allegations of electoral irregularities he made after February's vote.

Following the first-

round election, Noboa said there had been "many irregularities" and that in certain provinces "there were things that didn't add up." He provided no further details or evidence. Electoral observers from the Organization of American States and the European Union ruled out fraud.

As González walked through the streets of Canuto, a town in the coastal province of Manabí where she grew up, to reach her voting center, supporters shouted "Luisa is the people."

"We have all united to rewrite the history of Ecuador," she told people Sunday before denouncing reports of attempts to "plant marked ballots" with her name.

## Social (Un)Security / (In)Seguro Social

### The Origins of Social Security

The origins of Social Security can be traced to the economic hardships of the Great Depression. In the 1930s, the United States faced unprecedented unemployment rates, and millions of Americans were plunged into poverty. The prevailing belief was that individuals should rely on personal savings and family support during difficult times. However, the severity of the Depression revealed the inadequacy of this approach.

### The Social Security Act of 1935

In response to these challenges, President Franklin D. Roosevelt championed the creation of a social insurance program designed to provide financial assistance to the elderly. On August 14, 1935, he signed the Social Security Act into law. The Act established a system of old-age benefits for workers, unemployment insurance, and aid to families with dependent children. It represented a significant shift in government policy, emphasizing collective responsibility and shared risk.

The peace of mind this gave me and my wife is hard to explain, as we all want "security" for our children and loved ones.

## Two Cities, Two Hate Crimes, One Motive

**Anti-Muslim violence breaks bones and breaks hearts. It has to end!**

We all want to live and raise our children in a safe place. Two immigrant parents thought they came to the United States for exactly that, only to have their dreams dashed in March.

A Houston, TX teen, born in Afghanistan, was brutally assaulted by her classmates. She spent days in the hospital and was discharged with a neck brace. She's justifiably afraid of returning to school. A Columbus, OH, mom, born in Somalia and wearing a hijab, was attacked by her own neighbors outside her home. The Columbus Police know who her attackers are; they even interviewed them, and the assault was caught on video. But still, no charges have been filed.

These were violent, anti-Muslim acts targeting a girl and a woman who did nothing wrong. Said the Houston teen's father, "I heard about the U.S. That there is freedom, there's education, there's law." And then his daughter was attacked.

The Columbus mother said, "We're all created by God and we're all the same. We should all be treated the same way. They should not be doing this to someone else." That's why she spoke up and bravely called the police. But weeks later, she's still waiting for justice.

Meanwhile, a lawyer for the mass murderer who killed 23 people at an El Paso Walmart said his client acted to stop "the Hispanic invasion of Texas."

According to attorney Joe Spencer, his client "thought he had to stop the invasion because that's what his president was telling him, which is just not rational."

The Houston father and the Columbus mother are right. The United States should be a place where they can start over in safety and raise their families. And the Texas lawyer is right, too. His client's anti-immigrant worldview is *not* rational. But it is being incited, encouraged, and excused by the occupant of the White House and his entire team. Still, there are many people in the United States who *do not* want us to be this version of our country.

### Dos ciudades, dos crímenes de odio, un mismo motivo.

#### La violencia anti-musulmana rompe huesos y corazones.

##### *¡Tiene que terminar!*

Todos queremos vivir y criar a nuestros hijos en un lugar seguro. Dos padres inmigrantes pensaron que habían venido a Estados Unidos precisamente para eso, pero sus sueños se vieron frustrados en marzo.

Una adolescente de Houston, Texas, nacida en Afganistán, fue brutalmente agredida por sus compañeros de clase. Pasó días en el hospital y le dieron de alta con un aparato ortopédico. Tiene un miedo justificado de volver a la escuela. Una madre de Columbus, Ohio, nacida en Somalia y que llevaba un hiyab, fue atacada por sus propios vecinos fuera de su casa.

La Policía de Columbus sabe quiénes son sus atacantes; incluso los entrevistó, y la agresión fue grabada en video. Sin embargo, aún no se han presentado cargos.

Estos fueron actos violentos anti-musulmanes dirigidos contra una niña y una mujer que no hicieron nada malo. El padre de la adolescente de Houston

dijo: "Escuché sobre Estados Unidos. Que hay libertad, hay educación, hay leyes." Y luego su hija fue atacada.

La madre de Columbus dijo: "Todos fuimos creados por Dios y somos iguales. Todos deberíamos ser tratados de la misma manera. No deberían hacerle esto a nadie más." Por eso alzó la voz y, con valentía, llamó a la policía. Pero semanas después, sigue esperando justicia.

Mientras tanto, el abogado del asesino que mató a 23 personas en un Walmart de El Paso afirmó que su cliente actuó para detener "la invasión hispana de Texas." Según el abogado Joe Spencer, su cliente "pensó que tenía que detener la invasión porque eso era lo que le decía su presidente, lo cual simplemente no es racional."

El padre de Houston y la madre de Columbus tienen razón. Los Estados Unidos debería ser un lugar donde puedan empezar de nuevo con seguridad y a criar a sus familias. Y el



abogado de Texas también tiene razón. La visión anti-inmigrante de su cliente no es racional. Sin embargo, está siendo incitada, alentada y excusada por el ocupante de la Casa Blanca y todo su equipo. Aun así, hay muchas personas en los Estados Unidos que no quieren que seamos esta versión de nuestro país.

Deqa Haji, directora del Centro para Mujeres y Familias de Zamzam, apoya a la madre de Columbus en su lucha por la justicia. Dijo: "Ninguna madre debería temer ser violenta después de dejar a sus hijos en el autobús de la escuela. Este brutal ataque contra una madre de Ohio es desgarrador e inaceptable. Lo que no está claro es qué se está haciendo para llevar a estos agresores ante la justicia. Han pasado semanas desde que nos reunimos con la Policía de Columbus, pero nadie ha sido arrestado y aún no hemos recibido respuestas a nuestras preguntas."

Nuestras familias y comunidades merecen algo mejor. El racismo anti-musulmán y anti-inmigrante rompe huesos y corazones. Mata, y tiene que terminar. ¡Tenemos que terminarlo!

## Mother Mimi's Cinnamon Sugar Cookies

These cookies are inspired by the traditional Mexican *polvorones*—buttery, tender cookies with a delicate cinnamon-sugar finish. They've become a beloved family classic thanks to Mother Noemi (Mimi) Leija, who lovingly makes them for her children, grandchildren, and anyone lucky enough to be part of her world. Each batch carries the warmth of her kitchen and the sweetness of her heart.

### Ingredients:


- 4 cups all-purpose flour
- 2 cups Crisco (butter flavor)
- 1/2 cup sugar
- 1 tablespoon ground cinnamon
- 1/2 cup water or milk

### For Dusting:

- Additional sugar and cinnamon (mixed to taste)

### Instructions:

1. Preheat oven to 350°F (175°C).
2. **Make the dough:** In a large bowl, combine flour, Crisco, sugar, cinnamon, and water or milk. Mix until a smooth dough forms.
3. **Roll out the dough:** Lightly flour a clean surface. Roll dough to about 1/4-inch thickness.
4. **Cut out cookies:** Use cookie cutters to make desired shapes.
5. **Bake:** Place cookies on an ungreased baking sheet and bake at 350°F until lightly browned.
6. **Dust with cinnamon sugar:** While cookies are still warm, sprinkle with the cinnamon-sugar mixture.
7. **Cool:** Transfer cookies to a wire rack to cool completely. Enjoy!

## Head Start in Jeopardy

Cleveland, OH, April 14, 2025: *Step Forward*, Cuyahoga County's largest provider of Head Start services, is sounding the alarm as national discussions surface around a federal budget proposal that would eliminate funding for the Head Start program, a move that would deeply impact children, families, and the local economy.

This potential loss comes at a time when critical support systems are already being scaled back. Recently, the federal government closed the regional Health and Human Services (HHS) office that oversaw Head Start programming and compliance in Ohio.

"We are not just talking about a line item in the federal budget," Dr. Thea Wilson, Step Forward's Vice President of Children and Families, said. "Local parents will be forced to choose between childcare and their jobs, putting their livelihoods and the local economy at risk."

County families depend on every single day. Without Head Start, many of our community's youngest children will have nowhere else to go and the educational gap they already face will only grow wider."

Head Start is a vital resource for more than 750,000 of America's most vulnerable children. Locally, Step Forward serves about 2,000 children annually, offering high-quality early education, health services, and family support. The program is free for income-eligible families.

"Eliminating this support would not only create an immediate crisis in early childhood education,

but in our workforce," Dr. Wilson said. "Local parents will be forced to choose between childcare and their jobs, putting their livelihoods and the local economy at risk."

Step Forward's Head Start program provides



comprehensive, wrap-around services to families in Cuyahoga County, ensuring that children are not only ready for school but also supported in their overall development.

The agency provides essential resources, including formula and diapers for babies, as well as nutritious meals (breakfast, lunch, and a snack) for the children. In addition, Head Start offers free developmental screenings to assess and support early growth.

As we face the potential elimination of this vital program, Step Forward joins Head Start programs nationwide in urging every community member - families, educators, alumni, and advocates - to take immediate action and call on their Members of Congress to protect Head Start funding.

## **La Unión Americana de Derechos Civiles (ACLU) radica demanda de clase por la cancelación de visas F-1 a estudiantes en New Hampshire, Massachusetts, Maine, Rhode Island y Puerto Rico**

CONCORD, N.H., April 18, 2025: Cuatro afiliadas de la ACLU, junto con la firma legal Shaheen & Gordon, presentaron hoy una demanda de clase en el foro federal en representación de más de 100 estudiantes en New Hampshire, Massachusetts, Maine, Rhode Island y Puerto Rico, quienes vieron su estatus migratorio de estudiantes F-1 cancelado de manera abrupta e ilegal, sin que se especificara la razón. La demanda solicita a la corte que restituya su estatus F-1, lo que les permitiría continuar sus estudios.

"Seguimos profundamente preocupados por la decisión repentina de la administración Trump de cancelar el estatus de estudiantes universitarios en todo el país sin notificación previa ni explicación de motivos", declaró Gilles Bissonnette, Director Legal de la ACLU de New Hampshire. "Los estudiantes internacionales son una parte fundamental de la comunidad estudiantil en nuestras universidades estatales, y ninguna administración debería poder eludir la ley para despojar unilateralmente a los estudiantes de su estatus, interrumpir sus estudios y ponerlos en riesgo de deportación."

Según la demanda, estas cancelaciones unilaterales e ilegales, han interrumpido gravemente las oportunidades educativas de los

estudiantes afectados, quienes se encuentran en pleno curso de sus estudios (y en medio del semestre académico), y que simplemente buscan obtener, muchas veces con un alto costo, una educación en los Estados Unidos cumpliendo con todas las condiciones y normas establecidas. Ahora, con el estatus F-1 cancelado, también enfrentan un alto riesgo de detención y deportación.

Estas cancelaciones por parte del Departamento de Seguridad Nacional de EE. UU. han estado ocurriendo al menos desde el 1 de marzo de 2025 y han afectado a cientos, si no a miles, de estudiantes internacionales en Estados Unidos y sus territorios. La revista *Inside Higher Ed* estima que, hasta el 17 de abril de 2025, más de 210 universidades e instituciones han identificado a más de 1,400 estudiantes internacionales y recién graduados cuyo estatus legal sido modificados. Esto incluye a 112 estudiantes en New Hampshire, Maine, Massachusetts, Rhode Island y Puerto Rico.

La demanda detalla cómo la cancelación ilegal del estatus F-1 de estos estudiantes viola sus derechos al debido proceso, ya que el gobierno está obligado a proporcionar una notificación previa y ofrecer una oportunidad significativa para responder. Además, se afirma que el gobierno necesita tener



fundamentos válidos para cancelar un estatus de estudiante, y que la revocación de una visa F-1 no constituye un motivo suficiente para ello.

Para que la cancelación de estatus de estudiante sea válida, debe demostrarse que el estudiante incumplió con las condiciones establecidas. Por ejemplo, que el estudiante dejó de tomar cursos completos, está trabajando sin autorización, o ha sido condenado por un crimen violento con una posible pena de más de un año. Ninguna de estas situaciones aplica a los estudiantes representados en esta demanda.

La ACLU de New Hampshire presentó recientemente una demanda separada en nombre de un estudiante de Dartmouth College cuyo estatus F-1 también había sido cancelado. Un juez federal le restituyó temporalmente su estatus durante una audiencia de emergencia la semana pasada.






