Thousands rally across US for immigration reform; FLOC co-hosts townhall at UT

April 10, 2013 (AP): Tens of thousands of immigrants and activists rallied nationwide April 10th in a coordinated set of protests aimed at pressing US Congress to approve immigration measures that would grant an estimated 11 million undocumented immigrants a path toward eventual citizenship.

Organizers said demonstrations were taking place in at least 18 states and in Washington, D.C., where a large, festive crowd gathered on the west lawn of the U.S. Capitol Wednesday afternoon. Many carried hand-lettered signs and chanted "Si, se puede," "Spanish for "Yes, we can." "We won't win immi-

"We won't win immigration reform just coming to Washington. We need to walk the streets all over the country," said Ben Monterroso, national director of civic participation of the Service Employees International Union, which represents nurses and lower-wage employees including janitors and child care workers.

In Atlanta, more than 1,000 people marched around the Georgia Capitol Wednesday midday, calling for comprehensive changes to immigration policy and an end to deportation.

Supporters massed in several rallies in *New York City*, including in the Washington Heights section, as well as in Queens, Manhattan and The Bronx.

In San Francisco, several hundred demonstrators marched toward the federal building holding red and orange paper flowers representing the number of people deported daily for immigration violations.

InSanDiego, about 50 demonstrators gathered on a sidewalk outside the office of U.S en. Dianne Feinstein, a sharp contrast to massive protests in 2006 when thousands of demonstrators shut down downtown streets to support looser immigration policies.

Various seminars and town halls took place within the United States. In Toledo, for example, a town hall was held at the University of Toledo sponsored by the Farm Labor Organizing Committee (FLOC), The Blade, AFL-CIO, and Citizenship Now.

US Senators writing a sweeping immigration bill have said they hope to finish their work by April 16, opening what's sure to be a public debate over measures to allow foreignworkers into the country and grant eventual citizenship to the millions living in the United States.

A person familiar with proposed bipartisan immigration legislation being written in the Senate said Wednesday the bill would require greatly expanded surveillance of the U.S. border with Mexico [but not Canada] and greatly increased detention of border crossers in high-risk areas [Mexico, but not Canada]. The person provided the information on condition of anonymity because the

deliberations were private. Immigration rights activists said the size of their movement would be on display at rallies around the country, including in the nation's capital, where National Association for the Advancement of Colored People (NAACP) President Benjamin Jealous delivered the keynote address.

Gustavo Andrade, who laded a large immigrant advocacy group in Maryland and helped organize the DC event, said about 400 buses carrying activists converged on DC for the rally.

Several Democratic lawmakers including Sen. Bob Menéndez and Rep. Luis Gutiérrez, spoke briefly, as did Puerto Rican singer Olga Tañon and the Latino pop-rock group La Santa Cecilia.

Puerto Rican natives are US citizens by law, but the vast majority of Puerto Ricans support immigration reform, many of them believing that it is a question of civil rights, due process. & equal protection

For Esther García-Tio, who is also a member of its steering committee, it is important to 'promote educational and research activities to benefit Latinos and to highlight Latino contributions in Wood County," David Olivarez, manager of El Zarape restaurant and a member of La Conexión, believes that "there is great talent in the community; we have to identify our potential and provide people with the opportunities to succeed."

The organization's activities

are currently run by several

working committees, including: programs, organizing/outreach, communications and coordination. The organization holds English as a Second Language classes and a children's enrichment program at space donated by the First Presbyterian Church in downtown BG. 

TPS teacher Louis Jiménez is high-tech and hands-on

April 19, 2013: Thanks to the efforts of a Latino educator who wanted a career change five years ago, dozens of *Toledo Public Schools* (*TPS*) students are graduating high school with the *high-tech tools* they need to embark on a career in electronics.

One is studying at MIT. Another gained entrance to one of the toughest higher education institutions in the world: the University of Tokyo.

"I've had a hand in developing some pretty good talent and helping to put them on a career path," said Bowsher High School electronics instructor Louis liming."

The 62-year old Navy veteran has taught as a master training specialist in antisubmarine warfare in San Diego. He's spent several years making good money for General Electric Aerospace in Syracuse, NY. He's also taught Spanish naval officers and technicians in Rota, Spain.

But Jiménez seems to get no greater satisfaction than seeing his Bowsher High School students succeed in a grueling electronics program he researched and designed from scratch at the request of his TPS career-technical education supervisor a few years ago. A previous program at Woodward High School had gone dormant—so Jiménez had to go there every day after school for seven months to salvage leftover electronics equipment.

"The possibilities and capabilities of our students are exponential. The career

opportunities are expanding across every level in every field," he explained. "We have an electronics infrastructure that is global now. We're developing a dichotomy out there where knowledge and technology are expanding—and there are people who can do it and those who wish they could."

Jiménez was honored by the Electronics Technicians Association-International (ETA-I) as the organization's recipient of the Wallace Medeiros Memorial Educator of the Year Award two years ago for his dedication to his students. 20 juniors and 20 seniors are currently enrolled in the program.

In his Electronics Tech Prep I and II at Bowsher, juniors and seniors learn about parallax robots, parallax training programming, and earn certifications that include ETA-I's Certified Electronics Technician (CET) and Student Electronics Technician (SET), as well as OSHA Career Safe, Webxam and Tooling U certifications. They create exciting student projects that have involved equipment repair, plasma arcs, wireless power transmission and laser guitar pick-

"We have all of these great programs junior and senior years that allow students to develop a career and get college credit for it," he said. "They can get their technical skills and their educational skills as well. The possibilities are endless."

Jiménez spent a lot of time researching what other electronics programs offered students with the desire to make his state-of-the-industry. He ended up patterning the program after a similar one he found in Cleveland at the Polaris Career Center.

"I wanted to see what training programs were out there and model mine after the best ones out there so it would accomplish its goals," he said.

Jiménez only taught Andrew Alvarez during his senior year, but the Bowsher graduate was accepted to the Massachusetts Institute of Technology, one of the most rigorous college programs in the country. At the time, Alvarez told 13-abc he only applied to MIT on a lark and "for bragging rights."

Another former student is now studying abroad after mastering the Japanese language alongside his electronics coursework. For his senior project, Alex Mattoni built what he called a "carputer" which he installed in his old BMW: a microprocessor/microcomputer that is controlled by a touchpad.

"I've had a hand in developing some pretty good talent and helping to put them on a career path," he said.

Junior students are introduced to basic electronics concepts, circuit construction and analysis used in the new technology oriented security industry. As seniors, they gain a more comprehensive knowledge of analog and digital electronics concepts using the latest in electronic circuit design software. They also learn troubleshooting techniques for all manner of sophisticated electronics including

microprocessor and robotics technologies.

Students prepare for worldwide entry-level technical positions

Even before they graduate, students in the program find that the training makes them strong candidates for jobs in the electronics industry. After completing the program, students are ready for entry-level technical positions anywhere in the world.

"The tests are very, very hard and the program is demanding. It has what is referred to as 'rigor.' These are industry-level exams, not just high school or college," said Jiménez. "You'd think they'd do some college before this It's tough and demanding, but the rewards are great."

Jiménez recently submitted an article to The High-Tech News, an industry publication edited by ETA-I, about a third former student. Stefan Bumpus-Barnett never had to go to college, because he was the first student in the program to satisfy all the requirements to become a Certified Electronics Technician, the equivalent of an associate's degree-while still in high school. Bumpus-Barnett now earns more than \$30 per hour as an industrial/ biomedical electronics technician in New York state

"Career-technical education is at the heart of today's high-tech, high-skill global



economy," said Jiménez. "For America to remain economically competitive, our next generation of leaders, the students of today, must develop the critical reasoning, problem-solving, teamwork and collaboration skills that will help make them the most powerful and productive in the world."

TPS currently offers open enrollment for the Bowsher H.S. electronics program, but the transportation to campus is up to the individual family involved.

"That is a problem at this point," he said.

If voters pass a levy or another funding source is found, part of the district's transformation plan is to offer a careertechnical education specialty at each high school with open enrollment—and TPS will bus students to the school of their choice. That could lead to even more young minds for Jiménez to mold into high-tech superstars.


"Over the last four years, we've been either nationally or internationally recognized."

So why did Jiménez get into teaching after his military service turned into a lucrative career in the private sector? He was traveling and working all the time—and wanted to have summers off.

Now the career-technical instructor of Mexican-American descent is giving teenagers a better future through electronics.

"They didn't have anything like this when I was growing up," he said.



Ohio gov to continue fight for Medicaid expansion

COLUMBUS, April 10, 2013 (AP): Ohio Gov. John Kasich says he will continue to fight for extending Medicaid coverage under the federal health care law following the proposal's removal from the state budget.

Kasich told reporters Wednesday he doesn't take it personally that fellow Republicans in the Ohio House dropped the expansion. But he says he "profoundly" disagrees with them and couldn't have made his position clearer.

The GOP-led House un-

veiled its rewrite of the two-year state budget Tuesday. Many Republican lawmakers are averse to Democratic President Barack Obama's law and resistant to expanding government

Rejecting expansion means Ohio would forgo \$13 billion from the federal government over the next seven years to cover those newly eligible for Medicaid.

Kasich says he wants Ohiotaxpayers' federal dol-lars to help those in need.

awards. The course winds through the Zoo's grounds (before public hours), as well as the residential streets around the Zoo.


The Dart Frog Dash also features a popular Kids' Fun Run. This 1K walk/run is open to kids age 12 and younger; all finishes are recognized.



(Continued from Page 2) lobbying effort against a plan in North Carolina to provide driver's licenses to immigrants with the words: "NO LAWFULSTATUS."

The immigrant activism movement gained national attentionin 2007 when President George W. Bush and a bipartisan group of lawmakers unsuccessfully tried comprehensive immigration overhaul. Some high school and college students who were brought to the U.S. as young children began living openly and holding rallies.

The movement gained new supporters in 2010, when Congress debated but did not pass the DREAM Act—legislation that would have granted legal status to young immigrants living in the country without documentation.

Toledo Museum of Art presents Crossing Cultures: The Owen and Wagner Collection of Contemporary Aboriginal Australian Art at the Hood Museum of Art

April 12-July 14, 2013

The Toledo Museum of Artintroduces artworks from the other side of the globe—southern hemisphere—to a new audience when Crossing Cultures: The Owen and Wagner Collection of Contemporary Aboriginal Australian Art at the Hood Museum of Art goes on view April 12–July 14, 2013.

"Although exhibitions of art by Indigenous Australians have been shown on both the East and West Coasts of the United States, the Toledo Museum of Artis pleased to introduce these extraordinary works for the first time to our regional audience," said Director Brian Kennedy.

Kennedy, who wrote an essay for the exhibition catalog, became acquainted with Aboriginal artists while serving as director of the National Gallery of Australia in Canberra. He later met art collectors Will Owen and Harvey Wagner when he hosted an Aboriginal art exhibition in 2006 while director of the Hood Museum of Art at Dartmouth College.

Crossing Cultures explores more than 100 works of contemporary Indigenous art from Australia spanning

five decades by artists from desert communities as well as major metropolitan centers. Owen and Wagner collected the objects and donated them to the Hood Museum of Art. Among artists represented are: Michael Riley, Shorty Jangala Robertson, Danny Gibson Tjapaltjarri, Destiny Deacon and Walangkura Napanangka.

Curated by Stephen Gilchrist, curator of Indigenous Australian art at the Hood Museum of Art, the exhibition encompasses the broad range of media and materials employed by contemporary Aboriginal artists, from acrylic painting on canvas to earthen ochre painting on bark, as well as sculpture and photography, among other media.

"The diversity of artistic perspectives assembled in Crossing Cultures speaks to the richness of the contemporary Aboriginal art tradition, which has been called 'the last great art movement of the 20th century,'" said Gilchrist. "The objects included in this exhibition reference and reinvigorate traditional iconographies, speak to the history and legacy of colonization, and meaningfully contribute to the growing inter-



national discourse on contemporary Indigenous art."

Art historian Henry F. Skerritt, a contributor to the exhibition catalog, writes that Crossing Cultures offers "a perfect illustration of why Australian Aboriginal art is at the vanguard of international contemporary art." He notes in a recent blog posting that "better than any other single movement, Aboriginal art reveals the connective fibers that allow us to maintain and communicate our unique identities in a world of accelerating differences.

While a number of influential artists who contributed to the development of an Indigenous art canon since the 1970s

are in the exhibition, the focus is on subsequent generations of artists who are breathing new life into ancient stories and broadening the possibilities of Indigenous Australian art. There are contemporary paintings that summon aspects of "the Dreaming" as well as photographs from urban-based artists who depict the contemporary realities of Indigenous Australians.

For Indigenous Australian peoples the Dreaming refers to a time long ago when ancestral beings moved across the land creating life and the significant geographic features of the continent. Yet Aboriginal peoples do not conceive of the past, present and

future in progression but, instead, as part of one whole story. The Dreaming, then, also means to "see and understand" today the laws and responsibilities established by these ancestors. Some Dreaming stories are communal; others are personal, but all of the Dreaming stories pass on knowledge, cultural values and belief systems to later generations.

Resonant with cultural memory, objects in the exhibition speak to both the history and the legacy of colonization in Australia. The Hood Museum of Art organized this traveling exhibition with the generous support of Kate and Yaz Krehbiel, Class of 1991, Thayer 1992, and Hugh J. Freund, Class of 1967.



UAW Local 12 event raises awareness of violence against women

Toledo: On Saturday, April 13, 2013, hundreds of people from throughout Northwest Ohio gathered at the *UAW* Local 12 Hall for northwest Ohio's 19th Annual Take Backthe Night (TBTN) event. The program began with a Community Rally featuring speakers and musicians addressing violence against

women, followed by a women's march, a *Women's* Survivor SpeakOut, and a men's program.

The Clothesline Project-more than 200 shirts created by local survivors of violence against women-were displayed, along with the Silent Witness Project, a group of silhouettes honoring women who have been murdered by their partners or former partners; also, the Bandana Project which raises awareness to end sexual violence against farmworker and immigrant women in the workplace.


According to organizers, TBTN events are held in communities around the world. In Toledo, TBTN takes place in a different neighborhood each year, demonstrating that

violence against women happens everywhere. The goals of TBTN are to raise awareness about violence against women, to support survivors of violence against women, and to emphasize that everyone has a role in creating a community free of violence. By walking in the streets together to take back

the night, women are also symbolically taking back their homes and lives from violence.

"Take Back the Night reminds us that for too many women, neither homes no streets are safe places," says Diane Docis, a member of the TBTN organizing collective. "Millions of women are stalked every year. A woman is battered, usually by a male partner, every 15 seconds.

"One in six women in the U.S. have survived rape or attempted rape—more than 80 percent committed by a perpetrator who knows the victim. And even women who haven't survived violence must live everyday with the threat of violence. By taking back the night, we are saying, 'Enough. This is unacceptable.'"

Two intimate Cleveland Orchestra performances feature works by visionary American composers John Adams. Henry Cowell, Lou Harrison, Terry Riley, James Tenney, and, in a posthumous world premiere, Dane Rudhyar

The Calder Quartet will appear with the Orchestra in Riley's *The Sands*, a concerto for string quartet

The Cleveland Orchestra and the Cleveland Museum of Art collaborate in the presentation of California Masterworks, two intimate Cleveland Orchestra concerts at the museum featuring works by groundbreaking composers inextricably associated with California.

James Feddeck, Cleveland Orchestra assistant conductor, will conduct performances Wednesday, May 1 and Friday, May 3, 2013 in the museum's Gartner Auditorium. The programs include works by John Adams, Henry Cowell, Lou Harrison, Terry Riley, James Tenney, and, in a posthumous world premiere. Dane Rudhyar. The concerts are part of the museum's VIVA! & Gala Performing Arts series, which explores extraordinary performing arts from around

California Masterworks also includes three films highlighting California composers, plus concert previews with Case Western Reserve University Professor Henry Adams, speaking about modern and California art, and concludes with a special performance of a work by John Cage at MIX^{up}: Composition.

Cleveland Orchestra ConcertI-Cowell, Rudhyar, and Harrison

The program on May 1, at 7:30 p.m., begins, as does seemingly all music from California, with a work by Henry Cowell. Often considered alongside Charles Ives to be one of the first truly original American composers, Cowell wrote his darkly modernist Sinfonietta in 1928

The centerpiece of the program is the posthumous world premiere of a work by Dane Rudhyar, Out of the Darkness, composed in 1982. Born in 1895, Rudhyar was a wellregarded composer of the socalled "Ultra-Modernist" school alongside Cowell, Carl Ruggles, Edgard Varèse, and others, but moved away from music to concentrate on his writings in astrology, for which he is most well-known. He returned to composing large-scale works late in life, dedicated to, in the words of music scholar Deniz Ertan, "his firm belief in the totality of philosophy, art, and life, and his synthesis of Western and non-Western philosophies and approaches." Stephen Rose, principal second violin of The Cleveland Orchestra, is soloist in the concluding piece, Lou Harrison's Suite for Violin and String Orchestra. Originally written for violin and American Gamelan, a percussion orchestra Harrison's own devising, it was reorchestrated for the sake of practicality and to glori-

ous effect, drawing on both Indonesian and Baroque music, and juxtaposing elegant solo violin lines with eastern dance rhythms.

Cleveland Orchestra Concert II - Tenney, Riley, and Adams

The second program of the series, on May 3, at 7:30 p.m., features the Los Angelesbased Calder Quartet in Terry Riley's The Sands, a concerto for string quartet and orches-

The Calder Quartet have committed themselves to a substantial portion of Riley's string quartet oeuvre, and have even resurrected and belatedly premiered Riley's earliest string pieces - now considered the very earliest hints of Minimalism, of which the composer is generally acknowledged as the founding father. The quartet has worked closely with the composer, forging a relationship that started during their involve-ment in the Los Angeles Philharmonic's Minimalist Jukebox festival in 2006.

The Sands is a large, dramatic work commissioned by the Salzburg Festival in 1991. The program opens with James Tenney's Clang, a work the composer described as "one single modulated event," a close examination of the over-



tone series, and which involves players choosing from available pitches, As such, it encapsulates

Tenney's forward-looking ideas about composition and acoustics. Next is John Adams's Shaker Loops for string orchestra. Written in 1978 and revised in 1983, it clearly shows Adams's emergence as a major composer who has digested the lessons of Minimalism and embarked on his own singular path. The New York Times called it "the earliest of several Adams scores that have become bona fide contemporary classics."

California Music Masters

on Film

The museum will present three films incorporating the music of California composers Terry Riley and Lou Harrison. Tom Welsh, the museum's director of City Stages, will introduce and discuss the films.

Terry Riley's music is heard in two short films on Friday, April 26, at 7 p.m. First up is a 1976 experimental film, Crossroads, by Bruce Conner that looks closely at the 1945 atomic bomb explosion on Bikini Atoll. The second, Music with Balls, is a 1969 movie made for San Francisco television in which music is wedded to abstract visuals.

A new documentary, Lou Harrison: A World of Music, an intimate portrait of a freethinking musician whose groundbreaking compositions spanned decades, directed by Eva Soltes, receives its Cleveland premiere at the museum on Sunday, April 28, at 1:30 p.m.

Concert Previews-Henry Adams speaks about Modern

and California Art The museum is offering two free Cleveland Orchestra concert previews by Dr. Henry Adams, professor of art history at Case Western Reserve University. The first talk, on May 1, will explore "The Quest for Nirvana and the Birth of Modern Art," and the second, on May 3, will delve into "The Funkiness of California Art in the 20th Century." Both previews will begin at 6 p.m. in Gartner Auditorium and are open to the public.

Post-Concert Performance of John Cage's HPSCHD with five harpsichords

As a grand finale to the California Masterworks programs, the museum and the Orchestra will present John Cage's HPSCHD on Friday, May 3. One of the seminal figures of 20th-century music, Cage created the massive piece in 1969, scoring it for up to seven harpsichords, 51 reel tapes and 90 slide carousels Presented as part of the MIX^{up} at CMA series, HPSCHD will utilize five harpsichords from the museum's collection and run continuously in the Ames Family Atrium from 9 to 11 p.m. Admission to MIX^{up}: Composition is included in

the ticket price for attendees of both California Masterworks performances.

The landmark collaboration between the Orchestra and the museum began in May 2011 with Italian Master works, performances heralded by The Plain Dealer as one of the year's "high notes" in classical music. The partnership continues, again following a masterworks theme, this time turning attention to the West Coast of the United States Californian composers emerged with new voices, influenced by the cultures of Southeast Asia and Latin America. They incorporated non-European percussion traditions, tuning systems, and compositional architectures that found their way into music composed for orchestra and the concert stage, creating a classical canon of a different sort-refreshing and exciting.



CHIP Candidate Forum & Roundtable, a summary


Lorain, April 10, 2013: The Coalition of Hispanic/ Latino Issues & Progress (CHIP) held its 13th Candiand dates Forum Roundtable on April 10th. This year due to the work being done on the St. Joe's Auditorium the much anticipated event was held at El Centro de Servicios Sociales at 2801 Pearl Ave thanks to the efforts of Mr. Victor Leandry, who graciously accepted to host the event on the 2nd fl conference room of his building.

The room was tightly packed with residents, elected officials, and, of course, the many candidates looking to get their views out to the public. This event is always well attended for many reasons especially with the video taping of the event by Lorain City School's video dept and then it is aired on the LorainCommunity College's television network channel 20 as well as the LCS TV 19. This is a major advantage for the candidates to get their face connected to their name on the ballot. Also, WEOL was there to send some sound

bites on the air.

Joel Arredondo president of CHIP, opened the proceedings with a welcome and explained that only local races that are opposed are invited. Arredondo then went on to introduce the two moderators for the event—Mr. David Arredondo and myself. Mrs. Mary Santiago, the other co-chair of the political committee for CHIP, was not able to be our other

After explaining the ground rules for the forum [that each candidate would have a 2-minute opening statement after which the candidates will be asked a series of questions with a 1-minute answer then concluding with a 1-minute statement], I started the forum with calls to the local candidates for their respective positions on ballotissues for their respective communities. The primaries will be held in Amherst, Elyria, North Ridgeville, and Lorain. Half way through the pro-



gram two special roundtables were held, one with the superintendent of Lorain public schools-Mr. Tom Tuckerand the other with the mayor of Lorain, Mr. Chase Ritenauer. For the roundtable with Superintendent Tucker the questions were posed by Mr. Michael Ferrer and Mr. David Arredondo. In one statement Superintendent explained why he was quoted as being happy the state came in to take over control of the Lorain City Schools-he believed the state coming in was a good thing because they

were here (Lorain) to help get the schools backontrack. He stated he wasn't concern about anything other than the children of Lorain getting the best education possible.

The next roundtable was of the mayor of Lorain, Mr. $C \ h \ a \ s \ e$ Ritenauer, with myself and Mr. $D \ a \ v \ i \ d$

Arredondo asking the questions. Asked as to the future of Lorain, Mayor Ritenauer stated that cleaning house was one of his first activities and that he found many so-called case studies for the development of Lorain that he threw in the trash can. The one significant study done for the City of Lorain was done by the Staubach Group, which basically pointed out the difficulties the city was facing and had to fix before any major investor would consider Lorain as a viable option for development.

In a nutshell, the study reiterated the same facts that have been previously identified by all of the preceding studies. One was fixing the streets and clearing the blighted areas, but the maior obstacles were two: bring down the high tension towers along Black River Landing and move the sewage treatment plant at the mouth of the river. The Mayor stated that work was started on the removal of the high tension towers and that plans have been made to move the sewage treatment. He is hopeful that the remediation of these obstacles would open the door to a brighter future for Lorain.

The evening continued with candidates answering the questions posed to them by the moderators. Joel Arredondo closed the event with a "Thank You" and reminder that CHIP was hosting its 18th Annual Hispanic Leadership Conference at Lorain County Community College on April 20, 2013 and to visit the CHIP website: www.chiplorain.org for more information.





On March 23, 2010, President Barack Obama signed into law the *Patient Protection and Affordable Care Act*, PPACA), commonly called Obamacare or the *Affordable Care Act*, which together with the Health Care and Education Reconciliation Act represents the most significant government expansion and regulatory overhaul of the U.S. healthcare system since the passage of Medicare and Medicaid in 1965.

PPACA is a simed primarily at decreasing the number of uninsured US-Americans and reducing the overall costs of healthcare. On June 28, 2012 the United States Supreme Court upheld the constitutionality of most of the PPACA confirming it as the "Law of the Land."

Although many of the provisions of the Affordable Care Act such as requirements for

insurance companies to cover all applicants, offering the same rates regardless of pre-existing conditions, and keeping dependent children on their parents insurance plan until age 26 condutions, and aceping dependent critical on their patents instance plan unit age 20 regardless of whether they live with parents, are claimed on tax returns, are no longer a student and are married, have to a large degree been implemented, too many of our people, small businesses and non-profits are still uncertain about what they qualify for, how insurance and medical decisions will be made, what regulations prohibit insurers from dropping policyholders, or the extent to which Medicare is being expanded.

How many of us, for example, are aware that in 2012 all new health plans began to cover

mammograms, colonoscopies and women's preventive services without deductible, co-pay or cost-sharing? How many are prepared to adapt to the health insurance exchanges that will be commonplace by 2014? Will our small businesses know how to secure tax credits offered to them in 2014, or be able to manage regulated maximum deductibles mandated for employer ponsored health plans? For our marginalized and underrepresented communities Undocumented Immigrants" remain eligible for emergency services under the EMT & Active Labor Act?

These are just a few of the questions being asked by Latinos and the at large communities of which we are integral members. For these reasons we devote this year's conference to our Community's Health, The Affordable Care Act, Preventive Care Strategies, Hospice Care, Medicaid and Medicare expansion, poverty and toward activities which move us as a people, toward better health.

This year we bring you experts on the PPACA, doctors devoted to addressing diabetes, a major killer within the Hispanic/Latino community, agency directors, advocates for individual and community health, and workshop presenters dedicated to insuring the Latino and at large community have the information they need to better serve their clients, agencies, neighborhoods and communities. This is essential information and we urge you to collect it and take it back to share with your co-workers, agencies and communities. 
