## Medidas de Trump afectan a emprendedores cubanos

LA HABANA, 28 VI 17 (AP): La nueva política de Donald Trump hacia Cuba está generando ganadores y perdedores: Las agencias de viajes que programan tours esperan aumentar su negocio, pero los dueños de hosterías y cuartos de alquiler cubanos afirmaron que están perdiendo dinero.

Cinco de 12 arrendadores privados de La Habana y la ciudad colonial de Trinidad, al sur de la isla, dijeron a la Associated Press que hubo cancelaciones de reservas tras el anuncio de Trump del 16 de junio.

"Es una contradicción que él dice que quiere ayudar a la sociedad civil, al pueblo cubano, pero lo que está haciendo es perjudicando, en este caso a los arrendadores", dijo a la AP Tony López, dueño de un apartamento en el que alquila tres cuartos a turistas, ubicado en el Vedado habanero a donde una habitación cuesta entre 30 y 50 dólares la noche dependiendo de la temporada y las condiciones.

Entre los que cancelaron reservas figuran dos estadounidenses alarmados por los requisitos legales, como el de que deben tener comprobantes de todos los gastos.

"Recibimos mucho turismo estadounidense. Estamos alarmados. Las cancelaciones para lo que resta de junio y julio son significativas", explicó a la AP, Eliser Ruiz, una encargada del Hostal Lola de Trinidad que gestiona nueve habitaciones y en el pasado tuvo que recurrir a usar seis pertenecientes a sus vecinos pues no daba a basta.

Alex Bunten, de Charlotte, Vermont, esperaba viajar a Cuba con su novia en agosto "sin verte forzado a usar los tours en grupo, los programas fijos y todo eso. Nos gusta manejarlos a nuestro ritmo, comer bien, no estar detrás de un guía con un paraguas".

Pero Bunten desistió de ir porque bajo las nuevas normas, solo agencias de viaje autorizadas pueden llevar estadounidenses a Cuba en viajes para promover el contacto de "persona a persona". "Demasiadas complicaciones", dijo Bunten.

### BOOM DE LOS TOURS EN GRUPO O CONFUSIÓN PÚBLICA?

Las agencias de viaje que organizan tours "deberían estar brindando con champagne" por la nueva política, sostuvo John Caulfield, ex jefe de misión de la Sección de Intereses de Estados Unidos en La Habana y cofundador de la Fundación Innovadores, sin fines de lucro, que promueve la innovación en Cuba.

Entonces, las nuevas normas deberían provocar "un aumento en la demanda", dijo el director ejecutivo de Acces Trips Tamar Lowell. Pero mucha gente "se sentirá confundida por la nueva política", ya asumiendo erróneamente que no se puede ir a Cuba, acotó.

"Las agencias de viaje van a tener que asegurarse de que la gente sabe que se puede viajar", indicó Caulfield.

"¿Va a disminuir la demanda?", preguntó el

presidente de Classic Journeys Edward Piega. "Tal vez. Pero podríamos beneficiarnos".

### LA PROHIBICIÓN DE HACER NEGOCIOS CON LOS MILITARES

Las nuevas normas prohíben hacer negocios con entidades controladas por los militares y las agencias de inteligencia cubanas, incluidos unos 50 hoteles.

Muchas agencias de viajes dicen que eso no es un problema porque usan viviendas y restaurantes privados, así como guías y otro personal locales.

Caulfield afirmó que los hoteles a los que no pueden ir los estadounidenses pueden recibir turistas de otros países, liberando habitaciones para los estadounidenses que vienen con tours.

Los propietarios de pequeñas hosterías, por otro lado, forman asociaciones informales para acomodar a grandes grupos de estadounidenses en varias casas.

Piega indicó que el costo de los alojamientos subió el año pasado pero ya empezó a bajar, permitiendo que Classic Journeys reduzca sus precios de 4,995 dólares por cuatro días a 3,995 dólares.

Lowel estima que los precios podrían fluctuar en cualquier dirección. Al viajar menos estadounidenses en forma individual, habrá más disponibilidad de alojamientos privados, lo que haría bajar los precios. Pero si las agencias de viaje que organizan tours y no tienen acceso a los hoteles controlados por los militares empiezan a usar las viviendas privadas, los precios podrían mantenerse altos.

El tema de los hoteles no afecta a los cruceros porque la gente duerme en el mismo barco.

Carnival Corp., por otro lado, asegura que ya está cumpliendo con las nuevas normas incluso en tierra firme. "Muchos de nuestros tours actuales fueron armados incluyendo operaciones pequeñas, familiares, para que nuestros clientes tengan una experiencia cubana auténtica", manifestó el portavoz de Carnival Roger Frizzell.

Otros están reestructurando sus recorridos. "Tuvimos que reorganizar nuestro tour para mujeres en Cuba", dijo Phillips Stoller, de The Women's Travel Group, que programa un viaje para el 15 de marzo. "La agencia de viajes original planeaba visitas a zonas rurales que aparentemente están controladas por los militares".

Emprendedores privados, por otro lado, temen que el gobierno no permita que las agencias de viajes dejen de usar hoteles estatales y empiecen a emplear el sector privado, al menos no sin cobrar

una fuerte comisión.

En la década pasada que el presidente Raúl Castro comenzó a admitir cierto nivel de actividad privada, el gobierno ve a los emprendedores como aportes vitales al crecimiento económico y al mismo tiempo como competidores peligrosos que pueden perjudicar los negocios estatales. Dado que se exige a los tours usar autobuses y guías oficiales, el gobierno controla sus movimientos y exige a muchos negocios privados que reciben grupos de turistas que firman contratos con comisiones para el gobierno.

Las visitas a atracciones turísticas como la casa de Ernest Hemingway y el night-club Tropicana no deberían ser afectadas por las nuevas normas de Estados Unidos, dado que no son manejadas por los militares.

### EL APOYO AL PUEBLO CUBANO

El senador estadounidense Marco Rubio, de origen cubano y quien apoya las restricciones a los viajes, planteó que los viajes independientes deberían continuar. Dijo en un tuit que las nuevas reglas permiten viajes individuales a Cuba "al amparo de la categoría de Apoyo al Pueblo Cubano" siempre y cuando se usen "alojamientos de propiedad privada".

Eso esalentador para firmas como ViaHero, que crea recorridos personalizados y conecta a los estadounidenses con artistas, empresarios y otras personas en Cuba. El director ejecutivo de ViaHero Greg Buzulencia cree que su firma podrá operar al amparo de la categoría de "apoyo al pueblo cubano" porque sus recorridos "comienzan con conversaciones y promueven los negocios y las actividades independientes" en Cuba, al margen de la esfera gubernamental.

El modelo de ViaHero, por otro lado, es más barato y se puede viajar a La Habana por tan solo 400 dólares la semana, más una tarifa de 25 dólares diarios para planificación, comparado con los 5.000 dólares la semana que cuestan los tours en grupo.

Chad Olin, presidente de Cuba Candela, dice que los tours de "persona a persona" cumplen con las nuevas normas porque todos los alojamientos, los conductores, los restaurantes y las actividades culturales son programadas con el sector privado cubano. Pero también opina que los estadounidenses pueden viajar por su cuenta al amparo de la categoría "apoyo al pueblo cubano", siempre y cuando usen negocios privados y mantengan contactos significativos con los cubanos.

## Southwest Airlines cancela vuelos a 2 ciudades de Cuba

DALLAS, 28 VI 17 (AP): Southwest Airlines Co. anunció el miércoles la cancelación de vuelos a dos destinos cubanos, citando dificultades para atraer pasajeros y políticas estadounidenses más duras hacia la isla.

La aerolínea con sede en Dallas anunció que sus vuelos a Varadero y Santa

Clara terminarán el 4 de septiembre. Seguirá volando de Fort Lauderdale y Tampa a La Habana.

Este mes, el presidente Donald Trump anunció que revaluaría algunas de las relaciones que el gobierno del expresidente Barack Obama reanudó con Cuba.

El vicepresidente de Southwest, Steve Goldberg, dijo que

tomaron la decisión después de que un análisis de rendimiento de los últimos meses indicó que no había un futuro claro de sostenibilidad en esos mercados. También citó a las constantes restricciones al turismo de estadounidenses por parte de Estados Unidos.

## Mexico has filed affidavit expressing concern over Texas law

MEXICO CITY, DF, June 26, 2017 (AP): The Mexican government said Monday it has filed a form of affidavit expressing its concern over Texas' "sanctuary cities" law, which is supported by the Trump administration.

Mexico's affidavit is meant to help legal efforts by some police chiefs and immigrant-rights groups in Texas to stop the law from taking effect in September.

A federal judge in San Antonio is reviewing the constitutionality of the law,

which allows police officers to question people about their immigration status during routine stops.

It also threatens police chiefs and elected officials with jail time and removal from office if they don't comply with federal immigration requests to detain immigrants in the country without documentation.

Carlos Sada Solana, Mexico's assistant secretary of foreign relations, said Monday the affidavit will express Mexico's concerns

that the law "further criminalizes the phenomenon of migration."

The affidavit includes data on a big jump in the number of calls to an immigration advice hotline and requests for legal assistance at Mexican consulates since May, when Republican Gov. Greg Abbott signed the bill, known as SB4.

Sada Solana said "in our community there is concern, there is discomfort, and there is fear of this situation."

**La tribu: retratos de la Cuba cotidiana de un joven cronista**

Ciudad de México, 29 VI 17 (AP): *Carlos Manuel Álvarez* echa sus delgadísimos brazos al frente —como haría un pescador— para explicar la estructura de su segundo libro. Antes de elegir a los personajes que perfilan en *"La tribu"*, dice, se imaginó así mismo lanzando un anzuelo al agua para preguntarse qué es lo que cada uno le permitiría iluminar sobre su país.

“Diecisiete textos pueden parecer mucho, pero son 25 años de mi vida en Cuba. Eso es como una bota perdida en medio del mar”, explica el cronista de 28 años en la Ciudad de México, a donde viajó hace unos días para presentar la obra editada y distribuida por Sexto Piso.

A pocos meses de la muerte de *Fidel Castro* y varios giros en la relación de la isla con Estados Unidos, la Cuba de “La Tribu” no es la que disecan los analistas ni las columnas de opinión. “(El libro) es el retrato de una sociedad poco accesible a través de perfiles. (*Carlos Manuel*) es ese alguien que llegó para contarnos qué pasó con Cuba”, ha dicho el escritor mexicano Emilio Monge.

El lector reconoce dos nombres en “La tribu”: Fidel y Raúl. El resto es la Cuba anónima: Yorgelis, Idalmis, Amaury, Yurién, Ibelys. Por si solos no dicen mucho, pero Álvarez les da

voz.

“La tribu” tiene un subtítulo: “Retratos de Cuba”. Cada historia y cada personaje dan un pulso particular a los latidos de la isla. En la página 29, el texto sobre José Contreras —pitcher y jugadore de los Yankees— traza mucho en muy poco: el aterrizaje del avión de Contreras en La Habana sirve a Álvarez para hablar de leyes migratorias, de béisbol y del contraste entre el cubano que deja a los suyos para buscarse otra vida y el que regresa años después.

“El Contreras de los Yankees es un portento íntegro, una pieza de ébano sin figuras, un cuerpo sin articulaciones ni embates visibles. *El Contreras de Cuba*, en cambio, muestra la definición de sus partes, es como un juguete ensamblado. Fuerte, sí, pero todavía un boceto. Le faltan luces, glamour, pesas. Uno nota los amares de los hombros con los brazos, de los brazos con los antebrazos, de los dedos con las uñas, el zurcido de las fibras”.

En la página 85, los habitantes de un basurero bailan en la oscuridad. En la 115, un boxeador que sube a una lancha con destino a Florida termina detenido en Bahamas. En la 131, el hambrón feroz y el desconcertado tocan el hombro de los viajeros que no llegan a Estados Unidos por mar, sino por tierra, y pasan

por Colombia, Panamá y México. En la 229 hay un poeta.

En “La tribu”, Álvarez no alegiona ni especula. No escribe si la Revolución triunfó o fracasó. No sentencia si el líder fue un héroe o un tirano. Su libro no es una explicación: es un mosaico de ambientes —el aeropuerto, una calle, la orilla del mar— y la historia de un país a través de su gente y lo cotidiano. Es el lado del mundo de un periodista cuyo reporteo inicia en sí mismo.

Un verano de agosto, Álvarez —con su cabello negro, lentes de pasta, cuerpo de alfiler— fue hasta el Malecón “para combatir la melaza romántica que los malos poetas, los cronistas del noticiero y los trovadores deprimidos han vertido sobre este largo muro que ciñe las carnes de la ciudad”. Y entonces él, cubano, que durante cinco años vivió frente a ese Malecón, dejó de ser él —lo intenta— y sale de sí —lo intenta— para escribir. Camina, se detiene, se sienta en un borde y escucha a locales extranjeros. Toma notas. Piensa.

Nosotros, los lectores, espionamos por encima de su hombro. Un italiano critica el comunismo. Una mujer cincuentona se pasa seis horas vendiendo (Continúa en la p. 13)

**Las exageraciones de Donald Trump en torno a la inmigración—es la verdad!**

WASHINGTON, DC, 23 VI17 (AP): Donald Trump se atribuye la idea de construir un muro en la frontera con México con paneles solares. Pero en realidad es una idea prestada: otros plantearon la posibilidad de erigir un muro de millones que costaría un muro tradicional, y probablemente sería algo “extraordinariamente rentable”. Los autores del estudio analizaban una idea lanzada por el poeta y defensor del medio ambiente mexicano Homero Aridjis y por James Ramey en el portal World Post en diciembre.

La mención de los paneles solares fue apenas una de las afirmaciones erróneas que hizo Trump en un discurso pronunciado en Iowa el miércoles por la noche, muchas de ellas en torno al tema de la inmigración.

Hizo afirmaciones que no pueden ser corroboradas sobre la pandilla Mara Salvatrucha y exageró la reducción que hubo en la cantidad de inmigrantes que ingresan al país ilegalmente desde que asumió la presidencia. Declaró que “llegó el momento” de declarar una moratoria a los beneficios para inmigrantes, que en realidad rige desde hace dos décadas. Exageró enormemente la carga que representan los impuestos para la ciudadanía y habló de la forma en que se ha beneficiado la economía por medidas que todavía no tomó.

“Estamos pensando que el muro que vamos a construir será un muro solar, que genere energía y se pague solo. Así, México tendrá que pagar mucho menos dinero”, afirmó el mandatario, a pesar de que México ha dicho que no pagará por el muro. “Muy buena imaginación, ¿cierto?”, agregó Trump, pare rematar diciendo: “Mi idea”.

Su idea, sin embargo, fue aprovechar la idea de otros. La propuesta de usar paneles solares en el muro fronterizo fue analizada en un artículo de opinión del Wall Street Journal en marzo. Vasilis Frhenakis, director del Centro para el Análisis del Ciclo de la Vida de la Columbia University, y Ken Zweibel, ex director del Instituto Solar de la George Washington University, llegaron a la conclusión de que era algo “viable no solo desde el punto de vista técnico y económico”, sino que “podría ser más práctico

que una muralla tradicional”.

Dijeron que un muro solar de 3.200 kilómetros (2.000 millas) costaría menos de mil millones de dólares, comparado con los varios miles de millones que costaría un muro tradicional, y probablemente sería algo “extraordinariamente rentable”. Los autores del estudio analizaban una idea lanzada por el poeta y defensor del medio ambiente mexicano Homero Aridjis y por James Ramey en el portal World Post en diciembre.

La posibilidad de instalar paneles solares fue mencionada asimismo por una de las empresas que se presentaron a licitación para construir el muro. La firma Gleason Partners de Las Vegas planeó cubrir algunas de las secciones del muro con paneles solares y dijo que la venta de la electricidad generada por esos paneles podría cubrir los costos de la obra.

Durante la campaña electoral Trump dijo en numerosas ocasiones que la energía solar era “muy, muy cara” y que “no funciona tan bien”. El mandatario, por otro lado, afirmó que “llegó la hora de fijar nuevas normas a la inmigración que digan que quienes quieren ser admitidos en nuestro país deben estar en condiciones de mantenerse a sí mismo y no usar el sistema de beneficios sociales por un período de al menos cinco años. Esta legislación entrará en vigor a muy corto plazo”.

Ignoró el hecho de que en 1996 se aprobó una ley que básicamente dice lo mismo. Prohibe a todo extranjero que ingresa al país con visa de inmigrante apelar a beneficios como el Seguro Social y cupones alimenticios por los primeros cinco años. Quienes están en el país sin autorización no tienen acceso a esos beneficios, lo mismo que los extranjeros sin visa de inmigrante.

Trump declaró además que los miembros de la MS-13 “hacen cosas que nadie puede creer, son verdaderos animales” y que “los estamos sacando del país de a miles, de a miles”.

Si embargo, no hay pruebas que sustenten esas afirmaciones. En las últimas semanas fueron detenidos cientos de presuntos miembros

de la MS-13 y muchos de ellos fueron identificados como inmigrantes, pero no está claro si fueron deportados. Un pandillero que es ciudadano estadounidense no puede ser deportado. La pandilla surgió en Los Angeles hace varias décadas y se ha expandido.

Si bien los arrestos de inmigrantes sin permiso de residencia han aumentado en los últimos meses, las deportaciones han disminuido ligeramente, según las estadísticas oficiales más recientes.

El presidente, por otra parte, dijo que desde que fue elegido, “los crudos ilegales de la frontera —y esto es sin el muro— se redujeron en más del 75%, un logro histórico, sin precedentes”.

De nuevo, eso es una exageración, según cifras del gobierno. En los primeros cuatro meses de su gobierno los ingresos ilegales disminuyeron un 59%, lo que es una cifra estimable, pero significativamente por debajo del 75%.

Más de 56.600 personas fueron detenidas cruzando la frontera con México ilegalmente entre febrero y mayo, comparado con 137.800 en el mismo período del año pasado, cuando Barack Obama era presidente.

Trump afirmó igualmente que su gobierno impulsó “la reducción de impuestos más grande de la historia” del país y sostuvo que Estados Unidos “es el país que más impuestos paga en el mundo”.

Eso no es cierto. Estados Unidos es uno de los 32 países desarrollados o con economías de mercado emergentes que paga menos impuestos, de acuerdo con la Organización para el Desarrollo y la Cooperación Económica.

Los impuestos representaron el 26,4% de la economía estadounidense en el 2015, según la OCDE, comparado con el 46,5% en Dinamarca, el 32,5% en Gran Bretaña y el 36,9% en Alemania. Solo cuatro países de esa lista de la OCDE tienen impuestos más bajos que los de Estados Unidos: Corea del Sur, Irlanda, Chile y México.

## Drivers pay more for auto accident catastrophic coverage beginning July 1

LANSING, July 1, 2017: This date, Michigan drivers began paying more to cover the cost of medical care for those seriously injured in an auto accident. The increase, from \$160 per vehicle to \$170 per vehicle, is part of Michigan's one-of-a-kind mandate that requires drivers to purchase unlimited, lifetime medical benefits with their auto insurance.

Michigan is the only state in the country that requires drivers to purchase unlimited, lifetime medical benefits.

“Michigan drivers are tired of opening their pockets to pay more and more for a costly mandate that many can no longer afford,” said Dyck Van Koevering, general counsel of the Insurance Alliance of Michigan (IAM). “It's time to roll up our sleeves and work with the Legislature to fix Michigan's broken, outdated no-fault system.”

The Michigan Cata-

strophic Claims Association (MCCA) serves to reimburse auto insurance companies when medical costs exceed \$550,000 (starting July 1). Each year, auto insurers are assessed a fee to ensure there are enough funds in the MCCA to cover the lifetime costs of treating those injured in a catastrophic accident. Drivers then pay that assessment as part of their auto insurance premiums.

The MCCA pays out more than \$1.1 billion per year for medical care stemming from auto accidents. During the past decade, medical care costs have risen 20 percent in Michigan, while inflation increased 11 percent. From 2006 to 2016, the average auto insurance medical claim almost doubled from \$26,989 in 2006 to \$55,103 in 2016.

The increased medical costs have driven up the cost of auto insurance in Michigan to the third-highest in the country, according to the National Association of In-

surance Commissioners. A recent poll conducted by IAM found that more than 70 percent of Michigan voters believe it's time to reform Michigan's broken, outdated auto no-fault law.

When it comes to saving drivers money on their auto insurance premiums, there are three proposed changes to the no-fault system that will help reduce premiums:

- Create a fraud authority to crack down on fraud and scams, which costs the average Michigan family more than a hundred dollars each year in additional premiums.

• Enact a fee schedule to allow auto insurers to have a set rate for what hospitals can charge for procedures, just like in other types of insurance.

- Give consumers a choice of different levels of medical benefits, like a cell phone plan or cable subscription, so they can choose what works best for them – and more importantly, what they can afford.

## Judge OKs lawsuit over once-secret immigrant vetting program

SEATTLE, June 22, 2017 (AP): A class-action lawsuit challenging a once-secret government program that delayed immigration and citizenship applications by Muslims can move forward, a federal judge has ruled.

*U.S. District Judge Richard Jones* in Seattle on Wednesday denied the Justice Department's [DOJ's] request to dismiss the lawsuit, which was filed in February by the American Civil Liberties Union and the Northwest Immigrant Rights Project.

The lawsuit claims the government since 2008 has used the *Controlled Application Review and Resolution Program* to blacklist thousands of applications for asylum, legal permanent residency or citizenship as national security concerns.

The program imposes criteria on the applications that go far beyond what Congress has authorized, including holding up some applications if the applicants donated to Muslim charities or traveled to Muslim-majority countries, the complaint alleges.

The program was not publicly discovered until

2012, when an immigration officer discussed it during testimony in a different lawsuit. Immigrant rights advocates then filed Freedom of Information Act lawsuits to force U.S. Citizenship and Immigration Services to turn over more information about it, the lawsuit said.

"Congress has laid out the requirements for these programs," Matt Adams, legal director of the Seattle-based *Northwest Immigrant Rights Project*, said Thursday. "The agency doesn't have the authority to, one, impose its own requirements, and, two, impose them in a secret program on people who aren't even aware of them."

In addition to challenging the program, the lawsuit seeks to block any other "extreme vetting" that Donald Trump's administration might impose as an updated version of it.

A spokeswoman for U.S. Citizenship and Immigration Services [ICE], *Sharon Rummery*, said the agency would not comment on the pending lawsuit.

In its motion to dismiss the case, the government said the program falls within the legitimate background-check process for immigrants

applying for citizenship or other benefits.

"It is a way for USCIS to investigate and verify information in certain cases, and to ensure reasoned decisions," the DOJ argued.

Other lawsuits around the country have challenged the program, Adams said, but they were dismissed because immigration authorities quickly ruled on the plaintiffs' applications once the complaints were filed, erasing the legal grounds on which they sued.

The same thing happened in the Seattle case, Adams said: Five of the six named plaintiffs had their cases ruled on in the weeks after the case was filed.

One, a Somali immigrant named *Abdigafar Wagafe*, had waited 3½ years for a decision on his citizenship application—a decision typically supposed to be made within six months. It was approved five days after the complaint was filed, and he was sworn in as a U.S. citizen on March 2.

But the judge said the case could go forward on behalf of others whose applications were being delayed because of the program.

## Kaptur, Fudge bill would create a program that would help students turn school debt into home equity

Washington, D.C., June 30, 2017: This week, Congresswomen *Marcy Kaptur* (OH-09) introduced the *Transform Student Debt to Home Equity Act*. It was co-sponsored by Congresswoman *Marcia L. Fudge* (OH-11) and 5 others.

The bill directs the *Department of Housing and Urban Development* (HUD) and *Federal Housing Finance Agency* (FHFA) to create a pilot program for creditworthy student debt holders to transform their student debt into an opportunity to purchase and own a home.

"Congress must do more to help working and middle-class people create wealth and the *Transform Student Debt to Home Equity Act* offers us a road forward to help transform student debt into home ownership," said Rep. Kaptur. "This bill directs the U.S. Department of Housing and the Federal Housing Finance Agency to start a pilot program that connects people with student debt with habitable properties for sale but on

the federal ledger."

In the coming months, Congresswomen Kaptur and Fudge will be working with stakeholders in Ohio and Washington, D.C. to get input on how businesses, organizations, states and Federal agencies can work together to increase the opportunity for homeownership through student debt.

"Creating options for the millions of people with student debt to buy their first home, would allow a new generation to pay off debts and help strengthen neighborhoods, all simply by maintaining a home mortgage," continued Kaptur.

### What does the bill do?

The bill authorizes HUD and FHFA to establish a pilot demonstration that connects creditworthy federal student debt holders with housing properties for sale but held by the federal government. The goal of the pilot project would be to create a program that recalculates financing terms, debt-to-income ratios, interest rates, or other factors in

order to transition federal student loan debt into long-term homeownership.

The bill also requires the related agencies to report back to Congress on such a pilot program within 90 days of enactment. The bill does not direct any specific plan but does request the related agencies propose a pilot program that could potentially be used as a national model for enabling college graduates to restructure their student debt into an opportunity to purchase habitable foreclosed and vacant homes across the country.

The bill has five additional co-sponsors: *Reps. William Lacy Clay, Jr. (MO-01), Dwight Evans (PA-02), Robert Brady (PA-01), Pramila Jayapal (WA-07), and Chellie Pingree (ME-01)*.

## Disputa de paternidad requiere exhumar restos de Dalí

MADRID, 26 VI 17 (AP): Un juzgado de Madrid ordenó el lunes exhumar los restos de *Salvador Dalí* ante el reclamo de una mujer que dice ser hija del pintor surrealista y pese a la oposición de la fundación que gestiona el patrimonio del artista.

Pilar Gala, que nació el 1 de febrero de 1956 fruto de un romance que Dalí mantuvo con su madre, Abel, fue visible en un programa de la televisión local de Girona, donde reside.

Conocido sobre todo por su trabajo en pintura y escultura pero también en cine y otras disciplinas, Dalí es considerado una de las figuras más destacadas del surrealismo del siglo pasado.

Nació en la localidad costera de Figueres, en

Cataluña, donde también murió y fue enterrado en 1989. La esposa y musa del pintor, Gala, había fallecido siete años antes. La pareja no tenía hijos y Dalí legó todo su patrimonio al Estado español.

Según la decisión de una jueza de Madrid que se hizo pública el lunes, el estudio de ADN obtenido directamente del cadáver embalsamado del pintor es necesario porque no existen otros restos biológicos o personales para hacer la comparación genética.

Abel presentó hace dos años

la querella

para ser reconocida

como hija del artista contra el Ministerio de Hacienda y Administraciones Públicas, como depositario de la herencia, y la Fundación Gala Dalí, que surgió para gestionar el patrimonio del artista.

“Ellal que quiere es acabar


cuanto antes y tener el resultado ya con toda garantía”, dijo a The Associated Press *Enrique Blánquez*, el abogado de Abel.

Si las pruebas le dan la razón Abel podría emplear el apellido Dalí y litigar para obtener los derechos de autor desuobra, que como “heredera forzosa” equivaldría a una cuarta parte del patrimonio.

La Fundación Gala Dalí apelará la decisión de la jueza, señaló la portavoz de la fundación Imma Parada en un correo electrónico.

Pero Blánquez dijo que la apelación no tiene por qué impedir la exhumación de forma inmediata.

La primera vista del juicio, ya con los resultados de las pruebas de paternidad, está fijada para el 18 de septiembre, señaló el abogado.

**SOCHI**, Rusia, 29 VI 17 (AP): Catalogada como demasiado joven e inexperta al comienzo del torneo, la selección Alemana tardó mucho en madurar.

Contundente en ataque desde el silbato inicial, Alemania liquidó el jueves por 4-1 a México y avanzó por primera vez a la final de la Copa Confederaciones, donde se topará el domingo con una selección de Chile curtida en estas instancias después de conquistar dos títulos consecutivos de la Copa América.

**Leon Goretzka** madrugó a México con dos goles antes de los ocho minutos, y **Timo Werner** y **Amin Younes** agregaron otro par en el segundo tiempo para mantener el récord perfecto de Alemania en cinco enfrentamientos ante el conjunto norteamericano. Marco Fabián descontó en el último minuto con un cañonazo desde fuera del área.

“Nuestro equipo ha aprendido muchísimo”, afirmó el técnico alemán **Joachim Löw**, cuyo plantel es el más joven del torneo, con una edad promedio justo por debajo de los 24 años. “Realmente ha tenido la posibilidad de experimentar cosas muy diferentes, y ha habido una evolución. Se han desarrollado mucho, claro que han crecido mucho”.

“Esta experiencia es algo que acompañará y ayudará a mis jugadores no sólo ahora, sino también en los próximos años”, agregó el timonel alemán. “Les va a enseñar a controlar el ritmo y mantener el

control en situaciones difíciles”.

Esa madurez quedó en evidencia desde el arranque, cuando Alemania no perdonó las desatenciones de un México que apenas empezaba a acomodarse en la cancha y Goretzka venció al portero **Guillermo Ochoa** a los seis minutos con un remate desde la media luna, tras un desborde y centro de **Benjamin Henrichs** por la banda derecha.

El segundo llegó apenas dos minutos después, con un pase de Werner. A partir de entonces, México tuvo que remar contra la corriente frente a un oponente que defendió bien cuanto tuvo que hacerlo, y que también contó con buenas intervenciones de su portero **Marc-André Ter Stegen** en algunos momentos aciagos.

“Es complicado recibir dos goles tan rápidos al inicio, ante un rival como Alemania”, señaló Ochoa.

Asimilados los golpes, México empezó a ordenarse en la cancha y a partir de la media hora controló las acciones el resto del primer tiempo.

**Giovanni Dos Santos** tuvo dos remates casi sucesivos q los 32 y 33 minutos que fueron atajados por Ter Stegen, el segundo con una estirada de la pierna derecha. Poco después, **Javier Hernández** falló un mano a mano con el portero alemán, al enviar la pelota por encima del arco, y a los 39, un tiro libre de **Héctor Herrera** pasó cerca de la travesaño.

El entretiempo ayudó a los

germanos a reagruparse, y Werner amplió la delantera con el tercero a los 59, tras un pase de **Hector Jonas**.

“A veces la adrenalina nos gana, a veces cometemos errores que ellos aprovechan muy bien”, lamentó Fabián. “Nosotros tenemos que aprender eso, a ser contundentes, a aprovechar los errores”.

México tuvo otra oportunidad cuando **Raúl Jiménez** estrelló un cabezazo en el travesaño a los 75, uno de 11 jugadores mexicanos que tuvieron al menos un remate al arco. El equipo del técnico colombiano **Juan Carlos Osorio** finalmente pudo remecer las redes a los 89, cuando Fabián anotó con un inesperado y potente remate. Pero Younes volvió a ampliar el colchón casi de inmediato en el último minuto.

“Considero que merecíamos más”, afirmó Osorio. “El equipo fue siempre al frente, buscamos, continuamos con la idea de juego, a pesar de ir en desventaja, y ante un equipo replegado contanto se efectivos les generamos suficiente opciones como para haber hecho otro o dos goles más”.

México enfrentará a **Portugal** por el tercer puesto el domingo en Moscú. Los campeones europeos, que cayeron el miércoles en semifinales en una definición por penales ante **Chile**, no contarán con su estrella **Cristiano Ronaldo**, que abandonó la concentración por el nacimiento de sus hijos mellizos.

**De bares a estadios: Lady Gaga se prepara para su nueva gira**

**NUEVA YORK**, 29 VI 17 (AP): Sea en un bar o en un campo de béisbol, **Lady Gaga** dice que lo dará todo en cada actuación.

La cantante sale este verano en una gira por estadios alrededor del mundo, y también regresará al *Dive Bar Tour* con *Bud Light* para un espectáculo en Las Vegas el 13 de julio.

Su primera serie de conciertos en bares, que terminó el año pasado cerca del lanzamiento de su álbum *Joanne*, la calificó como una experiencia profunda.

“Cuando me paraba ahí olvidaba por completo dónde estábamos y entraba en modo de actuación”, dijo Gaga en una entrevista telefónica. “Para mí, no importa cuán pequeño sea el recinto, uno no actúa distinto a como lo haría en un lugar grande, no sería justo con los fans”.

El club del año pasado incluyó una parada en The Bitter End, el bar de Nueva York donde Gaga cantaba antes de alcanzar el estrellato. La nueva gira Dive Bar también incluirá presentaciones en Los Ángeles (26 de julio) y Nueva Orleans (30 de agosto), y será encabezada

por otros artistas aún por anunciar.

Gaga, de 31 años, comienza su gira mundial el 1 de agosto en Vancouver, Canadá. Actuará en estadios como el Citi Field en Nueva York, el AT&T Park en San Francisco, el Wrigley Field en Chicago y el Fenway Park en Boston.

Ahora que terminó de filmar la película *A Star is Born* con Bradley Cooper - una experiencia dijo fue “maravillosa” e “inspiradora”, que “cambia la vida” - está enfocada en su enorme gira.

“Esta va a ser un poco diferente”, señaló. “Me gusta cambiar las cosas. Tengo algunas ideas de cómo me gustaría interpretar algunos de los clásicos para mis fans”.

Parte del cambio deriva del sonido de *Joanne*, que incluye rock, country y temas más lentos en comparación con sus éxitos bailables del pasado, con sonidos electrónicos.

“El álbum fue extremadamente sanador y reflexivo para mí. Escribí sobre cosas que nunca había escrito antes que son extremadamente profundas y personales, y me atrevo a decir, cosas que me acecharon, que me estaban envenenando, que eran

tóxicas para mí y las saqué. Fue muy revelador en ese sentido”, dijo.

“Y la portada del álbum es muy indicativa de eso”, agregó. “Yo, poniéndome un sombrero que no había usado antes sin estar segura hacia dónde voy, pero sabiendo que tengo que salir de donde me encuentro”.

El pasado abril el festival de Coachella, que Gaga encabezó, la cantante lanzó “The Cure”, una canción animada sobre sanación.

Dijo que la escribió tras su actuación en el medio tiempo del Super Bowl, que está escribiendo nueva música y que podría lanzar otro tema no relacionado con el álbum.

“No diría que es imposible”, indicó.

## United Way of Greater Lorain County commits up to \$1.275 Million to continue providing Emergency Financial Assistance through 2020

LORAIN, June 29, 2017: United Way of Greater Lorain County announced that it has committed up to \$1.275 million over the next three years to continue providing year-round emergency financial assistance for rent, utilities, and other emergency basic needs through its United Community Assistance Network (UCAN) Community Collaborative.

UCAN covers every zipcode in Greater Lorain County through a neighborhood approach that places case managers at partner sites throughout the community. In addition to financial help, UCAN provides ongoing case management, benefits screening, and access to additional emergency resources.

Since launching in 2014, UCAN has assisted 1,306 households with over \$771,748 in financial assistance. Of those households needing help, less than five

percent have needed additional unplanned assistance in the future.

"We are so grateful to our donors and UCAN partners for making this community collaborative such a success," said United Way executive director Bill Harper. "Families can stay in their homes without the loss of vital services hanging over their heads, and children can enjoy the stability that is so critical to their growth and development. We're excited to extend our commitment to taking this proactive approach that keeps our families and community stable."

In addition to United Way of Greater Lorain County, UCAN collaborative partners include: Catholic Charities, Neighborhood Alliance, North Ridgeville Community Care, Oberlin Community Services, and Salvation Army locations in Elyria, Lorain, Oberlin, and Vermilion.

The partners meet regularly and continue to test improvements to become more efficient and provide better services. By creating a shared intake system as part of UCAN, partners have experienced a 50 percent reduction in the amount of time spent completing paperwork and a 30 percent reduction in the unmet need calls for rent and utilities.

The commitment from United Way will provide an amount not to exceed \$425,000 per year from July 1 of this year through June 30, 2020 to provide case management at the partner locations and fund the emergency financial assistance payments.

## Immigration lawyer David Leopold: US Supreme Court decision still a win

CLEVELAND, June 27, 2017 (AP): An immigration attorney who helped a *Cleveland Clinic* medical resident refused entry to the U.S. under a Trump administration order in January says the limited ban allowed by the Supreme Court is still a "win" for those opposed to the ban.

The Supreme Court is allowing the Trump administration to go forward with a limited version of its ban on travel from six mostly Muslim countries.

Immigration attorney David Leopold helped secure the return of Sudanese national Suhua Abushamma to Cleveland and

says he's happy that students like Abushamma won't be affected by the court's decision.

Leopold is concerned the court's decision could hurt refugees and is disappointed that the court didn't let prior injunctions stand.

The justices will hear full arguments in October.

## Tri-C Board of Trustees approves Bond Issue request

CLEVELAND, June 30, 2017: The Cuyahoga Community College (Tri-C) Board of Trustees voted to place a 0.5-mill bond issue on the Nov. 7 ballot for the repair, improvement, and construction of facilities vital for college completion and workforce education.

The bond issue levy would raise funding for the College to address decades of wear and tear on buildings; keep pace with rapidly changing technology; and create new instructional space for growing programs.

Collection of the bond issue would begin in 2018 and run 25 years. The request asks Cuyahoga County property owners for an additional investment of less than \$1.50 per month on a \$100,000 home.

The issue would generate \$227 million for investment across all Tri-C campuses. It would provide the resources needed to keep Tri-C students well prepared for the jobs of tomorrow.

- Construction of a second building for classrooms, student space and faculty at Westshore Campus in Westlake.

- Creation of a Transportation, Distribution and Logistics Academy in Euclid with classroom and training space.

- Repair and replacement of old roofs, plumbing, electrical, ventilation and security systems across the College.

- Renovations and equipment updates to labs used across the College by health care, manufacturing, information technology and other demand workforce programs.

- An addition at Western Campus in Parma dedicated to programs focused on science, technology, engineering and math.

- An addition to the Advanced Technology Training Center at Metropolitan Campus in Cleveland to create flexible lab space for engineering and manufacturing.

- With local support and hard work, Tri-C has been able to offer affordable, high-quality, life-changing education and training for more than 50 years," said Victor Ruiz, chair of Tri-C's Board of Trustees. "This bond issue will protect the public's investment in this vital community asset."

## Cleveland Foundation announces \$11.4 million in June grants

CLEVELAND, June 29,

2017: The Cleveland Foundation board of directors today approved \$11.4 million in grants for the month of June to support residents in Cuyahoga, Lake, and Geauga counties. The announcement brings the foundation's grantmaking total to \$21.2 million for the second quarter of 2017 and to \$41.8 million for the first half of the year.

This latest round of funding in the community primarily focuses on three of the foundation's priority areas of impact: education, youth development, and health & human services.

"This month we continued our focus on helping youth in our community and our underserved populations," said India Pierce Lee, Cleveland Foundation senior vice president, program. "From extending educational and mentoring opportunities, to supporting expansion of critical human services across a number of sectors—it's imperative that the foundation continue to serve all of Greater Cleveland."

### Highlights from the approved grants include:

#### Education

- Formed in 2010 with four schools serving 1,165 students, Breakthrough Schools will serve 3,400 students across 11 schools in the upcoming 2017-18 school year. In order to continue to build upon what a new Stanford University report recently dubbed "the strongest charter school operating group in Ohio," the foundation granted \$500,000 to Friends of Breakthrough Schools to support two new schools opening in fall 2017 and the grade expansion of Breakthrough's new schools that opened in 2015 and 2016. The grant also includes funding for support services that Breakthrough provides to all of its schools.

tion services to expand and strengthen resources for survivors of torture.

- Originally established as a collaboration between Amish families and medical professionals, DDC Clinic for Special Needs Children has evolved into an internationally recognized, pioneering research facility and family-oriented specialized care clinic— blossoming into a global leader in diagnosing, treating, and researching rare and complex genetic disorders. In addition to serving more than 800 patient families from 22 Ohio counties, 30 states and several foreign countries, DDC is also a licensed genetics laboratory. Due to significant demand for the organization's services and the need for additional research capabilities, the foundation granted DDC \$135,000 to retain a new physician-scientist who will provide patient care and lead complex research projects and clinical trials.

- Since 1991, Emerald Development and Economic Network (EDEN) has been providing, operating, and advocating for safe, decent, affordable housing and support services for some of the most vulnerable families and individuals in Cuyahoga County. The foundation granted EDEN \$225,000 to continue advancing its innovative approaches to addressing the community's housing needs by:

- Adding a full-time community housing agent who will extend services to those with substance use disorders who are exiting state prisons

- Engaging in the second year of a pilot addressing housing stability for young adults

- Conducting a market study to ensure the work EDEN is undertaking aligns with the current community housing needs and to identify gaps and areas for sustainable growth

## Latino small businesses can get help from MBAC's upcoming workshops

July 1, 2017: The number of Latino-owned businesses continues to grow in Northwest Ohio as the overall Latino population increases locally. But the survival of those small businesses depends on cash flow, access to capital, and a myriad of other issues where solutions may not be readily at hand.

The Minority Business Assistance Center (MBAC) at the University of Toledo-Scott Park campus is offering a series of monthly summer workshops to help Latino and other minority small business owners a way to troubleshoot ongoing problems and get free advice from other, more experienced pros.

"This brings that business acumen by way of a professional that can present the ins and outs, the details associated with this specific business subject matter," said Erik Johnson, director of the UT Minority Business Development Center (MBDC), which houses MBAC within its office complex. "Usually in small business, you have to find resources that are within other sources—and you don't always know the credibility of those sources."

The MBAC program vets the expertise of its presenters to ensure small business owners receive accurate, timely, and valuable information during those monthly workshops. One such seminar in early June covered developing web pages and marketing.

"By having workshops like

these, you can shore up small businesses," said Mr. Johnson. "Most small business owners are very good at the delivery of the solution or the service. But it's the back house things, day-to-day business, operational things that support that delivery, that they're not good at because they haven't had that exposure nor have that experience. They're good at what they do."

### The upcoming MBAC workshops schedule includes:

- July 13: Credit Repair
- Aug. 10: Business Roundtable: Problem Solving
- Sept. 14: Loss Prevention and Cyber Security

Each of the sessions runs noon-1:30 p.m. at UT's Scott Park campus, 2145 East Scott Park Dr. The MBAC is located within the Faculty Annex building.

Credit repair, according to MBAC officials, is a big deal to many small business owners, especially when they're seeking to grow the business. "When you first go into business, it's usually generated from an idea or some skill set that you possess," said Mr. Johnson. "You can go and introduce that service or that solution, so you start picking up customers. But as you grow and start having a greater de-

mand for money, all of a sudden you have to start looking at lending sources. Now the credit issue comes into play. Many small business owners, for whatever reason, were downsized or weren't getting steady work." That causes individuals to start to live off credit or leverage credit which causes some damage along the way. Now you need to repair it."

Some even co-mingle personal and professional funds and find that their credit is shot when it comes time to borrow the capital needed for more equipment, staff, or some other reason.

Cyber security has become an even bigger issue for small businesses, especially for those who are either suppliers or contractors with the federal or state government. Most are required to have some minimal level of technology and a cyber security plan. MBAC helps minority small business owners to become qualified for those sorts of contracts as a supplier or service provider.

Mr. Johnson stated having that plan becomes even more important for the little guy "when you start talking about tapping into presidential campaigns and things like that at the highest levels of our government system."

The outgoing MBDC director stated the problem-solving roundtable may be the most valuable resource offered for a minority small business owner—because once a discussion starts, that business owner sometimes picks up a connection, a customer, or even a partner along the way in addition to receiving helpful advice on a sticky problem plaguing daily operations.

"So many times we don't think about critical problem-solving processes, because we're so reactive in small business," explained Mr. Johnson. "We're wearing all these different hats trying to keep up with customer demands and sometimes it gets quite challenging prioritizing which problems to address first."

The workshops will continue despite some internal leadership changes at both the MBDC and the MBAC. Mr. Johnson soon will hand over the reins to someone else at the MBDC, a University of Toledo initiative which provides office space and technical assistance to small businesses as an incubator of sorts. Johnson is returning to the private sector

to grow his own construction supply business, as well as other ventures.

"It was a response to a call from the community to help support small minority businesses by way of a physical plant, a space where individuals can


come and set up shop in a professional environment," said Johnson. "They have access to professors on campus, as well as coaching and counseling within that center."

MBAC, which is funded by the state of Ohio as a regional program and housed at UT, offers free advice to existing businesses which have offices

or a storefront elsewhere in Northwest Ohio.

Long-time Latino insurance executive Mark Urrutia was recently named as the MBAC interim executive director. He had been serving as a minority small business consultant at the center.

## Mayors to Trump: immigration orders meddle with cities

MIAMI BEACH, June 25, 2017 (AP): Mayors are warning Donald Trump that toughening immigration enforcement meddles with U.S. cities' affairs.

More than 250 mayors are meeting at the U.S. Conference of Mayors in Miami Beach to take a stance on issues from climate change to the federal budget and healthcare. They are reviewing resolutions that would strongly oppose Trump's crack down on undocumented immigration.

Mayors were struck a blow in January, when Trump ordered to cut funding to jurisdictions that deny in some way cooperation with federal immigration agents. Most cities have defied the order, and a federal judge blocked it in April, at least temporarily.

"Some of us are proud to be places of sanctuary, to protect immigrants, but this idea that we're in violation of something, I think is a big charade," said *Los Angeles Mayor Eric Garcetti*.

Garcetti argued that all he wants from immigration officials is that they conduct enforcement in a "lawful, constitutional, court-ordered way," referring to policies where sanctuary cities demand warrants to turn over suspects to the U.S. Immigration and Customs Enforcement [ICE].

Police officers in Los Angeles do 20,000 to 30,000 requests for warrants from judges every year in the

middle of the night when the judges are probably in their pajamas," Garcetti said. "The idea that ICE can't do the same thing seems ridiculous."

Mayors from big cities say they fear the increased enforcement will push immigrant communities into the shadows, deterring them to report crimes or cooperate as witnesses. The police chief of Los Angeles, Charlie Beck, said in March that sexual assault and domestic violence reports by Latinos had dropped.

*Miami-Dade County*, which houses 34 municipalities including the conference host of Miami Beach, heeded Trump's January order and changed its policy so the corrections department honors all requests by ICE. Authorities have turned over 124 people to the U.S. Immigration and Customs Enforcement since Jan. 27.

But GOP-identified mayors from states such as Indiana and Florida disagreed this weekend on targeting non-criminal immigrants solely for being in the country illegally.

*Kent Guinn*, mayor of *Ocala, Florida*, says that although he is against offering a pathway to citizenship to the 11.5 million immigrants who are in the country without documentation, most immigrants he sees are "good." "The ones that we encounter on a day-to-day basis, they're very hard-working individuals that do the things that they need to do and participate in the economy. They work on horse farms, in restaurants. We

see them. They're good people. We're not going around looking for them."

The Republican Mayor of *Carmel, Indiana*, Jim Brainard, who is also bucking his party on the climate front, says he opposes Trump's immigration views.

"Punishing cities makes no sense," Brainard said. "Everyone who has come to this country, regardless of whether it was illegal, ought to have a pathway to legalization and then we can move to issues that really can help make our country better."

Besides opposing the order on sanctuary cities, several mayors propose extending a deportation reprieve granted by former President Barack Obama to young immigrants who arrived without documentation. Trump had vowed to end the program known as *Deferred Action for Childhood Arrivals* (DACA), calling it "illegal executive amnesty," but has not yet decided whether he will revoke it.

ICE said it arrested more than 41,000 people on immigration charges in Trump's first 100 days in office, an increase of nearly 40 percent from the same period a year earlier. *Nearly 11,000 had no criminal convictions, more than double the number of immigrants without criminal convictions that were arrested during a comparable period last year.*

## Merkel antes de G20: pacto de clima de París es irreversible

BERLIN, 29 VI 17 (AP): Europa está "más decidida que nunca" a hacer del acuerdo climático de París un éxito, dijo el jueves la canciller de Alemania, Angela Merkel. El pacto no es negociable, agregó la dirigente, que prevé conversaciones complicadas sobre el asunto en la cumbre del G20 de la próxima semana.

Merkel dijo también que espera una "señal clara" en favor del libre mercado y el sistema de comercio multilateral en la reunión que se celebrará el 7 y 8 de julio en Hamburgo, recordando que el proteccionismo no puede solucionar los problemas del mundo.

La canciller informó al parlamento alemán antes del encuentro que mantendrán más tarde el jueves los países europeos que estarán en la cumbre de las 20 principales economías del mundo.

Elenfoque "Estados Unidos primero" del gobierno de Donald Trump sobre comercio y otros asuntos ha causado preocupación generalizada, como ocurrió con su decisión de retirarse del acuerdo de París contra el cambio climático.

La Unión Europea implementará rápido sus compromisos con este acuerdo, señaló Merkel. "Desde la decisión de Estados Unidos de salir del acuerdo del clima de París, estamos más decididos que nunca a llevarlo al éxito", agregó.

"El acuerdo de París es irreversible e innegociable", declaró.

"No podemos esperar conversaciones fáciles en Hamburgo" sobre el asunto, añadió la canciller. "El desacuerdo es obvio, y sería deshonesto pasarlo por alto. Yo no lo haré, en ningún caso".

"El G20 no puede ignorar el desafío que supone el cambio climático para todo el mundo", dijo Merkel añadiendo que los líderes deben tener en cuenta las preocupaciones de naciones como las insulares, las más amenazadas por el aumento del nivel del mar.

Por otra parte, señaló que "todo el que piense que puede solucionar los problemas de este mundo con aislacionismo y protecciónismo está cometiendo un gran error".

El G20—un foro internacional que ganó

importancia tras la crisis financiera global—es más necesario que nunca porque el trabajo conjunto de los países es más efectivo para cambiar las cosas que las políticas nacionales descoordinadas, alegó.

Hamburgo prepara un enorme dispositivo de seguridad para proteger la cumbre, que se celebrará en el centro de la segunda mayor ciudad de Alemania.

"Sabemos que la cumbre y los días previos son un gran desafío para los ciudadanos de Hamburgo", dijo Merkel a los legisladores. "Sabemos que habrá protestas, y eso es más que legítimo en una democracia. Solo espero (...) que las protestas sean pacíficas".

El G20 incluye a Argentina, Australia, Brasil, China, Alemania, Francia, Gran Bretaña, India, Indonesia, Italia, Japón, Canadá, Corea del Sur, México, Rusia, Arabia Saudí, Sudáfrica, Turquía, Estados Unidos y la Unión Europea. Como invitados estarán Holanda, Noruega, España, Guinea, Senegal, Singapur y Vietnam.
