



#### Feds vs. state again in suit against Arizona law

PHOENIX, July 7, 2010 (AP): The federal lawsuit against Arizona's new immigration law focuses heavily on a question that has been in the spotlight repeatedly the past decade and dates back to the Founding Fathers: The right of the government to keep states from enacting laws that usurp

federal authority.

The lawsuit filed in Phoenix federal court on Tuesday sidestepped concerns about the potential for racial profiling and civil rights violations most often raised by immigration advocates. Experts said those are weaker arguments that don't belong in a legal challenge brought by the White House to get the measure struck down.

Instead, the suit lays out why the government believes that immigration laws passed by Congress and enforced by a range of federal agencies must take precedence to any passed

by a state Legislature.
The Arizona law requires officers, while enforcing other laws, to question a person's immigration status if there's a reasonable suspicion that they are here without documenta such as speaking poor English, traveling in an over-crowded vehicle or hanging out in an area where immigrants typically congregate.

The law also makes it a state crime for legal immigrants to not carry their immigration documents.

Backers of the law say the crackdown is a necessary tool to keep undocumented immigrants out of Arizona and com-bat problems such as drug trafficking, murders and violent kidnappings that have become so common in a state that is

home to an estimated 460,000 undocumented residents.

The federal government will ask a judge to grant an injunction to block the law from taking effect on July 29.

The arguments will focus on a core constitutional concern-balancing power between the states and the federal government. More specifically, the issue centers on the long-running "pre-emption" legal argument that says federal law trumps state law.

The nation's immigration laws reflect a careful and considered balance of national law enforcement, foreign relations, and humanirian interests," the suit says. The lawsuit goes on to say

"state may not establish its own immigration policy or enforce state laws in a manner that interferes with the federal immigration laws. The Constitution and the federal immigration laws do not permit the development of a patchwork of state and local immigration poli-

cies throughout the country." Backers of the law say that Arizona will have some strong arguments in its favor

in fighting the lawsuit. Kris Kobach, the University of Missouri-Kansas City law professor who helped draft the Arizona law has said the state law is only prohibiting conduct already illegal under federal law. And Harvard Law School professor Gerald Neuman believes Arizona could make a compelling legal argument that it has overlapping authority to protect its residents.

But courts have ruled that under the Supremacy Clause

law that conflicts with a federal law is pre-empted. Federal law, the framers said, "shall be the supreme law of the land."

The pre-emption tactic has been successfully used by the federal government on several occasions over the years, including by the Bush administration to limit product liability lawsuits. The government also used it to overturn bans on military recruiters passed by liberal California towns.

Federal courts have invoked the Supremacy Clause on immigration issues as well. For example, a federal judge in 2008 struck down a Dallas suburb's ordinance that banned apart-ment rentals to undocumented immigrants, saying the U.S. government has the ultimate authority to enforce immigration laws.

Within months of taking office, the Obama White House directed department heads to undertake pre-emption of state law only with full consideration of the legitimate prerogatives of the states. The 2009 directive was aimed at reversing Bush administration policy which had aggressively employed pre-emption in an effort to undermine a wide range of state health, safety and environmental laws.

Despite the precedent, that doesn't mean the lawsuit is a sure winner, or that state officials don't believe they pass laws that head into federal

In fact, efforts by many states trying to block the nation's new health care law run headlong into the Constitution's Supremacy Clause. But immigration is one area where federal

#### County GOP doesn't like 'Fiesta' theme

SANDPOINT, Idaho, July 8, 2010 (AP): Some Republicans are unhappy with the Bonner County Fair's theme of "Fiesta at the Fair," in light of ongoing battles to stop undocumented immigration from Mexico.

The Bonner County GOP said it will decorate its booth with the word "celebrate" instead of "fiesta. The Republicans have also asked Arizona officials for some license plates to put in the booth, to show support for that state's controversial law targeting illegal immigrants

"The Republicans at BCRCC want to make it very clear that English is our primary language, and call our booths 'Celebrate!' and display some Arizona license plates if you have some to spare," Bonner County Republican Central Committee Chairman Cornel Rasor wrote in a letter to Arizona Gov. Jan Brewer, according to The Spokesman-Review news-

paper. The fair runs Aug. 24-28 in Sandpoint, Idaho, a town with relatively few

minorities that is about 90 miles north of Spokane, Wash.

Bonner County fair board Chairman Tim Cary said the fairwas just looking for a theme that's fun to decorate with, and the choice had nothing to do with official language or immigration disputes.

Cary noted that one of the fair's regular offerings is the Mexican food sold at the Search and Rescue booth.

"Are we supposed to change the name of a burrito to something in English?" Cary said. "I'm thinking there's some narrow-mindedness here, but that's just my opin-

The county GOP at its monthly meeting in June voted to "affirm" Arizona's tough immigration law and to send the letter seeking the li cense plates for the fair booth to Arizona's governor.

Rasor, also a county commissioner, sought to distance himself from the clash Wednesday but acknowledged he signed and sent the

letter.
"Having a fiesta theme at the fair was OK with me, I didn't even think about it 'til somebody brought it up," Rasor said. "But their concerns are very real to them, so I don't want to downplay

Rasor said the words "fiesta" and "celebrate" mean

the same thing.
"So technically speaking we didn't have a different theme than the fair, it's just a different spelling," he said.

Last year's fairtheme was 'A Black Tie and Blue Jeans Affair.

The Arizona law, not yet in effect and under legal challenge, is intended to drive undocumented immigrants out of Arizona and discourage them from coming to the United States. It requires police investigating another crime to ask people about their immigration status if there's "reasonable suspicion" they're in the country without documentatin. It also makes being in the country without documentation a misdemeanor under state law.

The Idaho Legislature may consider a similar law in its next session.

"Immigration has traditionally and constitutionally been the historic preserve of the federal government, and

there are cases going back to the late 19th century that say as much," said Peter Spiro, a constitutional law professor at Temple University who has studied immigration law ex-tensively. "So the Obama Ad-ministration has a lot to work with in filing this claim, and the fact that the claim is filed

by the administration adds credibility ... and increases the chances that law will be struck

down on pre-emption grounds.

"That said, it not by any means a slam dunk," Spiro said.

Regardless of how the case is determined at the district

court level, it will likely be appealed. The U.S. Supreme Court is already set to hear an Arizona immigration case in the fall when it takes up a challenge to a 2007 state law punishing employers who knowingly hire undocumented immigrants.

If the high court doesn't issue a broad ruling on states' rights to implement laws on immigration in that case, prepare to see the case filed Tuesday make to the justices, Spiro

"It's clearly an important case. The Arizona law is unprecedented in its aggressive posture towards illegal immigrants. It's an important issue federally, really, that's the way the administration is framing it. They say the states do not have this kind of role as far an immigration legislation."

The host of Comedy Central's "Colbert Report" teamed up Thursday night with Arturo Rodríguez, the president of the United Farm Workers of America. in a challenge to unemployed U.S.-Americans: Come on, take our jobs.

ing Americans to fill out an online form under the banner "I want to be a farm worker" at www.takeouriobs.org.

Rodríguez says that so far just three have responded and were in the fields.

"Make that four," the comedian replied emphatically.

The U.S. Labor Department says more than half of farm workers are undocumented immigrants. The UFW argues they're not taking jobs from

most don't want the work.

Proponents of tougher immigration laws respond that the problem with the UFW's proposition is that growers don't want to raise wages and improve working conditions enough to attract U.S.-Americans.

Más de la mitad de de los Trabajadores los trabajadores agrarios Unidos de son inmigrantes indocumentados, según el Rodríguez para desafiar Departamento de Trabajo de Estados Unidos. El sindicato (UFW en inglés) asegura que no les están quitando empleos a los ciudadanos estadounidenses, porque la mayoría de éstos no quieren ese tipo de trabajo.

## Groups protest AZ All-Star Game outside **MLB** headquarters

NEW YORK, July 8,2010 zona law. (AP): Pro-immigration groups gathered outside Major League Baseball headquarters in Manhattan on Thursday to protest keeping the 2011 All-Star game in

Phoenix. Demonstrators said the game should be moved from Arizona in opposition to the state's strict new immigration law, signed in April. The statute. SB 1070, requires police, while enforcing other laws, to ask about a person's immigration status if there is reasonable suspicion that the person is in the country illegally.

"It goes against the core of who we are as a country," Hector Figueroa, secretary treasurer of immigrant labor union 32BJ, said of the Ari-

Organizers played "Take Me Out to the Ball Game" and the national anthem. Participants carried signs like "Steal bases, not civil liberties" and "Take me out to the ball game, don't check my papers first."

Commissioner Bud Selig has repeatedly said the game will remain in Phoenix, MLB had no comment on Thursday's events.

Chung-Wha Hong, executive director of the New York Immigration Coalition, said Selig would show a "lack of courage" if he doesn't move the game

"People don't want baseball to be associated with ... all that the Arizona law represents," she said.

Andrea Callan of the New York Civil Liberties Union held a sign that read "Sheriff Joe is not a team player." She said it was important to directly take their message to MI.B

"Maybe if they see us in person they'll hear our message more loudly," said Callan, the incoming statewide advocacy coordinator for the group.

A smaller countermovement of people in support of the Arizona law also gathered outside the MLB offices. New Yorkers for Immigration Control and Enforcement president Joanna Marzullo, wearing a cap said that "U.S. Border Patrol," said she isn't necessarily a big fan of baseball.

"I'm a big fan of the game remaining in Arizona," she said.

Barack Obama named him to


the Census post last year.

Washington, D.C. and Cleveland: Girl power is in action for the young ladies of club ELLA(EsperanzaInc.'s Latina Leadership Alliance), as they meet and learn from inspirational local Latinas, talk about feminine topics, and just enjoy being niñas. [Esperanza, Inc. has a comparable program for niños-Ellos.1

Late May, 2010, they had the opportunity to meet a prominent Latina who shattered a glass ceiling that created shockwaves in Washington, D.C. and the nation-Supreme Court Justice Sonia Sotomayor.

Thirteen members of ELI.A were chosen for the special meeting with the Justice as a reward for their hard work and participation, said Carmen DeHann, who created ELLA three years ago.

While ELLAs and their mentors were ecstatic for the meeting, Justice Sotomayor was also keen to get to know them: "She just fell in love with the girls and really took her time talking to them," said DeHann.

"I felt like I was the only person in the room when she answered my question," said ELLA Betsi Gómez, who will attend Bowling Green State University in the fall to pursue a degree in Early Childhood

Gómez said Justice Sotomayor is an inspiration because she has achieved something no other Latina has, and gives her courage as she breaks her own glass ceiling-being the first in her family to attend college.

For Gómez, ELLA is a 'safe' place, where she can open up, de-stress, talk about uncomfortable issues, and meet new people. "It is about us finding our own identities and knowing we can do anything in a male dominated world," she said.

Karen Meijas admired Justice Sotomayor's humility and down-to-earth manner; "She didn't have to be formal with us or use big words... she was open with

Alsoa Puerto Rican, Karen said meeting Justice Sotomayor reaffirmed her conviction that she can accomplish all of her goals and dreams-such as becoming a nurse and running a charity hospital. "I want to help people, make a difference and not because I want people to admire me but to provide for those in need," she said.

One comment that resonated with Mejias: 'Believe in yourself even if people

A self-proclaimed 'girlygirl,' Mejias is always encouraging friends to join ELLA because it is fun, informative, boosts confidence and, "Get their minds off of boys!

At ELLA, she has a team of supporters who lift her selfesteem, "I always believe in people when they tell me their dreams, because I would not want anyone else to not believe in me," concluded Meijas.

DeHann said Sotomayor encouraged the girls to stretch their minds, and dare to dream big—a core purpose of ELLA. The group was accompanied by Judge Keila Cosme, first Latina Ohio Appellate Judge, after being appointed by Gov. Ted Strickland to the 6th Appellate District (based in Toledo,

Also accompanying ELLA was Stephanie Morales, who is running for the District 2 seat on the Cuyahoga County Council in November, Morales is director of Key Career Place at Cuyahoga Community Col-

Morales said she idolizes Justice Sotomayor and shared the girls' sentiment when meeting her. "It was great to see the impact she had on the girls; she planted seeds of possibilities of the future in them."

Morales said she wishes a program like ELLA had existed when she was growing up-to foster relationships with peers and network with professional role models.

ELLA members presented Judge Sotomayor with a gratitude basket filled with ELLA and Esperanza trinkets and each received personalized autographed Time Magazine Covers as mementos. Private donors covered all expenses for the trip, and DeHann hopes it will become an annual event.

"We are the first ones to experience something so amazing but I hope we are not the last," said Betsi Gómez.

## ¡Viva Espana! A country rocks as Spain rules soccer

capital's downtown forming a sea of red and yellow in tribute to the nation's first World Cup

The country's flag and team colors were in full display on Paseo de Recoletos boulevard as hordes of fans watched the match live on gigantic TV

Then, as the final whistle marked Spain's 1-0 victory over the Netherlands in extra time. fireworks lighted up the sky. Crowds begandancing and singing one of the team's battle cries, 'Let's Get Them.'

Television shots showed partying in jammed town squares across the country, from Zaragoza in the northeast to Seville in the southwest. The celebrations were easily the biggest in the country in living memory.

A roar rose from Madrid, and almost certainly across the nation, when goalkeeper Iker Casillas lifted the cup in South Africa. Spain, long tagged a perennial underachiever, had never before gone to the World Cup final.

In the Netherlands, the mood was funereal. Fans wept and hugged in The Hague at the final whistle and tossed of handfuls of orange confetti into the air that had been intended for a

victory party.
"It's such a deception. We were so close. I feel empty, said Sander Lubbers, a 33-year-old shopworker. "It's a great shame, but Spain

was the better team," said Arend-"It's only football," he added,

as he headed for home kicking his way through piles of plastic

In Madrid, the beer tasted better. Vuvuzuela horns so typi-cal of the matches in South Africa this World Cup, had droned throughout the city and car horns

began to honk incessantly.

Tens of thousands put up with more than 100-degree heat

MADRID, July 11, 2010 from early in the day to get the (AP): A roaring celebration rocked Spain on Sunday, with some 300,000 people in the screens in major plazas intowns and cities. In Madrid, emergency ambulance services treated dozens of people who had fainted.

Television images even showed crowds waving Span-ish flags in the city of Barcelona, where more than 1.1 million protested on Saturday to demand autonomy for their Catalonia region.
Prime Minister Jose Luis

Rodriguez Zapatero, whose poll numbers have dropped due to the country's economic woes, said he celebrated the win with some Catalan sparkling wine. "We raised a glass of cava

and a few tears came to my eyes, which is unusual for me, because I know how to control my emotions,"Zapatero said. "They were 120 intense minutes for me. It was an epic victory. We all

feared penalties."
On the street, 22-year-old Marta Seco was overcome with emotion.

"This is the greatest sporting event in the history of the country," she shouted with tears in

The fiesta wasn't even contained to Spain. In Toronto, for instance, Spanish fans also took to the streets, dancing on a U-Haultruck, a streetcar, and even a transit shelter. In Mexico City, about 2,500

revelers converged at the Plaza de Cibeles in the trendy Roma Norte district. They banged drums blew vuvuzelas and marched around the fountain there \_ an exact copy of the monument with the same name in Madrid \_ chanting and sing-

Back in Madrid, one banner amid the masses read "Octopus Paul, Forever!" and featured a crudely drawn picture of the octopus from Germany who became a pop culture sensation by correctly picking World Cup matches. He was right again about the final.

Police helicopters hovered over Madrid into the early hours of Monday and riot police protected major monuments.

Fans watching from a patio barina working-class neighborhood whooped in joy, yelling "Spain! Spain!" They danced on their bar chairs and hugged each other. Others yelled "Yes!

Yes! The cup is now ours!" The night sky of the Alcoron suburb was bright with fireworks and the bar patrons cheered each other with beer and sangria on a sweltering summer night, then joined in the dancing, dodging firecrackers tossed about by other fans.

"It's just amazing, I almost don't believe it," said a beaming Feliciano Hernandez, a 25-yearold electrician. "I'm so proud, totally happy and living for the moment and not thinking about anything else right now."

Nacho Moreno danced in the street waving the Spanish flag he had kept wrapped around his head for luck during the game as cars drove by, honking their horns in salute. He said he would probably drink until dawn to celebrate.
"It's phenomenal! Spain

won. I was real nervous but I knew it was possible," said the 23-year-old waiter.



#### **Education, Family, Freedom**

How does one achieve and maintain the spirit of American independence in an utterly interdependent society? We do this by cultivating it in our hearts and minds, and by inculcating it in those of our children.

It is no longer possible for most Americans to maintain the physical independence so common in the agrarian days of our founders; we cannot practically grow our own food, or make our own clothing, or build our own houses. But we can grow our own minds, make our own decisions, and build our own futures.

The first tool is education. Imperfect though it may be, America's system public private education still pro-vides the essentials for learning. It must be encouraged and supported, not only by the citizens whose children use it, but by their neighbors in each community, the legislators who must adequately fund it, and the administrators responsible

for using each dollar wisely. Interestingly, in the spirit of independence, more families are successfully home schooling their children. As basic skills are gained, more available - an excellent example being our own Lorain County Community College, the best in Ohio. With education comes the skill to think independently and make reasoned decisions. Without it, we are sheep led by the loudest shepherd.

Second is family - the core strength of our nation. Study after study underscores the importance of a two-parent structure to the success of the children. Yet year by year, single-parent families increase in number, and are increasingly identified as a major factor in the problems of crime, school dropouts and welfare dependency that sap many Americans of the ability and will to think and act for them-

With the basic building blocks of education and familv. Americans are the better prepared to respond independently to the demands of their governance – to be aware, involved participants in the decision-making of their cities, counties, states and nation. Education - especially in history and civics - helps offset the propaganda of partisan politics. Strong family values give purpose to retaining that

which is good. Without that vigilance and participation, government falls into the hands of those least inclined to act for the betterment of the governed, and most inclined to prostitute it to their own selfish ends.

"We hold these truths to be self-evident," Jefferson wrote in the Declaration we celebrate today, "that all men are created equal, and are endowed by their Creator with certain unalien-able rights..." But those rights, and the independent spirit that recognized them and embedded them in the fabric of this nation, do not come without a price. That price is a continuing struggle by each and every one of us to improve ourselves, as independent individuals and citizens, so that coming generations may build upon the freedoms we have so enjoyed.



## Maya: 12-21-2012 does not equate to doomsday

The ending of two Mayan calendars on December 21. 2012 is not a prophecy for doomsday, but the ending of one cycle and beginning of another, said *Rainbow Eagle*, an Okla-Choctaw American

"All prophecies are really about the past, take courage to go backwards for clues to what is going on," he said. Rainbow Eagle is a respected teacher, scholar, author and 'Wisdom Keeper'. He has spent years traveling and living and studying with native tribes of North America and penned two books: 'The An-cient Roots of Christianity: A Native American's Look Through Christianity'.

## Toledo City Council misses an opportunity to join growing opposition to AZ immigration law

Ann Arbor, Michigan has done it!

Cleveland has done it! So have Columbus and ucas County, Ohio!

And so have dozens of cities/counties across the United States – all of whom passed resolutions opposing the draconian Arizona Senate Bill 1070 – the controversial immigration law signed by Arizona Governor Jan Brewer on April 23, effective July 29, 2010 [un-less enjoined by a court in pending litigation.1

That law requires all local law enforcement officers to investigate a person's immigration status when there is "reasonable suspicion" that the person is in the country unlawfully. It also makes it a crime to be in Arizona without documentation.
Further, it permits the arrest

of a person, without a warrant, if there is suspicion that the person has committed a public offense that makes the person removable from the United

Opponents of the law have been quick to point out that it encourages racial profiling and violates the 14th Amendment guarantees of Due Process and Equal Protection of the Laws for U.S. citizens, legal residents, and visitors who are detained for suspicion of being in the country unlawfully. It also undermines the U.S. Constitution which grants U.S. Congress the exclusive power over immigration matters.

The majority of police command are opposed to the AZ law, believing that it will also hamper police in effectively dealing with serious local crime; the police command are also concerned with the effects of the law, making immigrantvictims of crime more vulner-

At press time, at least seven legal challenges, including one by the U.S. Department of Justice, have been filed in Arizona courts against the law which is scheduled to become law at the end of the month.

But Toledo's City Council blewtheirchancetogoonrecord as opposing the bill – at least for another week.

On July 6, the Council split 6-6 on a cobbled resolution offered by Councilmen *Adam Martínez* and *Joe McNamara*. Although the resolution some-what sidesteps actual condemnation of the law, it still couldn't muster the seven votes required to get it out of a committee and before the full Council for a

In fact, the resolution is an omnibus creation addressing three pressing social issues the need for comprehensive immigration reform, opposing human trafficking, and opposing "unscrupulous em-

ployment practices."
So what self-respecting Council member wanted to go on record stating they opposed furthering a resolution against human trafficking much less a resolution advocating immigration reform?

How about D. Michael Collins, George Sarantou, Tom Waniewski, Council president Wilma Brown, Mike Ashford, and Rob Ludeman?

La Prensa left a detailed phone message for former Council president Ludeman asking him to explain his vote, but he never returned the call. However, Wilma Brown

defended her vote while point-ing to her long history of supporting Latino organizations such as the Farm Labor Organizing Committee (FLOC) and its president Baldemar

"Jim Crow" law But Baldemar Velásquez, Presi-dent of the Farm Labor Organizing ommittee (FLOC), found the new AZ law, a "shameful mea-

sure, blaming immigrants for current economic woes wrapped around immigration hysteria!" "We will continue to fight this Latino version of Jim Crow and other measures of intimidation," promised

Velásquez. Brown continued in her interview with La Prensa: This is an issue about a state's Home Rule, and I had some problems with the first three 'Whereas' paragraphs be-cause I was uncomfortable criticizing a state for a Home Rule decision and a law. We would not do these things here, but I felt we needed to

tweak the language.

Maybe President Wilma
Brown should read the U.S. Constitution, which gives the federal government exclusive jurisdiction in immigration matters—if she does not like the U.S. Constitution there are procedures to amend it.

"I also thought it be-longed in the Law and Criminal Justice Committee. So I did not actually vote against the resolution. I only voted on keeping it in committee," lamely explained Brown.

Councilman Mike Collins earlier told the Toledo Blade that he opposed taking up the

resolution because it does not deal with governing Toledo.

Toledo Mayor *Mike Bell*, who could have broken the tie vote, declined to do so, stating he would vote on the resolution at the next Council meeting on

July 20, 2010.
The *Blade* also reported that before the July 6 regular meeting, Council held a three-hour committee meeting on the immigration resolution and a separingration resolution and a sepa-rate ordinance to codify poli-cies regarding racial profiling. As worded, the Toledo reso-lution falls far short of similar

resolutions passed by other municipalities in which SB 1070 is actually singled out in a stand-alone resolution.

Indeed, the first of the three sections of the proposed To-ledo resolution states that the "City of Toledo opposes legislation that punishes victims as opposed to perpetrators of human trafficking and unscrupu-lous employment practices."

It is only in the second sec-tion that the Council "calls upon

the President of the United States and the United States Congress to pass a comprehensive immigration reform bill that will solve the problem of undocumented immigration at its roots instead of

through piecemeal en-forcement-only measures, that will keep families together, up-hold our values as Americans, promote economic growth and fix the broken immigration sys-

tem for the long-term." Yet according to Ryan Bates, a Michigan activist with the Reform Immigration for America organization, the Arizona law has touched off a virtual firestorm of opposition by cities across the United States including opposition in Phoe-

nix AZ.

Bates told *La Prensa* that dozens of cities including De-troit, Columbus, Los Angeles and San Francisco have gone much further than Toledo's effort by not only passing resolu-tions opposing SB 1070—and as in Ann Arbor calling for its repeal—but have actually called for boycotts or banning city-funded travel to Arizona in re-


sponse to the proposed law. Toledo City Council should take a hard look at the motives behind Arizona's SB 1070 and its effects upon minorities— Toledo should not become known as a "Hate City" as Arizona has become known as the "Hate State."




