Katiria Cordona and Rafaél Mercado find Tri-C right fit

CLEVELAND: A record number of Latino students applying for scholarships resulted in more than \$100,000 awarded to worthy *Cuyahoga Community College* students at its annual Hispanic Scholarship Luncheon held Friday, July 17, 2015 at Tri-C's Jerry Sue Thornton Center, 2500 East 22nd St.

120 Latino students received CCC scholarships, a new record. The scholarships for the upcoming academic year are awarded through the Cuyahoga Community College Foundation. Donors and corporate sponsors, such as AT&T and KeyBank, make the awards possible.

One of those scholarship recipients is Tri-C student ambassador *Katiria Cordona*, who recounted how she's overcome multiple barriers to pursuing a higher education.

Ms. Cordona, born in Puerto Rico and raised in The Bronx, moved to Cleveland when she was 20 years old. She has two children, Madeline and Joshua, and is pursuing her associate's degree in arts. She is the first in her family to attend college.

"Growing up, I remember my father being very strict. Both parents wanted the best for us," she told the luncheon crowd. "But honestly, they never made education a priority in our home. In fact, my dad's belief about going to college was very different. He didn't believe education was important for Hispanics because we would always be considered and treated as minorities, no matter what. This sentiment would end up being a self-fulfilling prophecy for me, as I ended up dropping out of high school in the ninth grade."

Ms. Cordona's parents later moved to Ohio, but she remained in New York City to work in a department store. She admitted quickly realizing she did not want to work in retail for the rest of her life. She re-entered school through a vocational training program and then worked in an office environment for a couple of years.

"I decided to try school again and enrolled in a community college program that would help me complete my GED and work toward an associate's degree," she said. "I was so excited and determined this time, but I soon learned I was pregnant and had to quit on school again."

Ms. Cordona then decided to move to Cleveland and raise herself near family and friends to give him a stable environment. Once she arrived in Ohio, her mother was diagnosed with a form of liver disease, which

forced her to become her mom's caretaker.

"My mother spent a lot of time in and out of the hospital," she recalled through tears. "It was my job to make her medical appointments, get her to those appointments, pick up her prescriptions, and keep in constant contact with her doctors. This was a difficult time for our family and my parents were counting on me. I was not going to disappoint them."

While deciding to re-enroll in school yet again, "two other life-changing events" affected Ms. Cordona's future: a second pregnancy and her mother contracting pneumonia.

"Throughout my life I made some very poor choices—and each time I postponed school," she admitted. "It fell farther out of my reach. I finally came to a conclusion that if I was able to attend to all the struggles I had dealt with so far, then going back to school would be worth the journey. This time, I would not quit."

Ms. Cordona told the audience she made a New Year's resolution and enrolled in a GED course through Tri-C. She passed the test and earned her diploma later that year. She immediately enrolled in college courses because she "had found the right place."

Along the way, she became more active in campus programs—as a student ambassador and later joining the college's STEP program and Hispanic Council. Since then, Ms. Cordona has maintained a 3.37 GPA and started working part-time in the counseling department at the metro Cleveland campus. She now plans to further her education after graduation by pursuing a bachelor's degree in social work.

"Truth be told, I know you can do anything you put your mind to," she concluded. "My mother recently had a stroke and is a rehabilitation center. I know she would be proud of my accomplishments, both personally and academically. I know I have a long way to go, but I vow to never give up on myself ever again."

Rafaél Mercado also addressed the luncheon, telling the audience about his personal journey as a first-generation Latino college student to help other students. Mercado, of Puerto Rican descent, is the middle of three children "with loving and supportive parents," his mother a credit union bookkeeper and his father a

Cleveland police officer.

"Both of my parents went on to some form of formal training beyond high school, but never went to college," he said. "They never forced education on me, but saw it as a way to get ahead."

The James F. Rhodes High School graduate found his way to Tri-C through the High Tech

Academy program at the start of his sophomore year as a way to "escape" the education system of the Cleveland Municipal school system, which, at the time, only had a 30 percent Latino high school graduation rate.

"The High Tech Academy served as a way to push me to not be a statistic, something my parents and grandparents also instilled in me at a young age," he said.

His grandmother, who passed away earlier this year, managed to raise seven children with just a third-grade education.

"I was taught to work hard for what you want in life and that nothing is given without the effort, as well as to not get in the habit of settling in what you are pursuing in life," he said.

Mercado told the crowd he was awarded a scholarship to attend the Ohio State University once he graduated high school. But he found the size of the campus intimidating, as well as "a daunting course-load" and "leaving the love and support of home." He came home in 2012 to "work odd jobs," such as at a car dealership and as a crew leader for a valet company.

"Personally, I see adversity as something I can use to build myself up stronger than I was before," he said.

He then enrolled at Cleveland State University in the fall of 2013 to continue his dream of earning a bachelor's degree in mechanical engineering in order to find out "it did not feel right." He returned to Tri-C where he began his education and has maintained a 3.6 GPA since.

Mercado joined Tri-C's STEP program and a pilot program to earn a certificate in 3D digital design and adaptive

manufacturing design. He intends to earn two associate degrees from Tri-C by the time he graduates in 2016: one in mechanical engineering technology and another in manufacturing and industrial engineering technology.

"In retrospect, I believe the biggest obstacle I have overcome is myself and my own self-limitations," he said. "I finally said to myself, if my grandmother was able to accomplish all she set out to do with such an extremely limited education, then someone like you with the support of family and friends and a further education, can accomplish anything I set out to do."

Mercado advised other students that if a school doesn't feel right, to just keep on looking for the right fit, rather than give up.

"The universities I faced in the past have not been a setback for me, but rather a compass to pointing myself in the right direction," he said. "I hope to work for a company that will have a role in changing manufacturing as we know it today, from something antiquated to something completely new and different. I want to be working in a position anywhere in the world, all because I never chose not to listen to those who judged me and my potential based on my heritage."

Both students thanked corporate sponsors for the scholarship opportunities that will allow each of them to continue to pursue a degree.

Four scholarships were presented in memory of Al López, who served as a counselor and professor at Tri-C for more than 32 years. Mr. López helped to establish the Hispanic Council in 1992 at Tri-C and was recognized throughout the years for his vision work to assist Latino students on campus. The scholarship awards were given to students "who demonstrated academic excellence, leadership, and an overall sense of passion for the Hispanic community."

Tri-C's foundation first established the special scholarship fund in 2003 to provide financial assistance to qualified Latino students. The event is sponsored each year by the college's Hispanic Council to promote Latino access and achievement in higher education.

The Hispanic Council of Tri-C serves Cleveland's Latino families by offering bilingual assistance with enrollment, financial aid, class registration, English-as-a-Second Language (ESL) courses and scholarship opportunities. It also connects Latinos with Tri-C programs, services, faculty, and staff.

Obama visits prison to call for a fairer justice system

EL RENO, Okla., July 16, 2015 (AP): Peering from the back seat of his armored black limousine, President Barack Obama rode into a razor wire-surrounded federal prison Thursday and said he met young inmates "who made mistakes that aren't that different than the mistakes I made."

Obama came to the medium-security *El Reno Federal Correctional Institution* near Oklahoma City to press his case that the nation needs to reconsider the way crime is controlled and prisoners are rehabilitated. The president met with inmates and walked past rows of empty cells secured by large grey doors. Prison officials opened cell no. 123 for Obama and he gazed at its sparse trappings: a double bunk bed and third bed along the wall, a toilet and sink, along with a small bookcase and three lockers.

"Three full-grown men in a 9-by-10 cell," he said.

The White House said Obama was the first sitting president to visit a federal prison.

The president said there must be a distinction between young people "doing stupid things" and violent criminals. Young people who make mistakes, he said, could be thriving if they had access to resources and support structures "that would allow them to survive those mistakes."

"When they describe their youth and their childhood, these are young people who made mistakes that aren't that different than the mistakes I made," Obama said.

Among the changes Obama is seeking is the reduction or outright elimination of severe *mandatory minimum sentences* for non-violent offenders. Earlier this week, he used his presidential powers to shorten the prison sentences of 46 people convicted on charges involving drugs.

The president has also called for restoring voting rights to felons who have served their sentences, and said employers should "ban the box" that asks job applicants about their criminal histories.

Obama has expressed hope that Congress will send him legislation to address the issue before he leaves office in 18 months, given the level of interest in the issue among Republican lawmakers and presidential candidates.

Presidential security was no small part of Obama's visit to the all-male institution. White House press sec-

retary Josh Earnest said "unique steps" were taken to protect Obama during the visit. He did not elaborate.

Sen. Rand Paul, R-Ky., a 2016 presidential contender, is pushing to restore *voting rights* to non-violent felons who have served their sentences. Another GOP candidate, New Jersey Gov. *Chris Christie*, was giving a speech Thursday calling for changes that in part

would give nonviolent drug offenders a better chance at rebuilding their lives.

From shortening the prison sentences of nearly four-dozen non-violent drug offenders to advocating the reduction, or outright elimination, of severe mandatory minimum sentences to visiting a federal prison, Obama this week has argued forcefully for an alternative to the continued lengthy incarceration of

people convicted of crimes he said did not fit the punishment.

Harsh prison sentences, particularly for nonviolent drug crimes, are to blame for doubling the prison population in the past two decades, Obama said earlier this week. Half a million people were behind bars in 1980, a figure that has since quadrupled to its current total of more than 2.2 million inmates.

Obama has expressed hope that Congress will send him legislation to address the issue before he leaves office in 18 months, given the level of interest in the issue among Republican lawmakers and presidential candidates.

Cuba: medio millar de invitados en apertura de sede en EEUU

15 (AP): Cuba llevará una delegación de más de 30 personas a la apertura de la embajada del país caribeño en Estados Unidos el lunes próximo y tendrá unos 500 invitados estadounidenses como testigos del histórico acontecimiento.

"Va a ser una celebración por parte nuestra", dijo el funcionario.

Machín no ofreció nombres de las personalidades estadounidenses que serán invitadas pero aseguró que van desde congresistas, religiosos y académicos a grupos de solidaridad. "Sobre sobre todo aquellas personas que en todos estos años han estado trabajando para lograr una mejor relación entre Cuba y Estados Unidos", señaló.

Pero los que seguro no estarán en la ceremonia serán los legisladores cubano-americanos como Marco Rubio o Ileana Ros-Lehtinen, fervientes opositores a una mejora de las relaciones, y a quienes de plano no se tuvo en cuenta para el histórico momento, explicó Machín.

"Usted no invita a su casa a aquellos que quieren hacerle daño", dijo el funcionario diplomático. "Sería un contrasentido por tanto, no, no están invitados", agregó.

La ceremonia será solemne y breve, se izará la bandera y se pronunciarán

algunas palabras.

El restablecimiento de las embajadas fue anunciado en Cuba y Estados Unidos el 1 de julio, para que entren en vigor el 20 de este mes y son el resultado de un acercamiento iniciado en diciembre pasado por los presidentes Raúl Castro y Barack Obama tras más de cinco décadas de hostilidades.

Pero la apertura de las sedes solo es una "primera fase" de un proceso de normalización total, consideró Machín, y que debe conllevar el levantamiento de las sanciones impuestas por parte de Estados Unidos para presionar un cambio de modelo en la isla.

Aunque está claro que ambas instalaciones —actualmente son Oficinas de Intereses bajo la protección de Suiza— serán consideradas embajadas el día 20 y Cuba hará su ceremonia en esa misma jornada, se desconoce la fecha en que Estados Unidos enviará sus funcionarios a la isla para una similar actividad.

Castro satisfecho con embajadas, pide flexibilidad a Obama

LAHABANA, 15 VII 15 (AP): El presidente Raúl Castro dijo que la apertura de embajadas de Cuba y Estados Unidos iniciará "una nueva etapa" en las relaciones binacionales y exhortó a su par Barack Obama a usar sus facultades para levantar las sanciones.

"El gobierno revolucionario tiene la disposición de avanzar en la normalización de las relaciones, convencido de que ambos países podemos cooperar y coexistir civilizadamente, en beneficio mutuo, por encima de las diferencias que tenemos y tendremos", dijo el miércoles Castro ante los diputados de la Asamblea del Poder Popular reunida en plenario.

Hasta este momento Castro no había emitido ningún comentario sobre la apertura de las embajadas que ambos países acordaron a comienzos de este mes. Los comentarios del gobernante fueron difundidos por el portal oficial Cubadebate. La prensa extranjera no tuvo acceso al recinto parlamentario.

Castro exhortó además a Obama para que siguiendo su actual política flexibilice las medidas que pesan sobre Cuba desde hace más de medio siglo.

"Esperamos que continúe usando sus facultades ejecutivas para desmantelar aspectos de esta política, que causa daños y privaciones a

nuestro pueblo", agregó el mandatario cubano.

Muchas de las normas que pesan sobre Cuba tienen rango de ley, por lo que es el Congreso de Estados Unidos el que debe derogarlas.

De todas formas, Castro indicó que las relaciones normales plenas entre los dos países no serán posibles mientras se "mantenga el bloqueo" a lo que debe sumarse la devolución del territorio de la Base Naval de Guantánamo y que cesen las transmisiones radiales y televisivas ilegales hacia Cuba, entre otros puntos.

Castro y Obama anunciaron el 17 de diciembre el inicio de un proceso de acercamiento camino a una normalización total de los vínculos.

El Parlamento cubano cerró una de sus reuniones bianuales este miércoles con la novedad de haber inaugurado una cuenta de Twitter y otra en Facebook, medios inusuales de comunicación en los organismos estatales de la isla.

Los medios de prensa locales informaron que la Asamblea contará con una cuenta en Twitter bajo el usuario (@)AsambleaCuba y otra en Facebook bajo el nombre "Asamblea Nacional Cuba".

Aunque muchas instituciones oficiales de otros países tienen este tipo de medios para informar sus actividades, en la isla es inusual en parte dada la poca conectividad de internet.

Entre los invitados a la Asamblea del Poder Popular, como se designa al parlamento, estuvieron

Gerardo Hernández, Antonio Guerrero, Fernando González, Ramón Labañino y René González, los cinco agentes de inteligencia que forman parte de una década estuvieron presos en Estados Unidos y que Cuba considera héroes por su labor de prevención de ataques contra la isla.

Tres de "los cinco" fueron liberados el 17 de diciembre pasado como parte del anuncio del proceso de establecimiento diplomático.

Castro, a cargo del discurso de clausura de la Asamblea, informó que el Producto Interno Bruto se incrementó este año, hasta el 30 de junio, en un 4,7%.

Según el mandatario se espera que el crecimiento anual se ubique en torno a 4% en 2015.

"Esto es muy bueno, teniendo en cuenta que en el pasado año sólo crecimos el 1%. No obstante, para lograr este 4% esperado, hay que trabajar duro y con mucha disciplina", explicó Castro.

El parlamento cubano se reúne habitualmente dos veces al año -en julio y diciembre- de manera plenaria y los diputados no reciben pago por su labor, sino que siguen integrados a sus trabajos y profesiones. Durante el resto del año la Asamblea cuenta con el trabajo de funcionarios que dan continuidad a los mandatos de los legisladores.

Consulado de México informa sobre el traslado de un cuerpo a México

La pérdida de un familiar siempre es un acontecimiento muy difícil de enfrentar y más cuando ocurre en un país que no es el nuestro, ya que muchas veces deseamos que los restos descansen en su tierra natal. En esos casos, los Consulados Mexicanos ofrecen asesoría y a veces apoyo económico a las familias que lo requieran.

"Si una familia se encuentra en una situación económica crítica, el Consulado puede llegar a brindar apoyo económico para el envío ya sea de las cenizas o del cuerpo del difunto", informó Juan Manuel Solana, Cónsul de México en Detroit. "El apoyo se brinda siempre y cuando el gasto que se haya hecho durante las pompas fúnebres sea lo mínimo indispensable para enviar el cuerpo al país de destino. Además de demostrar a través de una entrevista con nuestro personal que la familia no tiene la capacidad de realizar el pago correspondiente".

Los Consulados otorgan un apoyo, no pagan todo el proceso en su totalidad. "Normalmente no realizamos el gasto completo pero si ayudamos con una cantidad. En este tema lo que no queremos es que haya un abuso, me ha llegado gente con facturas de 15 mil dólares porque hicieron misas, le pusieron al féretro cosas especiales, están llevando el cuerpo en un avión especial y cuando se trata de una situación así, no podemos intervenir. El consulado apoya únicamente en el traslado del cuerpo, cualquier otro gasto adicional implica que la familia tiene recursos y entonces no estamos apoyando ya que contamos con recursos limitados para los que realmente lo necesitan", agregó el entrevistado.

El Cónsul Solana también señaló que el cuerpo es enviado a la ciudad de México y los familiares deben ponerse en contacto con las oficinas de

migrantes del estado al que corresponden para solicitar apoyo. "Algunos estados apoyan económicamente con el traslado del cuerpo, lo que es del aeropuerto de la ciudad de México a su destino final, pero eso ya lo tienen que ver los familiares directamente con las autoridades correspondientes para saber si procede el apoyo adicional o no".

Básicamente lo primero que se debe hacer cuando muere un familiar es contactar a la funeraria para solicitar información sobre costos y saber si ofrece el servicio de envío de cuerpos a México, ya que muchas funerarias no tienen conocimiento de cómo enviar un cuerpo a otro país. Si considera que está siendo abusado en cuanto a los costos o no encuentra a una funeraria que realice el trámite de envío a México, es necesario comunicarse al Consulado para que le recomiendan algunas funerarias con las que han trabajado y tienen costos accesibles.

Una vez que el familiar se comunica con las funerarias y obtiene costos, puede comunicarse al Consulado si no le alcanza. "El apoyo no se le da a la familia, sino directamente a la funeraria para que no se realice un manejo inadecuado del dinero", dijo el Cónsul de México.

Otra situación que se presenta en el envío del cuerpo a México es el cupo lleno en

los aviones en temporada de vacaciones, en especial en diciembre. Juan Manuel Solana comenta: "Como las aerolíneas tienen llenos sus vuelos en vacaciones, prefieren no mandar los cuerpos en esas épocas y como saben que están embalsamados previo a su envío a México, generalmente se esperan hasta que pasen sus buenas épocas, ahí puede haber problemas".

Además de eso, es importante saber que hay que contar con el certificado de defunción en donde se especifiquen las causas de la muerte para que el cuerpo pueda entrar a México. "Si murió por una enfermedad contagiosa puede haber problemas, por eso es importante tener todos los documentos a la mano y estar bien informados", destacó el mandatario mexicano.

Los Consulados lo que hacen es emitir la Certificación Consular de manera gratuita, es decir el visado de ciertos documentos para que los restos ingresen a México. La funeraria debe enviar, en original y acompañado de su traducción al español el acta de defunción, permiso de tránsito de cadáveres y/o entierro, carta de embalsamamiento y carta del médico forense donde se explique que no existe enfermedad contagiosa (en caso de que aplique). "El papeleo que se realiza en el Consulado tarda aproximadamente dos horas, si la funeraria nos presentados los documentos.

Es importante aclararlo porque en ocasiones las funerarias quieren echarnos la culpa a nosotros de su demora", aclaró el Cónsul Solana.

Debido a todos los trámites que conlleva el traslado de un cuerpo a México, el Cónsul titular de México en Detroit recomienda: "Si no hay un impedimento de religión e ideología, las cenizas son la mejor forma de que un cuerpo llegue a México. No se requieren, certificados especiales ni nada por el estilo".

De acuerdo a las estadísticas, hay un porcentaje elevado de gente que quiere que los cuerpos se envíen a México. "Normalmente las familias lo manejan por su parte, son pocas las que contactan al Consulado y lo hacen los que realmente no tienen la capacidad económica para realizar el trámite, o bien, cuando fallecen varios integrantes de una familia al mismo tiempo", concluyó el mandatario mexicano. ACLU brings "Prisons for Profit" documentary to Toledo

"Prisons for Profit," which recently premiered at this year's *Cleveland International Film Festival* will be shown at 6 p.m., August 11, 2015 at the Kent Branch of the Toledo-Lucas County Public Library, 3101 Collingwood Boulevard, Toledo. The short documentary was produced by the ACLU of Ohio and directed by Cleveland filmmaker *Craig Knowles*.

"Prisons for Profit" examines the first 18 months in the life of the nation's first state prison sold to a private corporation. The short film chronicles the disturbing and often dangerous set of issues that unfolded after *Corrections Corporation of America* purchased the Lake Erie Correctional Institution in 2011 from the state of Ohio.

These included rampant drug use, increased violence, and inadequate medical care, as well as the



incompetence and confusion on the part of state and private prison officials. These problems are not uncommon in prisons for profit—where revenues drive decisions. Prisoners, prison workers and those living near the prison are the first to suffer from unsafe and inhumane conditions.

Following the screening, criminal justice advocates will informally discuss with the audience the growing number of private prisons in Ohio as the state is poised to sell another facility, the North Central Correctional Institute in Marion.

Speakers include *Mike Brickner*, ACLU of Ohio se-

nior policy director, and *Tom Luettke*, reentry coordinator of the *Criminal Justice Coordinating Council*. The event will be emceed by *Sue Carter*, local Toledo activist and ACLU of Ohio board member.

"Prisons for Profit" is free and open to the public. It also has been approved for continuing legal education (CLE) credit. A reception will be held at 5:30 p.m. in Auditorium A of the Kent Branch. The trailer for "Prisons for Profit" is available on YouTube. More information about private prisons is available at www.acluohio.org/prisonsforprofit.

ACLU files brief on behalf of Free Speech in lawsuit from Ohio Coal Mine Operator

COLUMBUS, July 15, 2015: The ACLU of Ohio has filed an amicus brief in support of activists James and Lisa Ciocia and their free speech rights in the Eighth District Court of Appeals in Cuyahoga County.

The two have been sued by coal magnate Robert E. Murray of Murray Energy Corporation (MEC), a mining corporation in St. Clairsville, who once again is using a common legal practice known as a strategic lawsuit against public participation (SLAPP) in an effort to silence critics.

Murray is attempting to seek damages for claims of defamation and invasion of privacy against the defendants. A trial court ruling on a summary judgment found in favor of the Ciocias, but Murray ap-

pealed to the Eighth District court. Such SLAPP lawsuits are often used to suppress criticism, resulting in a chilling effect on free speech, according to Jonathan Peters, a cooperating attorney with the ACLU.

"Expressive activities are essential to democracy, and for too long SLAPP suits have undermined Ohioans' rights to speak and to protest peacefully," Peters said. "No one should be afraid to exercise his or her First Amendment rights. The filing of this brief makes clear that constitutionally protected speech should not be stifled by litigation—and sends a message to those who initiate such a lawsuit."

The lawsuit stems from a December 2013 group protest that the Ciocias were involved in outside offices owned by Murray in a

Cleveland suburb. The couple held signs and made statements to media that were critical of Murray and MEC for a variety of reasons.

This is not the first time that the ACLU of Ohio has gotten involved in legal matters concerning Murray. The ACLU of Ohio was co-counsel to Huffington Post contributor Mike Stark, who was named as a defendant in a SLAPP lawsuit filed by MEC for writing an article about Murray and MEC. The ACLU defended Stark, and the case was dismissed by a federal court in May 2014.

Historical women's group ends 110-year Alamo stewardship

SAN ANTONIO, July 10, 2015 (AP): The Daughters of the Republic of Texas will come to the end of their 110 years as custodians of the Alamo on Friday.

The San Antonio Express-News (<http://bit.ly/1Nx54gi>) reports that a solemn observance at the Alamo will mark the end of the 124-year-old group's stewardship of the mission-turned-fortress in downtown San Antonio.

"Bittersweet is the word that comes to mind," said DRT President General Betty Joe Edwards.

However, the group will operate a research center at the Alamo and conduct programs on the grounds.

"We'll still have a pres-

ence. We'll still be there in spirit," said Edwards, a Houston-area resident.

Edwards noted that the DRT's Alamo stewardship extended over the administrations of 25 governors.

However, under a state mandate, the DRT began turning authority over the Alamo to the Texas General Land Office in March. Last month, Gov. Greg Abbott signed legislation that removes a DRT representative from the Alamo advisory board.

The Alamo is the site of an 1836 battle in the Texas war of independence from Mexico. The battle led to the deaths by Mexican troops of some 180 defenders of the besieged fort. Weeks later, those deaths provided Texas irregulars with their rallying cry that

they carried to victory at the Battle of San Jacinto, which clinched Texas' independence from Mexico.

"Our organization cherishes its 110-year history as the custodians of this sacred shrine but recognizes a greater role from the state is required to address the ever-increasing needs of the structure. Finally that day has arrived," Edwards said.

A DRT lawsuit for control of the archives it has accumulated at the Alamo since 1950 is still pending. "The DRT will keep a watchful eye and we will continue our role in the preservation of the history of the state we love," Edwards said.

Lawmakers renew push to abolish death penalty

COLUMBUS, July 15, 2015: State Reps. Nickie J. Antonio (D-Lakewood) and Niraj Antani (R-Miami Township) today called for an end to capital punishment in Ohio and introduced bipartisan legislation to abolish the death penalty and replace it with a life sentence without parole.

"Pro life, small government conservatives should be against the death penalty," added Antani. "I believe there is a growing movement in the Republican Party to end the death penalty."

The lawmakers were joined by advocates from the Catholic Conference of Ohio, the Ohio Council of Churches, the First Unitarian Universalist of Columbus, and Columbus synagogues Tifereth Israel.

"Research has shown that the death penalty is

"The Catholic Church is

administered with disparities across economical and racial line and fails to act as a deterrent to violent crime," said Antonio. "I continue to believe that the best death penalty reform in Ohio is to stop the use of capital punishment and introduce legislation to abolish it with a life sentence without parole."

Ohio adopted its current capital punishment statute in 1981. To date, Ohio has executed a total of 393 convicts, while over 140 other prisoners remain on death row.

If passed, Ohio would join 19 other states in abolishing the death penalty. Nebraska most recently eliminated their death penalty statute this year, becoming the seventh state to do so since 2007.

Cuba announces 5-fold spike in cruise tourism since 2012

HAVANA, July 9, 2015 (AP): Cruise ship tourism to Cuba spiked more than five-fold over the last three years and is up even higher so far in 2015, government officials reported Thursday.

In a statement published on the state-run website *Cubadebate*, the Transportation Ministry said the number of cruise ship port calls rose from 24 in 2012 to 139 in 2014, while visits by cruise passengers saw a similar jump from 6,770 to 37,519 during the same period.

Already this year there have been 174 port calls and 62,183 passenger visits through May, according to the ministry's statistics.

The statement called the cruise industry an "important element of tourism development for the country," and said further growth is expected.

The report comes two days after U.S. cruise company *Carnival* announced a plan to begin running ships to the Caribbean island through its new

brand, Fathom, which focuses on trips in which passengers sail to a destination in order to volunteer there.

Amid a gradual thaw between Cold War foes Washington and Havana, Carnival has secured permission from the U.S. Treasury Department but is still awaiting approval from the Cuban government.

The Cuban Transportation Ministry said growth during the last three years "could have been even greater if not for the inhuman measures imposed on us by the U.S. blockade (embargo) which substantially hurts maritime activity—a signal that Havana may look favorably on Carnival's proposal and U.S. cruise ships in general."

Carnival hopes to begin the trips in May and says it would be the first U.S. cruise company to visit Cuba since the advent of the embargo, which went into full effect in 1962.

Cruise ships dock regularly in the port of Havana during the winter high season, disgorging hundreds of travelers at a time into the adjacent colonial quarter.

The Transportation Ministry also cited Cienfuegos, Santiago and other coastal points as centers of cruise tourism, and highlighted the Isle of Youth as an opportunity for possible future expansion of the sector.

US tourism to Cuba remains illegal under U.S. law, although Washington has relaxed rules in recent years to allow ever-greater numbers of U.S. visitors on cultural, academic, religious, and other types of exchanges considered "purposeful travel."

Carnival's weeklong cruises aboard the 710 passenger-capacity Adonia would offer legal "people-to-people" trips in which travelers spend most of the day involved in cultural activities in order to conform to U.S. regulations.

Most Cuban ports are not able to accommodate larger vessels that can hold tens of thousands of people. In Havana, an automobile tunnel that traverses the mouth of the bay prevents the city from dredging deeper to receive lower-drafting ships.

Pitbull said, "I want to tell Marco Rubio, step it up! Jeb Bush, step it up! Hillary Clinton, step it up! Because Donald Trump can't be president."

He added: "For all of the Latinos out there, keep your heads up, and Trump, watch out for El Chapo dude."

The rapper spoke in Spanish and also said, "I want him to know I'm not a politician. I'm a musician. I'm a Latino first. I support our people."

Tibetan lama dies in Chinese prison

BEIJING, July 13, 2015 (AP): Tibetan lama Tenzin Delek Rinpoche has died in prison 13 years into serving a sentence for what human rights groups say were false charges that he was involved in a bombing in a public park. He was 65.

Relatives were informed of the death Sunday, New York-based Students for a

sure, dizzy spells and problems with his legs that had caused him to fall on a number of occasions.

Born in 1950 in a Tibetan area of Sichuan, Tenzin Delek stayed in India from 1982 to 1987 to study under the *Dalai Lama*.

During that time, the *Dalai Lama* recognized Tenzin Delek as a *tulku*, or a reincarnated lama.

In 1987 he returned to China, where he worked to establish monasteries, health clinics, small schools and orphanages, rising in prominence.

Human rights groups have said his relationship with Chinese officials took a turn for the worse when he rolled back attempts to clear forests and because of his support for the *Dalai Lama*, who is considered a separatist by the government.

In India, exiled Tibetans marched Monday in New Delhi and in Dharamsala, where the *Dalai Lama* has lived since fleeing Tibet in 1959, carrying placards reading, "We want justice," and "Murdered in Prison."





EEUU y Cuba listos para reanudar relaciones luego de décadas

LA HABANA, 19 VII 15 (AP): La bandera de Cuba—una estrella blanca sobre fondo rojo junto a franjas azules y blancas—está lista para ser izada el lunes fuera de la misión diplomática del país caribeño en Estados Unidos, por primera vez desde que ambos países rompieron relaciones en 1961.

Aunque no está prevista alguna ceremonia formal en su contraparte en La Habana, la Sección de Intereses de Estados Unidos en Cuba también se convertirá plenamente en embajada justo después de la medianoche, cuando los dos enemigos de la Guerra Fría decidan entrar formalmente en una nueva era de acercamiento, a pesar de que los divide un profundo abismo ideológico.

"Es un momento histórico", dijo el diplomático y analista cubano Carlos Alzugaray, quien agregó que ahora comienza el trabajo verdaderamente difícil: resolver disputas espinosas, como reclamos mutuos en busca de reparaciones económicas, la insistencia de La Habana en poner fin al embargo comercial de 53 años y las exigencias estadounidenses a que Cuba mejore sus derechos humanos y la democracia.

"La importancia de la apertura de embajadas es que

se puede ver confianza y respeto; ambas partes tratándose con confianza y respeto", agregó Alzugaray. "Eso no quiere decir que no va a haber conflictos, es seguro que habrá, pero la forma en que se tratarán los conflictos ha cambiado por completo".

Cuba planea una realizar una ceremonia solemne el lunes por la mañana en su misión señorial en Washington DC, con unos 500 invitados, entre ellos una delegación de 30 representantes diplomáticos, culturales y de otros tipos de la nación caribeña, encabezada por el ministro de Relaciones Exteriores, Bruno Rodríguez.

El gobierno de Estados Unidos estará representado por la subsecretaria de Estado para Asuntos del Hemisferio Occidental, Roberta Jacobson, quien encabezó la delegación estadounidense durante seis meses de negociaciones que condujeron al anuncio del 1 de julio sobre la reapertura de las embajadas y Jeffrey DeLaurentis, el jefe de la Sección de Intereses de Estados Unidos en La Habana, quien ahora será encargado de negocios.

Rodríguez tiene previsto

reunirse el lunes más tarde con el secretario de Estado estadounidense, John Kerry.

Las autoridades norteamericanas han dicho que la Sección de Intereses de Estados Unidos en La Habana no izará inmediatamente la insignia de las barras y las estrellas, sino que esperará a agosto, para una ceremonia formal que se espera que sea encabezada por Kerry.

No obstante, ya se han perforado agujeros en el exterior del edificio de donde se colgarán letreros traídos desde Estados Unidos y se hicieron los arreglos para imprimir nuevas tarjetas de presentación y papeles membretados que lean "Embajada" en lugar de "Sección de Intereses".

Lo que durante años fue un asta de bandera solitaria fuera del edificio vistió de seis pisos en el Malecón de La Habana, un boulevard marítimo, fue rehabilitada recientemente, con todo y una calzada repavimentada.

Cada día durante la última semana, los empleados de la sección han colgado en una vallaletrores en español escritos a mano donde han hecho la cuenta regresiva, como uno que decía recientemente: "En seis días seremos una embajada".

La cuenta de la misión en

Facebook también adoptó un tono de celebración, con la publicación de una serie de fotos de antes de la revolución de 1959 y que muestran la presencia diplomática de Estados Unidos en La Habana. En un día reciente subieron una imagen de la bandera suiza con la palabra "Gracias!".

Amplias secciones intereses han operado técnicamente bajo la protección de Suiza. Los diplomáticos suizos también fueron los cuidadores de la antigua embajada estadounidense y de la residencia del embajador de 1961 a 1977, cuando Estados Unidos no tuvo presencia diplomática en el país en lo absoluto.

La Habana también ha acicalado las calles de los alrededores a la espera de una avalancha de cámaras de los medios de comunicación, pintando bordillos y farolas o fregando estaciones de vigilancia. Al menos un

edificio de viviendas en esa calle también recibió una nueva capa de pintura.

Sin embargo, la atención principal del lunes será en Washington. Entre los asistentes estará el cantautor cubano Silvio Rodríguez, el expresidente del Parlamento Ricardo Alarcón, el historiador de Ciudad de La Habana Eusebio Leal y el artista Kcho.

"Va a ser una celebración por parte nuestra", dijo Gustavo Machín, subdirector del Ministerio de Relaciones Exteriores de Cuba para asuntos de Estados Unidos.

Machín agregó que también han sido invitados muchos estadounidenses que han trabajado para cultivar los lazos entre Estados Unidos y Cuba en los últimos años.

Wayne Smith, un exdiplomático estadounidense que trabajaba en La Habana cuando se cortaron las relaciones y que volvió a finales de la década de 1970 como

jefe de la misión, confirmó que fue invitado: "¡No me lo perdería!".

Smith, un abierto crítico de la anterior política de Estados Unidos hacia Cuba, dijo que dejó el servicio exterior en 1982, luego de que quedó claro que Washington no iba a tratar de acercarse a La Habana. Así que el anuncio histórico de diciembre le fue personalmente gratificante.

"Yo no estaba de acuerdo con el sistema cubano y todo eso, pero me parecía que nosotros podríamos haber logrado más a través del diálogo que negándonos simplemente a hablar, manteniendo un embargo constante y empleando realmente solo una política totalmente hostil", dijo Smith. "Pero eso es lo que hicimos, año tras año, lo mismo de siempre, y no ganamos nada".

**México vence a Costa Rica y avanza a semis de Copa de Oro**Por RICARDO ZÚÑIGA,
Associated PressESTAD RUTHERFORD, 20 VII 15 (AP): Una tras otra, Miguel Herrera observaba desesperado las ocasiones de gol que su selección mexicana desperdiciaba ante Costa Rica en su duelo por los cuartos de final de la *Copa de Oro*.

Los remates de Carlos Vela que, solo frente al arco, salieron desviados por metros. Un disparo de Oribe Peralta que pegó en un poste. Otro de Carlos Esquivel que rechazó el travesaño. Hasta que, empatados 0-0 y a segundos de llegar a una definición por penales, el árbitro dio la mejor asistencia del partido.

Andrés Guardado anotó un penal a los 122 minutos, después que el árbitro Walter López pitió una dudosa falta sobre Peralta, y México superó el domingo 1-0 a Costa Rica para clasificarse a las semifinales del campeonato de la CONCACAF en las que enfrentará a Panamá.

México dominó las acciones de principio a fin, arrinconó a los ticos en el segundo tiempo y se cansó de llegar al área rival, pero nuevamente exhibió una alarmante falta de puntería en la definición.

“La verdad es que tiene cierta cantidad de pelotas para definir el partido antes de terminar sufriendo, y te empieza a pasar en la cabeza el fantasma del que perdonas pierde”, admitió el técnico mexicano Herrera. “Fallas tantas oportunidades, que tu cabeza empieza a maquinar qué es lo que puede pasar en la jugada de ellos, que no te perdonen, que tengas equivocaciones”.

Herrera evitó valorar la polémica jugada en la que López decidió que Roy Miller cometió falta sobre Peralta, cuando ambos disputaban una posición en el área luego de un centro de Miguel Layún. El delantero mexicano saltó y, sin que mediara mucho contacto con el tico, cayó al suelo. López inicialmente marcó saque de meta, pero luego cambió de parecer al consultar con uno de sus jueces de línea.

Guardado metió el gol por un México que, aparte de golear 6-0 a Cuba en su debut, sufrió en la fase de grupos al empate sin goles ante Guatemala y 4-4 contra Trinidad y Tobago.

El ‘Tri’ terminó segundo en su grupo cuando desperdió una ventaja de dos goles y Trinidad empató en la jugada final de su último partido por la fase inicial del torneo.

“La preocupación ha sido desde el principio del torneo, tratar de ser contundentes”, señaló Herrera. “Desafortunadamente en ese renglón no hemos podido ser lo certeros como quisieramos”.

Guardado, Esquivel y Jesús Corona fueron los más desequilibrantes de México. Los dos últimos entraron de cambio por Héctor Herrera y Carlos Vela, dos jugadores cuya titularidad quedó en duda para el duelo ante Panamá por semifinales.

**Obama visita prisión federal en Oklahoma**

EL RENO, Oklahoma, 16 VII 15 (AP): Observando desde el asiento posterior de su limosina negra blindada, el presidente Barack Obama ingresó el jueves a una prisión federal rodeada de alambre de púas y dijo posteriormente que se reunió con reos jóvenes “que cometieron errores que no son tan diferentes de los errores que yo cometí”.

El mandatario dijo que debe haber una distinción entre los jóvenes que “hacen cosas estúpidas” y los criminales violentos. La gente joven que comete errores podría ser próspera si tuviera acceso a recursos y estructuras de apoyo, dijo Obama, “eso les permitiría sobrevivir a esos errores”.

“Cuando ellos describen su juventud y su niñez, estos son jóvenes que cometieron errores que no son tan diferentes a los errores que yo cometí”, comentó Obama. Entre los cambios que está buscando el presidente está la reducción o cancelación de severas sentencias mínimas obligatorias para delincuentes no violentos.

A inicios de esta semana, Obama utilizó sus poderes presidenciales para reducir las sentencias de 46 personas condenadas por cargos relacionados con droga.

El presidente además pidió que se restituía el derecho a voto a delincuentes que han cumplido su sentencia, y que empleadores deberían eliminar de las solicitudes de empleo el renglón que pregunta sobre sus antecedentes penales.

Obama ha expresado esperanza en que el Congreso le envíe una legislación que atienda el asunto antes de que deje el cargo en 18 meses, dado el nivel de interés en la cuestión entre legisladores republicanos y pre candidatos presidenciales.

La seguridad para el presidente en su visita no fue poca. El secretario de prensa de la Casa Blanca Josh Earnest dijo que se tomaron “medidas únicas” para proteger a Obama durante la visita a la cárcel. No dio detalles.

Obama commutes sentences of 46 nonviolent drug offenders

WASHINGTON, DC, July 13, 2015 (AP): President Barack Obama cut the prison sentences of 46 non-violent drug offenders on Monday, including 14 who were sentenced to life in prison, saying "their punishments didn't fit the crime."

"These men and women were not hardened criminals," Obama said in a video released by the White House, noting that the overwhelming majority of the 46 had been sentenced to at least 20 years for non-violent drug offenses.

The move was part of a broader ongoing effort by the administration to make the U.S. criminal justice system fairer. Obama has now issued 89 commutations during his presidency, most of them to non-violent offenders sentenced for drug crimes under outdated sentencing guidelines. A commutation leaves the conviction in place, but reduces the punishment.

Obama wrote a personal letter to each of the 46 individuals to notify them of their commutations. Their sentences all now expire on Nov. 10, 2015.

In a letter to Jerry Bailey, who was sentenced to 30 years in prison for conspiracy to violate laws against crack-cocaine, Obama praised Bailey for showing the potential to turn his life around.

"Now it's up to you to make the most of this opportunity," Obama wrote in the letter, which was sent to Bailey's address at a federal correctional facility in Georgia. "It will not be easy." Obama said, "and you will confront many who

doubt people with criminal records can change."

Obama's lawyer, White House counsel Neil Eggleston, predicted the president would issue even more commutations before leaving office in early 2017. But he also said that Obama's powers to fix the problem were limited, adding that "clemency alone will not fix decades of overly punitive sentencing policies."

Obama this week is devoting considerable attention to the criminal justice system. He plans to lay out ideas for how to improve the fairness of the system during a speech to the NAACP in Philadelphia on Tuesday. And on Thursday, he is to become the first sitting president to visit a federal prison when he goes to the El Reno Federal Correctional Institution outside of Oklahoma City. While there, he will meet with law enforcement officials and inmates.

Obama said that after his commutations, there is still "a lot more we can do to restore the sense of fairness at the heart of our justice system."

Julie Stewart, president and founder of Families Against Mandatory Minimums (FAMM), a group seeking changes in sentencing, said the organization was "thrilled to see that more folks serving excessively long sentences for non-violent drug offenses are going home."

"But they're leaving behind many equally deserving people," she said, "so let's keep these commutations coming, while remembering that clemency is a tool made necessary by our failure to

reform mandatory minimum sentencing laws. Congress simply can't act fast enough."

The 46 sentence reductions announced Monday are the most presidential commutations in a single day since the Lyndon Johnson administration in the 1960s. Obama has commuted the sentences of 89 people, surpassing the combined number of commutations granted by Presidents Ronald Reagan, George H.W. Bush, Bill Clinton, and George W. Bush.

Editor's Note: President Barack Obama commuted the prison sentences of three Ohio inmates. The Ohioans had all been convicted of drug-related crimes: Shauna Barry-Scott of Youngstown was sentenced to 20 years in 2005 for possessing cocaine base with intent to distribute. Bart Stover of Ashland was sentenced to 20 years in 2005 for conspiracy to possess and distribute marijuana and cocaine and other charges. Kimberly Westmoreland of Columbus was sentenced to 15 years in 2004 for conspiracy to distribute cocaine base and carrying a firearm relating to a drug trafficking crime.

Obama granted freedom to Detroit-area man serving life for a drug conspiracy in 1999. Online records show the 65-year-old Patrick Roberts is in a federal prison in Terre Haute, Indiana. Court filings show he pleaded guilty to conspiring to distribute heroin, cocaine and marijuana. Their sentences will now expire in November.

Mayor: Los Angeles leads nation on immigration, wage fronts

WASHINGTON, DC, July 15, 2015 (AP): A decade from now, US-Americans will look back "shocked and embarrassed that immigration reform was so hotly contested," Los Angeles Mayor Eric Garcetti predicted Wednesday during a speech at the National Press Club in Washington.

Garcetti, who noted that he is half-Mexican and half-Jewish, said he was not offering any new, brave policies through his speech, but a return to the nation's past, which is embracing diversity as the strength of the nation.

He said Los Angeles formed an office of immigration affairs that makes sure immigrants have a say on city policies. He said the city also uses its libraries to help legal permanent residents access jobs, health benefits and become citizens.

Garcetti used the speech to highlight two Democratic priorities: reducing income inequality and providing a pathway for legal and undocumented immigrants to stay in the country permanently.

"We as mayors and cities are now leading because we must. We have to fill this vacuum," Garcetti said. "It's a practical necessity for our communities, just

as much as fixing that break of a water main, filling a pothole."

Garcetti, who is expected to run for re-election in 2017, also said he'd like to see more communities raise their minimum wage, though he cautioned that the Los Angeles model may not be for everyone.

"The cost of living is different in different cities and you need to cater it to what is right for your own city," Garcetti said.

Garcetti said the higher wages in Los Angeles would reduce employee turnover and attract better workers.

"When an employer at a McDonalds in Los Angeles can pick the very best, they will get the very best," he said.

Garcetti was elected after promising to focus on a back-to-basics agenda, including fixing cratered streets and buckled sidewalks. The city continues to struggle with some long-standing problems, including high housing costs, homelessness and clogged traffic.

EAST CLEVELAND CITIZENS SUBMIT PETITIONS FOR ANNEXATION BY THE CITY OF CLEVELAND

The Cuyahoga County Board of Elections has received approximately 1,600 petition signatures for the East Cleveland annexation issue and has begun the work on their verification. According to State law, (ORC 709.22 – 709.37) at least 559 valid signatures are required to initiate the annexation process that would conclude with the City of East Cleveland becoming part of the City of Cleveland.

Pat McDonald, Director of the Cuyahoga County Board of Elections expects the signature verification process to be completed by the end of this week. In order for a signature to be valid the voter must have cast a ballot in the last municipal election and be a resident of the City: (R.C. 709.24). "If the number of required signatures is reached and certified, it will then be up to the elected officials of East Cleveland to move the process forward," said McDonald.

The process East Cleveland officials must follow includes (this is just a summary there are some actions and possible scenarios that are not included):

- Declaring their intention to go into negotiations with the City of Cleveland to be annexed
- Appointing members of a commission from both cities who would negotiate the terms of the annexation
- Following negotiations, ballot language would be created
- Each voter would be mailed information concerning the conditions of the annexation
- The annexation question would be put to voters during a Primary or General Election

If all of the requirements for annexation are met the Cleveland City Council has the option of putting the issue before their voters or approving the annexation by a vote of Council.

If the effort falls short of collecting the 559 signatures state law does not allow the petitioners to gather additional signatures to reach their goal: (R.C. 3501.38 (l)(2)(b)). However, they may choose start all over again with a brand new petition Drive.

Documentary on Nicaragua Trip by Francisco Aguilar and Emilio Areas presented at "The Moxie Live"

July 18, 2015: A documentary film entitled "A Better Tomorrow," created by a pair of native Nicaraguans, debuted at *The Moxie Live* Theater, 1205 Adams Street, in Uptown Toledo on July 18th.

38-year old *Francisco Aguilar* and 24-year old *Emilio Areas* were the creators.

Sr. Aguilar achieved his goal of wanting to make the debut of the hour-long film an event in itself, with a DJ "playing old-school Spanish music," refreshments that included the Nicaraguan rum beverage *macua*, and input from the some 100 in attendance.

Aggie Alt, owner of *The Moxie Live*, was delighted. Sr. Aguilar stated the theater owner is a filmmaker herself who is "very supportive" of the project and approached the pair about hosting its debut.

Sr. Areas was unable to attend in person but a brief message from him was shown prior to the presentation of the documentary. "Emilio is a very talented young man. He brings an angle or an edge to the film, to the storytelling that is fresh, is young, that has wonderful camera angles, and great ideas," said Aguilar. "It was an awesome to do it with him. Through him, I was able to connect the bridges of generations. I'm 10

to 15 years older than him, but he is able to keep it fresh—and that's what he brought to the table."

The first part of the film does turn out to be a bit on the dark and gritty side. But the sun does eventually shine on the storyline.

"Like any other story, it does have its dark moments. But as you go and see the documentary, you start to see it's only as dark as we allow it to be," explained Aguilar.

"The whole trip was spiritual. Finishing this project, learning to work with somebody else who shares the same vision, has the same commitment, has the same passion, and seeing them feel what you feel—it changes you because you don't feel like you're the only one who has these thoughts, the only one who feels this way," he explained.

"You're no longer the only one who feels like family is important. There are others out there who feel that way, too. It's good to invest in family. That's the greatest investment you could ever do, is family."

History of Project

The project began in January, just before Aguilar left for Nicaragua to see his mother and celebrate her birthday. But his mother got very ill just



before he was to board a plane, then died before he could arrive to say a final goodbye.

"We talked about doing a project that was not going to be dark and gritty, but more of a celebration and, as it turned out, my mother passed away," said Aguilar. "Then we met again, just as I was leaving. We decided, let's do something different. Let's do a project where I go back and bury my mother. But it's not just about burying my mother and it's not an acultural project, either. I don't want to characterize this as a Latino project, or anything other than a project that reaches out to people."

With such a sad circumstance and somber backdrop to the film, why would the title be "A Better Tomorrow?"

"Basically, it's waking up

in the morning and appreciating life, knowing a better tomorrow is possible without those around you—in this case, family," Aguilar explained.

"This project is about family." The documentary tracks Aguilar's three-week stay in Nicaragua for his mom's funeral, which then turned into a spiritual journey of sorrow and hope that has changed him forever.

The sojourn also included encounters with Nicaraguans and scenery from across the countryside. The film contrasts the simple, happy life of a poverty-stricken people with the *gotta-have-it-now*, materialistic society that has become life in the U.S.

The Lucas County Job and Family Services caseworker admitted he was proud he and

Areas were able to stick to their original vision for the project once circumstances changed.

"It's basically having a vision and the ability to see through that vision, the discipline to make sure that vision takes place and being committed and having the passion to complete the vision," Aguilar explained.

"That is something me and Emilio talked about throughout these past six months—how do we make this happen, what do we have to do, and I am just so happy, just so glad we were able to complete this. A lot of people start things. Not a lot of people finish them."

Aguilar and Areas struck up a friendship, not just based on a vision for a film. The pair

shares a common Nicaraguan heritage and a familiarity with their poverty-stricken homeland. While they represent two generations 15 years apart, those common bonds will spark a lifetime friendship. They met during a class at the *University of Toledo*.

"We developed a very good relationship. We got to see each other and talk about a lot of things before we were able to start this project," Aguilar said. "I wanted to get a feel for where he was at in life. He also wanted to get that, because you've got to feel comfortable with the person you're working with and we just developed a very deep bond. I'm just so glad we met. It's been a blessing."
