Ejército de EEUU revierte baja de recluta inmigrante

17 VII 18 (AP): El Ejército de Estados Unidos revirtió su decisión de dar de baja a un recluta inmigrante que se había enrolado con la promesa de que le abriría una vía para su naturalización, de acuerdo con documentos presentados en la corte y con su aborado.

El inmigrante brasileño
Lucas Calixto interpuso una

Calixto, quien vive en Massachusetts y recientemente fue promovido a soldado raso de segunda clase, es uno de docenas de reclutas y reservistas inmigrantes a los que, según abogados de inmigración, las fuerzas armadas les han dado de baja o cancelado sus contratos sin dar una explicación

sin dar una explicación.

En documentos presentados en la corte el lunes, abogados del Departamento de Justicia dijeron que el ejército estadounidense decidió revocar la baja de Calixto y que esperan finalizar el proceso para el miércoles.

"Este es un primer paso importante para regresar al señor Calixto a su unidad militar, donde ha servido honorablemente por dos años, y permitirle completar su compromiso de servicio de ocho años", dijo Douglas Baruch, abogado de Calixto, en un comunicado el martes.

El Pentágono y el Departamento de Justicia se negaron a comentar sobre la decisión, alegando el litigio en curso con respecto al programa de reclutamiento de inmigrantes y la necesidad de proteger los intereses de seguridad nacional.

El Departamento de Defensa ha tratado de reforzar los requisitos de seguridad para el programa, a través del cual los inmigrantes históricamente han prometido arriesgar sus vidas por la posibilidad de naturalizarse. Finalmente, el programa Military Accessions Vital to the National Interest fue suspendido.

"No hay personas cuyos contratos hayan sido rescindidos o dados de baja de las fuerzas militares debido a su estatus de immigración", indicó la mayor de la Fuerza Aérea Carla Gleason, portavoz del Pentágono. "Existen riesgos significativos de amenazas internas como el espionaje, terrorismo, y otras actividades delictivas en el

programa".

Los abogados del
Departamento de Justicia
calificaron al programa de
reclutamiento como un
"elevado riesgo de
seguridad" en otro caso que
involucraba a 17 reclutas
nacidos en el extranjero,
quienes se enlistaron al
programa pero no han
podido aprobar los
requerimientos de
seguridad adicionales.
Algunos reclutas habían

falsificado sus registros de antecedentes y estaban vinculados con agencias de inteligencia respaldadas por estados, indicaron los documentos presentados a la corte.

US Army reverses course on discharging 1 immigrant recruit

Army has reversed its decision to discharge an immigrant reservist who sued when

with a promised path to citizenship, according to court
filings and his attorney

with a promised path to citizenship, according to court filings and his attorney. Brazilian immigrant Lucas Calixto filed a lawsuit against the Army in late June, saying the Defense Department hadn't given him a chance to defendhimself or appeal when he was discharged.

Calixto, who lives outside Boston and recently had been promoted to private second class, is one of dozens of immigrant recruits and reservists who immigration attorneys say have faced often unexplained military discharges and canceled contracts

and canceled contracts.

In a court filing Monday,
Justice Department attorneys
said the Army decided to revoke Calixto's discharge and
expected to finalize the process by Wednesday

expected to finalize the process by Wednesday.

"This is an important first step in returning Mr. Calixto to his Army unit, where he has been serving honorably for two years, and allowing him to complete his eightyear service commitment," an attorney for Calixto, Douglas Baruch, said in a statement Tuesday.

The Pentagon and Justice Department declined to comment on the specific decision, citing ongoing litigation concerning the immigrant recruitment program and the need to protect national security interests.

The reversal comes as the Defense Department has attempted to strengthen security requirements for the program, through which historically immigrants vowed to risk their lives for the prospect of U.S. citizenship. The Military Accessions Vital to the National Interest program, known as MAVNI, ultimately was suspended.

"There are no individuals being either released from their contracts or separated from the military due to their immigration status," said Pentagon spokeswoman Air Force Maj, Carla Gleason. "There are significant risks from insider threats such as espionage, terrorism, and other criminal ac-

tivity across the program."
Government attorneys called the recruitment program an "elevated security risk" in another case involving 17 foreign-born military recruits who enlisted through the program but have not been able to clear additional security requirements. Some recruits had falsified their background records and were connected to state-sponsored intelligence agencies, the court

filing said.

Eligible recruits are required to have legal status in the U.S., such as a student visa, before enlisting. More than 5,000 immigrants were recruited into the program in 2016, and an estimated

10,000 are currently serving. Nearly 110,000 members of the Armed Forces have gained citizenship by serving in the U.S. military since Sept. 11, 2001, according to the Defense Department.

Since 2013, however, more than 20 recruits to the MAVNI program had become the subjects of counterintelligence or criminal investigations by the Defense Department or FBI, according to the court filing.

Gleason could not say how many of those recruits had been charged with or convicted of crimes, nor did she provide details as to how such figures compared to those for U.S.-citizen service members.

As of April od 2018, 1,100 MAVNI recruits were awaiting basic training while undergoing security reviews, and Gleason said that based on historical estimates, about one-third of the group would not pass and likely would be discharged or have their contracts cancelled.

Some recruits say they were given no reason for their recent discharges. Others said the Army informed them they'd been labeled as security risks because they have relatives abroad or because the Defense Department had not completed background checks on them. Many were reservists who had been attending unit drills, receiving pay and undergoing training, immigration attorneys said.

The Pentagon has said there has been no policy change since lastyear, when Defense Secretary Jim Mattis said no one could ship out to basic training without completion of a background investigation.

This week, a Chinese recruit who said he was told his contract was being cancelled in March said U.S. Immigration and Customs Enforcement officials came to his home in Rochester, New York, and told him for the first time that his legal status in the United States had ended in June and that he was being placed into

he was being placed into deportation proceedings. Recruit Zhang, who gave only his last name for fear that his family could face reprisals in China if he was knownas aformer U.S. Army enlistee, said he and his wife were issued ankle monitoring bracelets Monday and ordered to appear in immigration court at the end of August. ICE officials said in a statement that Zhang had been charged with immigration violations and ICE enrolled him in the agency's Alternatives for Detention program "in an exercise of discretion."

Gleason and an Army spokeswoman declined to comment on the Zhang case.

"Me and my wife came to the U.S. because we wanted to be good immigrants, and we thought the program was a great fit," said Zhang, who has a business management degree and had been pursuing a masters. "I am very depressed right now, and it is hard to make a good plan for the future"

Cuba disputes Mexican airline finding on deadly May crash

HAVANA, July 17, 2018 (AP): A finding by a Mexican airline that pilot error was to blame for a deadly passenger jet crash in May was dismissed as premature Tuesday by the Cuban authorities charged with determining the cause of the accident.

An investigative commission said in a statement read on state TV that it has not completed its analysis of "many factors" that could have contributed to the May 18 crash. "For that reason, any assertion about the possible causes that caused the fatal accident is premature."

Mexican airline Global Air said in a statement Monday that the pilots of the Boeing 737 took off at too steep of an angle before the aircraft crashed near the runway of the international airport in Havana.

The May 18 accident killed 112 people and was one of the worst aviation disasters in Cuban history.

Global Air, which also operates under the name Damojh Airlines, said that ir recreated the flight using the black boxes and a simulator as it seeks to restore its operating license in Mexico.

Mexico's civil aviation authority said it is still conducting its own analysis and has not issued a finding. Cuba desestima culpar a tripulación por avionazo en mayo

LA HABANA, 17 VII 18 (AP): Cuba desestimó el martes las acusaciones de una empresa área mexicana que culpó a la tripulación de un Boeing de realizar malas maniobras ocasionando el accidente que le arrebató la vida a más de un centenar de pasajeros en mayo.

La empresa Global Air—
propietaria de la aeronave
que se estrelló el 18 de mayo
a pocos minutos de despegar
del aeropuerto capitalino
José Martí— indicó la
víspera que el fallo obedeció
a causas humanas, pues el
personal levantó vuelo con
un "ángulo muy
pronunciado" de ascenso.

Según un comunicado de la compañía, estos resultados preliminares obedecen a la recreación del vuelo realizado luego de extraer la información de las cajas negras recuperadas en el lugar del siniestro, un campo de cultivo en las afueras de La Habana. Sin embargo, una nota oficial leída en la televisión estatal el martes en Cuba y firmada por la Comisión de Investigación creada especialmente para estudiar el dramático episodio, aseguró que es

precoz arrojar conclusiones.

Un "proceso de esta magnitud requiere del análisis de múltiples factores

y aún no ha concluido. Por tal motivo cualquier afirmación sobre las posibles causas que provocaron el fatal accidente es prematuro", dijo el texto del grupo de expertos que analiza los datos del Boeing 737/200.

Global Air había rentado la aeronave a Cubana de Aviación y ésta cubría el trayecto entre La Habana y Holguín cuando se desplomó con 113 personas a bordo, una de las cuales sobrevivió, aunque todavía está en estado crítico en un hospital en esta capital.

"Una vez concluya el análisis de las evidencias se informarán los resultados", señaló la Comisión.

La firma mexicana se defendió de las acusaciones de falta de seguridad en sus naves que aparecieron en medios de prensa y acusó a funcionarios y exempleados vengativos de estigmatizarla por algo que consideró una "falla humana" en el manejo de la nave.

La Comisión de Aviación Civil de Cuba, la Dirección General de Aeronáutica Civil y la Administración Federal de Aviación de Estados Unidos son algunos de los organismos que intervienen en investigar las causas del avionazo

Niños migrantes dicen pasar hambre y frío en celdas de EEUU

SANTA ANA, California, 17 VII 18 (AP): Mojados y enlodados tras cruzar la frontera con México, los niños inmigrantes cuentan que se acostarono sentaronenel piso frío de las celdas a donde fueron llevados.

Era difícil dormir con la

Era difícil dormir con la luz prendida toda la noche y los guardias pateando sus pies, decían. Tenían hambre después de recibir lo que dijeron que eran sándwiches congelados y comida

apestosa.

Los más pequeños pequeños lorabanenespacios cercados, en donde estaban apiñados con adolescentes, e imploraban que los llevaran con sus padres. Los inodoros estaban sucios y el agua corriente era poca, cuentan. Esperaban, inseguros y asustados, por lo que les deparaba el futuro.

"No sabía dónde estaba

"No sabía dónde estaba mama", dijo Griselda, una guatemalteca de 16 años que ingresó a Estados Unidos con su madre por la zona de McAllen, Texas. "Vi a niñas preguntar en dónde estaban sus madres, pero los guardias no les decfan".

Decenas de abogados, intérpretes y otros voluntarios recorrieron el suroeste del país en junio y julio para entrevistar amás de 200 padres y menores migrantes sobre las condiciones en las celdas, centros de detención y

centros de detención y albergues juveniles.

Los activistas dicen que el gobierno ha incumplido con el acuerdo Flores de 1997, que dicta las condiciones de detención y requisitos de liberación para los niños immigrantes.

inmigrantes."

"Se han expresado en voz alta y clara, y lo que han dicho es que experimentan hambre forzada, deshidratación forzada, privación del sueño forzada", dice Peter Schey, un abogado de los niños que ha pedido a la corte designar un supervisor especial para que se cumpla con el acuerdo. "Están aterrorizados y creo que es hora de que las cortes y el público escuchen sus voces".

El Departamento de Seguridad Nacional, encargado de la inmigración y el control fronterizo, no ha respondido por el momento a solicitudes decomentario. Pero en sus propios documentos presentados a la corte el mes pasado, los supervisores del gobierno dijeron que las autoridades inmigratorias cumplen con las condiciones establecidas en el acuerdo. Estados Unidos (CBP, por sus siglas en inglés), documentó que la temperatura ambiental es adecuada en varias instalaciones fronterizas y que el mismo tomó agua de los contenedores de 20 litros (5 galones) en los centros de procesamiento de McAllen.

Dijo que algunos niños y padres le dijeron que no les gustaba la comida y no estaban seguros que el agua fuera potable, pero no hubo reportes de que la comida estuviera echada a perder.

de que la contina estavicia echada a perder. También probó el agua en la estación de Yuma en Arizona y "puedo confirmar que los bebederos funcionaban y el agua sabía limpia", dijo.

La letanía de quejas compiladas por los abogados se ha dado a conocer después que la indignación global orillara al gobierno de Trump a dar marcha atrás en la separación de familias inmigrantes en la frontera. Bajo otra orden de lacorte, las autoridades ahora reunifican alos padres y niños separados, y dicen que intentarán mantener a las familias juntas durante su proceso en cortes de inmigración, aunque según el acuerdo Flores, los niños inmigrantes deben ser dejados en libertad en aproximadamente 20 días.

Muchos de los niños describieron las condiciones en las instalaciones de la CBP a donde fueron llevados y en donde fueron procesados los primeros días después de cruzar la frontera. En los

Inmigración: 6 estados y NY demandan al gobierno federal

(AP): Seis estados y laciudad
de Nueva York demandaron
al gobierno federal,
uniéndose a otras ciudades y
estados que dicera que Washington intenta obligar
ilegalmente a las
comunidades "santuario" a

poder recibir fondos para

Las demandas fueron presentadas el miércoles en la corte federal de Manhattan en nombre del estado y la ciudad de Nueva York y los estados de Connecticut, Nueva Jersey, Washington, Massachusetts y Virginia.

En julio de 2017, el

En julio de 2017, el gobierno federal impuso condiciones que requieren que las ciudades que reciben subsidios para su seguridad notifiquen a los agentes federales cuando inmigrantes que se encuentren en el país sin autorización estén por ser liberados.

Desde entonces las cortes federales en *Illinois*, *Pensilvania y California* han anulado las condiciones que afectan a las llamadas comunidades "santuario".

El Departamento de Justicia no respondió de inmediato a un pedido de declaraciones.

declaraciones.

Los seis estados dicen que podrían perder casi 25 millones de dólares en subsidios. En semanas recientes les notificaron que deben participar en las políticas del gobierno federal como condición para poder recibir su dinero, informaron funcionarios.

e La ciudad de Nueva York eu no de los cinco gobiernos locales a los que se les ha asignado la mayor subvención, con 4 millones de dólares, dijeron las autoridades.

"Nuestromensaje es claro: las acciones del gobierno de Trump son ilegales e inmorales", dijo en un comunicado Bill de Blasio, alcalde de la ciudad de Nueva York.

"Hemos demostrado, una

y otra vez, que recibir a inmigrantes ha ayudado a hacer que esta sea la ciudad de gran tamaño más segura del país. Cualquier intento de poner en riesgo la confianza que existe entre nuestra agencia policial local y los inmigrantes neoyorquinos, fallará", dijo De Blasio.

En las demandas se pide que un juez declare la inconstitucionalidad del cambio de política anunciado en 2017, el cual entró en vigor el mes pasado.

Los abogados de los estados escribieron en documentos a la corte que el Departamento de Justicia obliga a esas jurisdicciones a aceptar condiciones ilegales que reducen su capacidad de fijar prioridades en materia de seguridad pública y protección de la comunidad

de la comunidad.

"Con la demanda presentada hoy, Nueva York y otros estados envían el mensaje fuerte y claro de que no soportaremos la intolerancia ni el odio, y no nos dejaremos a acosar con vergonzosas tácticas políticas, mucho menos unas que son d e s c a r a d a m e n t e inconstitucionales", dijo en un comunicado el gobernador demócrata de Nueva York, Andrew Cuomo.

6 states and NYC sue US over immigration-related policy

NEW YORK, July 18, 2018
(AP): Six states and New York
City sued the federal government Wednesday, joining other
cities and states who say the
government is trying to unlawfully force "sanctuary" communities to engage in federal
immigration enforcement if
they want anti-crime funds.

Lawsuits were filed in Manhattan federal court on behalf of New York state and city, Connecticut, New Jersey, Washington, Massachusetts, and Virginia.

The federal government in July 2017 imposed conditions requiring cities receiving public safety grants to notify federal agents when immigrants in

the country without documentation are about to be released from police detention.

Since then, federal courts in *Illinois, Pennsylvania*, and *California* have struck down the conditions affecting so-called "sanctuary" communities.

Justice Department spokesman Devin O'Malley called two lawsuits filed Wednesday "a disservice to these states' law-abiding citizens."

"By choosing not to comply with a federal statute that promotes cooperation between local jurisdictions and federal immigration authorities, political leaders deliberately choose to protect criminal aliens in their custody and tomake their communities less safe." he said.

safe," he said.
The six states say they could lose a total of nearly \$25 million in funds. In recent weeks, they were notified they must participate in the federal government's immigration policies to receive their money, officials said.

New York City is one of five local governments eligible to receive the largest awards, with \$4 million headed its way, authorities said.

"Our message is clear: the Trump Administration's actions are illegal and morally bankrupt," New York City Mayor *Bill de Blasio* said in a release

We have proven, time and again, that welcoming immigrants has helped make this the safest big city in the country. Any attempt to jeopardize the trust between our local law enforcement and immigrant New Yorkers will fail," de Blasio added.

The lawsuits seek a judge's declaration that the policy change announced last year and enforced recently is unconstitutional.

Lawyers forthe states wrote in court papers that the Justice Department was forcing states to accept unlawful conditions that diminish their ability to set their law enforcement priorities and protect their communities.

excanciller ecuatoriano Ricardo Patiño.

For ten years, the Farm Labor Organizing Committee (FLOC), a farmworker union representing tobacco farmworkers, has chal-lenged Reynolds as a leader in the tobacco industry to end abuses in their supply chain by guaranteeing farmworkers freedom of association and the right to collectively negotiate better working conditions. Reynolds sets the term of their grower contracts and is ultimately responsible for the working conditions of tobacco farmworkers in

their supply chain. According to FLOC, "in 2011, Oxfam America and FLOC released a human rights report detailing wide-spread abuses like dilapidated housing, sub-minimum wages, work-related illnesses, and fear of retaliation for speaking out. Since then, FLOC has continued to bring examples of farmworker abuse to the attention of Reynolds; however, Reynolds' response has been to support charity programs and issue empty standards that have had no impact on farmworkers' lives."

\$3 million investment could lead to Broadway revival

According to Chris Amato, Heritage South Initiative president, "Heritage South is making good on its commitment to revitalize the housing stock in the Old South End, while working to renovate a local park. The efforts also have drawn the largest business investment in that neighborhood in decades-a million-dollar carryout pizza shop expected to create up to 60 permanent jobs [July 13, 2018, La Prensa].

"All told, what is now known as the Old South End will become somewhat new again, with more than \$3 million invested in housing, an anchor business, and improved recreational amenities, including a new baseball field at Danny Thomas Park [July 20, 2018, La Prensa]. All of the improvements will occur in the next vear to 18 months."

Historic South secured \$300,000 in state funding from the biennial budget to rehab older housing stock in a four-block area bounded by Western Ave. and Crittenden Ave. Butthe community development corporation had to raise match funds, for a total pool of \$600,000. Toledo City Council recently added \$50,000 more to the pot with Community Development Block Grant (CDBG) funding. Key Bank, Fifth Third Bank, and ProMedica contributed matching funds.

"We're raising another \$400,000 or \$500,000 on our own in addition to that funding," said Amato,

That brings the total fund-

roughly \$1 million.

"We're going roofs, windows, siding. Sometimes we'll do a foundation or we'll paint the house," explained Amato. "There's literally a major transformation going on in those four blocks.

In a handful of cases, Historic South bought the property for an entire overhaul of the house-a \$70,000 investment in most cases-in order to resell the home. Contractors are replacing the water heaters. furnaces, entire electrical systems where needed. Even bathrooms have been completely renovated.

Home ownership-owneroccupied homes-is just above 40 percent in the Old South End so the effort is aimed at moving that needle upward in the next couple of decades to ensure neighborhood stability long-term. The other goal is to increase property values in the area.

"The very first house that we sold in that neighborhood is to a Hispanic guy, a first-time home buyer and his monthly rent was about \$700," said Amato. "Now his mortgage with taxes and insurance is \$355. Here is a first-time homebuyer, with about half the monthly cost compared to when he was renting. So they're getting a great deal on what is basically a new house.

Another home is being sold to a Latino family of 11, following a total rehab in partnership with St. John's Jesuit High School and Dr. Richard Paat, who is well-known for medical missions to Puerto Rico and Central America. A third home is ready for sale at

ing for housing rehab to \$45,000. Historic South plans to buy two more residential properties directly from the Lucas County Land Bank with the aim of more total home renovations.

When all is said a done. 80 houses will receive some sort of improvements. Contractors, dumpsters, and scaffolding have been common sites in that four-block radius since early spring.

"Basically, it's no questions asked," said Amato. "If they live in that four-block area, they qualify. Most programs have an income requirement. Here there is no requirement."

Beautification efforts also took place this spring. A local doctor donated boxwood shrubs for any homeowner who wanted to plant them. St. John's students performed some of their required community service by traveling the neighborhood and handing out annuals so homeowners could plant flowers in their front yards.

"The goal is we'll start with this one neighborhood and expand it over time, said Amato. "What all the experts told us was to concentrate on one small area and grow it out over time. What we're hoping is that when this two-year project is done, the state will see it as a huge success and that we're leveraging their money and that we can expand it to another four-block area. This is not going to happen overnight-but if we can have some patience, over the next 20 years, you're going to see a totally revised Old South

Lawyers to focus on addressing immigrant children's trauma due to Trump separation

NEW HAVEN, Conn., July 17, 2018 (AP): Connecticut lawvers who helped reunify two Central American children and their parents who were separated at the U.S.-Mexico border by federal authorities say their focus now is on ensuring the children get treatment for the trauma they suffered.

The 14-year-old El Sal-

vadoran girl and 9-year-old Honduran boy were detained by a government contractor in Groton for more than a month before being reunited with their parents and freed Monday. The reunification came after a federal judge ruled the separations unconstitutional and the parents were granted parole during deportation proceedings.

Friday's ruling came in a lawsuit against the federal government filed on behalf of the children by lawyers for Connecticut Legal Services and Yale Law School.

A court hearing in Bridgeport is scheduled Wednesday to address the children's post-traumatic stress disorder.

Gov. John Kasich grants reprieve and commutes another

COLUMBUS, July 20, 2018: Ohio Gov. John R. Kasich granted a reprieve to delay the execution of Cleveland Jackson and commuted the death sentence of Raymond Tibbetts to life in prison without the possibility of parole. Jackson had been scheduled to be executed on September 13, 2018 and Tibbetts on October 17, 2018.

Jackson was convicted for the 2002 murder of 17-year-old Leneshia Williams and three-year-old Jayla Grant in Lima. The reprieve will delay his ex-

ecution until May 29, 2019 to allow his newly appointed legal counsel sufficient time to review the case and prop-erly prepare for his clemency hearing before the Parole Board.

Jackson's previous courtappointed counsel withdrew their representation just four months prior to his initially scheduled execution after admitting that they failed to do any work to prepare his clemency application over the course of the previous four years.

Raymond Tibbetts was convicted for the 1997 mur-

ders of his wife, Judith Crawford, and the couple's landlord, Fred Hicks, in Cincinnati, Tibbets's commutation is being granted as a result of fundamental flaws in sentencing phase of his trial. Specifically, the defense's failure to present sufficient mitigating evidence, coupled with an inaccurate description of Tibbetts's childhood by the prosecution, essentially prevented the jury from making an informed decision about whether Tibbetts deserved the death

Northern Indiana US courthouse flags honor late Federal Judge Rudy Lozano

VALPARAISO, Ind., July 14, 2018 (AP): Flags at federal courthouses in northern Indiana will fly at half-staff through Monday to honor late U.S. Senior Judge Rudolfo "Rudy" Lozano.

The court for the Northern District of Indiana announced Friday that the 76-year-old Lozano died Wednesday. A memorial Mass for Judge Lozano will be celebrated at 10 a.m. Monday at St. Paul Catholic Church in Valparaiso.

Ronald President President Ronald Reagan appointed Lozano, of East Chicago, the first Hispanic federal judge in Indiana in 1988. The court said he took senior status in July 2007 but continued to

serve as a senior judge until his death.

Judge Lozano earned his law degree from Indiana University's Maurer School of Law in 1966. He had served in the U.S. Army Reserve.

The Northern Indiana District has courthouses in Hammond, South Bend, Fort Wayne, and Lafayette.

US trade, immigration, and biofuel policies hit

DES MOINES, Iowa, July 15, 2018 (AP): Farmers and agricultural economists are worried that Donald Trump's trade, immigration, and biofuels policies will cost farms billions of dollars in lost income and force some out of business.

Even before Trump began talking tariffs earlier

this year farm income was expected to drop 7 percent from last year to just under \$60 billion. That's half of farm income reported just five years ago.

In addition to falling corn, soybean, and pork prices caused by the tariff dispute, the administration's ethanol policy has reduced the use of corn by hundreds of mil-lions of bushels, helping to push prices below profitability and immigration actions risk hampering expansion

plans in pork industry.



Osorio clasificó a México sin sobresaltos y en la cima de la CONCACAF por primera vez desde las eliminatorias para Francia 98, además que en Rusia consiguió un resonante triunfo sobre

El currículum del colombiano está manchado con la histórica derrota de 7-1 ante Chile por la Copa América Centenario, el peor revés en la historia para México. En Rusia, una derrota de 3-0 ante Suecia en el último partido por la fase de grupos es el peor descalabro en Mundial desde Argentina 78, cuando Alemania goleó 6-0 al "Tri".

Osorio sí le dio a México algo de lo que había carecido: estabilidad en su banquillo. Antes de su arribo, el cargo fue una puerta revolvente por la que pasaron seis técnicos en cinco años: Enrique Meza, Efraín Flores, José Manuel de la Torre, Luis Fernando Tena, Miguel Herrera y Ricardo Ferretti lo precedieron.

El colombiano declaró el jueves que ha pensado en dirigir a la selección de su país, pero que "lo prudente es que entre hoy y mañana en México sabrán nuestra decisión y a partir de ahí será la decisión de otras personas"

Aunque su metodología de rotaciones constantes de jugadores fue cuestionada y tras la eliminación, muchos jugadores se pronunciaron por su continuidad.

"No es decisión de nosotros, pero si se queda jugadores apoyarían", dijo el delantero del LA FC, Carlos Vela. "La Federación está en un momento de cambios y decisiones y por ahora creo que no es tiempo de hablar, primero que decidan como va a estar todo y si habrá cambios o no".

El "Pelado" Almeyda terminó anticipadamente su acuerdo con el Guadalajara por diferencias con sus dirigentes con el armado del equipo v sigue viviendo en esa ciudad del occidente mexicano.

Otro candidato es el "Piojo" Herrera, quien perdió el puesto por agredir un periodista actualmente dirige al América.

that of the public."
The Justice Department has announced it is distributing \$200 million in funds to communities that share its commitment to "keeping criminal aliens off our eets and our law-abiding citizens safe," New York City said in its release.

In April, a federal appeals court in Chicago said the administration of Donald Trump exceeded its authority when it established new conditions for cities to qualify for grants. But it issued a partial stay of a lower court's order blocking the government until the full appeals court considers whether it was proper to block the federal government na-

Besides Chicago, cities from California to Massachusetts have established policies to protect immigrants since Trump won the 2016 election.

"With the lawsuit filed today, New York and other states are sending a message loud and clear that we will not stand for intolerance or hate and we will not be bullied with dis graceful political tactics, let alone ones that are blatantly unconstitutional," New York Democratic Gov. Andrew Cuomo said in a statement.

Riders present hundreds of letters in support of local transit funding

CLEVELAND: On July 23, 2018, over 100 transit riders from Clevelanders for Public Transit [CPT] marched from the Greater Cleveland Regional Transit Authority's [GCRTA's] headquarters to Public Square and rallied for transit funding.

On July 24, 2018, members of CPT presented over 700 letters to the RTA's Board of Trustees calling on the Board to place a transit funding levy on the ballot this November. Riders spoke and presented the letters during the at 9 a.m. Board meeting at RTA's Headquarters at 1240 W 6th St in downtown Cleveland.

According to its press release, RTA is losing \$20 million in annual funding due to a change in state sales tax collection policy which will result in significant service cuts to an already inadequate and shrinking system. Funding is urgently needed in order to reverse the current death spiral by providing immediate fare relief and service restoration. †In order to reestablish public trust and reform the organization, CPT is calling for the levy to be renewable after five years.

RTA's Board of Trustees has supported the longestserving transit administration in the country while those who depend on transit to provide for their family, to access medical care and to better themselves through education have endured rising fares and reduced service.

In 2006, a single trip on RTA cost only \$1.25. Since that time, fares have doubled while service has declined by over 25 percent. The result is record-low ridership of just 39.5 million rides last year — a decrease of over 30 percent in the past decade.

CPT is also calling on Cleveland's Mayor Frank Jackson, County Executive Budish, and the Mayors and Managers Association to include daily RTA riders as well as experts in rail and bus operation, finance and budget, land use, real-estate law and environmental sustainability. This will allow the Board of Trustees to make better informed decisions, rather than approving staff recommendations without careful consider-

CPT is calling on RTA's Board of Trustees to immediately reverse the death spiral by putting transit funding on the ballot this November. †"Residents of Cuyahoga County deserve the public transit service that will move our region forward for all," concluded the press release.

Immigrant children describe hunger and cold in Trump's detention

By AMY TAXIN, Associated Press

July 17, 2018 (AP): Wet and muddy from their trek across the Mexican border, immigrant children say they sat or lay on the cold, concrete floor of the immigration holding centers where they were taken.

It was hard to sleep with lights shining all night and guards kicking their feet, they say. They were hungry, after being given what they say were frozen sandwiches and smelly food.

Younger children cried in caged areas where they were crammed in with teens, and they clamored for their parents. Toilets were filthy, and running water was scarce, they say. They waited, unsure and frightened of what the future might

"I didn't know where my mother was," said Griselda, 16, of Guatemala, who entered the U.S. with her mother in the McAllen Texas area "I saw girls ask where their mothers were, but the guards would not tell them.'

The children's descriptions of various facilities are part of a voluminous and at times scathing report filed in federal court this week in Los Angeles in a case over whether the Trump administration is meeting its obligations under a long-standing settlement governing how young immigrants should be treated in custody.

Dozens of volunteer lawyers, interpreters and other legal workers fanned out across the Southwest in June and July to interview more than 200 immigrant parents and children in holding facilities, detention centers and a youth shelter.

Advocates said the government isn't complying with the decadesold Flores agreement, which lays out detention conditions and release requirements for immigrant children.

"They have spoken out loud and clear, and what they've said is they are experiencing enforced hunger, enforced dehydration, enforced sleeplessness." said Peter Schev, an attornev for the children who has asked the court to appoint a special monitor to enforce the agreement. "They are terrorized, and I think it is time for the courts

SANTA ANA, Calif., and the public to hear their voices.

> The Department of Homeland Security, which oversees immigration and border enforcement, did not immediately comment. But in their own reports to the court last month, government monitors said that immigration authorities were complying with the settlement agreement.

> In his report, Henry Moak Jr., juvenile coordinator for U.S. Customs and Border Protection, documented the air temperature as appropriate at a number of border facilities and said he drank the water himself from five-gallon containers at a processing center in McAllen

> He said some children and parents told him they disliked the food and weren't sure the water was drinkable, but there were no allegations the food was spoiled.

> At the Yuma station in Arizona, he said he tried the water there, too, and, "I can confirm the water fountains worked and the water tasted clean "

> The litany of complaints compiled by advocates comes after a global outcry drove the Trump administration to stop separating immigrant families at the border. Authorities are now reuniting parents and children under a separate court order and said they will seek to detain families together during their immigration proceedings, though under the Flores agreement immigrant children are generally supposed to be released from custody in about 20 days.

> Many of the children described conditions in U.S. Customs and Border Protection facilities where they were taken and processed in the initial days after crossing the border. They were identified in the reports solely by their first names.

> Timofei, a 15-year-old from Russia who sought asylum at the border with his parents over their beliefs as Jehovah's Witnesses, said night and day blended together in the locked, crowded room where he was held with other boys. It had a single window overlooking an empty corridor, he said. He said there was no soap in the bathroom, and he only sometimes got a single-use toothbrush.

He said he was offered a shower upon arriving at the San Ysidro, California, facility but didn't take one and wasn't allowed one on his second or third day

Some children were later sent to the Casa Padre shelter in Texas for immigrant children traveling alone or who were separated from their parents. The facility operates under a contract with the Department of Health and Human Services. There, teenage boys described going hungry and not being given enough time to speak with their parents by phone.

Kenneth Wolfe, a spokesman for HHS's Administration for Children and Families, said the agency wouldn't comment on specific cases but if a contractor doesn't comply with agency procedures, the issue is addressed.

Also in Texas, Keylin, a 16-year-old girl from Honduras, said she traveled north with her mother after her mother's life was threatened back home. The pair turned themselves in at the border near McAllen and were taken to a facility she called the "ice box" because it was so cold.

A day later, they were taken to a facility with caged areas she called the "dog house." There, they were separated and allowed to speak once for 10 minutes over the next four days, she said.

In both places, the food was frozen and smelled bad and she couldn't eat it, she said. She said female guards yelled at her and other girls and made them strip naked and leered at them before they showered.

"I was very frightened and depressed the entire time. I was scared of the guards and scared I would be deported without my mother," she said, adding they were later reunited and sent to a family detention center.

Angel, a 13-year-old who came from Mexico with his mother, said guards told boys in his cell in McAllen, Texas they were going to be adopted and wouldn't see their parents again. He was later sent to family detention with his mother where he said they passed an asylum screening and were awaiting release.

"I am excited to get out of here and get past this nightmare," he said.

Trump deporting crime victims while they wait for special visa

19 VII 18 (AP): Immigrants applying for a special visa awarded to victims of crime on U.S. soil are being detained and deported by Donald Trump's administration.

Under past presidents, people who were here without documentation but qualified for so-called "U

visas" were typically allowed to wait stateside until their petitions were approved. But now ramped-up immigration enforcement means some of them are getting swept up by U.S. Immigration and Customs Enforcement [ICE] before they have a chance to legalize.

Congress established the

U visa program in 2000 to encourage immigrants to report crimes to law enforcement. The visas are given to victims of crimes such as sexual assault, domestic violence, and obstruction of justice.

Advocates say recent deportations undermine the protection's spirit.

More than 300 older children split at border are reunited

2018 (AP): The Trump administration said Thursday that it has reunified 364 children ages 5 and older with their families after they were separated at the border, still leaving hundreds to go before a court-imposed deadline a week away.

The Justice Department reaffirmed in a court filing that it has identified 2,551 children who may be covered by U.S. District Judge Dana Sabraw's order. More than 900 are either "not eligible or not yet known to the eligible," the vast majority of them undergoing evaluation to verify parentage and ensure the children are safe.

ACLU attorney Lee Gelernt said he was concerned about the high numbeen cleared for reunification.

The administration and the American Civil Liberties Union [ACLU] are due back in court Friday for the fifth time in two weeks as the judge holds tightly to a July 26 deadline for all children to be reunified. He set an earlier deadline of July 10 for dozens of children under 5.

The government has identifiedeight U.S. Immigration and Customs Enforcement [ICE] locations to reunify children 5 and older, and people have been getting released throughout the Southwest this week.


