## El Centro offering Citizenship, ESL Classes on Saturdays

*El Centro de Servicios Sociales* in Lorain, Ohio is encouraging Latino individuals and families to better themselves on Saturdays at the community center, by attending citizenship and English as a second language (ESL) classes.

There are a few more sessions before the end of the year, some of which have been attended by Latinos from as far away as Toledo and Cleveland. But *El Centro* executive director Victor Leandry knows there is still a significant local population to reach with the course offerings.

"There's not that many classes in Northeast Ohio in regards to preparing people for citizenship or the process that people go through to get their citizenship, especially classes that are affordable and tailored to our community," he said. "We have seen how much impact those classes have had on helping people pass their citizenship test. Those classes are very important."

But Leandry points out the same people who take the citizenship class also have a need to improve their English-speaking skills. So, the classes are held back-to-back each Saturday, with the citizenship course at 10 a.m., followed by the ESL class at noon. Each runs two



hours long.

"You don't have to participate in both. You can choose one or the other one," he said. "But they are put together to complement each other."

*Lorain Community College* conducts other ESL classes during the week, but Leandry stated the feedback from people his agency serves is that those courses "are too advanced" for people who may need "English 101." So, the Saturday courses are conducted by *Oberlin College* students who must rack up some service-learning hours as part of their major.

"They come very organized, very prepared for those classes," said

Leandry. "They're fantastic. I'm here some Saturdays and sit down and see them ready to teach. Their English classes are more one-on-one and very conversational, really helping people to get the basics, at least."

The need comes from the migrant farm worker community who arrive each summer and the families who decide to stay. Lorain County also has seen a huge influx of Hurricane Maria refugees who fled to northern Ohio from their native Puerto Rico and decided to settle there. While there are no specific numbers of Spanish-speaking families, Leandry stated "we know the need is there."

"Maybe because it's

a long, long Saturday, people don't stay for the English classes," he said. "We were asked by the community to put on the English classes. We put it on a Saturday after the immigration classes, thinking if people are already going to be here for the immigration class, might as well have them stay for the English class. I don't want to stop that service. We want to open it up to anyone who may need it."

The classes involve group activities and one-on-one tutoring where needed. There are still a handful of classes to go before year's end. *El Centro* will take a pause over the holiday break, then resume in January.

Leandry pointed out college students also give

volunteer service hours providing child care, to make it more convenient for parents to attend courses. There is no pre-registration required; classes are held on a drop-in basis.

But Leandry has admitted that if attendance fails to improve, *El Centro* will be forced to discontinue the Saturday ESL session.

During his address, Rivera told the crowd of his passion for immigration, immigration reform, and his intent to start a nonprofit to help the immigration situation in retirement.

*"It was very powerful,"* said Leandry.

## Mexican immigrant fights for DACA as court ruling nears

NEW YORK, Nov. 12, 2019 (AP): A Mexican immigrant fighting President Donald Trump's attempt to end a program shielding young immigrants from deportation says he is nervous about the case finally being heard by the U.S. Supreme Court.

*Martin Batalla Vidal* is a lead plaintiff in one of the cases to preserve the Obama-era program *Deferred Action for Childhood Arrivals*, known as *DACA*, and has seen his name splashed in legal documents since 2016, when he first sued in New York. The 29-year-old certified nursing assistant at a rehabilitation clinic for traumatic brain injury in Queens, New York, has described the legal journey since then as stressful, with people sending him hateful messages. He has had to sacrifice days at work so he could go to protests, press conferences and meetings with attorneys.

Even with his worries, Batalla Vidal is hopeful immigrants like him will be able to stay in the country.

"I don't know what is going to happen," said Batalla Vidal, who lives with his mother, two brothers and a dog in an apartment at the border of Queens and Brooklyn. "Whatever the outcome is, we know that we have fought hard for it and we will continue fighting. I am trying to be positive."

The nation's highest court heard oral arguments on the case Nov. 12.

The program protects about 700,000 people, known as "*Dreamers*," who were brought to the U.S. as children or came with families that overstayed visas without documentation.

With the attempted elimination of *DACA*, there was renewed pressure in Congress to pass the *DREAM Act*, or *The*

*Development, Relief and Education for Alien Minors*, a series of never-passes proposals to protect young immigrants vulnerable to deportation. Opponents say the law rewards people for breaking the law, encourages undocumented immigration and hurts U.S. workers.

Trump ordered an end to *DACA* in 2017, but federal courts in different states, including New York because of Batalla Vidal's lawsuit, blocked him from ending it immediately.

The protections remain in effect at least until the U.S. Supreme Court issues its decision, which will likely be in 2020. Participants of the program can renew their status, but no new applicants can sign up.

The Obama administration created the *DACA* program in 2012 to provide social security numbers, work permits and protection from deportation to people who, in many cases, have no memory of any home other than the U.S.

The Trump administration argues that the program is unlawful because former President Barack Obama did not have the authority to adopt it in the first place.

Batalla Vidal initially sued when a federal court in a separate case ruled that *DACA* permits could not be extended for a third year, as the Obama administration wanted. Now he's part of the legal fight over *DACA*'s very existence.

When Trump ordered the termination of the program, lawyers for Batalla Vidal amended his original lawsuit to fight the termination and added more individual plaintiffs.

A federal judge ruled in their favor. The U.S. Supreme Court in June agreed to hear the administration's appeal of Batalla Vidal's and other cases from around the country.

On Monday, Batalla

Vidal planned to arrive to Washington, D.C., in a bus with his mother to join representatives from colleges, civil rights groups, Democratic-led states and individuals who also sued. On Tuesday, he will sit at the Supreme Court to hear oral arguments.

"Nobody thought we would get this far," he said after speaking last week in a conference at LaGuardia Community College, where he studies criminal justice as an undergraduate student. "I have my family, my community, which has had my back since day one."

Batalla Vidal crossed the Mexico border when he was 7 years old with his mother and a brother. He has two other brothers who are U.S. citizens.

After going to high school in Brooklyn, he said he worked making deliveries at a deli and later at a gym to save for college, and later on to support his single mother who has thyroid and osteoarthritis. Batalla Vidal also joined Make the Road New York, a nonprofit group that defends immigrant rights. Lawyers from the organization, along with the Worker and Immigrant Rights Advocacy Clinic of Yale Law School and the *National Immigration Law Center* filed the 2016 lawsuit.

"His bravery and commitment to justice for our communities throughout this legal fight have been admirable and captured the attention of people all over, thousands of whom sent him messages of support after he received hate-filled messages for suing Trump,"

said Marielena Hincapie, executive director of the *National Immigration Law Center*. "Martin is fighting for the freedom to thrive and be himself in this country, which is his home."

## Colorado governor vows to fight for DACA recipients

DENVER, Nov. 14, 2019 (AP): Gov. Jared Polis vowed Thursday to fight for thousands of immigrants who live and work in Colorado as the U.S. Supreme Court considers a case that could end an Obama-era program protecting them from the threat of deportation.

Pressed by reporters on a conference call, the Democratic governor offered few details on what his administration or Colorado lawmakers could do if the Trump administration is allowed to end the 7-year-old *Deferred Action for Childhood Arrivals* program, or *DACA*.

Those in the program were brought to the U.S. as children and lack legal status. Thousands are now adults, with jobs, families and few if any ties to their countries of birth.

The *Center for American Progress*, an advocacy group, estimates some 15,000 *DACA* recipients are in Colorado, paying \$113 million in federal taxes and \$59.1 million in state and local taxes each year.

The court heard arguments Tuesday on whether the Trump administration can abolish the program protecting 660,000-plus immigrants.

The administration ar-

gues that the program, adopted by former President Barack Obama, is illegal and that it has no choice but to end it. It also says it has the authority to end *DACA* as bad policy even if it is legal.

Congress repeatedly has failed to pass so-called *DREAM act* legislation allowing *DACA* recipients to seek U.S. citizenship.

Polis says his administration would ensure there is legal aid for *DACA* recipients if the high court decides next summer that the administration can terminate the program.

He also vowed to press Colorado's congressional representatives to find a solution. As a congressman, he was a co-sponsor of the *DREAM Act*. Opponents of the legislation say it would encourage undocumented immigration.

*DACA* recipients "are just as American as any other Coloradan," the governor said, decrying what he called "a horrific attempt to destroy our economy and rip families apart."

Immigrant advocates who organized the conference call said business and educational coalitions nationwide ultimately could

compel Congress to act, regardless of the high court decision.

Denise Maes, executive director of the *American Civil Liberties Union of Colorado*, suggested more options could come after the nation sees what the Supreme Court decision is.

Sergio González, deputy director of the *Immigration Hub* advocacy group, noted that elections have affected the level of bipartisan support for *DREAM* legislation.

Polis spoke the same week Colorado immigration hardliners submitted signatures for a proposed 2020 ballot initiative that would insist the state Constitution permit only U.S. citizens to vote—something the Constitution does already. Critics see it as a way to recruit pro-Trump voters ahead of next year's elections.

Since taking office in January, Polis has signed into law measures to limit police cooperation with federal immigration officials and to increase the availability of driver's licenses for immigrants here without documentation.

He's also appointed a *DACA* recipient, Marissa Molina, to the board of Metropolitan State University of Denver.

**Argentina: inflación se desacelera en octubre a 3,3%**

BUENOS AIRES, 14 XI 19 (AP): La inflación se desaceleró en Argentina a 3,3% en octubre respecto del mes anterior gracias al freno provisorio que puso el gobierno a los precios de los combustibles, alimentos y tarifas de servicios públicos en plena campaña para las elecciones generales que consagraron al opositor Alberto Fernández.

No obstante, los economistas pronosticaron que la tregua será breve.

Con la cifra de octubre, la inflación acumulada en 2019 es de 42,2%, según el informe dado a conocer el jueves por el Instituto Nacional de Estadística y Censos (INDEC). Respecto del mismo mes de 2018, la cifra escaló al 50,5%.

En septiembre la

inflación había sido de 5,9%, la mayor del año, como consecuencia de una brusca depreciación del peso por la incertidumbre que había generado en los mercados el escenario electoral. Con bienes y servicios que toman como referencia al dólar, el temblor cambiario se trasladó a los precios.

La fórmula encabezada por Fernández acompañado por la expresidenta Cristina Fernández de Kirchner (2007-2015) se impuso con el 48,24% de los votos en las elecciones generales del 27 de octubre sobre el actual mandatario conservador Mauricio Macri, quien aspiraba a la reelección, que obtuvo el 40,28%.

La desaceleración de la inflación en octubre estuvo ligada a las medidas

adoptadas por el gobierno en la campaña como la eliminación del impuesto al valor agregado (IVA) para los alimentos que conforman la canasta básica y el congelamiento en el precio de los combustibles y las tarifas de servicios públicos. Algunas de ellas ya caducaron, como en el caso de los combustibles y el gas para viviendas. En lo que respecta al IVA su vigencia es hasta fin de año, por lo que es de esperar que en noviembre repunte el costo de vida.

En octubre las mayores subas de precios se registraron en los rubros equipamiento y mantenimiento del hogar (8,1%) y en bebidas alcohólicas y tabaco (6,2%).

**Rey de España aboga por pluralidad y libre expresión en Cuba**

LA HABANA, 14 XI 19 (AP): El rey de España Felipe VI, de visita oficial en Cuba, abogó por que sean los cubanos quienes definan su futuro y por la diversidad política y la libre expresión.

“Cuál será ese futuro es algo que tiene que dilucidar el propio pueblo cubano. Los cambios en un país no pueden ser impuestos, tienen que nacer de dinámicas internas”, expresó el monarca en un discurso la noche del miércoles durante una cena junto al mandatario cubano Miguel Díaz-Canel.

Agregó que “es necesaria la existencia de instituciones que representen a toda la realidad diversa y plural que existe de los

ciudadanos y que éstos puedan expresar por sí mismos sus preferencias y encontrar, en esas instituciones, el adecuado respeto a la integralidad de sus derechos incluyendo, entre ellos, la capacidad de expresar libremente sus ideas, la libertad de asociación o de reunión”.

Aunque no hizo alusión directa, España expresó en varias ocasiones su expectativa de que la isla tenga un modelo pluripartidista y garantice al acceso de otros grupos a los medios de comunicación.

La visita de los reyes de España a la isla, que comenzó el martes, fue duramente cuestionada en el país ibérico por los sectores más conservadores que les

criticaron su respaldo al gobierno de Díaz-Canel.

Al mismo tiempo el

monarca expresó su respaldo a los empresarios españoles que residen en Cuba y que actualmente sufren las presiones impuestas por Estados Unidos a la isla.

Washington incrementó las sanciones contra Cuba este año autorizando incluso el apartado de la Ley Helms-Burton que permite a sus ciudadanos establecer pleitos contra compañías de terceros países que usen propiedades nacionalizadas por la revolución.

**Gobierno dice que Evo Morales no puede volver a postularse**

LA PAZ, 14 XI 19 (AP): La autoproclamada presidenta interina de Bolivia, Jeanine Áñez, anunció el jueves que el expresidente Evo Morales no está habilitado para participar en las nuevas elecciones que convocará su gobierno.

En una rueda de prensa, Áñez dijo que “toda la convulsión social” que atraviesa Bolivia es consecuencia de la insistencia de Morales de postularse a un cuarto mandato y aconsejó al Movimiento al Socialismo (MAS), el partido del exmandatario ahora asilado en México, que busque otro candidato.

“El MAS tiene todo el derecho para participar en elecciones, que busquen candidatos. Evo y (el exvicepresidente Álvaro García Linera) no pueden participar, no están habilitados”, dijo Áñez.

Morales quedó habilitado para participar en las elecciones del 20 de octubre, calificadas de fraudulentas por la oposición, gracias a un fallo constitucional después de perder un referendo que le dijo “no” a su postulación no autorizada por la constitución. Áñez declaró la víspera que hará gestiones para anular ese fallo, que sólo puede ser revocado por el mismo tribunal que lo dictó.

arrancaron placas de metal y tablones de madera de obras para usarlos como armas y algunos prendieron cartuchos de dinamita.

Policías antimotines respondieron con gases lacrimógenos mientras aviones de combate rugían en vuelos bajos sobre la multitud en una demostración de fuerza.

Morales cambió la política de Bolivia, gobernada durante décadas por descendientes de europeos, al revertir la profunda desigualdad. La economía creció con fuerza gracias a la suba del precio de las materias primas y promulgó una nueva constitución que creó un Congreso con escaños reservados para minorías indígenas a la vez que permitió el autogobierno de las comunidades nativas.

Aunque algunos de sus seguidores se mostraron descontentos por su insistencia en aferrarse al poder, Morales sigue siendo una figura popular, especialmente entre los aymara, el grupo étnico al que pertenece. Muchos de ellos están preocupados por la posible pérdida de los beneficios logrados.

“Nos han tratado de delincuentes. Aunque Evo se haya ido, eso no nos interesa, lo que nos interesa es el proceso de cambio. Estamos peleando por esos cambios. Han quemado la Wiphala y eso no lo podemos admitir porque representa a los indígenas”, dijo a The Associated Press Teodoro Ulo, habitante de El Alto.

Hasta el momento Estados Unidos, Gran Bretaña, Brasil y Colombia han reconocido al gobierno de Áñez. También el australiano presidente encargado de Venezuela, Juan Guaidó.

En Uruguay, donde se encuentra de visita, el presidente electo de Argentina Alberto Fernández, dijo que cuando asuma la presidencia de su país “será un honor recibir en sus pais a Morales”.

“Si hubiera sido yo presidente les hubiera ofrecido asilo en primer día”, dijo a periodistas.

## Escuela SMART Bilingual Academy receives \$2,500 donation

*Escuela SMART Bilingual Academy* received an unexpected monetary gift on Nov. 4, 2019 from a pair of Latino auto sales staff from *Taylor Hyundai*, 12681 Eckel Junction Rd. in Perrysburg.

The school's principal, some students, and their families attended a reception held at the dealership where a giant check was presented to the school for whatever purposes it deems. The kids posed for pictures holding the giant check. The reception also included food, refreshments, and a DJ.

*Melinda Sánchez* and her son *Dan Barboza* ran a promotion during Hispanic Heritage Month where they would donate \$100 for every new car and \$50 for every used car the pair sold during that time period. *Taylor Family dealerships* rounded out the donation to a total of \$2,500.

"I've always been involved in the community and I'm always about giving back, helping

in any way possible," said Ms. Sánchez. "Since we do a lot of work with TPS, I wanted to select a TPS school. Since this is the first year Escuela SMART is under their umbrella, what a better way to start than with Escuela SMART."

Principal Jessica Molina Kuhlman admitted there are no formal

plans on what to do with the money yet, although some may be used for staff recognition. She stated students are lobbying to get the school staff to buy keyboards to give them something to do during their lunch hour. The timing is interesting, because Escuela will begin a band program next semester for sixth graders.

"We've taken a tour of a different school before and that's what they did there, so I think maybe that's where they got the idea," said Ms. Kuhlman, pointing out the other school had a variety of musical instruments students could play if they finished their lunch early.

Ms. Sánchez stated the donation is the first of a quarterly effort to help Latino and community groups, so there will be three more such donations made in 2020. Word has quickly spread.

"We've had quite a few letters come in already, why we should consider their organizations next year," said Ms. Sánchez, who plans to open the letters after the New Year to select the spring recipient. "I know it's important to help organizations that don't have a lot of funding or still have a need. That's why I'm doing what I'm doing."

"We've been in the news quite a lot lately, so I think it's just the positive press that's getting the word out about our school and having people want to get involved in some way," said the principal, while



pointing out the *Taylor Hyundai* donation was "completely unsolicited."

"I wish we could have given more, but it was a decent contribution for our first check," said Ms. Sánchez, who will soon celebrate her 65<sup>th</sup> birthday. "Everybody wants your money, but nobody wants to give back. I'm not about that. It's not all about just making money."

Ms. Kuhlman called the funding critical support, as the K-6 student body currently numbers 280 students, far above TPS projections of 220-230 students at the beginning of the academic year. Those numbers don't even include the preschool which also operates there. According to the principal, the school has attracted out-of-district students from Washington Local, Sylvania, and Maumee. Some others transferred from charter schools.

"We definitely exceeded expectations," admitted Ms. Kuhlman. We have two classrooms in grades K through 4 and then we have one fifth grade class and one sixth grade class."

The current kindergarten class is at capacity, but each grade also saw significant growth over last year, when Escuela SMART was a charter school. Word of mouth between families is being credited for the significant growth and interest from suburban families. The school also employs a family outreach coordinator who attends a lot of community events.

"We've been in the news quite a lot lately, so I think it's just the positive press that's getting the word out about our school and having people want to get involved in some way," said the principal, while

better off in the facility we have now. I feel like our teachers are much better off, too," said Ms. Kuhlman.

"They have access to more resources and more support. It's a good year. It's a learning year. It's definitely a transition year, lots for us to learn, being a part of a big district. But everything is going very smoothly, considering that fact."


Escuela SMART moved from charter school status to public school at the end of the 2018-19 academic year, as TPS and the school's board reached a merger agreement. The students and staff moved to a former TPS elementary building in the Old South End that had been used for special-needs students. Those students, in turn, moved downtown into a former charter school.

The school and its families will celebrate the holiday season with a family potluck dinner in November and a winter concert in December.

State senator *Teresa Fedor* (D-Toledo) also recently visited the school. That stop is significant, because Sen. Fedor is a former educator who led the anti-charter school movement at the Ohio Statehouse and was very vocal about how they are regulated and measured academically—and she's visiting a former charter turned public school.

DETROIT, MI, 21 XI 19: El Consulado General de El Salvador en Chicago, realizará un consulado móvil en Detroit este sábado 23 de noviembre (de 9:00am a 6:00pm) y domingo 24 de noviembre (de 8:00am a 12:00pm) en el salón de la iglesia San Francisco de Asís, ubicada en el 4417 de la calle Wesson, Detroit, MI 48210. No es necesario realizar cita, se atenderá a todos los que asistan.

Los servicios que se ofrecerán, son: Aplicaciones de pasaportes y documentos para personas jubiladas. "También podemos tomar aplicaciones de escrituras públicas, aunque se nos complica un poco porque tenemos que tomar las solicitudes y luego regresar para entregarlas porque se deben escribir en un libro; es decir, es un sistema un poquito complicado. Trataremos de apoyar en todas las necesidades de carácter comunitario y si es necesario también de carácter familiar, como la pérdida de un ser querido. Buscaremos la manera de orientarlos y darles asesoría legal, en cuestión de asuntos migratorios. Vamos a tratar de ayudarlos en todo lo que nos sea posible ya que el objetivo es prestarles servicios a nuestros connacionales sin que tengan que viajar a Chicago", informó la Cónsul Patricia Haydee Fernández Montalvo.

Para el trámite de solicitud de escrituras públicas (poderes) (\$40) autorizaciones de menores (\$20); documento para INPEP, ISSS, AFP'S (\$10) es necesario remitir la documentación vía correo electrónico a más tardar el miércoles 20 de noviembre, incluir nombre y número de teléfono en el correo: consuladchicago@reee.gob.sv

Se atenderá a todas y cada una de las personas por orden de llegada, se les entregará un número y se les irá llamando poco a poco. Debido a que la comunidad salvadoreña en Detroit es grande, se espera la asistencia de entre 300 a 400 personas por lo que se pide su paciencia ya que únicamente viajan tres funcionarios del consulado para atender a esta cantidad de connacionales.

Al respecto, la Cónsul Fernández comentó: "Contamos con voluntarios que la iglesia nos provee, todos los años nos ayudan bastante, hemos trabajado super bien porque nos ayudan a facilitar el proceso y hacerlo un poquito más rápido. Es importante que lleven la documentación necesaria para no perder tiempo. Les pedimos paciencia a los asistentes, sabemos que a veces tienen que esperar pero atendemos a todos los que lleguen, hasta ahora no hemos dejado de atender a nadie y siempre viajamos las mismas tres personas, incluso cuando



hay que atender a comunidades grandes como Minneapolis donde llegan de 700 a 800 personas".

Debido a ese tiempo de espera, es por lo que siempre se busca realizar los consulados móviles en iglesias o lugares accesibles para el público, pues muchas veces acuden con niños pequeños y es importante que haya espacios donde puedan jugar, entretenerte y estar cómodos.

El Consulado General de El Salvador en Chicago tiene como jurisdicción todo el medio oeste, incluyendo Kentucky (12 Estados en total), por lo que se programa una visita al mes a cada uno de los Estados, aunque en ocasiones se realizan dos visitas al mes, como se realizará el próximo mes de diciembre: Un consulado móvil en Ohio y otro en el sur de Indiana.

"Existen Estados en donde las comunidades salvadoreñas son tan grandes que tenemos la necesidad de regresar una segunda vez durante el año", dijo la funcionaria salvadoreña. "Tratamos de viajar los meses que no hay problemas con el clima, es decir enero, febrero y marzo no viajamos, comenzamos a finales de marzo y nos programamos para tratar de atender todos los Estados de nuestra jurisdicción. Realizamos aproximadamente entre 10 y 12 consulados móviles al año. Tenemos una comunidad salvadoreña muy extensa e importante atenderlos a todos".

## Pedro Capó se lleva el Latin Grammy a la canción del año

LAS VEGAS, 14 XI 19 (AP): Pedro Capó recibió el jueves un lindo regalo de cumpleaños: el Latin Grammy a la canción del año por su éxito "Calma".

El cantante puertorriqueño superó a nominadas como "Mi persona favorita" de Alejandro Sanz y Camila Cabello, "Querer mejor" de Juanes con Alessia Cara y "Un año" de Sebastián Yatra. Además, obtuvo el premio a la mejor fusión/intérprete urbana por el exitoso remix de su canción con Farruko.

"A mi hermano del alma, que falleció creyendo en esta canción: Joy Santiago, ésto es para ti papá!", dijo Capó sobre el músico puertorriqueño y colaborador suyo fallecido en 2018. "A nuestros hijos porque al final del día sabemos todos los colegas que el sacrificio duro lo sufren ellos", agregó.

La 20ma edición anual de los Latin Grammy comenzó con un homenaje a la música latina en el que participó una veintena de artistas. Olga Tañón, Milly Quezada y Anita interpretaron el clásico de Celia Cruz "La vida es un carnaval", y tras ellas aparecieron Carlos Rivera, Reik y Leonel García para cantar "Querida" de Juan Gabriel. Natalia Jiménez, Calibre 50 y Prince Royce entonaron "Secreto de amor" de Joan Sebastian, mientras que Draco Rosa, Fito Páez y Beto Cuevas cantaron "De música ligera" de Soda Stereo.

"Me parece increíble que ya pasaron 20 años desde que pisé este

escenario por primera vez acompañado de dos grandes leyendas, Celia Cruz y Gloria Estefan", dijo Ricky Martin en su debut como conductor al terminar el show de apertura, al que se unió al final. "Hoy siento la misma emoción", agregó antes de presentar a las copresentadoras del espectáculo, las actrices Paz Vega y Roselyn Sánchez.

El primer premio de la gala televisada, a mejor álbum contemporáneo/fusión tropical, fue para Juan Luis Guerra y 4.40 por "Literal". El músico dominicano también ganó mejor canción tropical por "Kitipun" durante la llamada Premiere, una ceremonia previa no televisada en la que se repartieron la mayoría de los trofeos.

El segundo, a mejor álbum de música urbana, fue para Bad Bunny por "X 100Pre".

A todos los músicos, a toda la gente que pertenece a la academia, con todo respeto, el reggaetón es parte de la cultura latina y está representando, al igual que muchos otros géneros musicales, a nivel mundial a los latinos", dijo el astro puertorriqueño al recibir su galardón. "Igualmente le digo a mis compañeros de reggaetón vamos a echarle ganas, vamos a volver a traer creatividad y comunidad".

La Academia Latina de la Grabación fue criticada este año por no incluir a exponentes de este género en las categorías

principales, pese a que dominan las listas de popularidad, llenan estadios y suman millones de vistas en YouTube.

Alejandro Sanz, que encabezaba la lista de nominados con ocho menciones, ganó dos en ese evento: mejor canción pop "Mi persona favorita" con Camila Cabello, y mejor video versión larga por el documental "Lo que fué es lo que soy".

Durante la gala cantó la canción premiada, pero sin Cabello. La cantante, para quien este representa su primer Latin Grammy, no estuvo presente. Apareció únicamente cantando en un video pregrabado.

La sensación española

Rosalía, galardonada el año pasado con dos gramófonos y que le seguía con cinco nominaciones, también resultó una de las primeras ganadoras en la Premiere: superó a Sanz al ganar mejor álbum pop vocal contemporáneo por "El mal querer", que compite con "(hash)ELDISCO" de Sanz en la categoría de álbum del año. Y su álbum también ganó mejor ingeniería de sonido y mejor diseño de empaque, reconocimientos no para la cantante sino para los ingenieros, mezcladores y directores de arte que trabajaron en el proyecto.

Residente extendió el récord de victorias a 25 Latin Grammy al ganar el premio al mejor video versión corta por "Banana Papaya" con Kany García, quien además obtuvo el premio al mejor álbum cantautor por "Contra el

viento".

"Esto va para la igualdad de género, los derechos deben ser iguales para toda las razas y todas las preferencias sexuales", dijo Residente al aceptar el premio con García. "Lo quiero dedicar también a toda la gente que se está manifestando en Latinoamérica, que sigan luchando por sus derechos, es fundamental. "Como arreglista, productor, esto es lo más grande que he podido recibir en mi vida, de verdad", dijo Succar, quien es peruano. "Esto se lo dedico a todos, a cada uno de nosotros que estamos aquí luchando por nuestra música y por la música latina, porque todos nosotros estamos conectados con las raíces".

También ganaron trofeos, entre otros, Mon Laferte, Fonseca, Pedro Capó y Farruko.

Entre otros números musicales, Vicente Fernández, Alejandro Fernández y Alex Fernández, tres generaciones de una misma familia de intérpretes mexicanos, compartieron por primera vez un mismo escenario en uno de los momentos más aplaudidos.

"Sabén perfectamente bien que en estos eventos tenemos el tiempo bien medido", dijo Vicente Fernández mientras el público clamaba "¡Otra!". "Me faltaron como 50 canciones pero ni modo, se las debo para la siguiente".



## **Seeds of Literacy receives \$5,000 Grant from the CareSource Foundation**

CLEVELAND, Nov. 14, 2019: *Seeds of Literacy*, an award-winning adult literacy organization offering free one-to-one GED and high school equivalency tutoring for adults in Northeast Ohio, was awarded a \$5,000 grant from the *CareSource Foundation*, which will be used to aid and potentially expand *Seeds of Literacy's* programming for its students.

Recently, *Seeds* expanded its services to include offering its tutoring program in Spanish to better serve the large Latino population in Cleveland, as well as an early reader program to provide tutoring to students below an eighth grade reading level, most of who would not be accepted at traditional GED classes.

"Nearly 66% of adults in Cleveland are considered functionally illiterate, making everyday tasks such as understanding a bus route, reading the instructions on a medicine label or applying for a job online challenging, if not impossible. This generous grant from the *CareSource Foundation* will allow *Seeds* to continue to provide the exemplary programming our students have come to expect and rely upon while expanding our efforts in other areas, such as our GED tutoring in Spanish. *Seeds of Literacy* will continue to work to change the literacy rates in Cleveland, one student at a time."

## **Cuyahoga Arts & Culture announces \$11.8 Million in Grants to 277 Nonprofits to support Arts & Cultural Experiences in 2020**

CLEVELAND, November 13, 2019:

*Cuyahoga Arts & Culture (CAC)* will invest \$11,800,898 in 277 *Cuyahoga County nonprofit organizations* in 2020 through its General Operating Support and Project Support grant programs. CAC is one of the largest local public funders of arts and culture in the nation, granting more than \$193 million to more than 420 organizations since 2007.

All grants were approved by CAC's Board of Trustees during a public meeting on Wednesday, November 13<sup>th</sup> at the Children's Museum of Cleveland, a General Operating Support grant recipient. CAC's four board members voted to approve the grants, which were reviewed and scored by a diverse panel of arts and cultural experts in late September.

"Cuyahoga Arts & Culture could not be more excited to support these arts and culture organizations which demonstrate such a strong commitment to strengthening our county through their work," said *Charna E. Sherman*, president of CAC's Board of Trustees. "These organizations touch our residents in every corner of Cuyahoga County. We are grateful to our taxpayers for their belief the arts matter and their support of hundreds of local arts and culture organizations. We continue to be a shining ex-

ample to the rest of the nation."

CAC's General Operating Support program provides unrestricted, multi-year support grants to arts and cultural organizations based in and serving Cuyahoga County. Grants range from \$13,000 to \$1.1 million and support nonprofits that have a primary mission to provide arts or cultural services for the public. CAC granted a total of \$10.2 million to 65 organizations through the General Operating Support grant program for 2020. This year, Art Therapy Studio, Dunham Tavern Museum, Ensemble Theater, and Ingenuity join CAC's largest funding program.

The Project Support grant program promotes and encourages the breadth of arts and cultural programming in our community by funding projects of all sizes in Cuyahoga County. Grants range from \$1,000 to \$25,000 and support a variety of programs and events. CAC granted a total of \$1,600,898 in Project Support for 2020 to 212 organizations.

## Oregon's chief justice bars ICE from courthouse arrests

SALEM, Ore., Nov. 14, 2019 (AP): Seeking to halt federal agents from arresting people in courthouses for immigration violations, Oregon's Supreme Court chief justice on Thursday prohibited civil arrests in state courthouses unless the arresting agency has a judicial arrest warrant.

This sets up a potential conflict with federal agents. *U.S. Immigration & Customs Enforcement [ICE]* will continue its mission and anyone who obstructs it could be charged with crimes, ICE spokeswoman *Tanya Roman* said from Seattle.

Activists for immigrants have complained about increased enforcement activity around courthouses and other places under the Trump administration. ICE agents have been detaining people who appear for court proceedings and are suspected of being in the United States without documentation. In one incident, agents pepper-sprayed family members of a person they were trying to arrest in a courthouse in Astoria, Oregon.

"The courthouse rule stops these frightening practices and ensures that ev-

eryone can seek justice in our courts," said Katherine McDowell, attorney and board member of the *ACLU of Oregon*.

Judges on the Uniform Trial Court Rules Committee asked Chief Justice Martha Walters on Oct. 18 to impose the rule, saying immigrants, even legal residents, are afraid to go to court because of fear they will be detained.

Walters said arrests in courthouses have interfered with judicial proceedings and removed criminal defendants before they have been sentenced or completed their sentences.

She said the new rule was adopted "not to advance or oppose any political or policy agenda."

But Roman said ICE agents are forced to go to courthouses to make arrests because of "local policies that prevent law enforcement from cooperating with ICE."

"ICE will continue to carry out its mission to uphold public safety and enforce immigration law, and consider carefully whether to refer those who obstruct our lawful enforcement efforts for criminal prosecution," Roman said. Asked if that means ICE agents will continue to attempt courthouse arrests in Oregon, Attorney General Ellen Rosenblum said,

Some of the judges on the rules committee have worried the rule could cause an armed confrontation between county sheriff's deputies who provide court security and federal agents.

"I don't know how we would handle that situation, honestly," Judge Lung Hung of Malheur County Circuit Court said at last month's rules committee meeting. "It's the enforcement that concerns me."

Leland Baxter-Neal, a staff attorney with the *ACLU of Oregon*, told the committee that in jurisdictions that have adopted similar rules, ICE has respected them, and that he expected they would also be respected in Oregon.

"Thanks to this new rule, Oregon will be a safer and more welcoming place for all," Oregon Attorney General Ellen Rosenblum said.

## Doctores: Mundo más caliente es insalubre para los niños

WASHINGTON, DC, 13 XI 19 (AP): Los niños están creciendo en un mundo más caliente que los afectará con más y diversos problemas de salud en comparación con los que experimentaron sus padres, dijeron médicos en un informe internacional publicado el miércoles.

Con un aumento de enfermedades diarreicas, más ondas de calor, contaminación del aire y un incremento de las enfermedades transmitidas por mosquitos, como el dengue y la malaria, el calentamiento global causado por el hombre ya está perjudicando la salud pública en el mundo, de acuerdo con el informe anual sobre cambio climático y salud publicado por la revista médica *The Lancet*.

Pero los autores se manifestaron preocupados de que la salud futura de las personas más jóvenes del orbe será incluso peor si no se reducen las emisiones de gases de efecto invernadero.

"Los niños nacidos hoy estarán cada vez más expuestos a lo largo de su vida a más efectos nocivos de los que yo experimenté", dijo la coautora del estudio, la

doctora *Renee Salas*, médica de emergencias en Boston y profesora en Harvard.

"No puedo imaginar una mayor emergencia de salud", afirmó.

De hecho, el número de días con condiciones propicias para la propagación de bacterias del género *Vibrio* causante de diarreas debilitantes se han duplicado desde 1980, y el año pasado fue el segundo período más largo en la historia, según el reporte. Debido al calentamiento global, 29% más de costas estadounidenses son vulnerables al *Vibrio*. Las bacterias *Vibrio* del cólera se han incrementado casi 10%.

Nueve de los 10 años con las condiciones más propicias para la transmisión del dengue han ocurrido desde el 2000, de acuerdo con el informe.

Estas enfermedades atacan más a los niños, según el informe. Y los niños, los ancianos, los pobres y los enfermos son las principales víctimas de peligrosos golpes de calor, males respiratorios y problemas renales.

"Los niños son los más vulnerables. Habrán de soportar la vasta mayoría de los efectos del cambio

climático", dijo el doctor australiano Nick Watts, médico de emergencias y principal autor del informe mundial.

"El cambio climático repercutirá en su salud de una manera profunda y distinta".

Aunque la medicina y la salud pública han mejorado al paso de las décadas, permitiendo a la gente aumentar su longevidad, el cambio climático "amenaza con socavar todos los avances que hemos tenido", afirmó Salas.

La doctora *Cindy Parker*, profesora de salud ambiental de la Universidad Johns Hopkins, elogió el informe, del cual no fue parte, pero se dijo preocupada de que centrarse en las actuales secuelas de salud atenta urgencia al futuro.

"El cambio climático es un amplificador de riesgos", declaró Parker en un correo electrónico.

## Interim Director John Stanley to give free lecture at Toledo Museum of Art

**TOLEDO:** *John Stanley*, the Toledo Museum of Art's interim executive director and former chief operating officer (COO) for the Whitney Museum of American Art, will share an insider look and reveal the history of a decade's long effort to expand the Whitney's New York City Upper East Side Marcel Breuer-designed building during a free lecture Thursday, Dec. 5, 2019, at 7 p.m. in the Little Theatre.

Stanley will explain how after many failed attempts the process led to relocating the museum

Before rejoining TMA as director of special projects in March 2019, he served as the COO for the Whitney Museum of American Art in New York City.

A graduate of the University of Toledo, Stanley earned his MBA from Bowling Green State University and attended the Museum Management Institute at the University of California at Berkeley.

## Carli Lloyd scores twice, US holds off Sweden 3-2

COLUMBUS, Ohio, Nov. 7, 2019 (AP): New coach. Same result.

**Carli Lloyd** scored twice, *Christen Press* added a goal and the United States held off Sweden 3-2 on Thursday night at Mapfre Stadium, giving *Vlatko Andonovski* a victory in his first match as head coach.

The U.S. is 19-1-3 in 2019 and has a 22-match unbeaten streak.

The U.S. dominated early in the friendly, as Lloyd took a pass in the third minute from *Christen Press* with a right-footed shot from the center of the box and put it past goalkeeper Hedvig Lindahl to the bottom right corner.

Press followed in the 28th minute, faking out a pair of defenders with fancy footwork and burying a ball from Lindsey Horan for her 50th goal in international competition. Press is just the 11th American to reach that milestone.

"We knew what we wanted to do, and I think we did a good job controlling the game defensively," Andonovski said. "The only thing I thought we could do better, and we did it in the second half, is push the block a little bit higher from the middle to the high block. We were successful when we did that. Obviously, it will just take a little bit of time to adjust the timing, the angle and the approach to all the players."

Three minutes later, Lloyd found the back of the net again with a right-footed shot just inside the box, off a chip pass from Tobin Heath.

Lloyd, who has 22 multi-goal games, has 120 international goals and leads the U.S. in scoring this year with 15.

coach after the retirement of *Jill Ellis*, whose 106 victories made her the winningest coach in U.S. women's soccer history and the first international coach to win two Women's World Cup titles.

A native of Macedonia, Andonovski played in Europe before an indoor soccer career in the United States. He coached in the National Women's Soccer League for the past seven seasons, with FC Kansas City and Reign FC of Washington State.

Lloyd said she has already come to respect his coaching style.

"I think he's simple and effective," she said. "His training sessions are short, concise and to the point. You know the message. I think it's the belief in players and the confidence that he has in players that you fed off of."

"I've heard so many good things about him from so many different players, and now I know why. It's just an aura that he has about him. He's calm and collected. He makes this team better."

Andonovski certainly appeared calm after the win but admitted the first victory at the U.S. helm was "exciting," even as he focuses on areas that need improvement.

"I was excited for the team and they were excited for me," he said. "We have to fix the two goals. People who know me know I'm not happy when I get scored on. We have to finish strong."

The U.S. played without some of its most high-profile players, including *Megan Rapinoe* and *Alex Morgan*.

Next up for the United States is *Costa Rica* on Nov. 10 at TIAA Bank Field in Jacksonville, Florida.

## New athletic field dedicated at Danny Thomas Park

For more than two decades, leaders, coaches, and youth have made due with what they had available for sports programs in the Old South End. But on Wednesday, Nov. 13, 2019, those games changed significantly for the better, as local officials dedicated a new youth development complex at *Danny Thomas Park*, 2151 Broadway Street, Toledo.

The park is named after a Lebanese-American comedian, actor, entertainer, and humanitarian, who graduated from *Woodward High School* and attended the *University of Toledo*.

The multi-partner *Rick and Nancy Corbett Athletic Complex* presented by *Group1001* features a 75,000-square-foot multisport synthetic turf field that will be used for football, soccer, and baseball/softball and provide local youth with a safe outdoor place to play. There are future plans to improve the basketball courts and other sections of the park. Toledo Mayor *Wade Kapszukiewicz* called it a "world class sports facility."

"I cried, because after 27 years of being on that field and actually cutting the grass and pulling the weeds, I won't have to do that anymore. It's turf," said *Tonya Durán*, long-time baseball coach and *Believe Center* executive director. "I was excited."

The *Believe Center* currently has 131 kids in its baseball and soccer programs. But poor weather and snow on the ground forced cancellation of a soccer skills demonstra-

tion and scrimmage that was scheduled as part of the dedication ceremony. "They're the ones who are going to benefit from it," said Ms. Durán. "They're really excited about playing on that field. It's going to get a lot more use because it's safer grounds now. We won't have to worry about the potholes in the infield. We won't have to worry about trees or limbs falling down. It also brings pride back into the (Old) South End because the city did something like that in the South End."

At the noontime dedication ceremony on Nov. 13, where major-league baseball *Hall of Famer Cal Ripken, Jr.* celebrated the new field with Mayor Kapszukiewicz, former state senator *Randy Gardner* and other community members attended. But they remained quietly in the background, silently reflecting on what the day meant long-term.

"Sometimes those with deep pockets get the most recognition. That's okay, because it's got to come from somewhere," said *Ms. Sabina Elizondo-Serratos*, executive director of *Adelante, Inc.* "But there are also people behind the scenes who make stuff happen. Tonya Durán was one of those. This has been a long, long day in the making. She stayed focused [on the bigger picture]."

"I believed, is what I did. I believed, that as coaches, we made a difference in these kids' lives," said Ms. Durán. "There are players who have come back and are

coaching for me now. They're giving back. I was at (a recent event) and someone came up to me and asked if I remembered him. He told me I was the best coach he ever had—and I just cried."

The complex is designed for multisport play, including dugouts, a backstop, digital scoreboard, bleachers, foul poles, soccer goals and field lighting.

According to a press release, the facility will serve as the central location for programming offered by the *YMCA of Greater Toledo* and *The Believe Center*, "directly supporting thousands of at-risk youth who are exposed to high-risk factors, such as above-average crime rates, families living below the poverty line, and a high number of children being raised in single-parent homes." The athletic complex is the first and only one of its kind in Ohio, according to the *Cal Ripken, Sr. Foundation*.

Afterschool programming, such as organized team sports, also will be a part of the equation. Such organized activities serve as a powerful alternative during widely unsupervised time between 3 and 6 p.m. Research suggests 29 percent of all violent crime committed by juvenile offenders occurs during those hours.

The *Historic South Initiative* became one of the driving forces behind the project, bringing in some heavy hitters behind the scenes to provide funding, including the *Cal Ripken, Sr. Foundation*; St. John's Jesuit High School alumni, including *Rick Corbett*, for whom the ath-

letic complex is named, the city of Toledo, and state government through a capital improvement budget grant.

Other funders included: *Group1001*, the *Andersons Fund Supporting Organization*, *Owens Corning*, *Owens-Illinois (O-I)*, *ProMedica* and *KeyBank*. The *Ripken Foundation* has completed 90 multipurpose synthetic turf facilities in 23 states and Washington D.C.

The *Believe Center* director is among those who secured a \$200,000 grant from state lawmakers to help fund the project. She recalled she didn't know what to say during an interview in Columbus when the funds were at stake. But she was blunt and direct with state senators and representatives who would make those capital funding decisions.

"I told them, 'You took Libbey [High School] away. You took Newbury [elementary school] away. You took Westfield [elementary] away. And you took Jones [junior high school] away. Now you're taking Marshall [elementary] away be-



cause it's becoming a STEM (academy). What do our kids have?' It's not fair," she recalled. "I've realized that the words we use and the questions we ask are powerful. That's what I

teach my kids now."

But *Tonya Durán* also showed her student-athletes firsthand what can happen if you use powerful words and ask the right questions to achieve good in the community.




