### Rep. Ramos urges Congress to respect Puerto Rican "Call for Statehood"

On Nov. 6, 2012, voters in the Commonwealth of Puerto Rico voted by a 54% to 46% margin that they were no longer satisfied with their current status as a U.S. commonwealth. In a separate question, 61% of Puerto Rican voters chose statehood as the best alternative for governance of the island.

This marks the first time in the Commonwealth's history that voters have chosen statehood as a desired outcome in their relationship with the United States. Previous referendums were defeated in 1967, 1993, and 1998.

State Representative **Dan Ramos** (D-Lorain), Ohio's only legislator of Puerto Rican descent, has introduced a House Concurrent Resolution to ask Congress to take action that respects the will of U.S. Citizens in Puerto Rico, and takes steps toward admitting the Commonwealth of Puerto Rico to the Union as a state.

"As laid out in the Declaration of Independence, our country recognizes that government derives its power from the consent of the governed," said Rep. Ramos. "The people of Puerto Rico voted to change that, and that should be respected."

Puerto Rico has been governed by the United States of America since 1898. The territory's people were extended US-American citizenship on March 2, 1917 as part of the Jones-Shafroth Act under President Woodrow Wilson.

"Following the results of the November election I believe it is necessary that Congress take swift action and recognize the will of the United States citizens living in Puerto Rico," Rep. Ramos added.

"For nearly a century, these citizens have served in the branches of our armed forces defending our freedom. Now, through their vote, they have asked for statehood, with all of the rights and responsibilities this brings. Using the guidance of our forefathers, it is the duty of Congress to respect the call of U.S. Citizens for Statehood, as they have done since the 18<sup>th</sup> Century. This resolution asks Congress to do exactly that."

## Illinois officials push for undocumented immigrant licenses

CHICAGO, Nov. 20, 2012 (AP): Illinois could become the third state in the U.S. to grant driver's licenses to undocumented immigrants—a move top officials from both parties are pushing as a way to make roads safer and one that could have political implications for lawmakers seeking to court Hispanic voters.

Illinois Senate President John Cullerton said Tuesday that he believes he has the votes to get the measure through his chamber next week. Gov. Pat Quinn said he will sign it if it passes the House and makes it to his desk.

New Mexico and Washington are the only states in the U.S. to give driver's licenses to undocumented immigrants.

Quinn and Cullerton, both Democrats, were joined at a news conference by several key Illinois officials, including former Gov. Jim Edgar and Comptroller Judy Baar Topinka, both Republicans, and Chicago Mayor Rahm Emanuel, a fellow Democrat. All predicted bipartisan support.

The turnout showed the growing importance of Latinos and other immigrant groups. The bloc is credited with helping Democrats win big in Illinois and across the country on Election Day, and several top Republicans have said the GOP needs to change a perception their party is anti-immigrant if it is going to pick up seats in the next election.

Supporters of the measure say Illinois has about 250,000 undocumented immigrant motorists who can't get a driver's license or insurance. Allowing undocumented immigrants to obtain a license would mean more of those drivers would have to pass road and written driving tests and vision tests, supporters say. Also, uninsured, unlicensed immigrant drivers are responsible for \$64 million in insurance claims each year—costs that are picked up by people with insurance.

"By passing this legislation, this is going to incredibly benefit all of us," Cullerton said.

Quinn called the bill "the continuation of a movement" to support immigrants in Illinois that also has included passing the DREAM Act, which made college more affordable for undocumented immigrants.

Democrats proposed a similar bill in 2007 that passed the House but didn't get to a vote in the Senate. Although Democrats control the House and the Senate in Illinois, they don't all always vote together and measures generally need some GOP support to get through the General Assembly.

Edgar said he has been talking with Republican lawmakers and he expects more of them to support the legislation this time around.

"I think Republicans now realize we need to change our

image if we want to be a successful and a viable party in America," Edgar said. "It's important that we show these immigrants that we appreciate them being here, we appreciate what they contribute to our society and that we want to make it easier to contribute."

Lawrence Benito, chief executive officer for the Illinois Coalition for Immigrant and Refugee Rights, said he believes the Nov. 6 election was a factor in the decision to introduce the bill next week, though it's "first and foremost" about safety.

"We're doing this for good public policy reasons. If there are good political reasons as well, that's great," Benito said.

Republican leaders of the House and Senate were notably absent from Tuesday's news conference.

However, Senate Republican Leader Christine Radogno said that was because she had a scheduling conflict. She said she supported the 2007 measure but wanted to wait to see the new proposal before backing it.

Vicki Crawford, spokeswoman for House Minority Leader Tom Cross, said she had not yet spoken with Cross about the bill.

Benito said supporters will be talking to Cross once the final bill is drafted.

The General Assembly will meet Tuesday for the start of the postelection veto session. The session concludes Jan. 9.

## 49 millones de latinoamericanos con hambre

SANTIAGO, 22 de nov. del 2012 (AP): Cuarenta y nueve millones de personas padecen hambre en América Latina y el Caribe, pero no por falta de alimentos sino porque carecen de dinero para comprarlos, dijo el jueves un informe de la Organización de las Naciones Unidas para la Alimentación y la Agricultura (FAO).

Los países con mayor hambruna son Haití, con una prevalencia del 44.5%; Guatemala, con 30.4; Paraguay, 25.5%; Bolivia, 24.1% y Nicaragua, 20.1%. Los únicos países que han erradicado el hambre son Chile, Cuba, Uruguay y Venezuela, según el informe. El estado de la inseguridad alimentaria en el mundo 2012, presentado en Santiago por el oficial jefe regional de la FAO, Adoniram Sánchez.

El crecimiento

económico en los 33 países de la región no ha reducido la vulnerabilidad que afecta a una parte importante de la población latinoamericana, que incluye a 174 millones de pobres, según la Comisión Económica para América Latina y el Caribe, Cepal.

La FAO recordó que América Latina registró entre el 2011 y este año tasas de crecimiento superiores a las de la Unión Europea y Estados Unidos, cuando se registró un alza en los precios de los alimentos y materias primas.

"No obstante, América Latina y el Caribe aún muestra niveles de desigualdad muy altos en relación con otras regiones del mundo", según el documento.

Sólo nueve de los 33 países de la región tienen una tasa de prevalencia del hambre menor al 5% y en 16 naciones la tasa supera el 10%.

Según la FAO, en los últimos seis años, apenas un millón de

personas dejó de padecer hambre. La cifra se eleva a 16 millones de latinoamericanos que ya no pasan hambre si la actual situación se compara con la de los años 1990-1992, cuando había 65 millones de hambrientos.

El documento también abordó el problema de la obesidad. Preciso que en 2010 el sobrepeso y la obesidad en menores de 5 años afectaba a más de dos millones de niños en Sudamérica, un millón en Centro América y unos 300,000 en el Caribe.

Otra cara de la seguridad alimentaria es el sobrepeso, según FAO, que afirmó que en la mayor parte de los países la obesidad adulta sobrepasa el 20%, y que es bastante superior en México, donde abarca a un 33%; luego vienen Venezuela, con 31%; Argentina y Chile con 29%. El récord lo ostenta San Cristóbal y Nieves, con 40,9%.



## 10 foreign-born soldiers become US citizens

FORTHOOD, Texas, Nov. 24, 2012 (AP): *Pantaleon Montes* became a US-American the hard way—during his past 11 years in the US Army, the infantry staff sergeant has deployed to Iraq and Afghanistan. He faced combat in both countries.

Montes, a native of Mexico, became an US citizen during a naturalization ceremony inside III Corps Headquarters at Fort Hood earlier this month.

"It's like being a new person," said Montes, who submitted his application to become an American citizen four years ago.

Nine others soldiers became

citizens during the event, the first naturalization ceremony at Fort Hood since 2009.

The 10 soldiers, ranging in rank from private first class to staff sergeant, come from all over the world: *Cuba, Fiji, Italy, Kenya, Mexico, Micronesia, and South Africa.*

Nearly 200 fellow soldiers, including III Corps and Fort Hood commander Lt. Gen. Donald M. Campbell Jr., and family members watched the soldiers take the oath of allegiance.

Less than 1 percent of US citizens are in the military, Campbell said. "So just by serving, they have done more than most citizens will ever do."

The three-star general said all 10 of the soldiers are combat veterans. The US Army allows citizens of different countries to join the US Army as long as they possess a permanent resident visa, also known as a green card.

The ceremony included a congratulatory video from President Barack Obama and a music video featuring patriotic scenes and the song "God Bless the USA" by Lee Greenwood.

Officials from the San Antonio branch of the United States Citizens and Immigration Service orchestrated the ceremony, and along with Campbell, passed out official documents of citizenship to each soldier.

The soldiers have already

given much and "America hopes you will continue to give," said *Andrea Quarantillo*, acting regional director for the U.S. Citizens and Immigration Service.

For Staff Sgt. *Rodney Edwin*, 42, a trooper with the 1st Cavalry Division, becoming a U.S. citizen was more than just a goal he set for himself.

"When you have a wife and children, it's no longer about you," said Edwin, a Micronesia native who has been in the US Army 15 years.

His wife, Lani Edwin, and two of their four children were on hand for the ceremony.

"He's worked hard for it," Lani Edwin said.

## Republicans say party needs to get with the times

WASHINGTON, DC, Nov. 17, 2012 (AP): To hear some Republicans tell it, their party needs to get with the times.

Some of the early prescriptions offered by officials and operatives to rebuild after a devastating loss: retool the party message to appeal to Latinos, women and working-class people; upgrade antiquated get-out-the-vote systems with the latest technology; teach candidates how to handle the new media landscape.

From longtime Republican luminaries to the party's rising stars, almost everyone asked about the Republicans' Nov. 6, 2012 election drubbing seems to agree that a wholesale update is necessary for a party that appears to be running years behind Democrats in adapting to rapidly changing campaigns and an evolving electorate.

Interviews with more than a dozen Republicans at all levels of the party indicated that post-election soul-searching must quickly turn into a period of action.

"We've got to have a very brutally honest review from stem to stern of what we did and what we didn't do, and what worked and what failed," said former Mississippi Gov. *Haley Barbour*, who ran the party in the 1990s.

The party "has to modernize in a whole wide range of ways," added former House Speaker *Newt Gingrich*, who ran against White House nominee *Mitt Romney* in the 2012 presidential primary. "We were clearly wrong on a whole range of fronts."

To determine what went wrong, the Republican National Committee is examining every detail of the 2012 elections, with the goal of rebuilding the party for the future — much as the Democratic Party did in the 1980s after suffering a series of stinging losses at all levels of government.

Now, as was the case back then, the stakes are enormous for the party that failed to win the White House and has lost the popular vote for several national elections in a row. They're perhaps even higher for Republicans grappling for ways to court a rapidly changing electorate whose voting groups don't naturally gravitate toward the Republican Party. The dangers of failing to act could be severe: permanent minority status.

So it's little surprise that, after the election, some Republicans were quick to sound stark warnings.

The scale of the losses largely shocked a party whose top-shelf operatives went into Election Day believing Republicans had at least a decent chance of capturing the White House and gaining ground in Congress, where Republicans controlled the House of Representatives and had a sizable minority in the Senate.

Instead, Romney lost all but one of the nine contested battleground states, North Carolina, to President Barack Obama. Republicans also lost ground to Democrats in both houses of Congress, though

Republicans retained their House majority.

How to move forward dominated the discussions at last week's Republican Governors Association meeting in Las Vegas, where some of the party's leading voices castigated Romney's assessment — made in what was supposed to be a private telephone call to donors — that Obama won re-election because of the "gifts" the president had provided to blacks, Hispanics and young voters. These governors faulted Romney.

Louisiana Gov. *Bobby Jindal* attributed Romney's loss to a lack of "a specific vision that connected with the American people."

Massachusetts Sen. *Scott Brown*, who describes himself as a "pro-choice moderate Republican," echoed Republicans across the spectrum when he said last week: "We need to be a larger-ten party."

Brown lost his Senate seat to Democrat *Elizabeth Warren*. Across the board, Republicans say that arguably the most urgent task facing the party is changing its attitude about immigration as it looks to woo Hispanics. This rapidly growing group voted overwhelmingly for Obama, by margins of 7-to-1 over Romney, who had shifted to the right on the issue during the Republican primary campaign.

It didn't take long after the election for even staunch conservatives to start changing their tune on immigration. Days after the election, even conservative TV and radio host *Sean Hannity* said he would support an immigration reform bill.

Said *Barbour*: "If we would be for good economic policy in terms of immigration, that would go a long way toward solving the political problem."

It's not just Hispanics. Republicans said they also have work to do with single women and younger voters, many of whom tend to be more liberal on social issues than the current Republican Party. These Republicans said a change in tone is needed, though not a change in principles such as opposition to abortion.

"We need to make sure that we're not perceived as intolerant," said *Ron Kaufman*, a veteran Republican strategist who advised Romney's campaign. "The bottom line is we were perceived to be intolerant on some issues. And tone-deaf on others."

Republicans also said the party has to work on its relationship with working-class voters.

"Republicans have to start understanding that small business and entrepreneurs are important, but the people who work for them are also important," said Rep. *Charles Bass* of New Hampshire, who lost his seat to Democrat *Ann Kuster*. "We've got to be compassionate conservatives."

Republican leaders also said their party needs to change how it communicates its message. Obama's campaign, they said, (Continued on Page 10)

## "El Santos vs La Tetona" se presenta en México

20 de noviembre del 2012 (AP): "¿Y cómo es la voz de El Santos?", preguntó el actor *Daniel Giménez Cacho* a los caricaturistas *José Trinidad Camacho* y *José Ignacio Solórzano*, conocidos como *Trino* y *Jis*, cuando éstos le pidieron su voz para el proyecto que llevaría a su famoso personaje animado del papel a la gran pantalla.

"Tendrá la voz que tenga que tener", respondieron sus creadores, llevando al actor de la risa al pánico.

*Giménez Cacho* supo que tenía en sus manos una gran responsabilidad cuando asumió el reto de dar vida al mítico personaje de *El Santos*, una tira cómica que encantó a toda una generación en México por el modo desinhibido en que hablaba de sexo, política y drogas a finales de la década de 1980.

"Empezamos a jugar como

si fuera una radionovela, a actuar las situaciones entre todos, lo cual hizo de éste un proceso creativo y divertido", dijo el actor el martes durante la presentación de la película "El Santos vs La Tetona Mendoza" en la Ciudad de México.

"Tratar de retratar con tu voz una tira cómica que nos cautivó por su humor y su crítica me provocaba tensión. Era llevar a otro nivel aquella liberación que experimentamos con esta comedia inteligente y muy irreverente", añadió. "Estoy muy contento con los resultados".

Publicada en sus inicios en el periódico mexicano *La Jornada*, la tira creada por *Jis* y *Trino* narra las aventuras de un peculiar enmascarado de lucha libre que enfrenta a su enemigo el *Peyote Asesino*, llamado como la planta de origen mexicano que produce una droga alucinógena, y el amor de este anti-héroe por la *Tetona Mendoza*, un exuberante

rubia semidesnuda que gusta de mostrar sus senos firmes.

"El Santos se sale mucho del rigor de la animación tradicional. Estos dibujos son muy artesanales, incluso el color se sale de la figura, como si los espectadores apreciaran a los personajes impresos sobre el papel del periódico", dijo *Trino*.

### DPS' Bates, Cass Tech, Chrysler, Harms, Kettering West Wing and Ludington Magnet – among the Michigan Department of Education's "Beating the Odds" Schools added to the List of Reward Schools for 2011-2012

MDE released this year's list of "Beating the Odds" (BTO) schools for 2011-12 on Tuesday, November 20, 2012. According to MDE, based on traditional risk factors to student achievement, BTO schools either outperform their expected ranking or outperform similarly-situated schools.

What's really exciting is that these schools will also now be deemed Reward Schools as well!

In August 2012, 286 schools in Michigan were recognized as Reward Schools for high-performance or high progress in terms of student achievement.

According to Tuesday's announcement by MDE, the Reward School designation is part of Michigan's comprehensive, new accountability system authorized by the Elementary and Secondary Education Act (ESEA) Flexibility Request approved by the U.S. Department of Education. In addition to being publicly recognized for their achievement, Reward Schools will have opportunities to highlight their promising practices at state and local events for educators and the Michigan Department of Education is seeking other supports for Reward Schools such as increased flexibility in the use

of federal funds and corporate or philanthropic support.

The Michigan Department of Education surveyed all BTO schools regarding which factors contributing to their success. Top factors were:

- Highly effective and committed school staff
- A culture of high expectations for students
- Use of data to inform decisions
- Strong district and school leadership
- Implementing a system of tiered interventions
- Additional tutoring or targeted assistance for students

### Royal Oak considers ban on anti-gay discrimination

ROYAL OAK, Nov. 22, 2012 (AP): Royal Oak officials say they expect to consider extending civil rights protection in the Detroit suburb to people's sexual orientation.

The City Commission voted 7-0 Monday to support the drafting of a human rights ordinance, and Deputy City Attorney Mark Liss tells

the Detroit Free Press (<http://on.freep.com/SgOufc>) that the proposal should be before the commission before Christmas.

Voters in the northern Detroit suburb of 57,000 overwhelmingly rejected a similar ordinance in 2011.

Commissioner Jim Rasor says the ordinance will be modeled on the one in effect in Ann Arbor with the "widest

possible application."

He says the ordinance could protect gays as well as ban discrimination based on height, weight and other grounds. Neighboring Huntington Woods and Ferndale already ban anti-gay discrimination.

## Fallece Héctor "El Macho" Camacho

SAN JUAN, Puerto Rico, 24 de nov. del 2012 (AP): El boxeador Héctor "Macho" Camacho—polémico, exitoso y taquillero en los cuadriláteros pero asolado por las adicciones durante buena parte de su vida—falleció el sábado luego que los médicos lo desconectaron de un respirador del que dependía su existencia desde el martes, cuando recibió un disparo en la cabeza. Tenía 50 años.

El médico *Ernesto Torres*, director del Centro Médico de Puerto Rico, la clínica de traumatología en la que fue internado Camacho tras recibir el disparo, dijo que el púgil boricua sufrió un paro cardíaco en las primeras horas del sábado. Se le desconectó del respirador y falleció poco después.

La madre de Camacho, *María Matías*, dijo el viernes que había autorizado a los médicos a desconectar el respirador después que los tres hijos del púgil llegaron desde Estados Unidos y tuvieron la oportunidad de verlo por última vez.

"La familia está destruida", comentó el ex boxeador *Victor "Luvi" Callejas*, un amigo de Camacho que funge como vocero de la familia.

Los médicos declararon el jueves que Camacho había sufrido muerte cerebral clínica a consecuencia del disparo, en un ataque que mató también a uno de los mejores amigos del "Macho", cuando ambos estaban dentro de un automóvil en Bayamón, parte del área metropolitana de San Juan donde nació el boxeador.

"Perdí a mi hijo hace tres días, sólo está vivo por una máquina", reconoció Matías el viernes por la noche. "Mi hijo no está vivo".

Camacho fue tiroteado mientras estaba en un vehículo con su amigo de la infancia *Adrián Mojica Moreno*, quien murió en el ataque. El vocero de la policía, *Alex Díaz*, dijo que las autoridades encontraron nueve bolsas con cocaína en un bolsillo del amigo, y una décima en el automóvil.

La policía no ha realizado arrestos y sigue buscando testigos. El capitán *Rafael Rosa* le dijo a la prensa que siguen varias pistas, pero rehusó decir si hay sospechosos.

hora del Macho!), la cual gritaba con exuberante júbilo en promociones y sobre el cuadrilátero.

Juan Laporte, un ex campeón mundial peso pluma y amigo de la infancia de Camacho, lo describió como "un hermano menor que siempre se metía en problemas".

"Es un buen ser humano, una persona de buen corazón", comentó Laporte a las afueras del hospital donde falleció el púgil. "Mucha gente cree que es un tipo orgulloso, pero ese era su lema... por dentro era como un niño".

Camacho, cuyo hijo del mismo nombre también incursionó en el boxeo pero sin el mismo éxito, tuvo numerosos problemas legales y con sustancias controladas durante su carrera profesional, incluyendo el más reciente en abril de este año cuando fue detenido en Orlando por un caso de abuso de menores.

En 2007, fue sentenciado a siete años de prisión por el robo de una tienda de computadoras en Mississippi, aunque un juez le ordenó cumplir sólo un año tras las rejas y le permitió cumplir el resto de la condena en libertad condicional.

Tres años después, incursionó en la televisión, como participante del programa de concurso "Mira Quién Baila", producida por Univision. Prometió que si ganaba el primer premio, de 50.000 dólares, lo donaría a una organización puertorriqueña que ayuda a la prevención y atención de adicciones.

Finalmente, quedó eliminado en la primera ronda. Entre las personas que le sobreviven están su madre, tres hermanas, un hermano y cuatro hijos.

NUEVA YORK, 19 de nov. del 2012 (AP): Por primera vez en los 40 años de los Emmy Internacional los premios al mejor actor y la mejor actriz se los llevaron integrantes de una misma serie, y se trata de una producción argentina.

La Academia Internacional de Artes y Ciencias de Televisión anunció a los ganadores en una gala realizada el lunes por la noche en Nueva York.

Darío Grandinetti y Cristina Banegas fueron reconocidos por su actuación en "Televisión por la inclusión", un ciclo de unitarios de ficción producido por ON TV Contenidos que refleja temáticas relacionadas con la exclusión y la inclusión social. La serie comenzó a transmitirse en octubre de 2011 en el Canal 9 de la televisión argentina.

Grandinetti interpretó a Mario, un taxista divorciado con una vida difícil que no tolera a sus vecinos peruanos, y Banegas hizo el papel Paula, una madre con una hija con síndrome de Down que necesita una cirugía de corazón urgente.

Entre los créditos anteriores de Grandinetti, destaca el papel de Marco Almodóvar "Hable con

ella". El actor se midió con el británico Jason Isaacs, el noruego Stein Winge y el chino Zhu Yawen.

Banegas es una laureada actriz de teatro, cine y televisión argentinos, compitió con la británica Joanna Vanderham, la danesa Sidse Babbett Knudsen y con Rina Sa, de Hong Kong.

Por su parte la serie brasileña "A Mulher Invisível" ("The Invisible Woman"), sobre un hombre enamorado de una amante imaginaria, producida por TV Globo, se llevó el premio a la mejor comedia. El premio a la mejor telenovela también recayó en TV Globo por "O Astro" ("The Illusionist"); la historia de un ladrón que aprende magia tras las rejas.

"Celebramos a los ganadores de esta noche por sus extraordinarios logros hoy que entran en la historia del Emmy", dijo en un comunicado el presidente de la academia Bruce L. Paisner a propósito del 40 aniversario de los premios.

Francia ganó el galardón a la mejor serie de drama por la segunda temporada de "Braquo", la historia del policía Eddie Caplan, quien en esta temporada termina siendo acusado de cometer crímenes.

El filme "Terry Pratchett: Choosing to Die" de Gran

Bretaña, sobre el escritor Sir Terry Pratchett y su acercamiento a la eutanasia, tras conocer que padece Alzheimer, se llevó el premio al mejor documental.

El programa australiano "The Amazing Race Australia" y la miniserie británica "Black Mirror" fueron otras de las producciones ganadoras.

El premio internacional de la junta directiva de los Emmy fue para el doctor Kim In-Kyu, presidente y director general de Korean Broadcasting System, y presidente de Asia-Pacific Broadcasting Union, quien lo recibió tras un discurso del secretario general de la ONU Ban Ki-Moon.

Un total de 40 nominados de 15 países compitieron por el Emmy Internacional, que honra la excelencia en la programación televisiva fuera de Estados Unidos.

## Rock 'n' roll star now lives quiet Ariz. life

CASA GRANDE, Ariz., Nov. 17, 2012 (AP): These days, he's Richard Vaculig. Retiree, homeowner, Casa Grande resident for five years.

But a display of mementos from his rock 'n' roll band can be found in a bay at the Rock and Roll Hall of Fame and Museum in Cleveland. Back in the 1950s, he was Ricky Vac, rock 'n' roll band founder and lead singer.

"We started the band in 1955 and completed it in 1956 while I was still in high school," Vaculig said of Ricky Vac & The Rock-A-Ways.

That was in Berea, Ohio, a Cleveland suburb. Local disc jockey Alan Freed had just popularized the term rock 'n' roll to describe a new style of music most experts agree began with the song "Rock Around the Clock" by Bill Haley & The Comets. It was featured in the 1955 movie "Blackboard Jungle," and young Richard Vaculig was entranced while watching the movie at a drive-in theater. As artists like Elvis Presley, Little Richard and Jerry Lee Lewis helped popularize the new musical genre, Vaculig was quietly putting together a band to perform the exciting new style of music.

"When I was in high school, I didn't tell anybody I had the band," he said last week, explaining that he didn't want classmates to think he was bragging or stuck up. "We played everywhere but around where I went to school."

So he was mild-mannered Richard Vaculig by day, and rock 'n' roll singer Ricky Vac by night. The band found re-

gional success quickly, writing and playing their own songs in addition to covering popular songs. Ricky teamed with piano player Paul Ticherich to write perhaps the band's most successful song, "Colleen," about a girl they knew who occasionally sang with the band. Guitarist Jimmy Harris composed an instrumental, "Rock-A-Way Boogie," that became the band's theme song.

"Colleen" was enough of a hit that it landed the band on Danny Thomas' muscular dystrophy telethon on TV, where they sang it for a national audience. It was recorded on the Hill-Top record label, a subsidiary of DOT Records.

The band played at countless sock hops and theaters and on radio and TV, becoming a favorite on "KYW Traveling Radio Showcase" and WHK's "Teen Town."

There were some places they couldn't play, however.

"We couldn't play night clubs because none of us were legal age," Vaculig said. "Our youngest guitar player was only 13."

Possibly the nation's first band assembled solely to play rock 'n' roll, Ricky Vac & the Rock-A-Ways also may have been the first integrated band. One of its guitarists, Jimmy Harris, was black. Despite the turbulent times in race relations, it was never an issue for the Rock-A-Ways.

"We never had any problems," Vaculig said, regardless of the venue.

The band was playing to sell-out crowds by the end of 1961 and national recognition seemed inevitable. But

two band members left in a short time, then Vaculig was drafted into the Army and the Rock-A-Ways disbanded.

After a two-year stint in the Army, Vaculig tried his hand at a solo career. He was good enough to be backed by some of the best musicians of that time, including pianist Floyd Cramer, Buddy Harmon, Bill Black, Scotty Moore from Elvis Presley's band and the already famous Jordanaires.

But by then the British Invasion had begun as the Beatles and other bands arrived with a new style of pop music that quickly supplanted early rock 'n' roll.

"The music had really changed," he said.

Seeing the writing on the wall, Vaculig took a friend's suggestion and in 1965 began his own entertainment agency, representing other performers. King Vac Productions eventually booked some of rock's all-stars including the Platters and Coasters, Ricky Nelson, the Kingsmen, Pat Boone, the Flamingos and even Tiny Tim. He moved the agency to suburban Seattle in 1969 and remained there until five years ago, when he sold the agency to his partner and eventually settled in Casa Grande. He said much credit for his success goes to Jim Jaworski, his longtime manager.

"We went to California first because everybody always wanted to go to California" dating back to his high school days, Vaculig said of his retirement. "But it was so many people, and we went back home. A friend suggested Ari



 zona, so we came here on vacation. We rented a place for a few months and traveled all over the state."  
 Driving down Interstate 10 one day, Vaculig and his wife were intrigued by the name Casa Grande and got off the freeway to drive through the town. It was love at first sight.  
 "We liked the city," he said. "It's so clean, and everything is so close. We even liked the desert. We were tired of all the rain and clouds."  
 While he feels as if he's been blessed with a good life, Vaculig said he doesn't regret retiring. Now 74, he takes regular walks, enjoys meeting

friends for coffee and likes to build model cars and go to car shows.  
 "I've had close to 40 cars in my lifetime," he said, "and I've liked all the cars that I had. I'd drive them for a couple of years and then get another."  
 And, after all, cars have always been an important part of the rock 'n' roll culture.  
 He took a trip back to Cleveland earlier this year for his 55-year high school reunion and to see, for the first time, the Rock-A-Ways exhibit at the Rock Hall of Fame and Museum.  
 "It was the first time I was able to see the display," Vaculig said. "It was put in back in 2004."  
 While he was there, Vaculig

was interviewed on Sirius XM Radio, which broadcasts from the Rock Hall.  
 "(A hall spokesman) said we added so much history to Cleveland," he said.  
 And his alter ego finally was made known to his high school classmates during the reunion. A friend tipped off the disc jockey, who played one of the Rock-A-Ways' songs as he entered the room, then his musical identity was revealed for the crowd.  
 "They never put it together," he said of his classmates, who enjoyed posing for photos with him when his career was revealed.

# Con John F. Kennedy nació el voto latino en EEUU

25 de noviembre del 2012 (AP): Se suponía que el presidente John F. Kennedy se detendría sólo por un instante y saludaría de lejos con la mano.

En cambio, un grupo de latinos lo convenció de que entrase en un hotel de Houston para hablar ante numerosos defensores de los derechos de los mexicano-estadounidenses. Y allí, él convenció a su esposa, la primera dama Jacqueline Kennedy, de que hablase al público en español.

Era el 21 de noviembre de 1963. Horas después, el presidente había muerto y su asesinato hizo olvidar el significado de un discurso que podría considerarse como el nacimiento del voto latino en Estados Unidos, que en el 2012 resultaría decisivo para ayudar a reelegir a Barack Obama, el primer presidente de raza negra.

Para los historiadores, la presentación de Kennedy en el Salón de Baile del Hotel Rice en Houston fue probablemente la primera vez que un presidente reconocía oficialmente a los hispanos como un bloque importante de votantes.

Aunque no hay ninguna placa que conmemore la histórica ocasión, se trata de un jalón memorable para los activistas, aunque el lugar mismo donde Kennedy se sentó y oyó a una banda entonar baladas mexicanas y donde el público lo aclamó es hoy un salón remodelado en un edificio de departamentos donde se efectúan recepciones de bodas.

"Esa tarde... fue cuando empezó", afirmó Ignacio García, autor de "Viva Kennedy: Mexican Americans in Search of Camelot" ("Viva Kennedy: Los mexicano-estadounidenses en busca de Camelot") y profesor de historia en la Universidad Brigham Young. "Pero como muy poca gente supo sobre la reunión, es como si nunca hubiera ocurrido".

La visita sorpresiva sobrevino después que los mexicano-estadounidenses en Texas, Nuevo México, California, Arizona, Illinois e Indiana ayudaron a Kennedy a ganar en los estados reñidos en 1960, gracias a una campaña sin precedente de registro de votantes en comunidades hispanas. Surgieron clubes independientes "¡Viva Kennedy!". Los legisladores Dennis Chávez, de Nuevo México, y Henry González, de San Antonio, empezaron a hablar en vecindarios latinos y se erigieron en las primeras figuras políticas latinas reconocibles a nivel nacional.

Al igual que en el 2012, los republicanos en 1960 hicieron pocos esfuerzos por conquistar el voto hispano para su candidato presidencial Richard Nixon. Los hispanos también se identificaron con Kennedy, que era católico y de ascendencia irlandesa, miembro de un grupo étnico que había combatido la discriminación similar a la que sentían los hispanos en el sudeste segregado.

En las elecciones de 1960, Kennedy obtuvo el 85% de los votos mexicano-estadounidenses.

Pero durante los primeros meses de Kennedy en el cargo, los hispanos manifestaron decepción de que el presidente no hubiese designado latinos en su gobierno. Chávez lo criticó abiertamente por este motivo. Otros líderes hispanos lanzaron una campaña de cartas para censurar los lentos progresos en el terreno de los derechos civiles.

En previsión de otra elección reñida en 1964 y con la esperanza de relajar las tensiones, Kennedy visitó Texas en noviembre de 1963. Sus asesores le sugirieron que por lo menos hiciera una breve escala frente al lugar de una reunión de gala de mexicano-estadounidenses en Houston patrocinada por la Liga de Ciudadanos Estadounidenses Latinos Unidos (LULAC), el grupo hispano promotor los derechos civiles más grande del país en ese entonces.

"El Servicio Secreto nos dijo que podría detenerse, pero que no lo publicitarían porque no formaba parte de su programa oficial", dijo Alexander Arroyos, de 76 años, que era funcionario de LULAC en ese entonces. "Podíamos empujarlo oralmente. Pero nadie nos creyó".

Y después Kennedy se presentó. El presidente fue recibido en la puerta por Macario García, quien había sido galardonado con la Medalla de Honor, la máxima condecoración militar del país, por su desempeño durante la Segunda Guerra Mundial. Dentro del salón, Kennedy y la primera dama fueron recibidos con entusiasmo por veteranos de guerra, promotores de los derechos civiles y futuros funcionarios electos.

Kennedy habló brevemente sobre política exterior en Latinoamérica y la importancia de LULAC. La primera dama dijo al público en español que Texas tenía vínculos históricos profundos con los latinos. El público respondió con gritos de "¡Viva Kennedy!". Una banda cantó una balada en español mientras los fotógrafos tomaban instantáneas de los Kennedy y

del vicepresidente Lyndon Johnson y su esposa Bird Johnson.

Según los historiadores, hasta ese momento ningún presidente había reconocido a los hispanos como un bloque de votantes, dijo Emilio Zamora, historiador en la Universidad de Texas en Austin.

El presidente William Taft (1909-1913) pudo haberse reunido con un pequeño grupo de activistas hispanos en El Paso, Texas, agregó Zamora. El presidente Dwight Eisenhower probablemente estrechó las manos de algunos votantes mexicano-estadounidenses en una visita proselitista al sur de Texas en 1952. "Pero no creo que ningún presidente haya agradecido públicamente a mexicano-estadounidenses de esa manera", dijo Zamora.

Quince horas después de la histórica reunión, Kennedy estaba muerto.

Miembros de la banda musical que tocaron para el presidente la noche anterior lloraron al enterarse de la noticia. Cuando Arroyos se enteró de lo sucedido, le dijo a su jefe en una compañía importante que estaba demasiado conmocionado como para trabajar. Arroyos corrió a recolectar entre sus amigos tantas fotos como fuese posible de la visita de Kennedy al Hotel Rice para una futura edición de la publicación de LULAC.

El día de las elecciones del 2012, los analistas hablaron rutinariamente sobre el despertar de los hispanos como un gigante que había estado dormido y que había dado a Obama el 71% de sus votos. Pero Ignacio García dijo que esa evaluación omite el papel que han desempeñado los hispanos en las elecciones presidenciales durante más de 50 años.

En 1960, por ejemplo, su respaldo abrumador ayudó a poner a Texas y Nuevo México a favor de Kennedy durante la reñida contienda con Nixon. La campaña republicana no tenía presencia en los vecindarios mexicano-estadounidenses y tampoco un aviso televisivo en español, al contrario que Kennedy, que aprovechó a la primera dama para hacerlo. Kennedy también prometió designar a mexicano-estadounidenses en su gobierno.

Johnson disfrutó del apoyo de los hispanos que hicieron campaña para él hacia su



abrumadora victoria de 1964, y los mexicano-estadounidenses apoyaron firmemente al senador Robert Kennedy durante la primaria democrática de 1968 en California.

En el 2000, el entonces gobernador de Texas George W. Bush, republicano, logró superar al demócrata Al Gore, gracias en parte a haber recibido el 40% de los votos hispanos, según varios cálculos.

"El voto hispano no nació la noche en que Obama fue reelegido", dijo García. "Nació el 21 de noviembre de 1963".

El motivo de que el voto hispano atraiga atención en el 2012 se debe a que los hispanos son la primera minoría en Estados Unidos y a que las tasas de participación de sus votantes aumentan, afirmó.

La participación de votantes hispanos ha subido de 3,7 millones en 1988 a unos 12,5 millones en el 2012, según el Centro Pew Hispano. La cifra podría duplicarse en dos décadas, pronosticó el centro.

Arroyos dijo que la mayoría de los activistas de mayor edad desestiman la afirmación de que los hispanos estén por fin influyendo sobre las elecciones nacionales, aun cuando su generación ayudó a dar nacimiento al voto hispano. De todos modos, dijo que aun quienes recuerdan ese discurso de Kennedy probablemente no saben qué papel desempeñaron como anticipo de la participación hispana en la votación del 2012.

"No sabía que esa velada hubiese sido tan histórica", dijo Arroyos. "Sencillamente estaba feliz de que él se presentara, aunque sólo fuera para saludar".

**REPRESENTING TOLEDO:** Whitmer is looking to bring home the city of Toledo's first Division I football state championship since 1984. Toledo St. Francis DeSales defeated North Canton Hoover 17-14 to win the title that year.

**WELCOME BACK CINCINNATI:** Since 2000 the city of Cincinnati has sent a team to the Division I state championship game eight times. Moeller becomes the fourth team in that span to go to the finals, the others include Cincinnati Colerain, Cincinnati

Elder and Cincinnati St. Xavier.

**12TH FINAL IN 2012:** Moeller is playing in its 12th state championship game and first since 1997. The Crusaders are tied for second for most championship game appearances. Newark Catholic leads all schools with 14, followed by Moeller, Cleveland St. Ignatius (12), Youngstown Cardinal Mooney (11) and Versailles (9).

**LOOKING TO GO UNDEFEATED:** Whitmer, 14-0, is one of only five remaining unbeaten teams in the state and is looking to go undefeated for the first time in school history. The 14 wins is also the most in school history for one season, topping the 13 wins from the state semifinal team from a year ago.

**Division II**

**LOOKING FOR BACK-TO-BACK TITLES:** Trotwood-Madison returns to Massillon Paul Brown Tiger Stadium for the third year in a row and is looking to repeat as state champion in Division II. The Rams defeated Avon 42-28 to win their first state championship in 2011 after finishing as runner-up in 2010.

**REPRESENTING TOLEDO PART TWO:** Toledo Central Catholic is one of two schools representing Toledo in the 2012 football finals. Whitmer is the other (see Div. I note). The Irish have brought back the most recent title, and one of only three, to the city winning the Division II title in 2005, defeating Canfield 31-29.

**T R O T W O O D - MADISON'S GREEN:** Trotwood-Madison's Isreal Green ran the ball 35 times for 327 yards and six touchdowns in the 2011 state championship game as a junior. Green set all divisions records for most points (36), most touchdowns and most rushing touchdowns (6), along with the Division II record for rushing yards in a state championship game.

**FIRST CHAMPIONSHIP MEETING:** Central Catholic and Trotwood-Madison are meeting in the state championship game for the first time.

## U-M leads nation in Fulbright grants for sixth time in eight years

ANN ARBOR, Nov. 2012: More Fulbright grants were awarded to students from the University of Michigan than from any other U.S. institution for the 2012-13 academic year—the sixth time in the past eight years U-M has held the honor, officials said Monday.

A U-M record 40 students received the grants, allowing them to participate in one of the most competitive and prestigious programs in the world. They will travel to 24 countries to do research, study or teach English for six to 12 months as part of the U.S. government's flagship international education exchange program.

Their interests range from health care in Togo and political economy in Ukraine to urban transit in Germany and sculpture in China.

Along with helping the students achieve their academic goals, the Fulbright program seeks to increase mutual understanding between the people of the U.S. and other countries.

"The accomplishments of our latest Fulbright students speak to the global interests and impact of the University of Michigan," U-M President Mary Sue Coleman said. "The grants provide unique opportunities that will complement our students' impressive work on campus."

U-M also topped the nation in Fulbrights in 2005, 2007, 2008, 2010 and

2011. This year, Harvard University ranked second behind U-M with 31 grantees and Brown University placed third with 29.

Ken Kollman, director of the U-M International Institute, said the continued success with the Fulbrights highlights the university's dedication to providing a global education.

"We are extremely proud of the results of this year's competition, which reflect the tremendous effort of our students who plan compelling projects, the U-M faculty who readily lend their expertise and the advisers at the International Institute who consult with applicants," Kollman said.

Nearly 1,700 American students, artists and young professionals in more than 100 different fields of study were offered Fulbright grants for projects in more than 140 countries worldwide beginning this fall. Sponsored by the U.S. Department of State, the program provides the grants on the basis of academic or professional achievement as well as demonstrated leadership potential.

In the past 66 years, more than 44,000 students from the U.S. have benefited from the Fulbright experience.

Emefah Loccoh, one of U-M's grantees for 2012-13, is researching the health care system in Togo. She graduated this year with degrees in biochemistry and political science, and she plans to attend medical school.

"This scholarship gives me the opportunity to further explore the field of global health, better understand surrounding issues and observe different aspects of the field in order to further understand my future role within global health," she said.

Another new U-M grantee is Andrea Urbiel Goldner, who teaches in the School of Natural Resources and Environment. She is in Morocco studying landscape architecture.

"Anyone involved in design and construction in the current economic context of southeast Michigan has good reasons to become cynical and short-sighted," she said. "The Fulbright grant has enabled me to breathe in and out again. It has given me space and context to remember why I love cities and their neighborhoods and the practice of landscape architecture."

ANN ARBOR, Michigan, 29 de oct. del 2012: En el período académico 2012-13 se asignaron más becas Fulbright a estudiantes de la Universidad de Michigan que a cualquier otra institución de Estados Unidos, la sexta vez en los últimos ocho años en los cuales la UM ha tenido

ese honor, indicaron hoy funcionarios de la universidad.

La cifra sin precedentes es de 40 estudiantes de la UM que recibieron las becas las cuales les permitirán participar en uno de los programas más competitivos y prestigiosos del mundo. La UM también estuvo al top del país en becas Fulbright en 2005, 2007, 2008, 2010 y 2011.

Este año la Universidad de Harvard quedó en segundo lugar con 31 becarios, y la

Universidad Brown en tercero con 29.

Ken Kollman, director del Instituto Internacional de la UM, dijo que el éxito continuado con las Fulbright señala la dedicación de la universidad a la provisión de una educación global.

## Vargas Llosa recibe Premio Carlos Fuentes

21 de noviembre del 2012 (AP): El escritor peruano Mario Vargas Llosa fue distinguido el miércoles con el primer Premio Internacional Carlos Fuentes a la Creación Literaria en el Idioma Español en una ceremonia en la que destacó el papel del autor mexicano en el llamado "boom" de la literatura latinoamericana.

"Se ha dicho que 'La ciudad y los perros' fue, cronológicamente hablando, la primera novela del boom", dijo Vargas Llosa sobre su novela en el discurso de aceptación en la Ciudad de México. "Pero creo que sería más justo decir que ese papel pionero, anunciador del boom, debe concederse a la primera novela de Fuentes, 'La región más transparente', que apareció en el año de 1958, es decir, cuatro años antes que la mía", precisó al recibir la presea la noche del miércoles.

El también autor de

"Conversación en la catedral" y "Pantaleón y las visitadoras", nacido en Arequipa en 1936, reconoció su propio valor como integrante del movimiento que revolucionó la literatura latinoamericana a mediados del siglo XX.

"Soy muy consciente de que esta generosa decisión del jurado se debe en buena medida a ser yo algo así como el último sobreviviente operativo de ese movimiento", dijo con buen humor entre las risas de los asistentes.

Vargas Llosa, Premio Nobel de Literatura en 2010, dedicó en buena medida su discurso a la personalidad de Fuentes, fallecido en mayo, a quien conoció en 1962 en una noche de "tequila, mariachis y efusiones" en la que lo encontró cantando corridos y hablando de cine.

"Probablemente ninguno de los escritores a los que se considera integrantes del 'boom' se esforzó tanto como él (Fuentes) para acercarnos y amignarnos, hacernos sentir

parte de una aventura intelectual común y para que nuestros libros rompieran el confinamiento al que hasta entonces estaban condenados casi todos los escritores latinoamericanos", señaló.

"Fui testigo y beneficiario de su generosidad: Me recomendó a su agente literario en los Estados Unidos e hizo gestiones con sus editores extranjeros para que tradujeran mi primera novela", recordó sobre la relación de hermandad que forjaron.

El presidente Felipe Calderón entregó el premio al escritor y lo reconoció por su papel como crítico de la sociedad latinoamericana.

"Al poner en sus manos este galardón, los mexicanos reconocemos en su obra una aportación literaria medular de América Latina para el mundo. Reconocemos su vigorosa defensa de la libertad y la democracia, su vigorosa defensa del espíritu liberal, que por supuesto emana de un espíritu crítico imprescindible para construir

el porvenir".

A propósito de la libertad política que ha caracterizado al escritor a lo largo de los años, el presidente recordó el episodio en el cual Vargas Llosa calificó a México como "La dictadura perfecta" en televisión nacional en 1990, cuando el país comenzaba a pedir que terminara el largo gobierno del Partido Revolucionario Institucional, que estuvo finalmente al frente del país por 70 años.

"Esas palabras nítidas, controversiales, satanizadas por supuesto por las multitudes de aquel entonces... cambiaron en buena parte a nuestro país. Fueron palabras que retumbaron mucho más allá de los libros y las novelas de Vargas Llosa y sus contemporáneos", dijo Calderón.

La transparencia de Vargas Llosa fue la virtud más celebrada por el presidente en sus palabras de felicitación.

"Al final de cuentas es Vargas Llosa un hombre congruente con sus ideas,

muchas veces polémicas, muchas veces provocadoras, pero es de esos hombres que se buscan con ansia y se encuentran con dificultad, que son no sólo capaces de decir lo que piensan sino de hacer lo que dicen", estimó Calderón.

En la entrega del premio, que coincidió con la inauguración oficial de la remodelada biblioteca de la Ciudadela, también estuvo presente la presidenta del Consejo Nacional para la Cultura y las Artes, Consuelo Sáizar; el director de la Academia Mexicana de la Lengua, Jaime Labastida; el secretario de Educación Pública, José Ángel Córdova Villalobos, y Silvia Lemus, viuda de Fuentes a quien Vargas Llosa dedicó las últimas palabras de su discurso.

"Sin ella difícilmente hubiera nacido esa obra tan monumental que ahora celebramos", dijo para luego acercarse a abrazarla efusivamente.
