## Argentina pide informes al exterior sobre príncipe saudí

BUENOS AIRES, 28 XI  
18 (AP) — Un fiscal argentino pidió averiguar si en Arabia Saudita y Yemen existen procesos judiciales en contra del príncipe saudí *Mohammed bin Salman* por delitos de lesa humanidad antes de resolver si la justicia argentina debe impulsar una causa en su contra a pedido de un organismo humanitario.

El fiscal *Ramiro González* solicitó el envío de exhortos a esos países en un dictamen que le hizo llegar el miércoles al juez federal *Ariel Lijo*, dijo a The Associated Press un empleado del juzgado del magistrado que pidió no ser identificado por no estar autorizado a dar esta información.

El príncipe saudita llegó a primera hora del día a Buenos Aires para asistir a la Cumbre del G20 que tendrá lugar el viernes y sábado.

El juez Lijo recibió recientemente una denuncia de *Human Rights Watch* en contra del príncipe heredero, señalado como presunto responsable de crímenes de guerra en Yemen y de haber ordenado el asesinato del periodista saudita *Jamal Khashoggi* en Estambul en octubre. El fiscal Ramírez colabora con el magistrado en este caso.

El juez debe decidir ahora si da curso a lo solicitado por el fiscal, quien busca determinar si procede que la justicia argentina investigue al príncipe.

Ramírez indicó además en su dictamen que, si prospera, este caso podría ser de competencia exclusiva de la Corte Suprema Argentina, según extractos de su escrito reproducidos en medios de prensa.

El tiempo que le llevaría al juez decidir si avala el

dictamen del fiscal y el eventual pedido de exhortos a Yemen y Arabia Saudita a través de la cancillería argentina hacen muy improbable que la justicia del país sudamericano decida en el corto plazo las medidas que tomaría sobre la situación del príncipe.

El polémico heredero de la corona saudita se dirigió a la embajada de su país en Buenos Aires, donde se extremaron las medidas de seguridad con un vallado y decenas de agentes policiales.

Human Rights Watch

pretende que sea investigado en Argentina porque considera que la justicia saudita está bajo control gubernamental. Abogados de la organización humanitaria señalaron que la justicia del país sudamericano debería evaluar el papel de Mohammed bin Salman en posibles crímenes de guerra cometidos por la coalición liderada por Arabia Saudita en Yemen contra rebeldes desde 2015, cuando el heredero de la corona ejercía como ministro de Defensa.

Este es el primer viaje del príncipe Mohammed al exterior desde el asesinato del periodista, quien era un opositor a la monarquía saudita. El caso ha generado fuertes críticas de potencias occidentales que estarán presentes en la Cumbre del G20.

### Argentina judge acts on complaint against Saudi prince

BUENOS AIRES, Argentina, Nov. 28, 2018 (AP): Argentine legal authorities took initial action Wednesday to

crimes against humanity before deciding whether to open an investigation in Argentina.

Argentina's legal system allows cases to be brought against crimes against humanity allegedly committed elsewhere. But it is unlikely anything will happen soon, given the time it will take the judge to make a decision after the request for information from Yemen, Turkey, and the International Criminal Court is filed by the Argentine foreign ministry.

The judge has also asked rights groups to provide details supporting allegations against the prince.

*Human Rights Watch* accuses the prince of war crimes in Yemen and responsibility for the gruesome slaying of newspaper columnist *Jamal Khashoggi* inside the Saudi consulate in Istanbul, Turkey last month.

The Argentine judiciary, by taking steps toward a formal investigation, is sending a clear message that even powerful officials like *Mohammed bin Salman* are not above the law and will be scrutinized if implicated in grave international crimes, the group said in a statement.

"A cloud of suspicion will loom over him as he tries to rebuild his shattered reputation at the G20, and world leaders would do well to think twice before posing for pictures next to someone who may come under investigation for war crimes and torture."

The prince, who stopped in several Arab countries along the way, arrived in Buenos Aires early Wednesday and was taken to the Saudi Embassy, which is being guarded by dozens of police officers.

Argentina has cooperation agreements with Saudi Arabia in tourism and other areas.

## Chilean president signs transgender identity law

SANTIAGO, Chile, Nov. 28, 2018 (AP): Chile's president has signed a law that lets people over the age of 14 change their name and gender in official records.

President *Sebastian Pinera* says the measure signed Wednesday will help overcome "painful,

discriminatory experiences." But he says a full solution to discrimination against transgender people "requires a cultural change, which has to be in the soul, in the heart of all Chileans."

The measure will take effect after rules to implement it are drafted.

Congress passed the mea-

sure in September after a five-year political battle.

The law makes it possible to modify birth certificates through a simple process at the civil registry.

Those between the ages of 14 and 18 will need permission from a parent or guardian, along with consent granted by a family court.

## Puerto Rico approves laws for insurance holders post-Maria

SAN JUAN, Puerto Rico, Nov. 27, 2018 (AP): The governor of Puerto Rico overhauled the U.S. territory's insurance laws on Tuesday to help protect policyholders as thousands of claims remain unresolved more than a year after Hurricane Maria.

Gov. Ricardo Rossello signed six laws into effect as stressed that his administration was not pleased with how insurance companies handled complaints filed after the Category 4 storm hit.

One law now requires insurance companies to start making partial payments under certain conditions shortly after a state of emergency is declared.

Another creates special courtrooms with expert judges to solve appraisal disagreements via mediation, a first for Puerto Rico. All decisions reached during mediation will be binding but can be appealed in court. A third law sharpens the types of actions officials can take against insurance companies if they do not resolve cases promptly or act improperly.

"This is a historic moment," Javier Rivera, who oversees the Office of the Insurance Commissioner of Puerto Rico,

said in a phone interview. "It transforms how insurance companies will respond in a catastrophic event."

Another law will for the first time create micro insurance to help low-income people on an island of 3.3 million inhabitants with a poverty rate of nearly 45 percent. Additional new laws required that each insurance company have a written emergency response plan that has to be certified annually by the government and that a company pay the cost of an audit if it's required. A final law states that qualifying businesses can use surplus line insurers if at least three other companies decline partial or full cover.

"This...will result in considerable savings to our policyholders, who in many cases have seen unsustainable increases in their premiums," Rossello said.

Hurricane Maria caused more than an estimated \$100 billion in damage when it hit on Sept. 20, 2017, destroying Puerto Rico's power grid and forcing businesses to remain closed for months. Overall, it was the most expensive catastrophe for the insurance industry last year, with losses amounting to \$32 billion, higher than

Hurricanes Irma and Harvey, according to a report from Swiss Re, a reinsurance company based in Switzerland.

More than 287,000 claims were filed, and of those, nearly 11,000 claims representing a total of nearly \$2 billion have not been resolved, Rivera said. Insurance companies struggled after the storm, including Real Legacy, which folded. The number of claims that went unanswered or unpaid also prompted the government to file lawsuits against several companies to prevent them from dropping claims because they have allegedly expired. The lawsuits also seek \$2.6 billion in damages for those who have not been compensated.

*raelia Pernas*, executive director of Puerto Rico's Association of Insurance Companies, said by phone that no one was prepared for the level of disaster that Maria caused, and that the unresolved cases are the most complex ones and involve mostly government agencies and large businesses.

"We think it's a good initiative," she said. "God willing we don't have to test it."

## Puerto Rico governor backs US-sponsored statehood referendum

SANJUAN, Puerto Rico, Nov. 23, 2018 (AP): Puerto Rico's governor says he would back a federally sponsored referendum that asks voters whether the U.S. territory should become a state.

Ricardo Rossello made the announcement on Friday after U.S. Rep. Rob Bishop of Utah asked the U.S. attorney general this week to certify such a referendum.

Puerto Rico has held five

non-federal referendums, although none specifically asked people to simply vote 'yes' or 'no' on statehood.

U.S. Congress has final say on any changes to Puerto Rico's political status.

## Puerto Rico logra acuerdo de reestructuración de su deuda

SANJUAN, 29 XI 18 (AP): Puerto Rico anunció el jueves haber completado su primer acuerdo de reestructuración de su deuda desde que se declaró en bancarrota hace más de tres años, concediéndole a los acreedores 550 dólares en nuevos bonos por cada 1.000 que tenían en su poder.

El convenio fue concretado con los acreedores de casi 4.200 millones de deuda emitida por el ahora desaparecido Banco Gubernamental de Fomento, que alguna vez otorgó créditos y supervisó las transacciones de deuda de la isla, pero que en marzo dejó de funcionar en medio de una recesión de 12 años.

“El cierre de la reestructuración de la deuda del BGF es un hito histórico en el camino de recuperación económica para Puerto Rico”, declaró el gobernador Ricardo Roselló. “Es evidencia clara de que Puerto Rico tiene la credibilidad y voluntad necesaria para resolver sus retos fiscales”.

Si embargo, se desconocen los alcances del acuerdo con respecto a unos 70.000 millones de dólares de otras deudas que aún están pendientes de pago. Gran parte de ella está siendo abordada en tribunales, más que con acuerdos voluntarios.

El gobierno dijo que su

Autoridad de Recuperación de Deuda pronto extenderá a los acreedores bonos por casi 2.600 millones de dólares.

Sin embargo, algunos economistas se muestran recelosos frente al convenio, ante la incertidumbre de si los pagos podrán ser cubiertos debido a la fragilidad de las finanzas de la isla y la actual crisis, causada en parte por el gran endeudamiento de gobiernos anteriores para cubrir déficits enormes.

“Una preocupación que tenemos muchos economistas es que estos acuerdos sean temporeros y no garantizan que Puerto Rico ya no vuelva a caer en una crisis de deuda”, dijo por teléfono el economista José Caraballo.

Si embargo, elogió que el acuerdo otorgue un trato diferente a bonistas distintos. Un grupo, conformado principalmente por fondos de cobertura, recibirá primero los pagos, pero a un porcentaje inferior de sus inversiones originales. Un segundo grupo, que incluye a inversionistas locales, recibirá sus pagos en fecha posterior, aunque a un porcentaje mayor.

Pero Caraballo advirtió que otra crisis podría golpear a la isla antes de que el segundo grupo reciba sus pagos, y dijo que el acuerdo no pone fin a los problemas financieros de Puerto Rico.

porque no está basado en la capacidad del gobierno para pagar a largo plazo.

“Son acuerdos que no son sustentables. No es un punto final. Es una coma en medio de esta crisis”, afirmó.

Otro economista, Vicente Feliciano, destacó que el acuerdo depende de que los municipios mantengan los pagos con recaudaciones del impuesto sobre bienes inmuebles. El valor de las propiedades fue afectado por la migración de gran escala en la isla debido a las penurias económicas y por el paso del huracán María, que el año pasado causó daños por más de 100.000 millones de dólares.

“Siempre existe el riesgo de que en algún momento los municipios pudieran enfrentar dificultades para cumplir sus obligaciones”, señaló Feliciano en entrevista telefónica.

En conjunto, las agencias de Puerto Rico acumulan una deuda pública de unos 70.000 millones de dólares e intentan reestructurarla parcialmente vía judicial o mediante acuerdos con los acreedores. Una junta federal de control creada por el Congreso de Estados Unidos supervisa un proceso tipo bancarrota, así como las finanzas de la isla, que es territorio estadounidense.

## Canadá dice evaluar opciones para diplomáticos en Cuba

TORONTO, 29 XI 18 (AP): Un alto funcionario canadiense dijo el jueves que Canadá está estudiando todas sus opciones con respecto a su embajada en Cuba, después de que un diplomático empezo a padecer una enfermedad misteriosa. Agregó que el diplomático afectado manifestó los primeros síntomas a mediados de año y que los análisis lo confirmaron.

Canadá ha confirmado 13 casos de trastornos misteriosos de salud desde principios de 2017. También se han visto afectados 26 empleados de la embajada estadounidense en La Habana, con toda una gama de síntomas y diagnósticos que incluyen convulsiones cerebrales.

El funcionario dijo a la

prensa el jueves que miembros del gobierno visitarán Cuba la semana entrante para estudiar todas las opciones y asegurar la protección del personal. Se negó a aclarar cuáles eran las opciones en consideración. Canadá tiene actualmente 12 diplomáticos en su embajada en La Habana.

Ottawa ordenó a los familiares de los diplomáticos que abandonaron el país en abril. Entre los 13 afectados hay algunos diplomáticos y familiares.

El gobierno cubano no respondió de momento a la declaración canadiense. En abril, cuando Canadá retiró a los familiares, dijo que “el gobierno cubano respeta la decisión tomada por el gobierno de Canadá, pero considera que es injustificada y reitera que Cuba es un país seguro, estable

y sano para sus habitantes y los casi 5 millones de extranjeros que la visitan anualmente, entre ellos más de 1 millón de canadienses”.

Cuba es uno de los destinos turísticos preferidos de los canadienses y el gobierno del país norteamericano dijo que no tiene indicios de que los viajeros hayan sufrido trastornos de salud parecidos.

El funcionario canadiense, quien habló bajo la condición de anonimato, dijo que Cuba ha colaborado desde el principio y que ha expresado el deseo de hallar la causa de los trastornos.

Cuba y Estados Unidos restauraron plenas relaciones diplomáticas en 2015 durante la presidencia de Barack Obama, pero el caso de la enfermedad misteriosa las perjudicó gravemente.

## Cuba acusa a EEUU de denegar injustamente visas

LA HABANA, 29 XI 18 (AP): Cuba accusó el jueves el gobierno del presidente estadounidense Donald Trump de negar de forma injusta las visas a los diplomáticos asignados a trabajar en la Embajada de Cuba en Washington, lo que las autoridades cubanas describieron como parte de una acción más amplia para dar marcha atrás al acercamiento iniciado por el expresidente Barack Obama hacia la isla.

“Después de dos décadas de estar Cuba sin negar una visa a Estados Unidos, Estados Unidos ha dejado de contestar múltiples solicitudes de visa para nuestro personal que por demás trabaja en Estados Unidos para mejorar las relaciones de Cuba con los estadounidenses y atender la migración cubana y a los empresarios que nos visitan”, comentó a The Associated Press Johana Tablada, subdirectora de la Dirección General de Estados Unidos en la cancillería cubana.

El Ministerio de Relaciones Exteriores de Cuba dijo que Estados Unidos ha denegado seis visas a diplomáticos cubanos y ha aprobado 26 desde septiembre de 2017. Por su parte, señaló, Cuba ha aprobado 105 visas

temporales y permanentes para personal asignado a la Embajada de Estados Unidos en La Habana. Agregó que solo ha rechazado una visa, como respuesta a las sanciones del gobierno estadounidense.

Ni las autoridades estadounidenses ni cubanas han dicho cuántos diplomáticos tienen actualmente en sus respectivas representaciones.

Las relaciones se han visto deterioradas drásticamente desde que el presidente Trump asumió el cargo y prometió dar marcha atrás al acercamiento de Obama hacia Cuba.

Estados Unidos retiró a la mayoría de su personal de Cuba luego de acusar al gobierno comunista de permitir lo que los estadounidenses describieron como “ataques contra la salud” que han enfermado a más de una veintena de trabajadores de la embajada que estaban asignados en La Habana.

Cuba niega estar involucrada en la agresión y señaló que Estados Unidos no ha proporcionado ninguna evidencia que respalde sus afirmaciones de acciones deliberadas contra diplomáticos.

El mismo jueves, Canadá dijo que estaba considerando todas sus opciones en relación con su embajada en Cuba luego de que otro de sus diplomáticos

## Detroit's Immigration Task Force: Op Ed Statement against the proposed change to the Public Charge by Trump Administration

We, members of the *Immigration Task Force*, strongly object to the Trump administration's proposed change to 'public charge', which marks a significant and harmful departure from the current policy.

The proposed rule changes the definition of public charge to apply to anyone who is likely to use or has used in the past public benefit programs such as *Supplemental Nutrition Assistance Program (SNAP or Food Stamps)*, *Medicare Part D Low Income Subsidy*, *Housing assistance*, and non-emergency Medicaid.

The proposed rule also adopts a new income threshold for households seeking to overcome a 'public charge' test by giving negative weight to immigrants who earn less than 125% of the Federal Poverty Level. Additional negative factors include being a child or senior citizen, having limited English proficiency, poor credit history, limited education, a large family, and pre-existing health conditions.

This proposed change has resulted in many immigrant families being afraid of seeking basic needs assistance, instilling fear that individuals who have taken advantage of assistance like Medicaid and food stamps (amongst many other benefits) may result in the rejection of their visa petitions or green cards.

If implemented, this vindictive proposed change will punish many immigrants, especially those present in the U.S. lawfully and those eligible for family-based immigration. It has caused anxiety and sparked confusion, making immigrant families suffer even more under this unnecessary burden.

Even though certain immigrants may be exempt from the rule, such as refugees and asylees, the proposed rule is expected to cause many to disenroll from out of fear and confusion this rule will cause. Research has shown that this chilling effect would extend to 283,000 people in Michigan of which 114,000 are children.

It could potentially worsen the financial security of the families affected, aggravate homelessness and hunger which in turn affects the community at large.

America is a nation of diversity, both demographically and experientially. Diversity is the key to innovation and creativity and it is this diversity that has shaped our values, enriching our nation in the course of history and heritage.

We must stand up against this attack on values of family, community and fairness which form the very fabric that weaved America together.

So, let us work toward moving our nation forward by helping immigrants and their families succeed, because this outcome is crucial for our nation's progress and future.

The exhibit will be on view during normal library hours through February 2019.


Ms. Candiotti follows in the tradition of Argentinian Social Realist painters through her different series that research and depict the cultures and customs of various communities.

## Metroparks to take ownership of the Anderson's South Toledo property

Nov. 29, 2018: Most of the South Toledo property that was originally the *Anderson family farm* will become part of the Metroparks Toledo system sooner than anticipated, the company and the park district announced.

Metroparks will take ownership of just under 92 acres of land, which represents the culmination of an earlier gift combined with the purchase of additional land.

The timing of the Metroparks exercise of the option agreement was originally set for 2026 at the earliest, but The Andersons, Inc. decided to accelerate the gift. The option price paid for the pond and additional acreage on Holland-Sylvania Road was one dollar.

"It's an incredible gift to the community," said Dave Zenk, executive director of Metroparks. "This property, along with an adjacent property that was also donated to the park district, will continue to provide ecological benefits, and eventually become a park that families will enjoy for generations."

In 1995, The Andersons, Inc. donated 67.4 acres of land, subject to an easement agreement that allowed both Metroparks and family members limited use of the property. At the same time, The Andersons, Inc. granted Metroparks an option to acquire additional parcels, including a 12-acre pond and 4.34 acres of land fronting Holland-Sylvania Road.

"Both the family and the company are excited that the vision for this property becoming a community park asset is coming to fruition," said Mike Anderson, chairman of The Andersons, Inc.

"We look forward to the entire community being able to one day create memories on this property as my family has, and as many Anderson



employees' families have."

Metroparks will purchase another 8.023 acres for \$532,000, including a structure known as the Activities Building, a detached garage and additional land along Swan Creek.

An adjacent 52 acres donated to Metroparks in the late 1990s by Virginia Belt was recently developed into the Brookwood Area on Swan Creek Drive. That property is open for Metroparks programs and special events, and by reservation for private functions.

Combined, The Andersons and Belt properties total 144 acres along Swan Creek.

There are six parcels of land adjacent to the new South Toledo property that are owned by individual Anderson family members. The ownership of those parcels is unchanged.

## Op Ed News from Progress Michigan

LANSING, Nov. 28, 2018: Republicans in the Michigan State Senate are using *Lame Duck* to gut popular policies that raise wages and provide critical benefits to working families and Progress Michigan is calling them out for doing the bidding of their corporate donors.

Michigan Republicans saw historic losses in November and now they're using their waning days of unfettered power to try and screw working families out of hard-fought wage increases and earned sick time protections.

Republican lawmakers are working behind closed doors to push policies on behalf of their corporate

day. The *minimum wage law* was changed so much that the full effect of it won't be felt by workers for over a decade and tipped workers will still be forced to work for a subminimum wage under the proposed Senate changes.

Republicans have taken days off from session to go hunting, to work on their campaigns, to hob-nob with lobbyists on Mackinac Island and just last month voters gave many of them permanent vacations from public office. They should use their final days in office passing policies to help Michigan families.

## Latino businessman launches bid for Salt Lake City mayor

SALT LAKE CITY, Nov. 28, 2018 (AP): A Utah businessman is challenging Salt Lake City mayor Jackie Biskupski in hopes of becoming the capital's first ethnic-minority leader.

The Salt Lake Tribune reports Democrat David Ibarra made the announcement Tuesday backed by Salt Lake County Attorney Sim Gill and former mayor Rocky Anderson.

Ibarra's father was a migrant worker from Mexico, and he and his brother went into foster care after his parents divorced and his father was drafted into the military.

If elected, Ibarra said he

would address homelessness, help businesses develop and stay at the table through difficult negotiations with other leaders. The last statement appeared to reference Biskupski's

clashes with Republican state leaders over plans for a massive, largely state-controlled shipping hub in city limits.

Salt Lake City councilman Stan Penfold is also running for mayor.



## State of Ohio helps Small Businesses to hire Export Interns

Nov. 29, 2018: Ohio businesses looking to expand their export initiatives can get assistance from the State of Ohio's Export Internship Program. The Development Services Agency is accepting applications from companies to take part in the program right now.

The Ohio Export Internship Program provides an opportunity to businesses interested in growing exports by matching them with highly motivated college students who have taken export-focused coursework. This year, 52 students from 12 universities across the state have been selected to participate in the program.

"The interns are tremendous benefit for the businesses," said David Goodman, director of the Ohio Development Services Agency. "It's a great win for Ohio because we're getting an educated workforce, we're getting businesses that are productive, and we're creating jobs."

The Ohio Development Services Agency offers participating small to medium-sized businesses a 50 percent reimbursement for the wages of the intern, up to \$3,600.

This program has a track record of success with students increasing export sales for businesses. In the seven years of the program, 231 student-company matches were created, re-

sulting in 63 internship extensions, 44 new job positions and 303 new international markets, distributors or customers.

The program is a partnership among the Ohio Development Services Agency, The Ohio State University, Youngstown State University, and Cleveland State University.

Applications are now under review, so companies should apply now. The final deadline to apply is February 1, 2019. The summer internship runs from May 13 through August 9, 2019.

## Arizona's 1st Latino congressman, dies

PHOENIX, Nov. 28, 2018 (AP): Former U.S. Rep. Ed Pastor, Arizona's first Latino congressman, has died after suffering a heart attack. He was 75.

Pastor, a Democrat, served 23 years in Congress. He was the longtime senior member of the state's U.S. House delegation before he decided in 2014 against running for re-election.

Pastor went to Congress after winning a 1991 special election for the seat vacated by fellow Democrat Morris K. Udall.

Ronnie López, a longtime friend of Pastor and finance director of all of his campaigns, said Pastor had a heart attack Tuesday night while dining at a restaurant

with his wife, Verma.

Laura Pastor, a Phoenix City Council member and one of the former congressman's two daughters, said he "will be remembered for his commitment to his family, and his legacy of service to the community that he loved, the state of Arizona and the nation."

Arizona Gov. Doug Ducey, a Republican, called Pastor "an Arizona trailblazer and true public servant" and ordered that flags lowered statewide to half-staff to recognize "the long-lasting impact he will leave on Arizona."

U.S. Rep. Rubén Gallego, a Democrat who now represents the congressional district, said Pastor "dedicated his career to protecting the civil rights of every American and making

the American Dream accessible to everyone, including the most vulnerable in our society."

Pastor represented a heavily Democratic district centered on Phoenix. He previously served on the Maricopa County Board of Supervisors.

Current Phoenix Mayor Thelda Williams and former Mayor Greg Stanton said Pastor, who served on the House Appropriations Committee, championed transportation projects such as funding for Phoenix Sky Harbor International Airport improvements and construction of the metro area's light rail system.

"I adored Ed Pastor, and Phoenix is a better city because of him," Williams said.

## "Roma" es nombrada mejor película por críticos de Nueva York

NUEVA YORK, 29 XI 18 (AP): En la que podría ser la primera barrida de la aclamada cinta de Alfonso Cuarón basada en sus memorias, "Roma" dominó los premios del Círculo de Críticos de Cine de Nueva York el jueves, obteniendo el premio a mejor película, mejor dirección y mejor cinematografía.

El impresionante apoyo para "Roma" del grupo de críticos no fue una sorpresa. La película de Cuarón ha sido elogiada como una obra maestra desde que ganó el León de Oro en el Festival de Cine de Venecia. Se espera que compita por el Oscar a mejor película, entre otras categorías, en los Premios de la Academia y Netflix ha puesto su peso completo detrás de la campaña para la temporada de premios. Cuarón creó esta película en blanco y negro a partir de sus años de infancia en la Ciudad de México y fue su propio director de fotografía.

Los críticos votaron por Ethan Hawke como mejor actor por su papel en "First Reformed" de Paul Schrader y le dieron a Schrader el premio a mejor guion.

Estos triunfos fueron otro impulso para la angustiante historia sobre un pastor lleno de dedudas (Hawke), que se llevó los mismos premios en los Premios Gotham del lunes.

Aunque la selección de grupos de críticos como el Círculo de Críticos de Nueva York y la Asociación de Críticos de Cine de Los Angeles suele desviarse de las cintas favoritas de la temporada de premios, su prestigio y sincronía pueden hacer que películas y actores menos escuchados lleguen a los Oscar. Esto podría ocurrir con la elección del grupo a mejor actriz, Regina Hall, protagonista de la comedia independiente de Andrew Bujalski "Support the Girls",

sobre la mesera de un bar deportivo de Texas. Hall superó a Lady Gaga ("A Star Is Born") y a Olivia Colman ("The Favourite").

Los premios para actores de reparto fueron para contendientes más aclamados: Regina King por su interpretación como matriarca en la adaptación de "If Beale Street Could Talk" de Barry Jenkins basada en la novela de James Baldwin; y Richard E. Grant como el conspirador

libertino de *Melissa McCarthy* en el drama de falsificación literaria "Can You Forgive Me?".

Trasdejárselas catégorias principales a "Roma", los críticos votaron por la continuación de "Ida", "Cold War" de Pawel Pawlikowski, como mejor película de lengua extranjera. El premio a mejor documental fue para "Minding the Gap", el debut del director Bing Liu sobre un trío de amigos que andan en patinete en Rockford, Illinois. La tierna película de Bo Burnham sobre el paso a la edad adulta, "Eighth Grade", se llevó el premio a mejor ópera prima.

Tras sus reseñas favorables, "Spider-Man: Into the Spider-Verse" fue elegida como mejor película animada por encima de "Incredibles 2" de Pixar.

Los críticos también entregaron premios especiales para el curador del Museo de la Imagen en Movimiento, David Schwartz, quien se retira de su puesto, y a la colección de DVDs de Kino Classics "Pioneers: First Women Filmmakers".

### "Roma" named best film by New York film critics

NUEVA YORK (AP): In what may be the just the first of many such sweeps, Alfonso Cuarón's masterful, memory-drenched drama "Roma" dominated the New York Film Critics Circle Awards on Thursday, winning best film, best director and best cinematography.

The overwhelming show of support for "Roma" by the critics group wasn't a surprise. Cuarón's film has been hailed as a masterpiece since winning the Golden Lion at the Venice Film Festival. It's widely expected to contend for best picture, among other categories, at the Academy Awards, and Netflix has put its full weight behind an awards campaign.

Cuarón made the black-and-white 1970s-set film based on his own upbringing in Mexico City, serving as his own cinematographer.

The critics voted Ethan Hawke best actor for *Paul*

Schrader's "First Reformed," and named Schrader's script best screen play. Those wins provided yet another boost to Schrader's sanguine tale of a doubt-riddled pastor (Hawke), which took the same awards at Monday's Gotham Awards.

While the selections of critic's groups like the New York Film Critics Circle and the Los Angeles Film Critics Association often deviate from awards-season favorites, their prestige and early timing can bring less heralded films and performers into the Oscar conversation. That may have happened with the group's pick for best actress: Regina Hall, star of *Andrew Bujalski's* indie comedy "Support the Girls," about the waitstaff of a Texas sports bar. Hall bested the likes of *Lady Gaga* ("A Star Is Born") and *Olivia Colman* ("The Favourite").

Supporting acting prizes went to more widely acknowledged contenders: *Regina King* for her performance as the matriarch of *Barry Jenkins'* James Baldwin adaptation "If Beale Street Could Talk"; and *Richard E. Grant* as *Melissa McCarthy's* debonair conspirator in the literary forgery drama "Can You Ever Forget Me?"

Leaving the bigger categories to "Roma," the critics voted *Pawel Pawlikowski's* "Ida" follow-up "Cold War" best foreign language film. Best documentary went to "Minding the Gap," Bing Liu's directorial debut about a trio of skateboarding friends in Rockford, Illinois. *Bo Burnham's* tendercoming-of-age tale "Eighth Grade" took best first film.

And fresh off its glowing reviews, "Spider-Man: Into the Spider-Verse" was chosen as best animated film over Pixar's "Incredibles 2."

The critics also added special awards for the retiring chief curator of the Museum of the Moving Image, *David Schwartz*, and Kino Classics' DVD box set "Pioneers: First Women Filmmakers."

## A look at what happened at the G-20 summit in Argentina

BUENOS AIRES, Argentina, Dec. 2, 2018 (AP): Leaders of the world's largest economic powers have agreed to overhaul the global body that regulates trade disputes, but they faced resistance from Donald Trump over the Paris accord on climate change.

Here are some of the main developments at the Group of 20 summit, which wrapped up Saturday:

- **WORLD TRADE ORGANIZATION:** All G-20 leaders called for reforming the *World Trade Organization* and the issue will be discussed during the group's next summit in Osaka, Japan, in June. The gathering's final statement, however, did not mention protectionism after negotiators said the U.S. objected to the wording. Trump has criticized the WTO and taken aggressive trade policies targeting China and the European Union.

- **U.S.-CHINA TRADE WAR:** Financial markets will be cheered by the U.S. announcement that Trump and Chinese President Xi Jinping agreed at a dinner after the summit to have a 90-day truce in Trump's initiated trade battle.

Trump agreed to hold off on plans to raise tariffs Jan. 1 on \$200 billion in Chinese goods. Xi agreed to buy a "not yet agreed upon, but very substantial amount of agricultural, energy, industrial" and other products from the United States to reduce America's huge trade deficit with China, the White House said.

The cease-fire will possibly buy time for the two countries to work out their differences.

- **SAUDI PRINCE UNDER PRESSURE:** There were some awkward moments for Saudi Crown Prince Mohammed bin Salman as some leaders called him out over the gruesome October killing of dissident Saudi newspaper columnist Jamal Khashoggi at the country's consulate in Istanbul.

French President Emmanuel Macron was captured on video seemingly lecturing bin Salman, at one point being heard saying "I am worried," "you never listen to me," and "I am a man of my word." Macron said the crown prince only "took note" of his concerns.

British Prime Minister Theresa May also said she pressed bin Salman.

President Recep Tayyip Erdogan of Turkey said Canadian Prime Minister Justin Trudeau raised the issue during the official session. Erdogan called bin Salman's response—that the crime had not been proven—"unbelievable" and complained that Saudi authorities have been uncooperative.

But it wasn't all bad for bin Salman. On the gathering's first day, he and Russian President Vladimir Putin engaged in a hearty grip-and-grin as the two seemingly reveled in their shared status as relative outcasts.

U.S. intelligence agencies concluded the Saudi prince was behind the killing. Saudi Arabia denies he played a role.

- **UKRAINE CONFLICT:** Western leaders confronted Putin over Russia's recent seizure of Ukrainian naval vessels and crews, but the diplomatic pressure didn't seem to bring either side closer to solving the conflict. Russia and Ukraine have accused each other of being responsible for the standoff.

Trump cited Russia's actions as the reason that he canceled a planned meeting with Putin on the sidelines of the summit. EU Council President Donald Tusk sharply criticized "Russia's aggression" against Ukraine.

Putin tried to convince Trump and the leaders of France and Germany that Russia's actions were justified—even pulling out a piece of paper and drawing a map of the disputed area to make his point.

- **CLIMATE CHANGE:** The final communique signed by all 20-member nations said 19 of them reaffirmed their commitment to the Paris climate accord. The only holdout was the U.S., which has withdrawn from the pact under Trump.

Still, environmental groups praised the statement as welcome news.

"That G20 leaders signed up to the Paris Agreement reaffirmed their commitment to its full implementation in the resulting communique is important," the World Wildlife Fund said. "It is also a reflection of the Argentinian government rightly making climate an important topic on the agenda."

Greenpeace said that "the necessity of the U.S. being part of the effort to fight climate change cannot be denied, but this is a demonstration that the

U.S. is still the odd one out."

- **NAFTA:** After two years of negotiations, Trump signed a revised North American trade pact with the leaders of Canada and Mexico on the sidelines of the summit. The deal is meant to replace the North American Free Trade Agreement, which Trump long denigrated as a "disaster."

The new pact won't take effect unless approved by the legislatures of all three nations, and there are questions about the pact's prospects in the U.S. Congress, especially now that Democrats will control the House. Democrats and their allies in the labor movement are already demanding changes.

But Trump said on the way back to Washington that he plans to formally terminate NAFTA, so Congress will have to choose between accepting the new pact or going without a trade accord. Trump gave no details about what changes, if any, were in NAFTA.

- **LOW EXPECTATIONS, LOW OUTPUT:** Even the host country had lowered expectations ahead of the summit, saying before the gathering started that it might not be possible to reach a consensus for a final statement.

After sleepless days of round-the-clock talks by diplomats, a communique was produced, but analysts said leaders merely signed a watered-down statement that skirted trade and other contentious issues.

"The G20 veered all over the road" at the summit and the leaders failed to fix trade, which is widely seen as a priority for boosting growth in jobs and economies, said Thomas Bernes, a distinguished fellow at the *Centre for International Governance Innovation* who has held leading roles with the International Monetary Fund, the World Bank, and Canada's government.

"Leaders buried their differences in obscure language and dropped language to fight protectionism, which had been included in every G-20 communique since the leaders' first summit. This is clearly a retrograde step forced by United States intransigence," Bernes said.

## Educator gets grant to improve health of Asian-Americans

YPSILANTI, Mich., Dec. 2, 2018 (AP): The federal Centers for Disease Control and Prevention has awarded nearly \$3 million to an *Eastern Michigan University* educator to lead an effort to improve the health of underserved Asian-American populations in Wayne and Kent counties.

Eastern Michigan says Professor Tsu-Yin Wu will serve as principal investigator on a cooperative agreement with the CDC. Wu teaches nursing in Eastern Michigan's College of Health and Human Services.

The team will develop, implement and evaluate interventions to address risk behaviors such as tobacco use,

poor nutrition and physical inactivity among Asian-Americans with heightened risks for diabetes and other chronic conditions.

The grant is for more than \$590,000 per year for five years. The CDC has committed funds for the first year. Subsequent funding will be based on the team's progress.

## Lo que pasó en la cumbre del G20 en Argentina

BUENOS AIRES, 2 XII 18 (AP): Los líderes de las 20 potencias mundiales acordaron reformar el sistema que regula las disputas comerciales, pero se toparon con la resistencia del presidente estadounidense en cuanto al acuerdo de París sobre maneras de combatir el calentamiento global.

Se vio un video en el que el presidente francés Emmanuel Macron parece amonestar a bin Salman, y se le escucha decir frases como "estoy preocupado", "Usted nunca me hace caso" y "soy hombre de palabra". Macron dijo solo que el príncipe saudí "tomó nota" de sus expresiones.

La primera ministra británica Theresa May también dijo que presionó a bin Salman.

El presidente turco Recep Tayyip Erdogan dijo que el primer ministro canadiense Justin Trudeau fue el único líder en hablar del tema en la sesión plenaria. Erdogan calificó la respuesta de bin Salman • que el crimen no ha sido demostrado • "inverosímil" y se quejó de que el gobierno saudí no estaba cooperando en el asunto.

Pero no le fue tan mal al príncipe saudí. No quedó aislado, y las cámaras captaron momentos en que bromearon con el presidente ruso Vladimir Putin, al parecer tomándose a la ligera su compartido status de parias a nivel internacional.

- **EEUU-CHINA COMERCIO:** Tras una cena juntos, Trump y el presidente chino Xi Jinping acordaron una tregua de 90 días en su disputa comercial.

Trump accedió a suspender sus planes de imponer aranceles sobre China el 1 de enero, contra productos chinos por valor de 200,000 millones de dólares. Xi accedió a comprar una cifra "sustancial" de productos estadounidenses a fin de reducir la brecha comercial entre los dos países.

El acuerdo le dará tiempo a las dos potencias para zanjar sus diferencias en cuanto a las ambiciones chinas de arrebatarle a Estados Unidos la vanguardia en el área tecnológica.

- **PRESIÓN SOBRE EL PRÍNCIPE SAUDÍ:** El príncipe saudí Mohammed bin Salman se encontró bajo presión pues algunos líderes le increparon sobre el asesinato del periodista

compromiso con el Acuerdo de París para combatir el cambio climático. El único país que quedó fuera fue Estados Unidos, pues bajo el gobierno de Trump, se retiró del pacto.

Aun así, grupos ambientalistas elogiaron la declaración.

"Que los líderes del G20 firmantes del Acuerdo de París hayan ratificado su compromiso hacia la total implementación en el comunicado final es un hecho importante", dijo el Fondo Mundial de Vida Silvestre (World Wildlife Fund). "Es además reflejo de que el gobierno argentino ha hecho del clima un tema importante en su agenda".

Greenpeace dijo que "es innegable la necesidad de que Estados Unidos sea parte del esfuerzo para combatir el cambio climático, pero esto demuestra que ahora Estados Unidos es el excluido".

- **TLCAN:** Tras dos años de negociaciones, Trump firmó un nuevo acuerdo de libre comercio entre Estados Unidos, Canadá y México. El pacto deberá reemplazar al Tratado de Libre Comercio de América del Norte (TLCAN), que Trump ha calificado de "un desastre".

Sin embargo, el acuerdo no entrará en vigencia a menos que sea aprobado por los Congresos de los tres países, y hay dudas de que prosperará en la legislatura estadounidense especialmente ahora que los demócratas controlarán la Cámara de Representantes. Los demócratas y sus aliados en los sindicatos ya están pidiendo cambios.

Pero en el avión yendo de regreso a Washington, Trump dijo que oficialmente declararía nulo al TLCAN, de manera que el Congreso tendrá que decidir entre aceptar el acuerdo nuevo o no tener acuerdo alguno.

## Despidos en GM son una advertencia para todos en EEUU

DETROIT, XII 18 (AP): Durante generaciones, el sendero profesional para los muchachos inteligentes en Detroit y sus alrededores era graduarse de ingeniería o negocios y entonces ser contratado por un fabricante de autos o sus piezas. Si uno trabajaba arduamente tenía un empleo de por vida, con suficiente dinero para mantener una familia, tomarse vacaciones y comprar una cabaña para fines de semana en el norte de Michigan.

Ahora esa ruta una vez confiable a la prosperidad parece estar desapareciendo, como lo evidencia el anuncio de General Motors esta semana de que planea eliminar 8.000 empleos de cuello blanco, aparte del despido de los 6.000 obreros que ya había anunciado.

Fue una advertencia aleccionadora de que en esta era de cambios tecnológicos rápidos y radicales, aquellos con educación universitaria no están necesariamente protegidos del tipo de despidos que los trabajadores fabriles conocen bien.

Los despidos reflejan una transformación en curso en la industria automovilística y la economía estadounidense en general, con casi todo tipo de negocio orientado ahora hacia las

computadoras, el software y la automatización.

“Es una gran megatendencia que permea la economía”, dijo Mark Muro socio en el centro de estudios Brookings Institution que ha investigado los cambios causados por la era digital.

Ciudades que perdieron empleos manufactureros hace décadas están lidiando ahora con el problema de menos oportunidades para empleados de cuello blanco, como gerentes, abogados, banqueros y contadores. Es un fenómeno visto en lugares como Wichita, Kansas, que está viendo despidos en su industria aeroespacial, y en ciudades en Wisconsin que han perdido empleos en los sectores de autos, maquinaria y muebles.

En el caso de GM, los empleos que serán eliminados a través de paquetes de liquidación y despidos son mayormente de trabajadores expertos en el motor de combustión interna: ingenieros mecánicos y otros que se pasaron sus carreras trabajando con inyectores, transmisiones, sistemas de emisiones y otros componentes que no serán necesarios en vehículos eléctricos que al final se conducirán de forma autónoma. GM, el mayor fabricante de autos en el país, dice que ése es el futuro.

“Se trata de personas que hicieron una inversión substancial en su educación”,

dijo Marina Whitman, profesora de negocios y políticas públicas en la Universidad de Michigan y execonomista principal para GM. “Las transiciones pueden ser extremadamente dolorosas para un grupo de personas”.

GM sigue contratando empleados de cuento blanco, pero los nuevos empleos son para quienes pueden escribir código de software, diseñar sensores láser o desarrollar baterías y otros dispositivos para los futuros vehículos.

Quienes están quedándose sin trabajo pudieran tener que aprender nuevas profesiones si quieren encontrar empleo, algo que resalta otra cosa que dice Whitman sobre la nueva economía: “Tienes que considerar tu educación un proceso de por vida. Probablemente vas a tener numerosos empleos en tu vida. Tienes que mantener flexibilidad”.

Whitman dice que los ingenieros mecánicos son personas inteligentes que pudieran transferir sus habilidades al software o las baterías, pero necesitarán entrenamiento, y eso requiere tiempo.

“Anteriormente, con estos cambios, tarde o temprano se creaban empleos nuevos”, dijo. “Sucedrá esta vez o es el cambio demasiado acelerado para que todo el mundo sea absorbido? No lo sé”.

## Argentina and China sign deals strengthening ties after G-20

BUENOS AIRES, Argentina, Dec. 2, 2018 (AP): China's president signed new trade deals with Argentina on Sunday as the Asian giant expands its growing role in Latin American economies.

President Mauricio Macri of Argentina and Xi Jinping of China announced the more than 30 agriculture and investment deals during a state visit following the *Group of 20 summit* in Buenos Aires. The deals include an agreement to export Argentine cherries to China and an expansion of a currency swap.

China is among Argentina's top export markets, especially for agricultural commodities that are the engine of its economy. It is also one of Argentina's biggest lenders, financing about \$18.2 billion in infrastructure and other projects, according to the Inter-American Dialogue, a Washington-based think tank.

“China's development benefits Argentina, our region and the world,” Macri said during a ceremony at the presidential residence in the outskirts of the Argentine capital.

“We have complementary countries. There are few countries in the world that can buy so many of the high-quality products that we're capable of making,” Macri said.

The visit comes after U.S. officials said they had reached a 90-day truce in the trade dispute with China that has rattled financial markets and imperiled global economic growth. That announcement followed a Saturday dinner meeting between Xi and Donald Trump.

Argentina also granted Xi the top honor awarded to foreign politicians, and the Argentine polo association gave the Chinese leader a polo horse. The South American country is home to the world's top polo players, and Macri said that he

wants the sport to make a comeback in China.

Photos released by Argentina's presidency showed a smiling Xi petting the pony with one hand and holding the reins with the other. Macri also put a red polo helmet emblazoned with China's flag on Xi's head.

Xi congratulated Macri on a successful summit and said both of their nations believe the *G-20* spirit of solidarity must prevail in “the firm defense of multilateralism and free trade to build an open global economy and foment the world's prosperity and stability.”

Xi then flew to Panama, which has been negotiating a free-trade deal with China after shifting its diplomatic recognition to Beijing from Taiwán last year, a move that led to complaints from U.S. officials.

Chinese companies operate ports on both ends of the Panama Canal, which for most of the 20th Century was seen as a symbol of U.S. influence.



## NEW REINSTATEMENT FEE AMNESTY INITIATIVE Effective January 31, 2019

COLUMBUS: House Bill 336, the *Reinstatement Fee Amnesty Initiative*, created a six-month program for driver license reinstatement fee reduction and waiver for offenders whose driver licenses have been suspended for specific violations. The initiative only applies to a driver license or permit suspension; it does not apply to a commercial driver license or commercial permit suspension.

The Ohio Bureau of Motor Vehicles (BMV) will determine an applicant's eligibility based on the defined permissible qualifying offenses contained in Ohio Revised Code.

In order to be eligible for reinstatement fee reduction:

- Applicants must have completed all court-ordered sanctions related to the eligible offense other than the payment of reinstatement fees.
- At least 18 months must have passed since the end of the period of the suspension ordered by the court.

Those able to provide proof of indigence will qualify for a complete amnesty of reinstatement fees. As stated in HB336, "indigent" means a person who is a participant in the supplemental nutrition assistance program administered by the department of job and family services pursuant to section 5101.54 of the Revised Code.

Effective January 31, 2019, to apply, complete BMV form 2829, a BMV Reinstatement Fee Amnesty Application. You may obtain the form at your local Deputy Registrar, online at [www.bmv.ohio.gov](http://www.bmv.ohio.gov) or it can be mailed to you by calling 614-752-7500.

## Demócrata insinúa que socio de Trump mintió a Congreso

En general, existe un elevado umbral jurídico requerido para demostrar tal cargo, pero Schiff dijo que "hay algunas personas que estoy seguro han alcanzado y superado ese umbral".

Corsi ha dicho que el correo electrónico enviado a Stone en respuesta \_el cual pronosticó con precisión que WikiLeaks publicaría información perjudicial sobre el presidente de la campaña de Clinton John Podesta en octubre\_ estuvo basado en su propia deducción y no en el resultado de alguna información fuente cercana al grupo.

Los fiscales de la oficina de Mueller habían ofrecido a Corsi un acuerdo para declararse culpable de un cargo por testimonios falsos, pero éste dijo que rechazó la oferta debido a que no engañó a sabiendas a los investigadores. Corsi dijo que ahora espera que sea acusado.

## Actriz egipcia irá a juicio por usar vestido revelador

EL CAIRO, 2 XII 18 (AP): Una actriz egipcia irá a juicio por cargos de obscenidad pública por usar un vestido revelador que, según dice, no tenía el objetivo de ofender a nadie e imploró a sus detractores acerar en sus buenas intenciones.

En una publicación en Facebook de la tarde del sábado, *Rania Youssef* dijo que juzgó mal cómo la gente reaccionaría al vestido que utilizó para la ceremonia de clausura del *Festival Internacional de Cine de El Cairo* de este año, que revelaba todas sus piernas a través de una gasa transparente.

“Quiero reiterar mi compromiso a los valores y ética que nos han inculcado en la sociedad egipcia”, dijo *Youssef*, cuyo comunicado no alcanzó a ser una disculpa.

Las imágenes de *Youssef* en el evento fueron muy compartidas en redes sociales y provocaron que un grupo de abogados presentara una demanda al procurador, quien rápidamente envió a la actriz a juicio. Muchas demandas se demoran meses o incluso más antes de que haya un dictamen, así que la rápida acción deja al descubierto el deseo de

tranquilizar a quienes se sintieron ofendidos. *Youssef* deberá comparecer ante la corte el 12 de enero.

El vestido y las noticias del juicio de *Youssef* dominaron la conversación en redes sociales durante el fin de semana, llegaron a la primera plana del domingo en varios periódicos y fueron tema de varios artículos de opinión.

Emad Hussein, editor del respetado diario independiente Al-Shorouk, dijo que *Youssef* tenía todo el derecho, en teoría, de usar el vestido que quisiera, pero que su “gran error” fue que “parecía más un traje de baño”.

“Hay una ley que prohíbe ofender al público pero, más importante, hay valores sociales que deben respetarse”, escribió el domingo.

Es caso es el más reciente de la aceptación del conservadurismo religioso por parte de las autoridades laicas en un país mayoritariamente musulmán, en donde el ejército en 2013, entonces liderado por el actual presidente Abdel-Fattah el-Sissi, derrocó a un presidente islámico elegido libremente, pero divisivo.
