

El Gran Muro: Kennedy lamenta firma por Bush de ley de muro fronterizo Por NESTOR IKEDA

WASHINGTON (AP): El senador demócrata Edward M. Kennedy lamentó el jueves que el presidente George W. Bush haya firmado la ley para construir centenares de kilómetros de vallas en la frontera sur cuando faltan menos de cinco de semanas para el cambio de gobierno en México.

"Estados Unidos está en un momento delicado de sus relaciones con México", dijo Kennedy, asegurando que Bush no tuvo en cuenta que el

Latino voters courted in numerous tight races

BRIDGEPORT, CN, Oct. 25, 2006 (AP): As a new poll showed the 4th Congressional District race dead even, Democrat Diane Farrell pulled out a new weapon from afar Tuesday, bringing in the governor of Puerto Rico to stump for her.

Farrell is hoping the large and growing Latino vote will make the difference in her effort to unseat Republican U.S. Rep. Chris Shays and help Democrats regain control of Congress.

The Fairfield County district is better known for the rich towns of Connecticut's Gold Coast, but it also is among 12 to 15 highly competitive congressional races around the country where Latino voters account for 10 percent or more of the electorate.

"The Hispanic vote is getting a tremendous amount of attention," said Adam J. Segal, director of the Hispanic Voter Project at Johns Hopkins University. "There's every reason to believe that Hispanic voters can make the difference in this election. That's exactly why you'd see a politician from so far away come to try to motivate the voters there."

Latinos are 10.7 percent of eligible voters in the 4th District, the highest percentage of any district in Connecticut, according to Pew

Hispanic Center.

The U.S. electorate this year is 8.6 percent Latino, up from 8.2 percent in 2004, according to the center.

Democrats hope to turn back the Republican Party's advances among Latino voters in recent years as they try to recapture control of Congress. President Bush's efforts to court Latino voters have helped double the GOP's share since 2000.

An analysis by the National Association of Latino Elected and Appointed Officials concluded that Latino voters can prove critical in competitive Senate races in New Jersey and Washington, and House contests in Connecticut, Illinois, Louisiana, New Mexico, Ohio, Texas, and Washington.

In each state, the number of Latinos has grown much faster than the non-Latino population since the start of the decade.

On Tuesday, Anibal Acevedo Vila, governor of Puerto Rico, echoed Farrell's criticism of the war in Iraq, saying the money could be better spent fighting poverty in Bridgeport and to improve health care and education.

"Her priorities are very similar to my priorities as governor," Acevedo said at a community center in Bridgeport. "You don't go to Congress to make the rich more richer."

He also said he would urge people listening to a local Spanish-language radio station to vote for Farrell.

Michael Sohn, Shays' campaign manager, said Democrats run Bridgeport. Shays, who lives in Bridgeport, has worked hard to bring jobs and economic growth to the city by securing millions of dollars for transportation projects and money for after-school programs, a museum, emergency shelter, hospital and other projects, his campaign said.

"Is it more important to bring the governor of Puerto Rico here or show results in Bridgeport," Sohn said. "It's just more rhetoric and no substance from Diane Farrell."

Farrell said Shays and other Republicans have neglected those who need help the most in cities such as Bridgeport, while spending \$250 million daily on the war in Iraq. She endorsed tax incentives for businesses that create jobs.

"I believe that when we level the playing field for small business, we'll see less vacant storefronts not only here in Bridgeport, but across the district and around the nation," Farrell said.

The race is a rematch of the 2004 contest, which Shays won with 52 percent of the vote to Farrell's 48

percent. The district is one of three in Connecticut that Democrats are targeting as they try to win the 15 seats they need to take back the House.

A poll released Tuesday by the University of Connecticut and The Hartford Courant found each candidate with support from 43 percent of likely voters, with the war in Iraq as the driving issue.

Acevedo also has campaigned for Democratic Sen. Robert Menéndez, who faces a close race in New Jersey. Others, such as New Mexico Gov. Bill Richardson, have been helping candidates trying to reach Latino voters, said Segal, the Hispanic Voter Project director.

Radio is a particularly powerful way to reach Latino voters, Segal said, citing the massive immigration rallies over the past year.

presidente electo Felipe Calderón llegaba al gobierno después de unas elecciones que "pusieron a prueba las instituciones políticas mexicanas y desafiaron su democracia".

Dijo que Estados Unidos tendrá en los próximos seis años que trabajar con Calderón, un político del mismo partido del presidente saliente Vicente Fox que ha expresado que "la valla incrementará las tensiones e inseguridad en la frontera".

La Casa Blanca ha anunciado antes de la firma de la ley del muro que Calderón vendrá a Washington para una entrevista con Bush el 9 de noviembre.

Kennedy, promotor de una reforma más integral de las leyes de inmigración en el Senado, formuló sus comentarios por escrito luego que Bush convirtiera en ley el proyecto de la valla que fue apoyado mayormente por republicanos radicales de la Cámara de Representantes.

Nancy Pelosi, líder de la mayoría demócrata, calificó la firma de la ley por Bush como "expresión de un catastrófico fracaso" de los republicanos para buscar soluciones integrales a la situación de

11 millones de indocumentados que ya viven en Estados Unidos.

Pelosi sería la nueva presidenta de la Cámara de Representantes en caso que los demócratas ganen el control de esa cámara en las elecciones del 7 de noviembre.

La Ley de la Cerca de Seguridad 2006, como se llama el proyecto firmado por Bush en la Casa Blanca, tendrá meramente el efecto de "un slogan" en la búsqueda de una solución al cruce fronterizo por indocumentados, dijo Kennedy, de Massachusetts.

Dijo que Bush y el Congreso "tuvieron una oportunidad histórica de aprobar este año un plan integral y justo sobre inmigración, pero la desaprovecharon ante la preocupación republicana de concentrarse en obtener votos más que proporcionar soluciones".

Kennedy y el senador republicano John McCain son autores de un proyecto que pide más seguridad en la frontera mediante el cumplimiento estricto de las leyes de inmigración y la activación de un programa de trabajadores por tres años, con posibilidad de residencia permanente para los inmigrantes.





Authorities pull five bodies from Rio Grande

McALLEN, TX, Oct. 23, 2006 (AP): Authorities pulled five bodies from the Rio Grande River in an area known as a crossing place for undocumented immigrants. Starr County Sheriff Reymundo Guerra said Mexican authorities notified Starr County deputies that the bodies were floating in the river near the U.S. side. The bodies were found Monday evening just below Falcon Dam. The cause of death for the five people was unknown. An autopsy was planned. Authorities said a search for more bodies would continue overnight. An official with the Salinero Volunteer Fire Department said the dead included four men and one woman, all dressed in civilian clothes. The bodies were found near the rural town of Chapeno. Carlos Delgado, an investigator for the Starr County district attorney's office, said the bodies were decomposed and could have been dead for a week. El Gran Muro: Calderón y Harper hablan sobre cooperación

OTTAWA (AP): El primer ministro Stephen Harper ofreció el jueves un cauto apoyo moral al presidente electo mexicano Felipe Calderón, que se opone a la medida estadounidense de erigir un muro de 1.126 kilómetros a lo largo de su frontera sur. El mismo día en que comenzó una visita a Canadá, Calderón se vio ante el que probablemente sea uno de los asuntos más complejos en su próximo gobierno. El presidente estadounidense George W. Bush firmó el "proyecto de ley para una valla de seguridad" en una ceremonia efectuada en Washington, una medida diseñada para impulsar la imagen de los republicanos en los estados fronterizos antes de las elecciones legislativas a efectuarse el 7 de noviembre. Ante una pregunta planteada por medios de comunicación mexicanos acerca de la valla, Harper respondió haciendo énfasis en que Canadá y México tienen distintos asuntos por resolver en sus fronteras. Sin embargo, dijo también que

el gobierno canadiense también le ha presentado a Estados Unidos sus propios argumentos en contra del establecimiento de barreras físicas. Ottawa aún está luchando contra una ley establecida por Washington que a la larga requeriría que todos los canadienses porten un pasaporte o una identificación confiable para entrar a territorio estadounidense. "Creo que en repetidas ocasiones hemos dicho como país en nuestras relaciones con Estados Unidos que compartimos la preocupación de los estadounidenses para tener fronteras seguras", dijo Harper. "También creemos que a la larga va en favor de los intereses económicos de todos". "Al mismo tiempo", agregó, "obviamente emitimos una advertencia contra cosas que pueden generar barreras innecesarias, no sólo al comercio sino también al intercambio ordinario de turismo y relaciones sociales entre nuestros países".

Calderón, que asumirá el puesto el 1 de diciembre, criticó el proyecto de ley estadounidense. Tras reunirse con Harper en la Colina del Parlamento, Calderón consideró que la decisión de construir el muro en la frontera "es deplorable", e indicó que esa medida no resolverá ningún problema. El próximo mandatario dijo que la humanidad cometió un "enorme error" al construir el Muro de Berlín, y consideró que hoy en día Estados Unidos está "cometiendo un grave error" al construir la valla en la frontera con México. Detroit's Univision TV affiliate names Tejana as General Manager

DETROIT: Univision's Detroit television affiliate, WUDT-TV, has named Latina broadcast veteran Jessica S. Pellegrino as the station's General Manager. WUDT-TV is owned by Equity Broadcasting of Little Rock, Arkansas, ranked as the ninth largest broadcast company in the United States.

Broadcasting on Channel 23, WUDT-TV last year became the first Detroit-area television station to offer daily local news broadcasts in Spanish.

Pellegrino was previously the station's director of government and community affairs.

Born in Laredo, Texas, Pellegrino moved with her family to San Antonio when she was 12. "I still have family in both cities," she says. Her parents are César and Alice Cano.

An experienced veteran of the broadcasting industry, Pellegrino spent about a dozen years working in many aspects of radio and television broadcasting. While living in Texas, she worked at SER National in Dallas.

Pellegrino has lived and worked in Detroit since Feb. 1992, and most of her broadcast experience in Michigan has been in marketing and corporate development.

During a telephone interview this weekend, she told *La Prensa* that the station's production and news reporting is done locally and then transmitted to Equity's headquarters in Little Rock, where the local newscasts are prepared for their Univision affiliates.

"Our news team covers three or four stories locally every day which we send to Little Rock by computer. That's where the newscasters do weather, sports and news for six different mar-

kets. Every newscast is tailored to the market, and the news is fed to Little Rock by computer daily. Our reporter is in cell phone contact with the control room in Little Rock," explains Pellegrino.

Equity Broadcasting has 125 employees in Little Rock. The company, which also owns several professional sports teams, produces all the news for the 52 television stations they own and operate.

Every station in the group has its own general manager, sales department, and handles production of their local commercials. Pellegrino says she is not alone in being a woman at the top of the operation. She believes many of the general managers at Equity Broadcasting are female because women have long occupied the key internal positions in radio and television broadcasting from their traditional role in traffic through sales and operations.

WUDT Univision pro-

duces two local information and public affairs shows each week including *Informando*, hosted by Alma Lara and Gustavo Potes. Pellegrino says recent guests have included New Mexico Governor Bill Richardson and Michigan's Governor Jennifer Granholm.

The station also takes an activist stance for the Latino community, says Pellegrino. "We are currently conducting a voter registration drive because we stress to our viewers that government and the political parties pay attention to us and our issues when we vote," she explains. Other key issues for Pellegrino and the station are Michigan's Affirmative Action initiative and the building of the wall on the Mexican-US border.

Pellegrino's rise at Univision parallels the growth of Latino media nationwide. She says the Latino population in Grand Rapids has grown by 300 percent and Detroit

has seen a 44 percent increase. And she has the economic statistics to bolster her case.

"Latinos open new businesses at a rate three times as great as the (rest of the) population," says Pellegrino.

Divorced, she has three children: Michael, 24, who lives in San Antonio; Margaret, 20, who is a pre-med student at Wayne State University; and a 17-year-old son, A.J., who is a junior in high school.



Should next Ohio governor fill court vacancies based on merit, not politics?

A national reform group urged the next governor of Ohio to enact by executive order a judicial nominating commission to screen judicial appointments to Ohio's courts. *Justice at Stake*, which works to protect courts from special interests and partisan pressure, urged whoever wins this November's election to forgo basing judicial appointments on party politics.

"Serious conversations lie ahead about reforming Ohio's judicial elections. But with a stroke of a governor's pen, judicial nominating commissions can help ensure that every judge picked to fill mid-term vacancies meets the highest ethical and professional standards," said Bert Brandenburg, executive director of Justice at Stake, a non-partisan national campaign working to keep courts fair and impartial. "Regardless of who wins on November 7th, Ohio voters will win if the next governor minimizes courtroom partisanship."

All of Ohio's judges stand for election to retain their seats, but the governor has the ability to fill mid-term vacancies through a method of his or her choosing. Under the current administration, the practice "has been to request recommendations from party leadership in counties where vacancies exist," according to

the nonpartisan American Judicature Society.

In Ohio and around the country, judges frequently come to the bench to fill interim vacancies, and are thereafter retained in elections as "incumbents." Ohio is one of only a handful of states that does not employ a judicial nominating commission, formally or informally, at any level of judicial selection. One recent study found that in the 1964-2004 period, 37 percent of Ohio Supreme Court justices reached the bench through an interim appointment.

Many states, like Missouri, have such commissions enshrined within their state constitution as part of their normal procedure for appointing judges of the highest caliber. Others, like Minnesota, have adopted informal processes—often through executive order—as a means of minimizing the appearance that judges are being chosen for reasons other than their qualifications and experience.

Justice at Stake is a nonpartisan national partnership of more than 45 state and national organizations working to keep U.S. courts fair and impartial. Ohio Citizen Action and the Ohio League of Women Voters are campaign partners. Ohio's Chief Justice, Thomas Moyer, sits on Justice at Stake's board of directors.

Ohio high court says charter schools are constitutional

COLUMBUS, Oct. 25 (AP): Ohio charter schools won a key court victory Wednesday, when the Ohio Supreme Court ruled that publicly funded, privately held alternative schools are constitutional.

Charter school advocates hoped the court's 4-3 ruling would settle a five-year battle with public school advocates over whether their schools deserve to exist.

"I think there needs to be an end to the finger-pointing and a willingness to work together for the overall good of our children and of our state," said Perry White, chairman of the steering committee for the fledgling Ohio Alliance of Public Charter Schools.

But opponents of the movement—including teachers' unions, school boards, and the Ohio PTA—vowed to keep fighting.

"This is only the beginning of the fight from my point of view," said state Sen. Teresa Fedor, a Toledo Democrat who sits on the Senate Education Committee.

"This is a system that is set up, by design, to dismantle everything."

The court upheld the state Legislature's ability to create and give money to charter schools even if they are not subject to the same reporting and operational requirements as other public, or common, schools.

"As the state body, the General Assembly has the legislative authority and latitude to set the standards and requirements for common schools, including different standards for community schools," Justice Judith Lanzinger wrote for the majority.

Teachers' unions, later joined by the other groups, sued Ohio in 2001 over the state's 1998 charter school law, under which the alternative schools have grown from 15 in

1998 to 250 last year. As the movement has grown, criticism has intensified, particularly over charter school students' lagging standardized test scores.

State auditors in August identified slightly more than \$20 million in state money given to charter school operators that they believe was inadequately monitored in 2005 because Ohio Department of Education officials failed to make necessary site visits and other checks.

And just this week, the founder of a high-performing Cincinnati charter school, the W.E.B. DuBois Academy, was indicted on theft and other charges for stealing from the school's state stipend.

But Lanzinger wrote that Ohio's public school system before charter schools also got a bumpy start.

"Just as the common-school movement of the 1800s increasingly gained supporters throughout the United States, so too has the charter-school movement," she wrote.

In her dissent, Justice Alice Robie Resnick countered that, "whether the 'charter-school movement' has truly gained supporters or opponents, nationally or in Ohio, is a subject of social discourse for the political branches of our government."

In his dissent, Justice Paul Pfeifer said he agrees with the premise that charter schools are constitutional but disagrees that Ohio's charter schools are.

"Irrespective of the noble intentions of charter-school legislation, one undeniable effect is that public schools receive less money than they would in the absence of charter schools," Pfeifer wrote. "The mathematically unavoidable result is that public schools receive a greater percentage of their funding from local sources,"

First-ever group of Toledo Latino students visits OSU campus on recruitment trip

TOLEDO/COLUMBUS: Not even a steady downpour and high winds could dampen the spirits of the busload of Toledo Latino students who participated in the Scarlet and Gray Day activities at Ohio State University held here on Oct. 27, 2006.

The 18 students, all but four of them seniors from area high schools, were the first Toledo Latino honor students to be invited to attend the OSU recruiting festivities.

Outstanding local Latino students have traditionally been invited to similar programs at the University of Toledo and Bowling Green State University, says José Luna, Bilingual Educational Coordinator for Toledo Public Schools.

What has kept Toledo Latino students from considering the Buckeyes as an option? Luna says Ohio State's grade average requirements have been somewhat higher, "well into the 3.0 range," than those of the Toledo area's universities.

Another factor has been arranging transportation to Columbus. Luna said it costs a minimum of \$500 to charter a bus, a major problem for the cash-strapped TPS system. TPS buses were out of the question because they needed to be returned by 2 p.m. to pick up junior high school students, and the OSU event was scheduled to run into early afternoon. Luna said the bus to OSU planned to leave at 6:30 a.m. in order to arrive in Columbus at 8:30, and would not return to Toledo until after 4:30 p.m.

So how did Luna find a bus for the trip? David Ibarra, Assistant Principal

of Whitmer High School, had earlier told Luna about a friend, Normando Cabán, the Director of the Office of Minority Affairs at OSU.

Luna had contacted Cabán about a student from Port Clinton who wanted to go into a medical program, and Cabán was able to set up a tour of OSU for the student.

That's when Luna learned that Latino students from all over the United States, especially those from California, Texas, Florida and New York, visit OSU, but very few students who take the recruitment tour are from Ohio.

Luna and Cabán discussed OSU's requirements and then Cabán asked Luna, "What if I pay for the bus?" The funds came from OSU's Office of Minority Affairs, and the result was the Oct. 27 bus trip.

Unfortunately, no one could have predicted the weather. "We got there late because of traffic and missed the breakfast. But still, it was a great day for the kids. Each one had a positive experience," said Luna.

Each student was escorted to the individual building housing the school of their academic interest, including nursing, business, law enforcement, law, engineering and early childhood education.

"They talked to the students about the university's high expectations and the different scholarships that

are available including one of the largest scholarship programs available anywhere in the country. They also were told about the various internships to prepare the students for the real world, as well as all of the overseas learning opportunities. These are all programs designed to make them ready for the job market," explained Luna.

Afterward, the students were served lunch. Luna said the full menu was a far cry from the pizza the students usually get on trips to area universities.

After lunch, there was a session for the students and their parents. The one mother who was to accompany the Toledo contingent was unable to go at the last minute. Several students told Luna their parents would certainly have attended had they known of the afternoon session.

There were about 350 students and 75 parents from all over the country at the session. Luna said the Toledo students were possibly the only Latino kids there, although there may have been a handful of others in the overall group.

Cabán was optimistic that Toledo students would fill the

bus next year. Because OSU looks at students in the Top Ten of their school, Luna thinks students with a 3.2 from Libbey or other high schools might qualify. This would put OSU in competition with BGSU which offers free tuition to graduating seniors with a 3.0 average and a 21 on their ACT.

Cabán was invited by Luna to attend the TPS Latino Youth Summit next May.

Although the bus was late getting back, Luna said it returned in time for several Waite students to participate in Friday night's football game, including its quarterback, Jacob Moreno, who threw the touchdown pass when Waite HS defeated Woodward HS, 6 to 0.

Los Cardenales ganan su décima Serie Mundial

SAN LUIS (AP): Los Cardenales de San Luis, un equipo que hace un mes estuvo al borde de quedar fuera de los playoffs, ganó la décima Serie Mundial de su historia al vencer el viernes 4-2 a los Tigres de Detroit.

Jeff Weaver lanzó una joya monticular al cubrir ocho innings para llevarse la victoria, su tercera en la postemporada.

Adam Wainwright hizo abanicar el tercer strike a Brandon Inge para sellar la victoria de San Luis y desatar la algarabía en su casa del Busch Stadium ante 46.470 fanáticos teñidos de rojo.

Yadier Molina, que anotó dos carreras y disparó tres hits, fue uno de los faros del ataque de San Luis, en otro partido en el que los errores defensivos de Detroit cavaron su propia fosa.

Al imponerse cuatro juegos contra uno, San Luis desbarató los pronósticos que apuntaban a que los Tigres se los llevarían por delante en el Clásico de Otoño.

Detroit llegó a la serie con una semana de descanso tras ganar siete partidos consecutivos, pero la inactividad pareció su peor enemigo, al cometer ocho errores.

San Luis se proclamó campeón con todo y que su mejor artillero, el dominicano Albert Pujols, hizo muy poco en la serie. Pero contó con el inesperado resurgir ofensivo del puertorriqueño Molina, así

como el aporte de Scott Rolen y David Eckstein, a la postre el más valioso de la serie.

"Le tapamos la boca a mucha gente", dijo Molina sobre los vaticinios de que no pasarían de la primera ronda.

El décimo título de los Cardenales, y primero desde 1982, les ubica en el segundo lugar de ese departamento. Los Yanquis de Nueva York, con 26 conquistas, es el equipo más laureado de la historia.

Con su récord de 83-78, los Cardenales son el equipo con la menor cantidad de victorias que gana la Serie Mundial. Minnesota ganó 85 en 1987 al vencer a San Luis ese año.

Además, el mánager Tony La Russa, campeón con los Atléticos de Oakland en 1989, pasó a los anales del clásico al emular a Sparky Anderson (Cincinnati y Detroit) como los únicos dirigentes en consagrarse con equipos de ambas ligas.

También fue la primera vez desde 1912, cuando los Medias Rojas se impusieron en el Fenway Park de Boston, que un equipo se adjudica la serie en casa en un estadio inaugurado en la misma temporada.

Llovió todo el día en San Luis, pero se despejó un par de horas antes del primer lanzamiento. La temperatura al inicio era de 8 grados centígrados (47 Fahrenheit), pero se sintió más frío debido a una fuerte brisa.



Tratando de seguir con vida, el piloto de Detroit Jim Leyland mandó a lanzar a Justin Verlander, el novato de 23 años que perdió el primer juego. Inició con la brújula perdida al congestionar las bases con pasaporte y tirar un par de lanzamientos descontrolados.

Pero logró escapar bien librado tras 35 pitcheos. En cuenta de 3-2 y dos outs, el dominicano Ronnie Belliard conectó un roleta por el medio del cuadro interior que el torpedero venezolano Carlos Guillén recogió a tiempo y sacó al corredor por apenas un paso en la inicial.

San Luis logró adelantarse en el segundo, cuando Molina abrió con sencillo, avanzó a segunda con un toque de sacrificio de So Taguchi y luego a tercera con un roletazo de Weaver.

Eckstein conectó una batazo por la raya de la tercera base que Inge logró atrapar, pero su tiro a la inicial fue muy abierto, permitiendo que Molina anotara. A Inge se la acreditó el error, su tercero en la serie.

Weaver, un derecho que los Cardenales contrataron a mitad de temporada cuando los Angelinos de Los Ange-

les le dieron de baja para ascender a su hermano Jered, limitó a los Tigres a dos hits en los primeros tres innings.

Pero en un abrir y cerrar de ojos, Detroit le dio la vuelta en el cuarto. El guardabosques derecho Chris Duncan dejó caer un elevado de Magglio Ordóñez. Al siguiente lanzamiento, Sean Casey conectó un jonrón a las tribunas del mismo jardín.

Apilando más errores, los Tigres cedieron la ventaja inmediatamente.

Molina y Taguchi dieron sencillos con un out en la baja del cuarto. Weaver se sacrificó y Verlander tenía servido un out fácil en la antelala, pero tiró mal con lo que Molina anotó. Acto seguido, Eckstein remolcó a Taguchi con una roleta al campocorto, poniendo la pizarra 3-2.

Ocho de las 22 carreras permitidas por los Tigres fueron producto de errores. La de Verlander fue la quinta pifia de lanzador de Detroit en la serie, y la segunda en su cuenta personal.

"El equipo no pudo jugar a su mejor nivel", dijo Leyland. "No voy a poner excusas", dijo Leyland.

La fatídica secuencia de ese inning pareció ser la estocada definitiva que hirió de muertes a los Tigres, que se quedaron con las ganas de conseguir su primer campeonato desde 1984 y que hace tres años perdieron 119 juegos.

Verlander trabajó seis entradas en las que admitió seis hits y tres carreras, dos




Dan al gobernador de Oaxaca un plazo de 72 horas para que renuncie

México, D.F.— A partir de este viernes, Oaxaca podría estar en virtual estado de sitio, debido a que la Asamblea Popular de los Pueblos Oaxaqueños (APPO) amenaza con efectuar un bloqueo de carreteras en todo el estado, instalar las barricadas en toda la capital de esa entidad y, por primera vez, convocar a la población a realizar un boicot en contra de los grandes centros comerciales y cadenas transaccionales.

El llamado a estas nuevas actividades de protesta, mediante la lectura de un comunicado, se realiza a través de las estaciones de radio que en aquella ciudad mantiene tomadas dicha organización civil en rebeldía, al tiempo que dan un plazo de 72 horas al gobernador Ulises Ruiz Ortiz para que renuncie el puesto.

Pese a que tales exhortos se están haciendo en aquella región del sureste de México, la versión fue confirmada en el Distrito

Federal por Flavio Sosa, dirigente de la APPO, quien encabeza un plantón que lleva nueve días frente al Senado de la República.

Aseguró que "hay una gran indignación en Oaxaca porque no hacen nada para solucionar el conflicto, y esta responsabilidad recae exactamente en el gobierno federal".

Hizo énfasis en que el punto de partida para solucionar la crisis consiste en la destitución del mandatario estatal, del Partido Revolucionario Institucional, y en seguida la realización de reformas económicas, políticas y sociales en beneficio de la población.

Asimismo el líder de la APPO corroboró que la militancia de esta agrupación deberá respetar la decisión, si la Sección 22 del Sindicato Nacional de Trabajadores de la Educación (SNTE) decide reanudar las clases, luego de una consulta que se lleva a cabo entre los profesores de las regiones



rurales y urbanas.

Sosa aclaró que está en desacuerdo con que se abran las escuelas sin la aprobación de los padres de familia, pues, "son los directamente involucrados", y que la medida es para proteger a los estudiantes de grupos de porros enviados por la gubernatura de Oaxaca.

Mientras tanto, cientos de integrantes de la referida asamblea llevaron a cabo una manifestación frente a la sede de la Organización de las Naciones Unidas (ONU), en la Ciudad de México, con el objeto de empezar a extender el contexto del conflicto a nivel internacional.

Los activistas entregaron un documento a una comisión de tal institución mundial, en el

cual describen la problemática en Oaxaca y denuncian las presuntas violaciones y el abuso de autoridad del gobierno encabezado por Ruiz Ortiz.

Al mismo tiempo, en la zona norte del istmo de Tehuantepec, cientos de maestros marcharon para condenar la alianza entre los senadores del PRI y del Partido Acción Nacional (PAN) que la semana pasada impidió la desaparición de poderes en su estado.

Por su parte, el secretario de Educación Pública, Reyes Tamez Guerra, aseguró que el gobierno federal cuenta con un plan alternativo para resolver la suspensión del año escolar en Oaxaca, que ha afectado a miles de niños y adolescentes.

Se negó a anticipar algún detalle del proyecto porque "las cosas que decimos las bloquean, y cuando ya existen negociaciones hay muertos" y ello, lamentó, frena la posibilidad de diálogo entre las partes involucradas.

Sin embargo, garantizó que a juzgar por la evolución que recientemente ha tenido el problema, hay indicios para pensar que "a la brevedad los niños oaxaqueños podrán regresar a clases". ■



Se registran gastos récord para elección

Washington DC.- La campaña electoral para los comicios legislativos del 7 de noviembre en Estados Unidos, será la más cara hasta ahora, con un gasto de 2 mil 600 millones de dólares, reveló un grupo independiente que investiga el gasto electoral.

"El 2006 será el de la elección más cara para el Congreso de Estados Unidos", dijo Sheila Krumholz, directora

ejecutiva del Center for Responsive Politics, institución que analiza la influencia del dinero en los procesos electorales y la política pública.

La investigación conducida por el grupo encontró que el gasto de los candidatos en la campaña de este año tiene un incremento del 18 por ciento sobre las últimas elecciones de mitad de

mandato en 2002.

"El dinero en esta campaña ha fluído rápida y furiosamente", agregó Krumholz, y añadió que la proyección del gasto de 2 mil 600 millones de dólares es "un estimado conservador" que podría resultar aún mayor el día de las elecciones.

"Los candidatos aún en carrera para la Cámara de Representantes han gastado en promedio 760 mil dólares, mientras que los candidatos del Senado han gastado 5.8 millones de dólares desde 2001", dijo Krumholz, refiriéndose al estudio publicado a exactamente dos semanas de las legislativas.

"Los senadores en ejercicio tienen en promedio una ventaja de cuatro a uno sobre sus rivales, y los representantes en ejercicio superan a sus actuales rivales por siete a uno", acotó.

El centro anotó que el gasto de la elección de 2004 fue de 4 mil 200 millones de dólares, pero que el costo mayor refleja el gasto adicional asociado con las elecciones presidenciales entre el George W. Bush y el demócrata John Kerry. ■

Cancelan desfile; dejan cancha a AMLO

Ciudad de México.- El desfile deportivo con el que el gobierno conmemoraba el 20 de noviembre será cancelado y en su lugar se realizará una ceremonia cívica en Los Pinos.

El vocero de la Presidencia, Rubén Aguilar, descartó que la eliminación se deba a que ese día Andrés Manuel López Obrador vaya a asumirse como "presidente legítimo".

"No tiene nada que ver. Entiendo que este evento (...) será en el Monumento a la Revolución, así ha sido anunciado. Entonces, tiene otro carácter", dijo.

Sin embargo, el evento de López Obrador está convocado en el Zócalo a las 15:00 horas. Aguilar explicó que el desfile había venido desgastándose, e incluso, varios deportistas habían anunciado su deseo de no participar.

"Nuestro País está inmerso en un proceso de profundas transformaciones



(...), esto nos lleva a replantearnos la pertinencia de viejos ritos y la necesidad de revalorar las fechas significativas", dijo.

El presidente del Senado, Manlio Fabio Beltrones, consideró que con la cancelación del desfile Fox le quiso sacar la vuelta al perredista. "Estoy confiado en que López Obrador no piense en hacer otra celebración el 12 de diciembre, porque a lo mejor también acaba con los festejos de la Virgen de Guadalupe", ironizó. ■

El Gran Muro: México y 27 países más critican muro fronterizo de EEUU

MEXICO (AP): México, apoyado por otros 27 países emitió el miércoles una declaración en la Organización de Estados Americanos, en la que criticó los planes de Estados Unidos para construir un muro fronterizo de cientos de kilómetros en la frontera.

La declaración, leída en las oficinas generales de la OEA en Washington, señaló que los muros no resuelven el problema de la inmigración sin documentación, e instó al gobierno estadounidense a reconsiderar su posición, de acuerdo con comunicados de prensa del organismo y de la Secretaría de Relaciones Exteriores de México.

Las 28 naciones expresan su "profunda preocupación" por la decisión estadounidense, la cual "constituye una medida unilateral contraria al espíritu de entendimiento que debe caracterizar la atención de los problemas comunes entre países vecinos, y afecta la cooperación en el hemisferio".

La declaración fue leída por el embajador mexicano Alejandro García Moreno.

Estados Unidos se negó a

firmar la declaración. Su embajador Robert Manzanera dijo que no podía atacar una decisión tomada por el poder legislativo de su país, de acuerdo con el comunicado de la OEA.

El mes pasado, el Senado estadounidense aprobó una iniciativa para construir una valla fronteriza de 1.100 kilómetros (700 millas). El presidente estadounidense George W. Bush promulgaría la ley el jueves, pese a que el gobierno mexicano lo ha instado a vetarla.

El presidente mexicano ha considerado "vergonzosa" el muro y la ha comparado con el Muro de Berlín.

Unos 11-12 millones de mexicanos viven en Estados Unidos, aproximadamente la mitad en forma ilegal.

Los 27 países que apoyaron a México en la declaración del miércoles fueron Antigua, Argentina, Barbados, Belice, Bolivia, Brasil, Colombia, Costa Rica, Chile, Ecuador, El Salvador, Granada, Guatemala, Guyana, Haití, Honduras, Jamaica, Nicaragua, Panamá, Paraguay, Perú, San Cristóbal y Nevis, San Lucía, San Vicente, Surinam, Uruguay y Venezuela.

• México gets support of 27 OAS nations to attack U.S. plans for double-layered border wall—El Gran Muro!

MEXICO CITY (AP): México, supported by 27 other nations, made a declaration at the Organization of American States (OAS) slamming U.S. plans to build hundreds of miles of double-layered wall on its southern border.

The declaration, read aloud Oct. 25th at the OAS headquarters in Washington, D.C., said the barriers would not solve the immigration problem and urged the U.S. government to rethink its position, according to press releases from the OAS and Mexican foreign ministry.

The 28 nations express "deep concern regarding the decision adopted by the United States of America to build and extend a wall on its border with México, considering it to be a unilateral measure that goes against the spirit of understanding," it said in the declaration, which was read out by México's Ambassador Alejandro García Moreno.

The United States refused to sign the declaration, with its Ambassador Robert Manzanera saying it could not attack a decision made



by its legislative bodies, according to the OAS release.

Last month, the U.S. Senate approved a bill to build 1,100 kilometers (700 miles) of border wall—El Gran Muro. U.S. President George W. Bush signed it into law, despite pleas from the Mexican government for a veto.

Mexican President Vicente Fox has called the

plan "shameful" and compared it to the Berlin Wall.

An estimated 11-12 million Mexicans live in the United States, about half of them without documentation.

The 27 nations that supported México in the declaration were: Antigua, Argentina, Barbados, Belize, Bolivia, Brazil, Colombia,

Costa Rica, Chile, Ecuador, El Salvador, Granada, Guatemala, Guyana, Haití, Honduras, Jamaica, Nicaragua, Panamá, Paraguay, Perú, San Cristóbal and Nevis, San Lucía, San Vicente, Suriname, Uruguay, and Venezuela.

México has also said it will challenge the wall plans at the United Nations.

Castro aparece en televisión y se defiende de rumores

LA HABANA (AP): Para defenderse de los rumores de que está muerto, el presidente cubano Fidel Castro apareció en la televisión isleña el sábado por la tarde y se burló de sus "enterradores".

Castro, de 80 años de edad, se veía flaco, pero se lo mostró leyendo en voz alta el periódico del día, completamente lúcido y caminando despacio.

"Prematuramente me han declarado moribundo o muerto. Me complace enviar a mis compatriotas y amigos de todo el mundo este pequeño material fílmico", dijo Castro mirando a la cámara.

El video fue grabado por la Mesa Redonda, un programa que se difunde todos los días en las cadenas televisivas, es de carácter estatal y en él suele fijarse posición oficial sobre temas de interés para la población.

El 31 de julio, el mandatario delegó temporalmente el poder _debido a que fue intervenido quirúrgicamente para detenerle una hemorragia intestinal_ en su hermano, el vicepresidente y ministro de Defensa, Raúl Castro, cinco años menor que él.

La sorpresiva noticia generó toda suerte de

especulaciones sobre el verdadero estado de salud del histórico líder de la revolución cubana, quien no había tomado una decisión semejante de dejar interinamente su puesto en más de cuatro décadas de gobierno.

Posteriormente Castro recibió en su lecho de enfermo a varias personalidades y amigos que lo saludaron sobre todo durante la Cumbre de los No Alineados (NOAL) a mediados de septiembre, según fotos, cintas y hasta una entrevista difundida entonces, pero después volvió a desaparecer del escenario público dando lugar a nuevos rumores.

Vestido con un mono deportivo azul, blanco y rojo, el mandatario aseguró que se sentía "entero" y que en la medida de sus posibilidades trataba de ayudar a las personas encargadas de las labores de gobierno en estos días.

"Observo las principales noticias por la televisión... también participo de las decisiones más importantes, con los compañeros de la dirección del Partido (Comunista) y del gobierno, hago todo lo posible por apoyar a los compañeros y ser útil", expresó el barbado dirigente.

Castro comentó que las "boberías" de matarlo antes de tiempo y los rumores lo estimulan "a trabajar y a luchar". Sin embargo, dijo

que tal como lo había anticipado su recuperación será laboriosa.

"Voy evolucionando tal como estaba previsto... Me siento entero", comentó antes de despedirse con uno de sus habituales "Patria o Muerte, venceremos".

El líder se encuentra recluso en un centro hospitalario no identificado y se carece de un parte médico sobre sus condiciones físicas.

Según el conductor del programa televisivo en el cual se presentó el video, Randy Alonso, el material fue grabado durante la misma tarde del sábado.

"Para desengaño de esos ilusos enterradores y para alegría inmensa de los cubanos les brindamos estas imágenes de nuestro comandante en jefe... que muestran la marcha de su proceso de recuperación y su excelente estado de animo", comentó.

Por otro lado, el mismo sábado el presidente boliviano Evo Morales pronosticó que en "dos o tres semanas" Castro volverá al gobierno.

"Fidel ya está caminando, creo que de acá a dos o tres semanas se hará cargo nuevamente de la conducción de Cuba", dijo Morales durante un encuentro con pobladores de Pauriti, en el departamento de Santa Cruz al oriente de Bolivia.

Prevenga el cáncer dándole color a su dieta, Comer vegetales y frutas de colores fuertes, puede reducir el riesgo de cáncer

ANN ARBOR: El jurado está aún en deliberaciones sobre si las dietas bajas en carbohidratos son la mejor manera de perder peso, pero moderarlos, puede ayudarle a prevenir el cáncer.

"Hay claridad que en los cánceres más importantes, la dieta influye en el riesgo de desarrollarlos", dice Mack Ruffin, profesor de Medicina Familiar en el Sistema de Salud de la Universidad de Michigan, U-M, y miembro de Centro Integral de Cáncer de la U-M.

Si su cena está llena con alimentos blancos, con almidones, tome nota: No sólo que la comida es poco atractiva, pero está cargada de calorías y tiene menos vitaminas y minerales para luchar contra el cáncer.

"Le faltan todos los agentes de protección y además corre el riesgo de consumir demasiadas calorías. El riesgo es más o menos el mismo que si usted consumiera concentraciones mínimas de dioxina u otro producto químico o un pesticida que puede ser dañino", explica Ruffin.

Ruffin sugiere llevar a la

mesa color a través de vegetales y frutas en las familias del amarillo, verde, rojo y naranja. Frutas y vegetales contienen miles de micro nutrientes, que son las vitaminas y minerales de las plantas. Estos micro nutrientes tienen un efecto antioxidante, que reduce la cantidad de sustancias químicas producidas en el organismo. Los nutrientes, incluyen las vitaminas A, B y E, carotenoides, selenio y calcio—que trabajan conjuntamente y de manera individual para proteger su organismo.

Entre más fuertes los colores de los vegetales, más ingredientes protectores, por lo que las patatas no se incluyen. Busque espinacas, brócoli, zanahorias, frambuesas y fresas.

"Es increíble ver en un supermercado cuantos colores hay en la sección de frutas y vegetales y la falta de color que hay en otras secciones. Si compra por color y trata de hacer una mezcla, realmente logrará una gran diferencia", dice Ruffin.

Tomar un suplemento de vitaminas y minerales no es la misma cosa. "Cuando su

dieta tiene miles de sustancias químicas no hay manera de tomar una pastilla o varias pastillas y lograr el mismo efecto de protección como de una dieta con alto contenido de frutas y vegetales y baja en calorías", dice Ruffin.

Debido a que la obesidad se relaciona a un mayor riesgo de cáncer, es clave controlar las calorías. Una dieta basada en plantas, con muchas frutas, vegetales, granos integrales y legumbres, también ayudará a controlar el peso, como así también a prevenir enfermedades cardíacas y diabetes. Ruffin sugiere incluirán su rutina diaria, actividad física moderada.

"Intente comer menos calorías, más frutas y vegetales, menos carbohidratos y equilibre con actividad física, para que tenga un buen balance de energía", dice. "Por ahora, casi todo Estados Unidos vive con un desequilibrio de energía. Consumimos demasiadas calorías y no botamos calorías. Hay que equilibrarlo".

Consejos para comprar Ruffin ofrece estas

sugerencias para adoptar decisiones inteligentes en el supermercado:

Busque las frutas y vegetales con colores fuertes e incorpore una variedad de colores en su dieta.

Compre frutas y vegetales enlatados o congelados. Tienen los mismos nutrientes que los frescos y los puede obtener durante todo el año.

Intente no comprar cuando tiene hambre, que lleva a hacerlo de manera impulsiva.

Manténgase a distancia de carbohidratos procesados, que no añaden ningún valor nutritivo a su dieta, aparte de las calorías.

Color your diet with foods to prevent cancer,

Eating richly colored vegetables and fruits can reduce cancer risk

ANN ARBOR: The jury may be out on whether a low-carb diet is the best way to lose weight. But moderating the carbohydrates you eat could help prevent cancer.

"It's very clear for all the top cancers that diet has an influence on your risk of getting cancers," says Dr. Mack Ruffin, professor of family medicine at the University of Michigan Health System and a member of the U-M Comprehensive Cancer Center.

If your dinner plate is filled with all-white, starchy foods, take note: Not only is



the food plain, but it has fewer cancer-fighting vitamins and minerals and is loaded with calories.

"So you're lacking all of those protective agents and you're at risk for eating too many calories. The risk is about the same if you were eating micro-concentrations of dioxin or other pharmaceutical or other pesticide agents that might be harmful," Ruffin says.

Instead, Ruffin suggests bringing color to the dinner table through vegetables and fruits in the yellow, green, red and orange families. Fruits and vegetables contain thousands of micronutrients, which are vitamins and minerals from the plants. These micronutrients have an antioxidant effect, reducing the amount of chemicals produced in the body. The nutrients—including vitamins A, B and E, carotenoids, selenium and calcium—

work individually and together to protect your body.

The more richly colored vegetables pack more protective ingredients. So mashed potatoes won't cut it. Look for spinach, broccoli, carrots and deep-hued berries such as blueberries or strawberries.

"It's amazing when you walk into a grocery store how much color there is in the fruit and vegetable section and how much lack of color there is everywhere else. So if you shop by color and try to mix that, you'll really make a big difference," Ruffin says.

And no, taking a vitamin or mineral supplement is not the same. "When your diet has thousands of chemicals that make a difference, there's no way to take a pill or handful of pills and get the same protective effect as a diet that's high in fruits and vegetables and lower in calories," Ruffin says.

Since obesity is linked to a higher risk of cancer, controlling calories is key. A plant-based diet, filled with fruits, vegetables, whole

grains and legumes, will also help control weight, as well as prevent heart disease and diabetes. Ruffin suggests including moderate physical activity in your daily routine as well.

"Try to eat fewer calories, more fruits and vegetables, fewer carbohydrates, and balance that with physical activity so you're in a nice energy balance," he says. "Right now, almost all of America is in an energy overbalance. We're getting way too many calories in and not enough calories out. You have to balance that."

Shopping tips: Ruffin offers these suggestions for making smart choices at the store:

Look for fruits and vegetables with rich color and incorporate a variety of colors into your diet.

Buy canned or frozen fruits and vegetables. They have the same nutrients as the fresh stuff and are readily available year-round.

Avoid grocery shopping when you're hungry, which leads to impulse buying.



Stay away from processed carbohydrates, which add no nutritional value beyond calories.

Ohio high court says charter schools are constitutional

which is unconstitutional."

The court ruled three times previously that Ohio's system of school funding is unconstitutional because of its over-reliance on property taxes.

Charter schools have existed in a majority of states since 1992, and only about 10 states have not created a charter system. Recent court decisions around the country are leaning, as Ohio's did, toward empowering — rather than restricting — the innovative alternative schools.

In August, for example, the Michigan Court of Appeals dismissed a lawsuit filed by the state's largest teachers' union that could have shut down charter schools run by a tribal community college. And, in September, charter schools in Maryland got a boost when the state's second highest court sided with

the state school board in a dispute with the Baltimore public schools over how the local board was paying city charter schools.

Ohio House Speaker Jon Husted, a Kettering Republican, said the ruling here is a victory for parents and students searching for better educational options.

The academic performance of charter school students is continuing to improve, he said.

"The bottom line is that we need to best serve the needs of the child in an environment that is conducive to learning," he said. "Charter schools are doing that each and every day for students across the state."

Ohio Federation of Teachers union President Tom Mooney said the groups behind the lawsuit will continue to raise issues with charter schools through legislative channels and a second court case involving specific alleged violations of state law by

charter school operators. That case is pending in Franklin County Common Pleas Court.

"Constitutional or not, this thing is clearly out of control. The taxpayers have lost control of over half a billion of their tax dollars," he said.

Fedor said charter school operator David Brennan, whose White Hat Management signed on against the lawsuit, has given generous campaign donations to Supreme Court candidates and that she wasn't surprised they voted in favor of his issue.

Since 1998, Brennan and his wife have donated nearly \$60,000 to successful and unsuccessful candidates for Supreme Court, according to state records. Among those the Brennans supported were Lanzinger and Chief Justice Tom Moyer, who both voted with the majority Wednesday, and Pfeifer, who dissented.



Thanksgiving Helps Us Remember God...




