Latinos criticize Republican Web site and attack on Mexicans

(AP): Numerous Latino importation of Caadvocacy groups are upset about a Web site set up by the National Republican Senatorial Committee (NRSC) that criticizes Democratic U.S. Sen. Debbie Stabenow of Michigan.

The Web site, paid for by the NRSC and not authorized by any candidate, pictures a cutout of said. Stabenow in a sombrero. "Mexican Hat Dance" plays while the NRSC's review of Stabenow's voting record on immigration and border security is displayed in Spanish or English.

The National Council of La Raza, for example, asked for the Web sitewww.muchasgracias debbie.com -to be removed, saying it is offensive and misrepresents some policy debates.

The site is just one set up by the NRSC to criticize Stabenow, who faces a re-election challenge from Republican Mike Bouchard, the Oakland County sheriff.

nadian trash in both French and English. Another tackles Stabenow's record on the economy and other topics in English only.

A site set to debut soon will criticize Stabenow's record on China in both Chinese and English, the NRSC

NRSC spokesman Brian Walton said in a statement that the Web sites are a way to show voters Stabenow's record in the Senate that he says "she is misrepresenting and the mainstream media is failing to examine."

Walton said the NRSC does not plan to pull down the Web sites.

The Democratic Senatorial Campaign Committee also has been criticized this election season by Latino groups that said a Web ad unfairly depicted undocumented immigrants as terrorists.

Cuba: 30 años después de ataque a avión piden justicia

LA HABANA (AP): Tres disputa política y jurídica décadas después Ondina Pérez no puede olvidar aquel 6 de octubre de 1976 v todavía sus ojos se llenan de lágrimas al evocar ese día: su hermano, piloto de Cubana de Aviación, murió dramáticamente a los 32 años cuando la nave en la cual viajaban 73 personas estalló en pleno vuelo.

Junto a familiares de otras víctimas ella marchó el viernes por el cementerio capitalino pidiendo justicia exigiendo que Estados Unidos procese o extradite a Venezuela a Luis Posada Carriles, vinculado como autor del ataque terrorista y actualmente centro de una

entre Washington, Caracas y La Habana.

"Es triste ver a todos estos hijos, nietos, padres sin sus seres queridos hoy", dijo a la AP la mujer cuyo hermano era Wilfredo Pérez.

Portando fotos gigantes con los nombres de sus familiares y precedidos por una banda de ceremonia, cientos de personas se dieron cita para rendir homenaje a las víctimas del atentado de Barbados, como se conoce popularmente a ese sabotaje ocurrido cuando la aeronave regresaba a La Habana y sobrevolaba las costas de la vecina isla.

Encabezando la marcha luctuosa un cartel pintado sobre una tela de varios metros expresaba: "Exigimos justicia".

Muchos de los asistentes eran además deportistas de alto rendimiento, pues en el avión venía el equipo de esgrima que acababa de competir exitosamente en Venezuela.

"Documentos desclasificados hace poco tiempo confirman que el gobierno de Estados Unidos conoció con antelación los planes de Posadas... pero no hizo nada por impedirlo", dijo a viva voz Dasnay Hayes y a nombre de los familiares-

Text of letter from 7-year-old Latino to Bush

Dear President Bush.

I, Saul Arellano, age 7, an American Citizen, do now formally request a meeting with you. I request that you grant safe passage for my mother, Elvira Arellano, so that she can be with me at this meeting and can return safely to our church. I request also that our pastor, Rev Walter Coleman and his wife, Emma Lozano, and my congressmen Luis Gutierrez and Bobby Rush, and Rafael Pulido and Abel Uribe and my friend Daysha DelValle also be present at this meeting.

I want to tell you why I believe my mother should be allowed to stay with me in my country. I want to tell you also that there are more than 3 million children like me. We are U.S. Citizens but the government is taking away our mothers and fathers.

México sends U.S. diplomatic note critical of border Mexican-Wall plan

MEXICO CITY (AP): México sent a diplomatic note to the U.S. government on Oct. 2, 2006, saying a plan to build hundreds of miles of wall on their common border would damage relations.

President-elect Felipe Calderon urged U.S. officials to reconsider the plan, saying one "could stop more migrants with a kilometer of new roads and development (in México) than with a wall."

In the letter to the U.S. State Department, México's Foreign Relations Department said only comprehensive reform could stem the tide of undocumented immigrants heading north in search of work.

"The diplomatic note explains that the construction of this barrier will hurt the relations between the two countries and that it is not the solution to strengthen security on the border," the department

President Vicente Fox. who leaves office Dec. 1, has spent his six-year term lobbying for a new guest worker program and an amnesty for the millions of Mexicans working illegally in the United States-proposals that have been supported by President Bush.


However, U.S. lawmakers, who face midterm elections in November, have shown a greater appetite for border security measures. On Friday, Sept. 29, 2006, the U.S. Senate approved a bill authorizing 700 miles of new fencing in border states.

Fox has called the barrier "shameful" and compared it to the Berlin Wall.

Calderon said Oct. 2 that the barrier would not deter migrants from walking across the desert or swimming over the Rio Grande in search of a better life.

"A border that unites two nations allows the free movement of labor but is closed to drugs, guns and criminals," he added. Calderon spoke in Guatemala, where he met with President Oscar Berger on his first international tour since the July presidential election.

On Friday, Foreign Secretary Luis Ernesto Derbez said he would try to per-



suade Bush not to sign the bill-but Bush did sign the bill.

"We think it is a gesture that doesn't reflect the friendship between the nations of Latin America and the Caribbean and the United States," Derbez said.

Mexican Presidentelect Felipe Calderon has also criticized the Mexican-Wall plans.

An estimated 11-12 million Mexican citizens are in the United States, about half of them without documentation.

Last year, Mexican migrants sent home more than \$20 billion in remittances, the country's second leading source of foreign income after oil. In the first eight months of 2006, remittances rose by nearly 20 percent over the same period last year, according to figures released by the Mexican Central Bank on Monday.

Anti-affirmative action ballot Proposal 2 stirs up delving debate

(AP): Jennifer Gratz, a white student from suburban Detroit, says she was turned away from the University of Michigan-Ann Arbor in 1995. The high school honor student says if she had been black, Native American or Latino, she would have gotten in.

Eleven years later, Michigan voters will decide whether state universities and government should be allowed to use race and gender preferences to decide who gets into school, which job candidates get hired and which businesses receive contracts.

The Michigan proposal, Proposal 2, survived more than two years of legal challenges to make it to the November 8th ballot. The measure to ban some types of affirmative action programs is opposed by both candidates for governor and a slew of business, labor, educational and religious groups.

"No one should ever have to wonder if they are in a position or were rejected for a position because of their skin color or their sex," says Gratz, now 29 and leader of a group called the Michigan Civil Rights Initiative. "You should know it's your character and your makeup and your qualifications that get you to certain places ... or don't get you to certain places, that someone else was better.'

Lawsuits filed by Gratz and others against the University of Michigan over its admission policies led to the 2003 U.S. Supreme Court ruling that upheld a general affirmative action policy at the university's law school but struck down the undergraduate policy as too rigid because it awarded admission points based on race.

That decision is one of claims are an insult to the the driving forces behind the ballot measure.

"Passing Proposal 2 hurts women too"

Opponents of the proposal say passing it would be a step backward in the quest to achieve equality for minorities and women. They say programs aimed at helping women and minorities break into careers where they are now underrepresented would be eliminated or hampered by the proposal.

'We don't want to roll back the progress we've made in our state," said David Waymire, a spokesman for a coalition called One United Michigan. We've made progress. Why would we want to stop that now? It wouldn't make any sense."

The coalition-which includes executives from groups as varied as General Motors Corp., the Michigan Catholic Conference, state universities and the NAACP—has set fundraising goal of \$3 million to \$5 million to fight the proposal.

A summerlong television ad campaign paid for by a nonprofit group that opposes the proposal raised awareness of affirmative action programs without mentioning the ballot proposal itself, but the focus was expected to shift to the measure as the election neared.

The proposal's opponents said MCRI used deception to persuade enough registered voters to sign the petitions needed to make the ballot. They say signature gatherers told some signers it would protect affirmative action and civil rights for minorities and women.

MCRI denied the fraud

thousands of people who signed the petitions knowing the proposal's intent. And supporters say the ballot proposal does protect civil rights-for everyone, regardless of race, gender or ethnicity.

State courts ruled the proposal should go on the ballot. At the federal level, U.S. District Court Judge Arthur Tarnow of Detroit said he believed fraud took place in gathering the signatures, but that it wasn't a violation of the Voting Rights Act because all voters were targeted regardless of race. Voters would have their recourse in November, he said.

MCRI says that opponents have overstated the proposal's potential impact to try and persuade people to vote against it. Gratz says opponents often bring up programs that she savs would not be affected by the proposal, such as breast cancer screenings and girls' sports programs.

"They are trying to frighten people out of supporting it," said Ward Connerly, an MCRI adviser and a former University of California regent who has long opposed race and gender preferences and has helped fund the group. "The opposition is trying to distort this issue."

The proposal wouldn't ban affirmative action programs based on geography or income. It would not ban any affirmative action programs at private businesses or organizations, although opponents worry employers would scrap their programs if government is forced to do so.

A similar proposal passed in California in 1996. Courts had to sort out how the proallegations and says the posal related to several pro-

grams, and the same is likely to happen in Michigan if the measure passes

"There would likely be numerous lawsuits filed to test the boundaries of the amendment and to interpret and clarify its impact in Michigan," says a study of the proposal by the nonpartisan Citizens Research Council of Michigan.

The University of Michigan could have to again rewrite its admissions policy if the ballot proposal passes, according to CRC's review.

That review said it does not appear the impact would be as significant for undergraduate admissions at other Michigan public universities, but it's harder to tell if preferences are used for graduate schools and law schools.

If a university has gender-based preferences within specific programssuch as a nursing school program that favors male applicants-those likely would be banned.

(Continued from Page 2) forever change the nature of Michigan's identity and commitment to social justice. Voters will be asked to amend our state constitution by voting on Proposal 2, a ballot proposal to ban affirmative action. It threatens to eliminate all programs that address inequalities of opportunity or special needs that exist for women, for persons of color, and for ethnic or

national minorities. If passed, Proposal will undermine Michigan's basic commitment to justice, equality and inclusivity. This proposal is an outright assault on equal opportunity, and, should this anti-affirmative action proposal pass, Michigan will be taking a giant step backward.

Preserving the option of affirmative action as a means of pro-

moting social justice is a moral imperative. We rise up, as a gathering of clergy and religious leaders, to defend a social policy which preserves our common message of human dignity and hope. It is not only appropriate and necessary for faith leaders to take a stand opposing an extreme and divisive proposal, but we are obligated to mobilize effectively and defeat it from the pulpit and in the public arena.

As religious communities, we have different modes of worship and ideas about divine service. Yet our scriptures, traditions, and understanding of the beloved community all teach us that freezing present inequality and injustice into law is contrary to our deepest religious truths. Our shared values as religious citizens bring us together to oppose this constitutional amendment.

Congressional candidate hopes second time's a charm

Robin Weirauch, candidate for the U.S. House of Representatives (OH-5) is once again challenging nine-term Republican incumbent, Paul Gillmor. In 2004 Weirauch captured 33 percent of the vote in her bid to unseat Gillmor.

This time she's hoping that her previous political experience and the rising tide of discontent with the Republican-controlled Congress will translate into a much different result.

Weirauch, a resident of rural Napoleon with extensive roots in the 16county Ohio 5th district, resigned her position as assistant director with the Center for Regional Development at Bowling Green State University in order to campaign full time.

Last Saturday, October 7, Weirauch joined migrant workers for a pot luck picnic in Tiffin to discuss immigration issues, fair wages and other matters of importance to the farm laborers. Weirauch's stances on such matters are in direct contrast to those of her opponent.

She quite obviously relishes such differences. In spite of her relative political inexperience, she feels "very well qualified" for a congressional post and she also believes that the traditionally conservative district is ready for a breath of fresh air.

"For the whole demo-

cratic process, it's important to have choices," Weirauch told *La Prensa* last week.

told *La Prensa* last week. Gillmor voted for HR 4437 at the end of 2005, the infamous House bill that would have made felons of all undocumented workers and those who rendered any assistance to them.

assistance to them.

"The House version was much too extreme in treating undocumented workers as felons," said Weirauch.
"And it would make matters worse. They will just go deeper into the shadows and the job of finding who is here legally will be more difficult. The bill is overly harsh and unrealistic."

Weirauch spoke of the complexities of the issue of dealing with immigration as a matter of policy and said that she would urge colleagues, if she is victorious to distinguish what should fall in the law enforcement area and what should be considered multic policy.

sidered public policy.

"Are we talking border security or control over the inflow of people?" she asks.
"Border security is one set of policies, labor flow is another."

She also urges policy makers to remove the discussion from the political arena and initiate a "sound public policy discussion."

HR 4437 is not the only point of divergence in views

between Weirauch and the incumbent. The War in Iraq, for example, on which Gillmor has consistently sided with the administration's approach, brought a much different response from Weirauch.

"We're going to be there for 10 to 15 years," she said of the Republican approach. "That's unacceptable."

Weirauch graduated from BGSU in 1980 with a degree in business administration. Shortly thereafter, she founded a non-profit charitable organization to improve the quality of life for people and animals of the greater Henry County area. She also served as the regional program coordinator for the Humane Society for 10 years.

Weirauch was recruited to run against Gillmor in 2004 by the Democratic Party. It was not a hard sell. Seeking political office had been a long-time goal for the community activist. If this campaign does not succeed, in fact, she can envision herself trying again in 2008

again in 2008.

"There are a whole lot of folks looking for a change," she said.



Latina diagnosed with Rett Syndrome

Angelica and Anthony Handy were typical proud parents when their first child, Alexia, started to crawl, then walk and even talk when expected. Photos of these milestones were proudly displayed in wallets, on desks, and in holiday cards.

But slowly, the skills



started deteriorating.

Her parents noticed that Alexia began to withdraw from daily play. She stopped responding when her parents called her name. Her eating habits changed and drastic weight loss occurred. In short, this once vibrant, outgoing

little girl was regressing.
"The changes in
Alexia's behavior
scared us," said Angelica Handy, Alexia's mom. "For 18 months, we had been watching Alexia grow and learn, but then her progress just stopped."

Because of this drastic change, the Handys' pediatrician referred them to Early Intervention, a division of the Lucas County Board of Mental Retardation and Developmental Disabili-ties. Early Intervention specialists worked with Alexia and the Handys to get to the bottom of this mystery.

Over the course of a year, and several incorrect diagnoses, it was finally determined that Alexia, who was then 2 ½-years-old, had Rett Syndrome, a debilitatng neurological disorder. Because this disorder is now a part of the Handys' lives forever, they are not only learning new ways to help their daughter, but also working to increase aware-ness about Rett Syndrome.

the Rett Svndrome Řes e a r c h Foundation Strollathon

"When you have children, you don't ever expect anything to be wrong with them," Handy said. 'Immediately, you ask your-

self, 'Did I do something to make this happen? What did I do wrong?

The Handys did nothing wrong. Rett Syndrome (RTT) is caused by mutations in the gene MECP2, located on the X chromosome.

Neurological disorder affects about 1 in 20,000 females, has no cure or treatment

RTT is diagnosed almost exclusively in females between 6 and 18 months of age – just like Alexia. At this age, children with RTT enter a period of regression, losing speech and motor skills. Most develop irregular breathing patterns, sei-zures, extreme motor control problems and repetitive hand movements.

It was Alexia's hand-

wringing that alerted doctors to the possibility that she had RTT.

"A sense of relief came – followed by instant fear," Handy said. "We were happy to find out what was wrong with our daughter, but at the same time, we knew what this meant for her. It

was a nightmare we're still learning to cope with.

There is no cure for RTT, which leaves its victims profoundly disabled, requiring maximum assistance with every aspect of daily living. Although some individuals with RTT die at a young age, the majority live into adulthood.

Alexia and her family

are proud to be a part of the Rett Syndrome Research Foundation Strollathon to help raise funds for and awareness of this rare disorder.

The Strollathon is the signature event of the Rett Syndrome Research Foundation. It is a funfilled family event that raises crucial research dollars and public aware-ness of Rett Syndrome in communities across the country. The program has grown substantially since the inaugural event in 2002 and has raised nearly \$1.5 million for RTT research.

This Strollathon is one of several scheduled across the country this year. Other locations in-cluded Cape Cod, Mass.; Harrisburg, Pa.; Seattle, Wash.; Portland, Ore.; Roanoke, Va. and Rockland City, N.Y.

All proceeds raised from the Strollathon program are allocated to RSRF's research program. Since 1999, RSRF has awarded more than 80 reawarded more than 80 re-search grants totaling al-most \$9 million. With sup-port, RSRF will continue to fund the world's most promising RTT research and move the organiza-tion closer to finding treatments and a cure for Rett Syndrome.

"We have to believe that one day there will be a cure," Handy said. "I am dreaming of the day when Alexia will be able to feed herself again and lift a crayon or turn the pages of her books. She has so much life in her and wants to say so much, but we can only wonder what she's really thinking."

Governor candidates spar over abortion, interest groups

COLUMBUS, Oct. 3 (AP): Ohio's top governor candidates divided most intensely on abortion dur-ing a face-to-face meeting, Democrat Ted Strickland advocating a woman's choice in the matter and Republican Ken Blackwell challenging his position.

Strickland, a congressman from Appalachia who is leading in the polls, accused Blackwell of changing his position on abortion over the course of the year, in a meeting Monday with the editorial board of

The Columbus Dispatch.
He said Blackwell, Ohio's secretary of state, opposed abortion under any circumstances during his heated primary against Attorney General Jim Petro, but "has since nuanced that in a rather clever way" to allow abortion to save a mother's life.

Blackwell, who would be the state's first black governor, said his state-ments on saving the mother's life don't represent a position change.

He said medical science has advanced to a point where choosing between the life of the mother or baby is "no longer the dilemma the medical profession had to deal with." Strickland said doctors have told him that assertion "is just flat out wrong."

Holding his hand almost in Strickland's face, Blackwell said: "Take a look at the color of my skin. There would be very few people of this color if the instinct of the slave that was brutally attacked, the slave woman, was

to kill the baby."

Blackwell said rape victims today can use the so-called "morning-after pill" to prevent pregnancy, but that if one of his two daughters were raped and surpassed that opportunity, he would view aborting the pregnancy as the "more traumatic choice" than carrying the baby to term.

"It ought to be her choice," Strickland said. "That is where we differ," Blackwell replied.

During their nearly two hours with the newspaper's editors, the candidates also jockeyed to label each other as a puppet of interest groups, with Blackwell painting a Strickland administration as beholden to labor union bosses and Strickland suggesting a Blackwell administration would be captive to the religious right.



Strickland called Blackwell an opportunist for embracing a government-limiting constituamendmentdubbed Tax and Expenditure Limitation, or TEL—throughout the primary, then abandoning it when public pressure mounted.

"I think that calls into question your judgment, and quite frankly, whether or not you would be good for Ohio," Strickland said.

Blackwell questioned Strickland's response to the investment scandals that have plagued the Ohio Bureau of Workers' Compensation since last spring, suggesting Strickland protected AFL-CIO President Bill Burga, a member of the bureau's oversight commission, by not asking for him to re-

sign.
"Your silence was deafening, because it would have required you to ask Mr. Burga to come down off of that board, and you just didn't have the leadership courage to do that," Blackwell said.

New U.S. citizens urged to vote in Ohio

COLUMBUS (AP): The 20,000 immigrants in Ohio who have become U.S. citizens since the 2004 election are being courted by politi-cal parties and encouraged by immigrant groups hop-ing for more clout at the polls.

The Ohio Democratic and Republican parties have been printing campaign literature in Spanish as a way to attract

Latino voters.

Democrats also have advertised in Latino newspa-pers and visited precincts with heavy Latino popula-tions. Republicans have held fundraisers in private homes so Latino immigrants can meet with politicians and have been calling them di-

"You can't be part of the solution if you abstain," said Julia Arbini Carbonell, presi-dent of the Ohio Hispanic Coalition.
According to the 2000

census, there were nearly 136,800 Latino residents of voting age in Ohio. Immigrants made up 1.6 percent of Ohio voters in 2000, with more than 76,000 of the 96,384 foreign-born citizens who were registered voting, according to a 2004 study by the Immigration Policy Center.

Immigration has become a major political and social issue, with officials debating how to strengthen the country's border with México and proposals to criminalize illegal immigra-

Several immigrant groups in Ohio also are urg-ing Somalis to become more

politically active.

About 35,000 Somalis live in central Ohio and about 16,000 have become U.S. citizens, according to the Somali American United Council of Ohio, whose leaders plan to create the Somali Political Action Committee to discuss issues important to immigrants, including


Governor of Virginia from 1990 to 1994, Wilder was commended for his sound fiscal management. "Financial World" magazine ranked Virginia as the best managed state in the U.S. for two consecutive years under his administration. He served as lieutenant governor from 1986 to 1990.

Wilder became the first African-American state senator in Virginia since Reconstruction, serving from 1969 to 1985. During his five terms as a state

senator, he successfully sponsored Virginia's first drug paraphernalia law and the compulsory school attendance law.

Other legislative achievements include providing state health care coverage for sickle-cell anemia patients, toughening penalties for capital murderers and prison escapees, and expanding low and moderate income housing. Wilder is a Distinguished Professor at Virginia Commonwealth University, a newspaper columnist and the driving force for establishing a national slavery museum in Fredericksburg, VA. Recipient of more than three dozen honorary degrees, he has received numerous awards that include the



NAACP Spingarn Medal, Anna Eleanor Roosevelt Medallion of Honor, SCLC Drum Major for Justice Award, B'Nai B'rith's Great American Traditions Award, and Thurgood Marshall Award of Excel-



You and the Law in Ohio

Time limitations for pursuing personal injury and other money damage claims

All claims for money damages in Ohio and other states, whether for personal injuries or another type of claim, have a specific time limitation called a "STATUTE OF LIMITATION." The importance of that statute is that if your claim or case is not filed in the appropriate state or federal court, within the time limitation specified for that claim, the opportunity to pursue money damages is lost forever.

The time limitations vary between different types of claims, and from state to state. For example, in Ohio, an auto or truck collision case, caused by negligence, with bodily injury and/or property damage, has a two year statute of limitations, while a medical malpractice case against an Ohio doctor or an Ohio hospital may be as short as one year from the last date of treatment.

Correspondingly, a death from an injury occurring in Ohio, due to negligence, has an absolute time limitation of two years from date of death. Certain intentional acts. such as assault, slander or libel have a one year statute of limitations.

If you or a member of your family believe that you have a claim for money damages, such as a personal injury case, please consult an attorney immediately to determine the time limitation for your injury claim. Please do not wait. You may loose your right to compensation

Casamayor gana título de los ligeros por decisión dividida

LAS VEGAS (AP): Diego Corrales no pudo vencer ni a Joel Casamayor ni a la báscula.

El cubano Casamayor se apoderó del título de los ligeros por el Consejo Mundial de Boxeo (CMB). el sábado por la noche, al imponerse por decisión dividida a Corrales, quien debió renunciar a su cetro un día antes, cuando no dio el límite de peso de 61.2 kilogramos.

En un combate que estuvo a punto de cancelarse luego de que Corrales no dio el peso, Casamayor asestó los mejores golpes para ganar el título vacante.

El cubano ganó por 116-111 en la anotación de uno de los jueces y por 115-112 en la de otro. El tercero dio la ventaja a Corrales por 114-113. The Associated Press dio el triunfo a Casamavor por 116-112.

"Sé que gané", dijo Casamayor. "Pero estaba un poco preocupado cuando debimos ir a la decisión".

Corrales, quien dijo que no había comido por cuatro días antes de dar un peso de 63 kilos el viernes, comenzó lento y nunca logró colocarse a la distancia adecuada para hacerle daño al ex campeón olímpico cubano.

"Creo que peleé muy bien", dijo Corrales. "¿Cómo puede ganar alguien huyendo?"

Casamayor frustró a su oponente desde el campanazo inicial, y ni siquiera una controversial caída en el quinto asalto ayudó a que Corrales descifrara el estilo del púgil zurdo. Ganó los primeros tres episodios en las tres anotaciones, un margen que Corrales no pudo recuperar en los asaltos finales.

El referí Kenny Bayless determinó que Corrales derribó a Casamayor en el quinto acto, pero la repetición en vídeo mostró que el cubano tropezó con los pies de su contrincante. Casamayor se levantó de inmediato y extendió los brazos, con un gesto de incredulidad.

"No fue una caída clara, pero fue una caída", dijo Corrales, quien debió dividir su bolsa de 1,2 millones de dólares con Casamayor para que la contienda se realizara después de que no dio el peso. Corrales fue multado además con 240.000 dólares por la Comisión Atlética de Nevada y perdió su cinturón de monarca ligero del CMB antes de subir siquiera al

cuadrilátero.

El entrenador Joe Goosen diio que estaba preocupado por la salud de su púgil, quien no había comido sino trozos de hielo antes de la ceremonia de pesaje. Sin embargo, consideró que Corrales hizo lo suficiente para llevarse el triunfo.



The Buckeyes (6-0) toyed with the Falcons (3-3), tacking on two touchdowns in the final quarter to turn a surprisingly close 21-7 game into a rout. Ohio State stretched the nation's longest winning streak to 13 in a row.

Smith didn't do anything to hurt his Heisman Trophy candidacy, completing 17-of-20 passes for 191 yards with no interceptions. His touchdowns covered 3 yards to Rory Nichol, 11 yards to Ray Small and a lightning strike 57-yarder to Ted Ginn Jr.

The 85-percent completion rate was the third best ever for an Ohio State quarterback.

Pittman carried 13 times for 61 yards, scoring on two 8-yard runs.

After 20 years in EEUU, Don Francisco still rules TV's varieties

the actors strip to their underwear. Then come the puma and alpaca. Cue the Tejano singers with the hiphop dancers, then the Mexican pop rocker who's just done a TV movie with Disney

Finally, there's a surprise for an 11-year-old Honduran boy who sneaked across the U.S. border to find his mother-he won't be deported after all.

And that's all before the first break in taping of "Giant Saturday," or "Sabado Gigante," as it is known to its 100 million loyal viewers. Even non-Spanish speakers stop channel-surfing for a peek when they see the show's dapper host Don Francisco, his pompadour slick, his grin malleable and his flock of beauties always nearby.

The variety show marks 20 years in the U.S. this year and next year will hit 45 in Chile, where it originated. Yet those who would dismiss Don Francisco as a relic of the "Gong Show" era of television would be sorely mistaken

Beneath the sardonic and bufoonish Don Francisco is his alter-ego, the show's mastermind and creator, Chilean entertainer Mario Kreutzberger. It is the reserved Kreutzberger's ability to seamlessly channel Carol Burnett, Johny Carson, Pat Sajak and Phil Donahue all into his Don Francisco character that has made "Sabado Gigante" the world's longest running variety show, according to the Guinness Book of Records.

And it has allowed Kreutzberger to do what no politician in America has been able to achieve-create a space each Saturday

(AP): In the first sketch, evening that unites a wide swath of Latinos across nationalities, cultures and even age and gender.

> During this week's Tejano performance, older women in the audience stand and sway to the familiar beat. During alt-rocker Belinda's thrashing pop, the teens bust out. The "Baywatch" demographic stays for the sexy and multicultural babes, while the kids love the animal segments.

> Born in Chile to Jewish parents who fled the Holoin Germany, Kreutzberger got his first taste of fame performing in the conservatory where his mother, a former opera singer, enrolled him.

"It was in the genes," he

Kreutzberger, 65, tried following the footsteps of his tailor father, but fame kept beckoning. He began his first show in 1962 in Chile and in 1986 headed to Mi-

It is his ease at moving between identities-Jewish, immigrant, Chilean, Hispanic-that has helped him relate to so many cultures, as well as the immigrant experience of many of his fans.

"To be an immigrant is never easy in any part," Kreutzberger says. "It's not easy to adapt yourself to a new place, new food, new friends. I was a star in Chile, and I came here and for the first time I was working for a community that was the minority."

The man has reach.

During the past two presidential elections, both Democratic and Republican candidates appeared on his show to woo Hispanic voters, and Latin American politicians frequently stop in.

In 1973, Gen. Augusto Pinochet even sought him out to announce the overthrow of Chilean President Salvador Allende.

Kreutzberger has said it took some fast talking to convince officials that a TV host was not the appropriate person to announce a military coup.

He has been honored by the U.S. Congress, served as a United Nations Children's Fund goodwill ambassador and earned a star on the Hollywood Walk of Fame. His annual telethon for disabled children has raised more than \$240 million.

His popularity extends to some of the most remote places. Ron Magill, a zoologist who makes frequent appearances on the show, met fans deep in Panama's Darian Jungle.

"Here were these ethnic Indians," he recalls. "This woman wearing no top and beads, no shoes, she explains that once a week they walk to the nearest village to watch 'Sabado Gigante."

Between tapings, as the models in barely there gold spandex fiddle with their toes. Kreutzberger waits in the wings in his crisp, charcoal gray suit, pink shirt and matching pocket handkerchief. He carries the gravitas of a world leader.

And then he is on. His voice booms across the studio, making racy jokes he is lucky the Federal Communications Commission has too few Spanish-speakers to monitor.

Kreutzberger has been criticized for his use of scantily clad models and has become more reserved since he settled a sexual harassment suit in 1994 with a former model. He maintains his innocence. He admits his wife of 44 years, Temy, has on occasion been jealous. but he is unapologetic about the show's dancers, saying simply, "I like half-naked girls.

He keeps his show fresh by staying up with the current political and cultural trends. His latest read: "The End of Poverty," by Jeffrey Sachs, with a foreword by

But will current trends, and changes in his audience, leave his show behind?

During a recent kidswith-animals segment, he had to remind one youngster of the Spanish word for chicken.

Kreutzberger says he isn't fazed by the expansion of Spanish-language and bilingual networks or studies that suggest Hispanics in the U.S. increasingly prefer En-


"There will always be more (immigrants). Even if they put up electric fences, or whatever else, there will be millions of people on the other side of the border who are living in worse conditions than they could live here," he says, adding, "to maintain the economy of the U.S., vou need American organization together with Hispanic labor."

Kreutzberger is keenly aware of his influence. After the show's lawyer explains that 11-year-old Wilson Lonez won't be deported to Honduras, Don Francisco offered the audience a disclaimer about his legal team's abilities.

"We can't do miracles here, and we don't want you to think we can," he says.

And yet as the audience watches him run through the show, the look on their faces suggests many still believe otherwise.







MARIA CONCEPCION ORTIZ Y PINO DE KLEVEN Former lawmaker, Latino culture activist laid to rest

SANTA FE (AP): A historian drew laughter from about 200 people who gathered for the funeral of María Concepción Ortiz y Pino de Kleven by suggesting the woman is stalled at the Pearly Gates, arguing over the admission of the handicapped, women and

"She was legendary because of the quirky nature of her contentiousness," Marc Simmons said during the Mass held at the Cathedral Basilica of St. Francis of Assisi on Friday, Oct. 6, 2006.

Ortiz y Pino, known simply as Concha, was hailed as a Latina role model, who was not shy about voicing her opinion.

She died Sept. 30 of pneumonia at a Santa Fe retirement community at the age of 96. Ortiz v Pino was elected to the Legislature for three terms, in 1936, 1938 and 1940, In 1941, at age 30, unmarried and Latina, she became Democratic majority whip—the first woman to hold such a position in a state government.

Among her causes: letting women serve on juries, equalizing funding for urban and rural schools and mandatory Spanish-language instruction in seventh and eighth grades. She also encouraged the preservation of traditional arts and crafts helping to set up workshops during the Depression.

In his homily, Archbishop Michael Sheehan of the Roman Catholic Archdiocese of Santa Fe recalled how Ortiz y Pino was the last person a few years ago to receive communion at a Sunday Mass

Afterward, he said, "She looked me in the eve and said, 'Archbishop, promise me you will be at my funeral."

He said he told her he would, provided he didn't die first.

"That's not likely," Sheehan said Ortiz y Pino responded.

At the dedication of a new church in Villanueva, Sheehan said Ortiz y Pino told him that he "should thank the people who built this beautiful shrine.

When he asked who had done it, he recalled her saying, "I did and my family." Members of the Order of the Holy Sepulcher, a Roman Catholic society to which Ortiz y Pino belonged, accompanied her body to Rosario Cemetery for the burial. The women of the order wore black lace mantillas that were common of Ortiz y Pino's

The Spanish culture activist and matriarch of a longtime New Mexico family also was known for her sharp tongue, which put her at odds with many.

The Very Rev. Msgr. Jerome Martínez y Alire, rector of the cathedral, closed the service by asking anyone whom Ortiz y Pino had offended to forgive her.

Venezuela's CITGO's earnings up

CARACAS (AP): Venezuela's state oil company, CITGO, saw its net earnings rise to nearly US\$6.5 billion (euro5.1 billion) in 2005 amid soaring crude prices, the company's president said Oct. 3.

The rise in earnings represented a 20 percent increase over 2004, said Rafael Ramirez, president of Petroleos de Venezuela SA.

PDVSA's costs also rose, partly cutting into earnings. Overall revenues reached US\$85.7 billion (euro67.3 billion) last year, a 32 percent increase over 2004, Ramirez told a news conference.

The company reported expenses of US\$53.2 billion (euro41.8 billion) in 2005, representing 22 percent increase from the previous year.

That did not include US\$5.8 billion (euro4.5 billion) in taxes, and an unspecified amount that went toward investment.

Ramirez, who is also Venezuela's oil minister, said the government is very satisfied with the earnings, and that PDVSA also provided more than US\$6.9 billion (euro5.4 billion) last year for state social programs, sharply up from US\$1.2 billion (euro970,000 million) in 2004.

He also said Venezuela, the world's fifth largest oil exporter, has cut its production by 50,000 barrels a day, starting this past Sunday, in an effort to shore up flagging international petroleum

Venezuela has managed to increase production in the past year, and even with the cut the country is still producing more than 3.3 million barrels a day, Ramirez said.

"Our production rose in the order of 100,000 barrels a day in 2005," said Ramirez, adding that the country was producing just under 3.3 million barrels a day last year.

Some analysts dispute Venezuela's production figures and claim the nation really produces some 2.6 million barrels a day.

Venezuela is continuing talks with other members of the Organization of Petroleum Exporting Countries, or OPEC, on



world oil markets and proposals to boost falling prices. Venezuela wants OPEC to reduce oil output.

Ramirez said "we are waiting for talks" with other OPEC members on the matter, but suggested that OPEC members will not discuss the issue in detail until the next OPEC meeting near the end of this year.

Ramirez also said PDVSA will soon turn in its 2005 financial reports to the U.S. Securities and Exchange Commission. He said he hopes that will be the last time it the company submits information to the U.S. agency.

Venezuela remains a major supplier of oil to the United States despite disputes between President Hugo Chávez's government and Washington, D.C.





Mexican archaeologists unearth monolith showing early calendar decapitated mujeres

MEXICO CITY (AP): Researchers said they have unearthed what may be one of the earliest calendar entries in Meso-America, a monolithic sculpture that suggests women held important status roles in pre-Latino culture.

The massive stone sculpture depicts two decapitated women with streams of blood or water flowing from their necks.

Markings on top of the figures appear to depict an entry from, or part of, a 13-month lunar calendar, said archaeologist Guillermo Ahuja, who led the excavation of the monument.

"This would be the first depiction of a calendar or calendar elements in such an early time period," Ahuja said Thurs-

The monolith, which measures more than 8 meters (yards) and weighs about 20 tons, was found in March 2005 at the Tantoc ruins in San Luis Potosi state, near México's northern Gulf coast, by construction workers.

The stone's glyph-like inscriptions were carved sometime around 700 B.C., likely by the Huasteco culture and may predate other early calendars by hundreds of years, Ahuja said.

That theory has not yet been proven or published in scientific journals; its feasibility depends on whether the markings really are glyphs or calendar entries, and whether they really are that old.

"The earliest calendrical inscriptions that we know of for certain come from Oaxaca ...



and they date to no earlier than 500 B.C.," said E. Wyllys Andrews, an archaeology professor at Tulane University. "Finding this in the Huasteca (region) at 700 B.C. would be a real stretch."

The lunar calendar has frequently been associated with female figures. The site where the stone was found was also a sacred area and burial ground occupied by the graves of 14 females, whose pottery offerings depicted women.

"This suggest that women played very important roles, not only as priestesses, but politically as well," Ahuja said.

Luciano Cedillo, director of México's National Institute of Anthropology and History-which employs Ahuja—called the find "important and surprising."

In many pre-Latino cultures, prisoners of war or sacrificial victims were often decapitated or flaved. Most depictions show males, but some cultures depicted decapitated females as a symbol of fertil-

The blood or water flows from the necks of the two women in all directions, and into the belly button of a third, central figure depicted as an almost skeletal figure, neither male nor female.

The announcement came four days after archaeologists in México City discovered a smaller monolith near México City's main square, but the sculpture on that monument cannot yet be read because much of the stone remains buried.

The smaller monolith-it measures about 3.5 meters (yards) on its longest side-was probably erected in the closing years of the Aztec empire, between 1502 and 1521, when the Spaniards conquered México.

Cedillo said the earth covering the stone could be removed by sometime next week, at which point experts could examine and evaluate the carvings, which some researchers believe could be dedicated to Tlaloc, a rain god.

Tlaloc is also depicted on one of two small altars discovered near the monolith in México City's Templo Mayor ruins, the main worship site for the Aztecs, who founded the city in 1325. The other altar depicts a minor deity, possibly related to farming.




