## BGSU Center for Regional Development creates Toledo Region Data Center

BOWLING GREEN, Feb. 18, 2020: Industry, pay rates, the number of workers employed—mountains of data exist for every city in the world. *Bowling Green State University's Center for Regional Development (CRD)* is looking to make all that data more accessible for businesses, organizations and elected officials.

The CRD is devoted to finding solutions to economic and community development challenges in northwest Ohio, and the task of creating the *Toledo Region Data Center* was another way for them to support the community. Created for the Toledo Regional Chamber of Commerce, the Toledo Region Data Center provides economic and workforce information for the Greater Toledo region with data being calculated for the Toledo metropolitan statistical area, which includes Lucas, Wood, and Fulton counties.

"The origin of this project

was a conversation that we had with the Toledo Regional Chamber of Commerce," said Dr. Russell Mills, senior director of the CRD. "They mentioned that a lot of companies come to them and they often ask for pretty high-level data on the region. We brainstormed and came up with the idea of a dashboard for the region."

Businesses hire a site selector firm to go out and do a first cursory look at a region, determine things such as average wage, population size and workforce numbers in certain industries. In essence, the CRD created a dashboard to provide an easy one-stop-shop for companies looking to expand or relocate to the region. It's also a great way for BGSU students to support the local economy. "This project, other than the initial connection and identifying their needs, was mostly done by our graduate students," Mills said.

To get a better idea of how to go about creating the data

dashboard, the CRD researched other areas that had a working dashboard in place from all around the country. BGSU students, many of them from the applied statistics program, worked on the different iterations which were presented to the Chamber.

"We had to have somebody collect the data and determine what data to present," said Deminique Heiks, economic development program coordinator for the CRD. "We had graduate students assisting and tweaking the dashboard and we update it and determine if there are additional data sets that people are interested in and add that data. It's a continuous process."

Local businesses and bigger companies cycle through every area, and Bowling Green is no exception, making the information fluid. The Toledo Region Data Center is comprised of data from a num-

ber of sources, including the Census, Bureau of Economic Analysis and the Bureau of Labor Statistics.

"A lot of organizations tend to use people from out of the state or out of the region," Mills said. "Our goal is to give people a sense of the capabilities that the CRD has within the region."

The project was supported by funding from the Economic Development Administration (EDA), through the U.S. Department of Commerce's University Center Economic Development Program and the State of Ohio Rural University Program.



## GM plans to pull out of Australia, New Zealand and Thailand

DETROIT, Feb. 17, 2020 (AP) General Motors decision to pull out of Australia, New Zealand, and Thailand as part of a strategy to exit markets that don't produce adequate returns on investments raised dismay Monday from officials concerned over job losses.

The company said in a statement Sunday that it plans to wind down sales, engineering and design operations for its historic Holden brand in Australia and New Zealand in 2021. It also plans to sell its Rayong factory in Thailand to China's Great Wall Motors and withdraw the Chevrolet brand from Thailand by the end of this year.

"This is a very disappointing outcome," said Karen Andrews, Australia's minister for Industry, Science and Technology. She said it was unfortunate both because about 500 workers would lose

their jobs, but also because "they only advised the government of this decision just before the announcement."

Dave Smith of the Australian Manufacturing Workers' Union also expressed chagrin.

Workers at Holden had thought they'd "been through the worst of it, and that's not the case," Smith said. "For many of them their long-term workers have been very loyal to the company ... they've loved being part of the car industry, and now, it was such an iconic brand coming to an end; it'll mean an end to their jobs."

GM has 828 employees in Australia and New Zealand and another 1,500 in Thailand, the company said.

In Thailand, the decision to sell GM's plant in Rayong, south of Bangkok, may well end up being good news for

workers there.

Great Wall Motors, a major maker of sport utility vehicles and pickups, said it intends to expand in Southeast Asia using the plant in India as its base.

"We will also promote the development of the local supply chain, research and development and related industries, plus contribute more to the exchequer of both the local Rayong and Thailand governments," Great Wall's vice president for global strategy, Liu Xiangshang.

Thailand is still determined to be the "Detroit of Asia," Krichanont Iyapunya, a spokesman for the Ministry of Industry said. He said plant closures and openings happen constantly.

"The automobile industry must be adaptive," Krichanont said.

Liu, of Great Wall Motors,

said the Thai expansion was part of the company's global push, following the launch of a plant in Tula in Russia in 2019 and plans to acquire GM's Talegaon plant in India.

GM has struggled in Asia in the past year. Its International Operations, which include China, lost \$200 million last year, including \$100 million in the fourth quarter. It analyzed the business case for future production at the Rayong plant, but low utilization of its capacity and low sales volumes "made continued GM production at the site unsustainable," the company said.

GM's CEO, Mary Barra, said the company wants to focus on markets where it can drive strong returns, scaling back operations in Australia, New Zealand, and Thailand to selling niche specialty vehicles. GM will support its employees and customers in the transition, she said.

GM is making the same moves in Japan, Russia and Europe, where "we don't have significant scale," she said.

"We are pursuing a niche presence by selling profitable high-end imported vehicles supported by a lean GM structure," International Operations Senior Vice President Julian Blissett said in the statement.

GM said it will honor all warranties in the markets, and it will continue to provide service and parts. Local operations also will handle recalls and any safety-related issues, the company said.

The Detroit automaker expects to take \$1.1 billion worth

of cash and noncash charges this year as it cuts operations in the three countries.

GM President Mark Reuss, who once ran the Australian operations, said the company explored options to continue Holden, "but none could overcome the challenges of the investments needed for the highly fragmented right-hand-drive market, the economics to support growing the brand, and delivering an appropriate return on investment," he said in the statement.



## Puerto Rico online scam targeted more than \$4M amid crisis

SAN JUAN, Puerto Rico, Feb. 13, 2020 (AP): An online scam that targeted Puerto Rican agencies attempted to steal more than \$4 million, police said Thursday, deepening concerns about the management of local government finances during an economic crisis.

Authorities have frozen at least \$2.9 million, said an official who was not authorized to comment on the case and requested anonymity. The government has not said how much money was seized by the hacker.

The scam began when someone hacked into the computer of a finance worker at the island's Employee Retirement System in December, said José Ayala, director of the fraud unit within the bank robbery division. The hacker then posed as the female employee and sent emails to various government agencies alleging a change in bank accounts, he told The Associated Press.

Two agencies fell victim to the scam in recent

months: Puerto Rico's Industrial Development Company sent \$63,000 in December and more than \$2.6 million in January, while the island's Tourism Company sent \$1.5 million in January to fraudulent accounts on the U.S. mainland, he said.

Puerto Rico government officials realized what had happened when the finance worker at the Employee Retirement System called the agencies and said she had not received any payments and officials responded they had already sent them.

"That's when they call us and all hell breaks loose," Ayala said.

*El Nuevo Día*, a Puerto Rico daily newspaper, had reported the \$1.5 million payment that the tourism company had made. The other payment became public late Wednesday through a police report.

Ayala said no other government agencies have reported a loss as a result of the scam. He said the FBI is investigating how the computer at the Employee Retirement System got hacked.

On Thursday, legislators demanded a probe as government officials de-

clined to provide further information, citing an ongoing investigation.

"The government of Puerto Rico is in a serious fiscal crisis. It doesn't have enough money to fulfill its obligations," said Puerto Rico Rep. Ramón Luis Cruz, who filed legislation seeking an investigation. "It's truly absurd and unsustainable to have such a shallow and vague explanation."

Incidents in which hackers spoof or compromise an email account from a legitimate person or company are common in the public and private sector, said Meredith Ward, policy and research director at the National Association of State Chief Information Officers.

"It can be compared to knocking on the door," she said. "Happens every day, but entry isn't always gained."

Around the same time the Puerto Rico incident occurred last month, a school district in Manor, Texas, reported an email phishing scam that resulted in the loss of \$2.3 million.

Meanwhile, officials in Griffin, Georgia, reported a loss of more than \$800,000 last year after

receiving an email requesting an account change.

More than 23,700 business email compromises, as such scams are known, were reported on the U.S. mainland last year, with total adjusted losses of more than \$1.7 billion, according to the FBI. A special FBI team said it helped recover more than \$300 million stolen in that type of scheme last year.

Manuel Laboy, executive director of Puerto Rico's Industrial Development Company, told the AP that the agency is trying to recover the money.

Tourism spokeswoman Yolanda Rosaly referred questions to the governor, whose office said local and federal authorities were working on the case and that it cannot provide comment until the investigation is complete.

Puerto Rican Rep. Jesús Manuel Ortiz said the lack of information is unacceptable.

"There are a lot of questions that have not been answered," he said. "The government has to explain what happened."

## US wrestlers compete in Cuba despite frayed relations

HAVANA, Feb. 11, 2020 (AP): Two dozen athletes from the U.S. flew to Cuba despite rising tensions between the countries to participate in the island's most important Greco-Roman and freestyle annual wrestling competition.

The athletes came from states including New York, Minnesota, and Wyoming and included several Olympians.

"We're down here to compete in one of the greatest sports in the world," said Robby Smith, a 2016 Olympian from Danville, California.

He said he was too focused on the sport to think about political issues. "When it comes down to it—sports—it gets rid of all that. It's a peaceful thing. It's not political."

The visit comes several months after the Trump Administration imposed major restrictions on educational and recreational travel to Cuba as Trump continues to roll back Obama-era efforts to restore normal relations.

Luis Alberto Orta, a Cuban wrestler in the

130-pound (60-kilogram) category, brushed aside those issues. "It's essential that athletes from all countries be able to fraternize with us," he said.

A total of 14 countries are participating in the Gramma Cup and Cerro Pelado competition in Havana, among them Canada, Honduras, Argentina, and Hungary.

The Gramma Cup hosts Greco-Roman wrestlers and takes place Monday and Tuesday. The Cerro Pelado is for freestyle wrestlers and is scheduled for Feb. 15-16.

Manuel Rodriguez, a member of Cuba's National Wrestling Commission, said it is the event's 53rd edition.

"Trump can have those policies, but we are always going to receive all those athletes who want to come and compete with us," he said.

The U.S. athletes are visiting at the same time as Cardinal Timothy Dolan, the Roman Catholic archbishop of New York. Dolan was invited by Cuban President Miguel Diaz-Canel and has said he seeks to build bridges between the people of both countries.

## Científicos: Este enero fue el más caluroso desde 1880

WASHINGTON, DC, 13 II 20 (AP): El mes pasado fue el enero más caluroso desde que los científicos comenzaron a llevar los registros de las temperaturas en 1880, dijeron el jueves meteorólogos del gobierno de Estados Unidos.

La temperatura global promedio en la tierra y la superficie del mar en enero se ubicó 1,14 grados centígrados (2,05 Fahrenheit) por encima

de las temperaturas promedio para ese mes durante el siglo XX, debido al cambio climático, indicó la Oficina Nacional de Administración Oceánica y Atmosférica (NOAA, por sus siglas en inglés).

En partes de Rusia, Escandinavia y el este de Canadá, las temperaturas rebasaron los promedios previos en 5 grados centígrados (9 grados Fahrenheit).

Las temperaturas más cálidas causan el

derretimiento de la nieve y el hielo. La extensión del hielo en el océano Ártico se redujo 5,3% respecto del promedio de 1981-2020, y la del océano Antártico 9,8%.

El enero más caluroso después del segundo año más caluroso registrado "es uno de esos indicios de que las cosas se están calentando drásticamente", dijo el científico climático Don Wuebbles, de la Universidad de Illinois.

## Gobierno de Puerto Rico pierde 2,6 mdd por "phishing"

SAN JUAN, 12 II 20 (AP): El gobierno de Puerto Rico perdió más de 2,6 millones de dólares en un ataque con "phishing", según un alto funcionario.

El director de finanzas de la Compañía de Fomento Industrial de la isla, Rubén Rivera, dijo en una denuncia presentada el miércoles a la policía que la agencia gubernamental envió el dinero a una cuenta fraudulenta.

Rivera dijo que la agencia transfirió los fondos el 17 de enero después de recibir un correo electrónico fraudulento que alegaba que había habido un cambio a una cuenta bancaria vinculada a

pagos de remesas, según requeridos, y agregó que las autoridades intentan recuperar el dinero.

"Yo no puedo especular de cómo estas cosas pueden suceder", afirmó Rivera, refiriéndose a las severas críticas de los puerorriqueños, que quedaron estupefactos al enterarse de la noticia.

Rivera dijo que su agencia se tomó muy en serio la administración de los recursos públicos.

"Es una alta responsabilidad", afirmó.

La policía no respondió las llamadas para solicitarle sus comentarios.

La isla, que es territorio estadounidense, continúa sumida en una recesión que comenzó hace 13 años y que ha obligado al gobierno a reducir algunos servicios.

## EEUU investiga obsequios de extranjeros a universidades

NEW HAVEN, Connecticut, 13 II 20 (AP): Las autoridades estadounidenses investigan los obsequios de gobiernos extranjeros otorgados a las universidades de Harvard y Yale, como parte de una pesquisa más amplia sobre recursos foráneos a casas de estudio superior del país.

El Departamento de Educación informó el miércoles que está investigando la posibilidad de que algunas universidades exclusivas no hayan declarado cientos de millones de dólares en contratos y donaciones otorgados por Arabia Saudí, Irán y China.

Anteriormente, esa instancia había anunciado investigaciones de la Universidad de Georgetown y la de Texas A&M.

"Desafortunadamente, mientras más investigamos más descubrimos que

muchas universidades no reportaron esos ingresos o los reportaron erróneamente. Seguiremos recordando a las universidades de sus obligaciones y trabajaremos con ellos para garantizar de que sus registros financieros sean completos, precisos y transparentes como lo requiere la ley", declaró la secretaria de Educación, Betsy DeVos.

Una vocera de Yale, Karen Peart, indicó que la universidad está revisando la solicitud del Departamento de documentos relevantes a ciertos obsequios y contratos y considerando su respuesta.

Un vocero de Harvard, Jonathan Swain, también reaccionó afirmando que la institución está evaluando su respuesta.

Bajo la ley federal, las universidades están obligadas a reportar contratos y donaciones extranjeros que sean de 250.000 dólares o más.

En el caso de Yale, el Departamento de Educación dijo haber descubierto que la universidad posiblemente no reportó por lo menos 375 millones de dólares en obsequios y contratos extranjeros. En una carta, el departamento le notificó a Yale que al parecer esa casa de estudios no reportó ni un solo obsequio o contrato extranjero entre 2014 y 2017.

En Harvard, un profesor fue acusado el mes pasado de mentir sobre sus vínculos con un programa de reclutamiento chino y de ocultar pagos recibidos del gobierno chino para realizar investigaciones.

El Departamento de Educación mencionó el arresto en su anuncio el miércoles y manifestó inquietudes de que Harvard "podía carecer de controles institucionales apropiados sobre financiamiento extranjero" y podría haberse negado a reportar obsequios.

## Michigan zoo plays cupid with snow leopards to produce cubs

BATTLE CREEK, Feb. 16, 2020 (AP): Officials at a Michigan zoo are hoping its male snow leopard hooks up with a female snow leopard he was paired with through a breeding program that aims to give the threatened species a boost.

*Battle Creek's Binder Park Zoo recently introduced Victoria, a 2-year-old snow leopard that arrived in August from Omaha, Nebraska's Henry Doorly Zoo and Aquarium, with Raj, who's been at the Binder Park Zoo since 2012.*

Until Victoria arrived, the 7-year-old Raj was the lone snow leopard in Battle Creek. Zoo officials are hoping the pair will mate and produce a litter of cubs.

The big cats were matched through a Species Survival Program breeding recommendation from the Association of Zoos and Aquariums to make sure they were genetically compatible, the Battle Creek Enquirer reported.

"They do have a 'dating profile,' so to speak, but it's driven by science rather than romance," said Leslie Walsh, manager of marketing and development for Binder Park Zoo.

Walsh said the Association of Zoos and Aquariums Species Survival Plan maintains genetic data on the snow leopard population and makes breeding recommendations focused on the goal of genetic diversity.

Kathryn Sippel, the curator of collections at Binder Park Zoo, said

zoo officials had been watching the animals closely for cues from Victoria that she's ready to meet Raj.

Mating season for snow leopards is January through mid-March, followed by a gestation period of 98 to 104 days. The species is native to the mountain ranges of Central and South Asia.

The average litter size for snow leopards is two to three cubs. If Victoria and Raj mate, their cubs will most likely stay at the Binder Park Zoo until they mature. After that, they would hopefully receive their own breeding recommendations, Walsh said.



Last year, Michigan's Large Carnivore Act was amended to allow accredited zoos to breed large carnivores with a state permit.

Binder Park President and CEO Diane Thompson said the change in that law allowed the zoo to further its mission of conservation.

"When guests see snow leopards at the zoo, it's a special experience that creates awareness and understanding that we can make a difference together—for snow leopards and other animals, too," she said in a statement.

## Suit: District wrong to punish students over racist posts?

SALINE, Mich., Feb. 12, 2020 (AP): Four students in Saline sued their school district over discipline they received in the wake of racist social media posts directed at black students.

The federal lawsuit, filed Tuesday against Saline Area Schools, alleged district officials lacked authority to suspend the students over the posts, which led to a school meeting when a white parent asked a Latino parent why he didn't "stay in Mexico." Last week, people rallied in the community about 40 miles (60 kilometers) southwest of Detroit to promote unity and inclusion hold-

ing signs whose messages included "Racism Not Welcome."

The white students, who were not identified, were among those added to a private group on Snapchat, according to the lawsuit. Many of the students in the group, who were both white and black, were using what the lawsuit called "offensive terms like the 'N' word"—language it states was "inappropriate" and "immature," yet shared "between friends and in a joking manner."

Following that, the lawsuit added, school officials "made a grossly negligent decision to verbally suspend all the Plaintiff chil-

dren and barred them attending Saline High School indefinitely." The suit seeks damages and injunctions reinstating the youths, two of whom have returned to class, as well as having their names cleared.

Scot Graden, Saline schools' superintendent, told The Associated Press via email that the district can't comment on pending litigation. He said in a statement on Feb. 4 that "hate, prejudice and racism have no place in our schools or our community," and the district has been working "to ensure a welcoming, inclusive and safe environment for all students and families."

## BGSU enrollment continues to grow

**B O W L I N G GREEN**, Feb. 12, 2020: *Bowling Green State University continues to buck the national trend of declining enrollment. Overall enrollment for the spring 2020 semester is up 3 percent over a year ago, meeting the University's goals.*

Total student enrollment for spring 2020 is 19,331, up from 18,776 in 2019. BGSU's fall-to-spring retention rate remains strong at nearly 91 percent for spring 2020.

Undergraduate enrollment on the Bowling Green campus for spring 2020 is up 3 percent over last year with a headcount of 14,658 compared to 14,196 in spring 2019. BGSU

Firelands saw an enrollment increase of just over 5 percent, from 1,977 in spring 2019 to 2,080 in spring 2020. Graduate enrollment is steady with 2,593 students to 2,603 students in spring 2019.

The University saw a dramatic increase in enrollment for the second year of its winter session, which adds a three-week session to the academic calendar. Enrollment was more than 1,400 students and included those participating in courses online, courses on campus and experiences both abroad and throughout the United States. Winter session enrollment last year was 1,062.

These numbers are released every semester on the 15th day of



classes, which marks official enrollment counts that are reported to the State of Ohio.

"We're extremely pleased with our progress in enrollment growth, and most importantly, in our measures of student success. We continue to improve in retention and set a new mark by achieving the highest four-year graduation rate in our history," said BGSU President Rodney K. Rogers. "Our students are engaged in a learning community that prepares them to live meaningful and productive lives."

## Kaptur announces over \$53 million in Federal Funding to strengthen Northern Ohio Economic Development and Affordable Housing

Washington, D.C., Feb. 13, 2020: *Congresswoman Marcy Kaptur (OH-09), Chair of the House Appropriations Subcommittee on Energy and Water Development, has announced \$53,288,348 in federal investments for communities across Northern Ohio.*

The funding was provided by the Department of Housing and Urban Development. Specifically, the funding comprises \$38,391,672 in Community Development Block Grant (CDBG), \$10,282,141 in HOME Investment Partnership Program (HOME), \$3,034,624 Emergency Solutions Grant (ESG), and \$1,579,911 in Housing Opportunities for Persons with AIDS (HOPWA) funding.

"The Community Development Block Grant, HOME, ESG, and HOPWA are all vital streams of investment that support local economic development, community revitalization, and affordable housing essential to the success of our local community residents and economies," said Rep. Kaptur. "Without this important funding, many of the job-creating projects across Northern Ohio might not be here today. I am glad to have played a role in securing increased funding for these life-sustaining programs. While the Trump Administration continues to zero out these investments,



vides housing assistance and related supportive services to local units of government, States, and nonprofit organizations for projects that benefit low-income persons medically diagnosed with HIV/AIDS and their families.

The announcement is a result of the FY20 appropriations package, which allocated \$3.425 billion to the Community Development Fund, \$1.35 billion to the HOME program, \$290 million to ESG, and \$410 million for HOPWA.

## Demand: Líderes de Luz del Mundo abusaron de mujer 18 años

LOS ÁNGELES, 13 II 20 (AP): Una mujer del sur de California declaró que los dos líderes de la Iglesia mexicana La Luz del Mundo abusaron sexualmente de ella durante 18 años, desde que tenía 12, manipulando pasajes de la Biblia para convencerla de que su maltrato era, en realidad, un regalo de Dios, según una demanda federal.

Sochil Martin, de 33 años, dijo que desde los 9 años fue "criada" para complacer a los autores de la Iglesia, el difunto *Samuel Joaquín Flores* y su hijo *Naasón Joaquín García*. Se le enseñaron bailes eróticos que derivaban en toqueteos y caricias sexuales.

Después de que cumplió 20 años, el abuso se incrementó a violaciones, golpizas y humillación pública por parte de García, aseguró Martin, y continuó hasta que escapó de la Iglesia en 2016 junto con su esposo.

"Durante los primeros 30 años de mi vida se me enseñó a creer que mi cuerpo, mi mente y mi alma pertenecían a La Luz del Mundo porque esa era la voluntad de Dios", dijo el jueves con la voz entrecortada en una conferencia de prensa. "Hoy doy la cara porque esto debe acabar. Generaciones de niños criados por La Luz del Mundo han sido obligados a convertirse en servidores sexuales de los apóstoles de La Luz del Mundo".

Martin se presentó junto a sus abogados y su esposo en Los Ángeles, donde incoaron la demanda el día anterior. The Associated Press normalmente no identifica a las personas que aseguran haber sido víctimas de abuso sexual, pero ella dijo que quería que su nombre se publicara.

El abogado de García no comentó de inmediato sobre la demanda, que solicita un juicio con jurado e indemnizaciones aún no especificadas.

García fue arrestado el año pasado y permanece detenido sin derecho a fianza por cargos de violación de menores y tráfico de personas, relacionado con tres niñas y una mujer, entre 2015 y 2018 en el condado Los Angeles. Él niega haber cometido algo ilegal.

Martin, quien no es una de las mujeres en el caso penal, dijo que ha cooperado con las autoridades de México y Estados Unidos desde octubre de 2018, pero sus abogados se negaron a dar detalles. El Departamento de Justicia de California, que lleva el caso contra García, declinó comentar.

García, de 50 años, sigue siendo el líder espiritual de La Luz del Mundo. Su abuelo es el fundador de esa Iglesia evangélica cristiana con sede en Guadalajara, México, que asegura tener 5 millones de fieles alrededor del mundo.

Martin nació en Monterey Park y fue miembro de cuarta generación de La Luz del Mundo, según indicó. Desde temprana edad se le dijo que era "propiedad" de los apóstoles de la Iglesia. Su tía, quien la crió desde que tenía 3 años, le hacía favores sexuales a Flores y ayudó a convencer a su sobrina, diciéndole que no se podía negar a los deseos sexuales de los líderes, según la demanda.

Martin dijo que creía que los actos sexuales eran "en fomento de la voluntad de Dios". Durante los procedimientos judiciales, los fiscales han dicho que algunos padres dentro de la Iglesia entregaban a sus hijos a los apóstoles porque lo consideraban una "bendición".

En la denuncia, Martin dijo que intentó suicidarse y que no estuvo lo suficientemente saludable a nivel emocional ni psicológico para interponer una demanda sino hasta finales del año pasado.

En la demanda se describe el extravagante estilo de vida de García y su familia, incluyendo

la posesión de animales exóticos y un museo privado de autos clásicos restaurados, todos adquiridos con las contribuciones de los feligreses y la mano de obra gratuita. La denuncia calcula que Martín trabajó alrededor de 30.000 horas sin sueldo para la Iglesia, incluyendo en su departamento de difusión en México y California.

En 2010 Flores se preocupó por la obsesión de su hijo con Martín, pensando que podía poner en riesgo la estabilidad de la Iglesia. Intentó organizarle un matrimonio a ella y obligó a García a trabajar en otro lugar, según la demanda.

Poco después del fallecimiento de Flores en 2014, su hijo reanudó su relación sexual con Martín, se añade en el texto. Además, se le pidió que preparara a menores para García, y se afirma que recibió una golpiza cuando se negó a participar en un acto sexual con un niño de 14 años.

El esposo de Martin no estaba al tanto de la relación de su esposa con García hasta 2016, cuando encontró mensajes de texto pornográficos entre ella y el líder y fue entonces que la ayudó a escapar de la Iglesia.

Posteriormente, según la demanda, La Luz del Mundo emprendió una campaña de calumnias contra su familia en México y California e intentó comprar su silencio, mandó destruir su casa y ordenó que la siguieran. La campaña continuó incluso después del arresto de García.

En la conferencia de prensa, Martin se dirigió a otras posibles víctimas, instándolas a dar la cara.

"Es momento de que digan 'basta'", comentó. "No es una bendición, no es un regalo de Dios, no está bien".

## Man convicted of killing woman in church lot sentenced

CLEVELAND, 11 II 20 (AP): An Ohio man accused of running over and killing a woman who tried to stop him from stealing her family's van in a church parking lot has been sentenced to life in prison with parole eligibility in 23 years.

The sentencing on Monday came after a jury in Cleveland last month convicted Michael Preston, 24, of murder and other charges.

Lesley DeJesus, 33, was at a Cleveland church in November 2018 planning her daughter's Quinceañera, a traditional Latino celebration of a girl's 15th birthday. The daughter saw two men in the parking lot trying to steal the van, prompting DeJesus and her husband, Jesús Cruz-Maldonado, to run outside to stop them, authorities said.

Preston drove away as the couple fought with him, dragging Cruz-

Maldonado a short distance and then running over DeJesus, prosecutors said. Preston was later identified from DNA evidence found inside the van.

Messages seeking comment were left with Preston's attorneys on Tuesday.

Preston declined to speak at sentencing based on his attorneys' advice because he maintains his innocence, cleveland.com reported.

## Muere Paula Kelly, actriz de cine, teatro y televisión

Kelly murió el domingo de enfermedad pulmonar obstructiva crónica, según la compañía Ebony Repertory Theatre en Los Angeles.

Fue postulada a un Emmy a mejor actriz de reparto en 1984 por su

papel de la defensora pública Liz Williams en la primera temporada de "Night Court" de la NBC, y fue nominada nuevamente en 1989 por interpretar a una lesbiana en la miniserie de ABC "The Women of Brewster Place" ("Las mujeres de Brewster Place").

Kelly debutó en Broadway en 1964 en el musical "Something More!"

dirigido por Jule Styne y protagonizado por Barbara Cook. Más tarde compartió el escenario con Morgan Freeman en "The Dozens". Uno de sus papeles más importantes fue el de Helene en "Sweet Char-

ity", que primero representó en el circuito teatral de Londres y luego repitió en la ópera prima de Bob Fosse.

Sus créditos en el cine incluyen "The Andromeda Strain" ("La amenaza de Andrómeda"), "Top of the Heap" ("Patrullero Lattimer") y "Soylent Green" ("Cuando el destino nos alcance"), mientras que en televisión apareció en series como "Santa Barbara" ("Santa Bárbara"), "Mission: Impossible" ("Misión imposible"), "Kojak" y "The Golden Girls" ("Los años dorados").



### Fund Raising for Toledo Sister Cities-Qinhuangdao and Nanchong (QHD/NC)

By February 10, 2020, the new coronavirus (2019-nCoV) has infected over 40,000 people in 29 countries, with the majority of them in China. Over 1,000 patients have lost their lives.

Many cities in China have suffered from the epidemic, including two of Toledo's sister cities in China: Qinhuangdao and Nanchong. By February 10, there were 32 confirmed cases in Nanchong and 9 in Qinhuangdao. Qinhuangdao and Nanchong reached out to Toledo Sister Cities International (TSCI) on Jan 30<sup>th</sup> and asked for HELP, especially for N95 or KN95 face masks and disposable medical gowns.

On Feb 9, the TSCI-QHD/NC Committee invited local community leaders to discuss QHD/NC's requests for help and decided to initiate a fund-raising campaign for the two sister cities. The TSCI worked with Toledo City Council (TCC) closely, and the TCC will pass a resolution on February 11 to support the TSCI's fund-raising efforts. El Comité Mexicano de Cleveland tomó la iniciativa el pasado mes de octubre del 2019 cuando realizaron una primera reunión para comenzar el proceso de establecer un Jardín Cultural Mexicano. Continuaron reuniéndose y planificando hasta que el pasado 20 de enero del presente año, presentaron sus planes a la Junta Directiva de la Federación de Jardines Culturales de Cleveland.

Rey Esparza, presidente del Comité, comentó: "Muchas organizaciones han creado jardines representando a países de todas partes del mundo, pero hasta ahora no hay ninguno de Latinoamérica. Apenas nos dimos cuenta que a finales del año pasado Colombia presentó su proyecto y creo a principios de este año se los aprobaron. Muchas organizaciones habían querido realizar la propuesta pero no se habían aventurado al ruedo. Así que comenzamos a investigar, realizar reuniones y darle forma al proyecto para que fuera aprobado. Lo que nos ayudó es la organización que tenemos en nuestro Comité".

inicio operaciones hace tres años con la unión de varios líderes mexicanos en el norte de Ohio, quienes realizaron una lluvia de ideas para establecer las líneas de trabajo y de esa manera, decidieron trabajar sobre tres ejes: Arte y cultura, servicios y educación.

El primer año lo enfocaron en Arte y Cultura realizando eventos y celebraciones para dar presencia a la comunidad mexicana y tratar de romper con los estereotipos de ese momento. Al respecto, Eduardo Rodríguez, vicepresidente del Comité, señaló: "Con las cuestiones políticas que se estaban dando en ese entonces, nos calificaban de violadores, ladrones, entre otros, y por eso decidimos realizar eventos que contrarrestaran esa información".

El segundo año ofrecieron Servicios en unión con el Consulado de México en Detroit y apoyaron a la realización de un consulado móvil en esa área. En el tercer año se enfocaron en Educación y es ahí donde entró la propuesta del jardín cultural. Para presentar dicho proyecto, era necesario convencer a la Junta de la Federación que son un grupo representativo de la comunidad mexicana, es por ello que se dieron a la tarea de trabajar con diversas universidades y recaudar información sobre la presencia de los mexicanos en el norte de Ohio.

"De acuerdo con los datos del Censo, a nivel local somos el primer grupo en el Estado, pero a nivel ciudad somos el segundo grupo, primero está el puertorriqueño", dijo Rodríguez. Sin embargo los números varían mucho, unos dicen que somos seis mil connacionales, otros que alrededor de 20mil porque hay muchos que no se cuentan por su estatus legal migratorio. Sin duda alguna los datos de este nuevo Censo 2020 nos ayudarán mucho a definir mejor los números".

El Vicepresidente destacó que la consolidación del grupo, el trabajo realizado durante los pasados tres años y demostrar que realmente representan a la comunidad mexicana, es lo que les permitió recibir la aprobación de la Junta de



la Federación de Jardines Culturales de Cleveland.

Ahora, el siguiente paso es seleccionar el área en donde desean llevar a cabo el proyecto. "Ya fuimos a ver los jardines y tenemos un candidato de área que nos gustaría fuera aprobada. Es un espacio bastante grande donde se creará el jardín y también tendrá espacio para crear eventos como celebraciones del 5 de mayo, 16 de septiembre o bien, quinceañera o boda. Son bastante amplios los terrenos", informó Rey Esparza.

Una vez que sea aprobado el espacio, el Comité deberá darse a la tarea de buscar un arquitecto que realice el diseño adecuado. Gracias al trabajo que realizaron con las universidades, ya se tienen algunos contactos con los que se puede integrar un equipo de recién graduados de arquitectura, así como compañías establecidas de diseño para involucrar a los jóvenes con los expertos.

Para este proceso se requerirá de la recaudación de fondos de todo tipo, desde donaciones pequeñas, medianas, grandes y participación activa de la comunidad para ensuciarse las manos en la limpieza y mantenimiento del lugar.

"La ciudad aportará mantenimiento básico pero nosotros como comunidad tendremos la responsabilidad de darle el mantenimiento adecuado dependiendo de la vegetación que pongamos, como cambiar las plantas cada estación año si es necesario, todo va depender del diseño que se realice", destacó el Presidente del Comité.

Por su parte, Patricia Esparza, secretaria del Comité Mexicano de Cleveland, apuntó: "No queremos que la gente tenga la idea de que es un jardín de Cleveland, ya que es un proyecto único

conciertos; así como pláticas y talleres tanto con artistas extranjeros como locales.

Cabe destacar que el Comité Mexicano de Cleveland está conformado por alrededor de 25 personas. Hay un Consejo Directivo conformado por una directiva que es el presidente, vicepresidente, tesorero y secretaria. Después están los directores de área y los coordinadores de proyecto. "Cada proyecto tiene una persona encargada, es por eso que siempre damos continuidad a todos nuestros proyectos. El Programa de Consulados Móviles tiene como objetivo principal la prestación de servicios consulares a los mexicanos que residen en poblaciones alejadas de las sedes consulares. Bajo este programa, los connacionales que viven en estas comunidades tienen la facilidad de obtener documentos de importancia, como Pasaportes y Certificados de Matrícula Consular de Alta Seguridad (MCAS).

El pasaporte es un documento de identidad y viaje que identifica a su titular como nacional del país que lo expide y le permite viajar a otros países, siempre y cuando cumpla con los requisitos migratorios y/o de visado del país al que se dirija.

La MCAS es un documento que cumple con fines censales y de protección. Además, tiene la ventaja de ser aceptado por un gran número de instituciones privadas y oficiales como documento de identidad, como prueba de nacionalidad, y como comprobante de domicilio en un distrito consular dado. No obstante, es importante aclarar que la MCAS no comprueba ni pretende sustituir el documento extranjero de legal estancia en un país. En ese sentido, solamente muestra que el portador está domiciliado en el extranjero y registrado ante la representación de México.

Durante los Consulados Móviles también se puede recibir información sobre los diversos servicios que se ofrecen en la representación consular y asesoría de protección preventiva con valiosos consejos sobre qué hacer y a dónde dirigirse en caso de que un connacional se encuentre en una situación de emergencia legal.

"Generalmente nos acompañan abogados, representantes de organizaciones o autoridades para dar alguna asesoría gratuita, mensaje o plática en materia de protección. También nos han acompañado representantes del Departamento del Trabajo para ofrecer orientación", informó Claudio Uribe, nuevo Cónsul del Departamento de Documentación.

Uribe fue Cónsul del Departamento de Protección durante dos años en el Consulado de México en Detroit, y en diciembre del 2019 se realizó una rotación del personal.

El diplomático mexicano comentó que en cuanto se tengan las sedes en donde se llevarán a cabo cada uno de los consulados móviles, se darán a conocer. Asimismo, dijo que durante estas jornadas también se ofrece el servicio de Actas de Nacimiento y permisos OP7 para menores de edad, que son las autorizaciones que otorgan los padres para que un menor pueda obtener su pasaporte, ya sea en otro Consulado o en México.

En algunas ocasiones también se incluye en los Consulados Móviles, el servicio de Registro Civil para registrar a los hijos de padre o madre mexicano que hayan nacido en el extranjero. "Este trámite era algo que hacíamos exclusivamente aquí en la sede, pero ya hemos hecho excepciones para tomar citas en algunos lugares. Todo depende de los aliados que tengamos en cada localidad que visitamos. Es un proceso complejo y requerimos que nos ayuden a recopilar la información previamente, nos la envíen dos o tres semanas antes para que la revisemos y el día que estemos allá puedan ir las familias a concluir el trámite de registro de sus hijos", agregó el entrevistado, quien aseguró que previamente se darán a conocer los lugares en donde ofrecerán este servicio para que los connacionales puedan organizarse y hacer su cita.

Otro de los servicios que se ofrece es el registro de las solicitudes para el trámite de la Credencial para Votar desde el Extranjero del Instituto Nacional Electoral (INE). "Nosotros no emitimos esa credencial, únicamente hacemos la solicitud para enviarla a México y posteriormente se reciba por correo", destacó Uribe.

La credencial para votar es un documento para que los mexicanos que residen fuera de México puedan votar en las elecciones mexicanas desde el extranjero. Es también un documento de identificación oficial reconocido en México. Es importante tener en cuenta que al momento de realizar este trámite, el nombre será separado del padrón electoral para formar parte de la Lista Nominal de Electores Residentes en el Extranjero. Por esta razón, si al momento de celebrarse una elección la persona se encuentra en México, no podrá votar.

Para ser atendido en los Consulados Móviles, es indispensable hacer cita en Mexitel en el 1877 6394835.

## Notice of Closing the Low-Income Public Housing (LIPH) Waiting List



**MICHIGAN / OHIO:** Desde el pasado 1 de enero, el Consulado de México cuenta con nuevos precios para los servicios de pasaporte, matrícula consular, poderes notariales, testamentos, copias certificadas de actas de nacimiento y menaje de casa.

### Los nuevos costos son los siguientes:

#### PASAPORTE

Vigencia 1 año (solo para menores de 3 años de edad o casos especiales de protección): \$34;

Vigencia 3 años: \$78;

Vigencia 6 años: \$107;

Vigencia 10 años: \$150;

Las personas mayores de 60 años reciben un descuento del 50%.

**MATRÍCULA CONSULAR** Vigencia 5 años: \$30.

**PODERES NOTARIALES:** \$127 (personas físicas) y \$190 (personas morales);

**TESTAMENTOS:** \$323;

**CÓPIAS CERTIFICADAS DE ACTAS DE NACIMIENTO:** \$14;

**MEJANE DE CASA PARA MEXICANOS:**

\$105;

#### MEJANE DE CASA PARA EXTRANJEROS: \$140.

**Claudio Uribe**, Cónsul de Documentación en el Consulado de México en Detroit, dijo que el pasaporte de 1 año se otorga únicamente a menores de edad o en casos de protección. "Son para todos aquellos que no cumplen con los requisitos que la ley señala para obtener un pasaporte ordinario, por ejemplo que tenga un error en el acta de nacimiento o que no cuenten con una identificación y deban viajar a México por una emergencia comprobable o deseen regresar al país.

También si se tiene cita pendiente en corte y se muestra el citatorio o bien, para que puedan ser atendidos en un hospital. Son los tres casos generales en donde se otorga este tipo de pasaporte".

Asimismo, destacó que el aumento del costo en los documentos fue poco. "Fueron unos cuantos dólares. El pasaporte de tres años costaba \$74 y aumentó \$4 dólares, el de 6 subió \$6, el que más aumentó fue el de 10 años, antes costaba \$136 y ahora cuesta \$150. Ya tenía varios años que no se actualizaban los precios".

Los pagos se realizan

#### Los requisitos siguen siendo los mismos. Pasaporte por primera vez:

1. Acta de nacimiento certificada por el Registro Civil, no se aceptan actas enmendas, alteradas y/o mutiladas. El acta original se devuelve;

2. Identificación oficial con fotografía. Debe tener el nombre completo del interesado tal y como aparece en el acta de nacimiento. Las identificaciones que se aceptan son: Certificado de primaria o secundaria con foto, credencial de elector (INE), cartilla del servicio militar, matrícula consular,

título o cedula profesional. Identificación oficial expedida por autoridad médica o de Michigan u Ohio;

3. Acta de Matrimonio solo si desea que en su documento aparezca el apellido de casada. Si se casó fuera de México o los Estados Unidos, su acta deberá estar legalizada o apostillada.

**Renovación:** Presentar pasaporte anterior en lugar de acta de nacimiento. Si el pasaporte que va a renovar fue expedido con "observaciones", deberá de cumplir con la condición/es señalada/s para poder renovarlo. Los pasaportes expedidos en territorio nacional antes del año 1995 y, pasaportes expedidos en las oficinas consulares antes del año 2006, se hará el trámite como primera vez, por lo tanto, se requieren los originales de todos los documentos que presente.

#### Pasaporte para menores de edad:

1. Acta de nacimiento;

2. Identificación oficial. Certificado de primaria o secundaria de la SEP, identificación de la escuela o constancia de estudios con foto del menor y sello oficial de la escuela.

En caso de menores de 6 años: Constancia médica expedida por el pediatra con nombre completo del menor con sello del consultorio o firma del pediatra sobre la foto del menor.

3. Permiso OP7. Tanto para el trámite por primera vez como para la renovación ya sea del pasaporte o de la Matrícula Consular es indispensable que se presenten ambos padres, con identificación oficial con el nombre completo tal cual aparece en el acta de nacimiento del menor. La forma se proporcionará en las oficinas del Consulado. En el caso de que uno o ambos padres no vivan con el menor tramitar autorización en el Consulado o delegación de la SRE que le corresponda.

4. Acta de Matrimonio sola para mujeres casadas.
