FLOC: Lead Paint to be renewed as Community Issue to be solved

March 2019: Toledo's minority community will once again call for a solution to lead paint in the city's older homes, hoping to stem the health effects on children in the community's rental housing stock.

The Brown and Black Unity Coalition plans to demand answers from Toledo City Council as to why they fell silent on the issue following a court order blocking lead paint legislation from being implemented last year. The coalition will be led in the effort by Baldemar Velásquez, president/founder of the Farm Labor Organizing Committee (FLOC), and Ray Wood, NAACP president.

"That lead in the paint causes brain damage to children. Studies were done of people incarcerated and they found out some 70 percent of the inmates had elevated levels of lead," said Velásquez.

"The chips from the paint, and the dust from the paint are still there," said Wood. "Every day, kids are being impacted by the effects of lead paint poisoning. Once you're contaminated, it's irreversible. You have that forever. It affects the way your mind operates."

Lead paint in the central city could become a hot-button political issue in the coming months, as six district seats on Toledo City Council will be up for grabs in September's city-wide primary and November's general election. Republican city councilman Tom Waniewski is term-limited



and cannot run again, while the Lucas County Democratic Party recently refused to endorse incumbent councilman Tyrone Riley in an upcoming three-candidate race in the city primary.

"I can't comprehend that any elected official thinks it's all right under any circumstances to damage and to poison children's minds," said Velásquez.

"Every time we've brought this up in the past, we've not had the stamina to see it all the way through," said Wood. "This is one of those things where if you don't stay on top of it, it will get swept under the rug or everybody will forget about it, but the issue continues."

The issue is gaining political traction, making the time ripe for the Black and Brown Unity Coalition to begin raising their voices. At-large Toledo city councilman Larry Sykes announced he

would reintroduce lead paint legislation that covers all rental homes and apartment buildings.

"Push the elected officials, push the politicians to not allow the slum landlords who don't even live in those areas, to take our money and take our rent and poison our children," said Velásquez. "We've got to give our politicians some courage."

Sykes stated he got tired of waiting for a mayor's working group to craft a solution. The group has been meeting since last summer, when Judge Linda Jennings struck down a previous city ordinance as unconstitutional and discriminatory. Critics believe it could be years before that working group crafts a passable compromise, while kids continue to suffer lead poisoning.

The previous law only covered smaller rentals, not all rental housing units. The

judge also ruled city leaders don't have the authority to grant enforcement authority to the Toledo-Lucas County Health Department, which was originally assigned with registering properties. The amended lead-safe ordinance Sykes is pushing moves that task to Toledo's Department of Neighborhood and Business Development

"We're not going to walk away from that. We've appealed (the case) and we're going to continue with other groups in the city to stay on top of this," said Wood. "I think they are hoping, because it was overturned in court, that we're going to walk away from it and continue to let kids be poisoned. This is going to be one of our focal targets and we will stand together and make sure that we can win this for the sake of our kids."

"Why are we being so polite about this issue?" Velásquez wondered aloud. "If it was my children living in that old house, I'd be very urgent about it. I wouldn't care about what people say or how they're using the law to stop this. We need to FLOC tactics to go after these suckers. We need some creative non-violence."

A group of landlords known as The Property Investor's Network brought the lawsuit and now some of its members sit on the mayor's working group. The Black and Brown Unity Coalition contends some of those same landlords attended community forums to show support for a lead-safe law to clean up

César Chávez celebration to feature lecture by renowned Chicano civil rights and educator José A. Gutiérrez

In 2003, former governor Jennifer Granholm established March 31 as César E. Chávez Day in Michigan. The date marks the birthday of the labor leader, who worked to improve the lives and livelihoods of impoverished, disenfranchised farm workers in the nation's agricultural fields. Wayne State University's Center for Latino/a and Latin American Studies will commemorate the occasion with a pub-

lic lecture by José Angel Gutiérrez, a contemporary of Chávez who played a vital role in shaping the direction of the Chicano Movement.



A Texas native who holds advanced academic degrees in political science and law, Gutiérrez became an activist, community organizer and

reformer. He founded or co-founded several influential organizations that championed the democratization of social, educational and political institutions, including

the Mexican American Youth Organization, the La Raza Unida Party, the National Council of La Raza, and the Mexican American Legal Defense and Education Fund. The founder of the Center for Mexican American Studies at the University of Texas, Austin, Gutiérrez has authored or co-authored over a dozen books on politics; history; higher education; land rights; and Chicanas in the public arena, student leadership, and aviation.

Gutiérrez's public lecture will focus on his latest book, *The Eagle Has Eyes: The FBI Surveillance of César E. Chávez and the United Farm Workers Union of America, 1965-1975*. The lecture will be held on Wednesday March 27, from noon to 1:30 p.m. at Wayne State's General Lectures Hall, Room 150, located at 5045 Anthony Wayne Drive.

Autographed copies of the book will be available for purchase. Event is free and open to the public. Light refreshments will be served.



Antonio Barrios: Lorain Latino seeking City Council seat

With the prospect of losing a Latino voice on *Lorain City Council*, a community activist is stepping forward to run for an available seat in the May 7, 2019 primary to ensure representation remains in place.

Antonio Barrios recently announced he'll seek a city council seat. The Lorain resident of Puerto Rican descent has been very active within the Lorain County Democratic Party, serving as a member of the party's central committee. As 2nd Chair of the county party, Barrios also serves on the executive committee.

Although he is running for an at-large city council seat, much of his political experience is based in his own neighborhood—serving as the 5th and 6th Ward area leader and as precinct committee person in the 5th Ward. Those roles are instrumental in grassroots get-out-the-vote campaigns for Democratic candidates. He started 15 years ago with a group known as *Reclaim Lorain*, after seeing some inner-city wards get neglected in favor of more affluent areas of the city.

"I want people to understand—I'm not the Wizard of Oz," he said. "I'm not coming in with a magic wand and abracadabra and all of a sudden everything's fixed. But I'm coming in with a passion and love for this town I grew up in. I was here in its heyday. I know what it was and can be. We can retool and remodel ourselves and do other things differently. We're right on the brink of

making that leap."

Barrios, 71, recently launched Facebook page for his candidacy under a theme of "knocking down walls to unite the people," a direct reference to repeated attempts in Congress by President Trump to get funding to build a wall along the Mexican border to control immigration.

"Now is the time to create unity and I believe that all residents together, can make changes happen for the good of all citizens of this international city," Barrios wrote on his Facebook page. "In this moment of chaos and confusion, it is of dire importance that cooler minds prevail and that we focus on knocking down the walls that have been created to divide the people. We must make room for healthy dialogue which will be the best path for communication and uniting the people."

Longtime Lorain City Council President *Joel Arredondo* recently lost a bid to be appointed as a Lorain County Commissioner, which is considered a full-time elected office. The Lorain County Democratic Party central committee instead chose *Sharon Sweda* for the appointment from a six-candidate field. She recently ran unsuccessfully for a seat in the Ohio Senate.

According to Barrios, one in five Lorain residents is Latino. He believes the elected political representation should reflect the makeup of the community, so their voice is heard on issues.

There are two other Latino

Lorain city councilmen, but *Angel Arroyo* is not running for re-election. Barrios and another Latino candidate, *Ray Carrion*, if both are elected, would increase the Hispanic influence in city politics.

Barrios is running for at-large seat because he wants to see more sections of the city get attention. For example, he believes the momentum of the current downtown development should be moving at a faster pace.

"We should be putting more assets and whatever we have as resources into making that the place of destination. We should be working a lot more on that," he said, while emphasizing the arts could be a catalyst for more businesses to locate there and increase tourism.

As executive director of the *Lorain Arts Council*, Barrios is very active in the northern Ohio arts scene. He was instrumental in the unveiling last September of a large veterans' mural in the downtown area, a five-month project designed to help veterans cope with their post-war struggles and find their purpose through art. Veterans went through instruction in painting, water colors, and drawing—then

created wooden paddles depicting various "stories."

Barrios also hosts the weekly "Sabor Latino" radio show on WDLW Kool Kat Oldies 1380 AM and 98.9 FM, a three-hour program focusing on current issues facing the Latino community. Interspersed in discussion and interviews is throwback "Jibaro" music. Barrios even finds time to be a small business owner with *FrameWorks*, which focuses on photography and video.

Barrios has served as president of the *Puerto Rican Culture Committee* and vice president of the *Coalition for Hispanic/Latino Issues and Progress (CHIP)*, an advocacy group working to ensure there is growing Latino influence in the political and economic landscape of northern Ohio.

Barrios was born in Santurce, Puerto Rico, but moved to Lorain at the age of four with his mother and siblings. His father preceded the family to northern Ohio as part of the first group of 500 Puerto Rican men brought to Lorain to work in the steel mills. He grew up in a low-income, working-class neighborhood of mostly sugar cane workers before his family settled in Lorain.

Their life stateside started in the basement of a friend's house. He worked as a young boy picking produce in the fields, while his family sent him to Catholic schools through the eighth grade. He moved to public school and graduated from *Lorain Admiral King High School*, then attended *Lorain County Community College* for an associate's degree in computer technology and *Cleveland State University*, where—when time permits—he is working towards obtaining a bachelor's degree in film and digital media.

Honoring César Chávez

César Chávez died near his hometown of Yuma, AZ on April 22, 1993 at the age of 66. Chávez was in San Luis, AZ to assist UFW attorneys defend the union against a lawsuit brought by Bruce Church Inc. (BCI), a giant California-based lettuce and vegetable producer.

Following two days of intense grilling by BCI lawyers, Chávez died in his sleep of natural causes. The jury awarded BCI \$2.9 million, but nearly two years later, the Arizona Court of Appeals overturned the decision. A year later, BCI and the UFW agreed on a contract for workers.

I recount this case to point out that Chávez had major victories and many setbacks in his struggles to unionize farmworkers and

obtain contracts with their employers. His efforts involved many tactics and strategies, including nonviolence, labor strikes, boycotts, marches and rallies, legal challenges, fasts, and legislative initiatives.

Today, the work lives of farmworkers are greatly improved compared to the pre-Chávez period, but there have been many setbacks since his time. Driving these setbacks has been the shift in political beliefs from social democratic principles to free market fundamentalism, the ideas of today's "conservatives."

The shift is from principles of individual freedom, equality, social justice, and solidarity to principles of radical individualism, limited government, and limits on labor rights. Chávez lived through

this shift, having faced the setbacks imposed by California Governor George Deukmejian, who sided with growers and used the California Agricultural Labor Relations Board against farmworkers by loading the Board with pro-agribusiness members. By the time that Chávez died, the free market fundamentalists had radically changed the political values of the nation, and empowered the wealthy as a ruling class.

They reduced government by cutting taxes, privatizing government functions, eliminating regulations that kept corporate power in check, and reducing the rights of labor. This is the political environment in which we find ourselves today. Indeed, Trump has taken free market fundamentalism to an extreme, con-

tinuing to cut taxes on corporations, making the Federal Government dysfunctional, and appointing justices that support free market fundamentalist principles.

Most Americans recognize that the nation is at a crossroads; either go down the road in which the wealthy rule the country in their own interests, or take the road that promotes equality of opportunity, social justice, and a government that protects the rights of all and promotes social progress. Free market fundamentalist policies have created great economic suffering among Americans, which is why there is great interest in the ideas of Bernie Sanders, Elizabeth Warren, and others. In response, conservatives have trotted out the "communist" and "socialist" bogeymen

seeking to frighten Americans and to mobilize hostile sentiments against socialist democratic principles.

As we pay tribute to César Chávez, we must remember that it is not enough to honor him for his courage and heroism; we must also *act like him*. That is, we must have the courage to stand up for basic human rights and dignity, demand competent and just government, and ensure equal opportunity for all.

How do I register my child for Kindergarten?

- Obtain a TPS enrollment packet from your neighborhood elementary school or download one from tps.org
- Completed registration packets can be returned to your neighborhood elementary school

What do I need to register my child for Kindergarten?

3. Custody papers (if applicable)
4. Immunization or shot records
5. Three (3) proofs of residence, including:
 - Lease agreement or mortgage deed (mandatory)
 - Two from the following list:
 - Source of income, utility bill, telephone bill, US Post Office change of address form, Driver's License

Taquería El Nacimiento, la casa de las estrellas

DETROIT, marzo 2019: *La Taquería El Nacimiento* es uno de los restaurantes más populares en el barrio hispano de esta ciudad gracias a su gran calidad, excelente servicio y exquisito sabor. Se encuentra ubicado en el 7400 de la Vernor Hwy, y su menú incluye desayuno, almuerzo, cena, café y bebidas; además ofrecen servicio para llevar y banquetes para fiestas. Tel. 313-554-1790.

Con casi 18 años de servicio constante, *El Nacimiento* es conocido como la casa de las estrellas, ya que muchos de los artistas que dan conciertos en Detroit, aprovechan para comer ahí. "Antes conocía a todos los artistas en la televisión y ahora ellos vienen a comer aquí, hemos tenido a Espinoza Paz, Ramón Ayala, Jenny Rivera en paz descansé, Pedro Infante Jr., Julián Álvarez, entre otros. Aquí es la casa de las estrellas, donde la estrella eres tú; es decir todo el que entra aquí es una estrella", señaló *Rodrigo Padilla*, propietario del lugar.

Todas las estrellas van en busca de una comida auténticamente mexicana, pozole, birria, carnitas, tacos de pastor, de cabeza, lengua, etc. "Nuestro éxito se debe a que le ponemos mucho amor a todo lo que hacemos. La comida tiene que estar siempre al 100, no al 95 ni al 99, sino al 100 para que pueda estar buena. Yo nunca pensé estartan arriba por las puertas

se me han ido abriendo, es por eso que le digo a mis hijos, nunca hay que quedarnos en un solo lugar, es como una escalera, tenemos que ir avanzando escalón por escalón para ir siempre arriba", agregó el entrevistado.

Pero el éxito de *El Nacimiento* no llegó de la noche a la mañana, requirió de muchos años de arduo trabajo. El Sr. Padilla nos relata su historia: "Nosotros vivíamos en un rancho que se llama *El Nacimiento*, ubicado a unos 25-30 kilómetros de Arandas, Jalisco. Una vez en Michigan, el Sr. Padilla empezó a trabajar en la construcción, en fábricas y donde le dieran oportunidad, hasta que un día, el dueño de una ferretería que era su amigo, le vendió el lugar. "No tenía dinero pero como pude le compré y que me entregó en septiembre del 2000. A partir de ese momento con la ayuda de amigos y familia fui convirtiendo la ferretería en un restaurante, lo modifiqué y le construí la cocina, los baños, etc. Gracias a Dios repare todo y lo arreglé a mi gusto, con las ideas que ya traía de México y lo que había visto en California, en donde tuve oportunidad de trabajar en un restaurante lavando platos".

Mientras remodelaba el lugar, pensaba en el nombre adecuado para el restaurante. Llegaba cansado a su casa pero se daba tiempo de escribir sus propuestas, cambiarlas y rehacerlas hasta que se decidió por *El Nacimiento Restaurante Mexicano*, nombre del rancho en donde nació. En Detroit hay mucha gente de Arandas y ubican bien ese rancho, ya que ahí hay una conocida fábrica de tequila.

por si eso fuera poco, a un lado del restaurante tienen dos salones en donde se realizan bodas, XV años, bautizos, primeras comuniones, etc; todos ellos solicitan la comida de *El Nacimiento* y quedan completamente satisfechos.

Gracias a la constancia y trabajo arduo es cómo *El Nacimiento* se ha mantenido en el gusto del público y se ha hecho muy popular. Cuentan con clientes fieles desde que abrieron, que los siguen recomendando. Están abiertos todos los días, hasta días festivos, desde muy temprano hasta las 11:00pm. El viernes y sábado son los únicos que están abiertos hasta las 5:00am. Le dan de comer a cientos y miles de personas año con año.

"Nunca pensé estar tan arriba, pero las puertas se me han ido abriendo. Navarre Park to be revitalized

March 21, 2019: Toledo Councilman Peter Ujvagi, Toledo Mayor Wade Kapszukiewicz, and representatives from Toledo Refining Company and Mercy Health announced a partnership Thursday to improve East Toledo through the revitalization of Navarre Park.

According to the 1948 Universal Declaration of Human Rights, Article 14, everyone has a right to seek asylum (www.un.org). The United Nations High Commission for Refugees (UNHCR) states that any foreign national that has "well-founded" fears of persecution is a refugee and not an "illegal immigrant." Neither refugees nor asylum-seekers are "illegal" (www.unhcr.org)

Why are asylum-seekers not granted refugee status upon arrival when they, like the refugees, are both fleeing persecution, fear for their life, and overall a safer place to live? *What is the difference between a refugee and an asylum-seeker?* These are two (2) of the most commonly asked questions I have gotten since writing these journals.

An asylum-seeker is someone who left their native country for international protection (asylum) in another country but has yet to receive "refugee-status." A refugee is someone who has been recognized as having "refugee-status" under the 1951 *Refugee Convention*; a United Nations treaty relating to the *Status of Refugees* (www.unhcr.org). And, both refugees and asylum-seekers are people that have left their country to come to another country out of desperation and the need to survive. Both groups seek refuge and asylum.

Refugees are granted refugee-status upon arrival to the U.S. because they were able to stay in their country or protected until it was completed. Asylum-seekers, on the other hand, arrive to a U.S. port of entry under extreme circumstances, and most have walked miles through deserts, mountains, across waters and war-torn countries. Many asylum-seekers traveled inside of a semi-truck or on top of a watercraft with little or no food for weeks and months. Once an asylum-seeker arrives to a national border they are detained, vetted, screened, and processed by U.S. Homeland Security personnel. When the screening process is completed, some asylum-seekers will not be allowed to enter to the U.S., while others will get *Temporary Protection Status (TPS)* that authorizes them to live in the U.S. while their petition for refugee-status is being processed and completed. This process can take years.

Asylum-seekers, moreover, need to have someone who will financially "sponsor" and support them throughout their court proceedings for refugee-status. This person will also need to buy them their Greyhound bus ticket to travel through the U.S. to their new home with their sponsor/s. If an asylum-seeker does not have a person in the U.S. that can sponsor and buy their bus ticket/s, the individual is given an "ankle monitor" to wear until they are able to pay the government back the monies loaned for their bus

ticket/s.

And, how do we know this? Because, this week at the station we had a Guatemalan dad who was wearing an ankle monitor. Unfortunately, however, the battery he was given was running low and he was afraid the battery would die or set off a notification to Immigration and Customs Enforcement (ICE) or the local police that it was deactivated. Dad had a two-year-old daughter in his arms as he frantically asked everyone in Spanish for a battery charge.

Por qué a los solicitantes de asilo no se les otorga el estatus de refugiado cuando llegan, cuando ellos, como los refugiados, huyen de la persecución, temen por su vida y, en general, también están buscando un lugar más seguro para vivir? ¿Cuál es la diferencia entre un refugiado y un solicitante de asilo? Están son dos (2) de las preguntas más frecuentes que he recibido desde que escribo estas columnas.

Un solicitante de asilo es alguien que dejó su país de origen para la protección internacional o protegido until it was completed. Asylum-seekers, on the other hand, arrive to a U.S. port of entry under extreme circumstances, and most have walked miles through deserts, mountains, across waters and war-torn countries. Many asylum-seekers traveled inside of a semi-truck or on top of a watercraft with little or no food for weeks and months.

Once an asylum-seeker arrives to a national border they are detained, vetted, screened, and processed by U.S. Homeland Security personnel. When the screening process is completed, some asylum-seekers will not be allowed to enter to the U.S., while others will get *Temporary Protection Status (TPS)* that authorizes them to live in the U.S. while their petition for refugee-status is being processed and completed. de estatus de refugiado. Este proceso puede llevar años.

Los solicitantes de asilo además necesitan tener a alguien que pueda apoyarlos financieramente durante sus procedimientos judiciales para el estatus de refugiado. Esta persona también tendrá que comprarles su boleto de autobús de Greyhound para viajar a través de los EE. UU. a su nuevo hogar. Si un solicitante de asilo no tiene una persona en los EE. UU. que pueda comprar su(s) boleto(s) del autobús, el individuo recibe un "monitor de tobillo" para usar hasta que pueda devolverlo al gobierno el dinero prestado para su autobús.

¿Y cómo sabemos esto? Porque, esta semana en la estación, tuvimos un padre guatemalteco que llevaba puesto un monitor de tobillo. Desafortunadamente, la batería que le dieron estaba agotada y temía que la batería se agotara o provocara una notificación a Inmigración y aduanas (ICE.) o a la policía local de que estaba desactivada.

El papá tenía a su hija de dos años en sus brazos mientras frenéticamente les pedía a todos en español por una carga de batería. La eliminación o desactivación de un monitor de tobillo es un delito federal y una violación de su TPS, que puede terminar en su arresto y deportación.





Tri-C student wins National Landscape Competition

HIGHLAND HILLS: Linden of Rocky River posted the top score in computer-aided landscape design for the second consecutive year, while Cole Jacobs (Bay Village) and JC Mazzurco (Chester Township) placed first in irrigation assembly.

Vareska, of Mentor-on-the-Lake, competed in five events. He paired with teammates to place second in landscape maintenance operations and third in both landscape plant installation and maintenance cost estimating.

He becomes the second Tri-C student to win the competition, following Hayden Angelotta in 2014.

His performance led Tri-C to a third-place overall finish at the event, which attracted more than 60 of the nation's top horticulture and landscape programs from two- and four-year schools. Tri-C placed first among community colleges.

The annual competition challenges students in 29 individual or group events

that require the expertise needed to work in the industry. It is organized by the National Association of Landscape Professionals.

Linden of Rocky River posted the top score in computer-aided landscape design for the second consecutive year, while Cole Jacobs (Bay Village) and JC Mazzurco (Chester Township) placed first in irrigation assembly.

Tri-C has emerged as a powerhouse in the competition, with a handful of Top 5 finishes in the past six years. This year's placing matched the 2016 effort for the College's top ranking.

Another member of the College's team, Drew Krueger of Dayton, finished sixth overall with strong showings in five events. He teamed with Jake Barber (Chester Township) to win the hardscape installation challenge.

Tri-C claimed two other event championships. Lauren

For Those Age 60 or Better Who Are Worried about Heating Bills, HEAP Can Help

For people with low or modest incomes – including many older adults and people with disabilities – high energy prices are a frightening prospect as we head towards cold weather.

But help is available through the Home Energy Assistance Program (HEAP). HEAP is a federally funded program administered by the Ohio Development Services Agency. It is designed to help eligible low-income Ohioans meet the high costs of home heating.

If you are eligible for assistance, the amount of your one-time HEAP benefit will depend on:

- federal funding levels
- how many people live with you
- total household income (\$21,245/year for one household member and \$28,805/year for a couple)
- and the primary fuel you use to heat your home

In most cases, the one-time benefit will be a credit applied to your energy bill by your utility company (or fuel vendor). The one-time benefit is typically credited in January depending on when an individual applies for assistance.

Applications are available online and through a number of community organizations. Applications may be submitted any time from now through June 30, 2019.

Understanding eligibility requirements and completing and submitting benefit applications can be challenging for many older adults – especially those who are homebound. Working with our community partners, Council on Aging provides information and assistance to older adults and people with disabilities who wish to apply for the program. In-home assistance is also available. Last year, COA and our community partners provided information or assistance with HEAP applications to almost 1,000 older and disabled adults in southwest Ohio.

Older adults and people with disabilities who wish to apply for the program should call the **Area Office on Aging at 419-382-0624**.

Para las personas con ingresos bajos o modestos - incluidos muchos adultos mayores y personas con discapacidades- los altos precios de la energía crean una perspectiva aterradora a medida que nos acercamos a la temporada de frío.

Pero la ayuda está disponible a través del Programa de Asistencia de Energía para el Hogar (HEAP). HEAP es un programa financiado por el gobierno federal administrado por la Agencia de Servicios de Desarrollo de Ohio. Está diseñado para ayudar a los residentes de Ohio de bajos ingresos a ser elegibles a poder cubrir los altos costos de la calefacción en el hogar.

Si es elegible para recibir asistencia, la cantidad de su beneficio HEAP por única vez dependerá de:

- Niveles de financiamiento federal
- La cantidad de personas que viven con usted
- Ingreso total del hogar (\$21,245 al año para un miembro del hogar y \$ 28,805 al año para una pareja)
- y el combustible primario que usa para calentar tu hogar.

En la mayoría de los casos, el beneficio por única vez será un crédito aplicado a su factura de energía por su compañía de servicios públicos (o proveedor de combustible). El beneficio de una sola vez se suele acredecir en enero dependiendo de cuándo la persona solicitó la asistencia.

Las solicitudes están disponibles en línea y a través de varias organizaciones comunitarias. Las solicitudes pueden presentarse en cualquier momento a partir de ahora hasta el 30 de junio de 2019.

Comprender los requisitos de elegibilidad, completar y enviar las solicitudes de beneficios puede ser un desafío para muchos adultos mayores, especialmente aquellos que están confinados en su hogar. En conjunto con nuestros socios comunitarios, el Consejo sobre el Envejecimiento proporciona información y asistencia a los adultos mayores y las personas con discapacidades que desean solicitar la ayuda. También está disponible la asistencia a domicilio. El año pasado, COA y nuestros socios comunitarios proporcionaron información o asistencia con las solicitudes de HEAP a casi 1,000 adultos mayores y discapacitados en el sureste de Ohio.

El Centro invita a sus clases de ciudadanía

Una agencia de servicios sociales con 44 años que le gusta colaborar con los demás

LORAIN, 29 III 19: *El Centro de Servicios Sociales, Inc.* [agencia de servicios sociales] invita a todos aquellos interesados en presentar su examen de naturalización a prepararse con las clases de ciudadanía que ofrece para hispanos. Las clases son impartidas por estudiantes del Colegio Oberlin y la mayoría de los que toman este curso pasan la prueba. Los interesados en inscribirse pueden comunicarse al teléfono: (440) 2778235 x 7022 con Anabel Barrón.

Este programa tiene ya cuatro años, las clases se imparten cada sábado durante tres meses, en un horario de 10:00am a 12:00pm. "Son dos horas de clases en español pero los preparan para contestar en inglés. Aunque las clases son en grupo, se brinda apoyo especial por separado a quien lo requiera. Tenemos un promedio de que el 95% de nuestros participantes pasan el examen, el otro 5% no lo han pasado por el record criminal ya que hay muchas cosas que ver antes de someter una aplicación", informó Anabel encargada del programa.

Un profesor del prestigiado Colegio Oberlin fue quien preparó las clases para satisfacer las necesidades de la comunidad y un grupo de estudiantes tienen el liderazgo de capacitar adecuadamente a sus compañeros para que imparten las clases tanto en español como en inglés. El objetivo es que los participantes entiendan las

preguntas en inglés y se familiaricen con las respuestas, para que estén bien preparados cuando presenten el examen. Los estudiantes de Oberlin son de diferentes departamentos que forman parte de un programa en donde realizan trabajo comunitario.

"Los que vienen son chicos que tienen interés en el sistema de migración y en ayudar a nuestra comunidad. Hemos sido bendecidos con los estudiantes que nos han enviado, todos muy bien preparados y con un gran don de servir. Ya tenemos planes a futuro con el Colegio para hacer actividades en beneficio de los migrantes", destacó Víctor Leandry, Director Ejecutivo de El Centro.

En la última clase del curso de capacitación, un representante del Departamento de Ciudadanía y Servicios de Inmigración (USCIS) acude para realizar una entrevista de práctica con todos los estudiantes, eso les ayuda a perder el miedo y trabajar en los puntos que sea necesario reforzar.

"Es importante mencionar que cuando te presentas al examen, lo primero que hace el oficial es realizar preguntas personales y hay que estar relajados, mirarlo a los ojos y responder claramente. Al tomar el curso pierdes el miedo, prácticas con compañeros y te preparas correctamente", agregó Anabel.

Cabe destacar que en caso de requerirse, El Centro también ofrece

adicionalmente, el servicio gratuito de interpretación y transporte para el examen. Por si eso fuera poco, los cursos de ciudadanía son acompañados por el servicio legal de abogados pro-bono de Cleveland. "Hace dos años cambiaron las aplicaciones, antes eran 3 páginas y ahora son 20, es complicado poder llenarlas y los abogados ofrecen ese servicio de apoyo; lo que pedimos únicamente son \$25 dólares para brindar algún refrigerio o comida a los abogados y sus asistentes mientras están aquí ya que tardan de dos a tres horas en llenar una solicitud", dijo la entrevistada.

Anabel tiene cinco años trabajando en El Centro como encargada del departamento de Servicios para Apoyo a los Adultos. "En El Centro tenemos servicios para la comunidad en general ya sea hispana o no, pero este departamento está enfocado específicamente a los hispanos y la razón por la que tenemos un gran corazón y misión para ayudar a la gente indocumentada", compartió Víctor. "En Lorain la mayoría de la gente es puertorriqueña y los atendemos muy bien pero no tenemos quien tuviera la destreza de trabajar con la comunidad indocumentada".

Anabel Barrón Sánchez es originaria de Dolores Hidalgo, Guanajuato, México, fue voluntaria para la iglesia El Sagrado Corazón, a la que pertenece desde hace 20 años,



y se encargaba de llevar personas a sus citas médicas e interpretaba. Una vez que se incorporó a El Centro, recibió entrenamiento de UnidosUS, anteriormente conocido como Consejo Nacional de La Raza (NCLR por sus siglas en inglés). "Ha desarrollado una gran colaboración con el Consulado de México así como con senadores y congresistas. Traemos el consulado móvil aquí; ella ha hecho talleres de educación con el consulado mexicano en diferentes partes de Ohio hablando de los derechos de los inmigrantes, aprendiendo de finanzas y de diferentes tópicos. Ha desarrollado esa destreza de abrir las puertas a la comunidad, se sienten en confianza de venir a El Centro para pedir ayuda", señaló Leandry.

El Centro es una de las agencias de servicios sociales más estables en Ohio, tiene 44

años de haberse fundado y cuenta con los mejores estándares de atención. Se encuentra ubicada en el 2800 de la Avenida Pearl en Lorain, Ohio. Lead Paint to be renewed as Community Issue

problem properties.

"What they said about being concerned about lead poisoning and children didn't mean anything, because at the end of the day, their total concern was with their pocketbook and how much they would have to spend to make sure that these dwellings and these units were up-to-code," said Wood. "This ordinance was to let landlords know they were going to be held accountable if they didn't take care of their property. You won't eliminate it, but you try to make it lead-safe."

The issue also is getting attention at the state level. Governor Mike DeWine announced a plan March 13 to invest millions more over the next two years to address lead poisoning in Ohio's housing stock and test children.

"It is unconscionable to me that in 2019, there are still children whose opportunities are stifled because they live in homes where they are exposed to lead paint. Every year, thousands

of Ohio children under the age of six test positive for unsafe lead levels. Undoubtedly, there are countless more who have never been tested," said Governor DeWine. "No child should be poisoned in their own home."

Just 60 percent of Medicaid-eligible children are tested each year. The governor's plan would force providers and managed care organizations to test all eligible children. An additional \$24 million would go to the Department of Developmental Disabilities' Early Intervention Program, among other things, help provide physical, speech, and occupational therapy services to children who have dangerously high levels of lead in their blood.

Ohio Department of Health data shows that since 2016, 933 children age 6 and younger in Toledo have had confirmed blood-lead levels above CDC levels of concern. Another 391 kids had unconfirmed elevated levels, but did not get a confirmatory second test.

Under the governor's plan,

The Ohio Department of Health will provide \$10 million from the State Child Health Insurance Program to fund investigations and lead abatement. The state health department also would set aside \$450,000 to reimburse individuals the costs of becoming licensed lead workers and contractors in order to increase the lead hazard control workforce.

Landlords would be eligible for an income tax credit of up to \$10,000 if they incurred expenses to make their homes lead-safe. The new Ohio Director of Children's Initiatives is being tasked to convene an internal working group of experts from four state agencies to streamline and improve the state's lead detection, abatement, and early intervention services. The funding proposals are outlined in the governor's two-year budget proposal, which must be passed by state lawmakers.

Broadway Corridor roadwork forum set, March 27

Toledo and Ohio Dept. of Transportation (ODOT) engineers have yet to reach any sort of consensus on how best to resolve the public's demand for better access to an Old South End neighborhood, but some answers may be forthcoming. A community forum is set for Wed., March 27, 2019, 6 p.m., at St. Peter and Paul Catholic Church, 705 S. St. Clair St.

Initial complaints from church leaders and Latins United members has led to new detour signs pointing the way into the neighborhood via Erie St. from downtown Toledo, the only access point to the church and private club at the moment. Bright orange signs popped up along the Broadway Corridor late last week.

"It's awesome to see that they're actually working with us, can't believe how quickly they made those signs," said Chevo Torres, Latins United president. "They just popped up. It makes it a lot easier to actually get here now. But we still have people who can't find this place."

Torres lamented that Nueva Esperanza Community Credit Union held its annual meeting at the Lat-

ins United Hall on Wed., March 20 and people called the social club questioning how to find the location with at three access points to the neighborhood shut down due to separate road and bridge construction projects. Now Torres hopes the forum will help spread the word.

"We just want to invite the community and people who are interested and want information or just want to hear what we've been doing to make it easier," said Torres. "(We want to) tell them that they have everything under control as far as emergency vehicles getting in here without going through all the detours like we do. That was the main concern."

Latino leaders want to make sure Old South End residents get accurate information. The initial lack of communication from city and ODOT transportation officials has led to a wild series of rumors about how long projects will take to complete, inflated emergency response times—all causing quite a bit of worry, especially among older residents.

"They're actually working with us now, when this should have happened months before they started working on it and everything would have worked out great," said Torres.
