



La violencia y la pandemia golpean a Estados Unidos

WASHINGTON, June 1, 2020 (AP): Con varias ciudades heridas por días de violentas protestas, Estados Unidos inició una nueva semana con vecindarios llenos de escombros, calles urbanas cortadas y una confianza mermada sobre cuándo encontrarán sus gobernantes las respuestas para controlar el caos, en un clima de emociones en carne viva por las muertes de personas negras a manos de la policía.

Entretanto un policía en Fort Lauderdale fue suspendido al difundirse un video en que aparece lanzando al piso a una mujer arrodillada en las protestas del domingo.

Los colegas del oficial inmediatamente lo alejaron de la mujer y a otro lado de la calle. El alcalde Dean Trantalis informó a reporteros que el oficial fue suspendido mientras se desarrolla una investigación. No dio el nombre del policía.

"Si se llega a confirmar que actuó inapropiadamente, habrá de inmediato medidas disciplinarias. No aceptamos ese tipo de conducta... pensamos que esto jamás debió ocurrir", declaró Trantalis el domingo por la noche.

En Washington, se informó que el presidente Donald Trump le pidió a gobernadores mano dura contra protestas, diciéndoles: "La mayoría de ustedes son débiles."

Todo colisionó contra un país ya afectado por los más de

100.000 muertos de la pandemia del coronavirus, y un desempleo en niveles inauditos desde la Gran Depresión.

El domingo cerró un accidentado fin de semana en el que las autoridades locales y estatales desplegaron a miles de soldados de la Guardia Nacional, impusieron estrictos toques de queda y cerraron sistemas de transporte público.

Pese a todo, muchas manifestaciones derivaron en violencia cuando los manifestantes arrojaron piedras y bombas incendiarias contra la policía en Filadelfia, encendieron una hoguera cerca de la Casa Blanca y fueron recibidos con gas lacrimógeno y aerosol de pimienta en Austin y otras ciudades. Siete policías de Boston fueron hospitalizados.

En algunas ciudades, los ladrones allanaron tiendas y se llevaron todo lo que pudieron cargar, dejando a los propietarios, muchos de los cuales estaban reabriendo sus negocios tras los cierres por el coronavirus, la tarea de limpiar los cristales rotos.

En otras, la policía intentó rebajar la tensión arrojándose en solidaridad con los manifestantes, al tiempo que mantenía un amplio despliegue por seguridad.

Las manifestaciones comenzaron tras la muerte de George Floyd, un hombre

negro que suplicó pidiendo aire mientras la policía le presionaba el cuello con la rodilla. Las tensiones ya habían subido en las semanas previas tras la detención de dos hombres blancos en mayo por matar a tiros a Ahmaud Arbery, un hombre negro que había salido a correr en Georgia, y la muerte en marzo de Breonna Taylor, baleada en su casa por la policía de Louisville.

"Siguen matando a nuestra gente", dijo Mahira Louis, de 15 años, que acudió junto a su madre y cientos de personas a una manifestación en el centro de Boston. "Estoy harta de esto".

Las protestas ante la Casa Blanca se recrudecieron el domingo después de tres días de manifestaciones. La policía empleó gas lacrimógeno y granadas aturdidoras contra una multitud de más de mil personas, que coreaban lemas al otro lado de la calle, en el Parque Lafayette. La multitud salió corriendo y apiló señales de tráfico y vallas de plástico para prender una gran hoguera en una calle cercana. Algunos quitaron una bandera estadounidense de un edificio y la lanzaron a las llamas.

Un edificio del parque que aloja una oficina de mantenimientos y baños públicos fue incendiado. Las manifestaciones continuaron más allá del toque de queda, y la policía de Washington dijo estar respondiendo a varios avisos por incendios

provocados en la capital.

Toda la Guardia Nacional de Washington D.C. -unos 1.700 soldados- fue desplegada para ayudar a controlar las protestas, según dos funcionarios del Departamento de Defensa que insistieron en mantener el anonimato porque no estaban autorizados a comentar el asunto de forma pública.

A medida que las protestas aumentaron de dimensión, el presidente Donald Trump retuiteó al comentarista conservador Buck Sexton, quien pidió "fuerza abrumadora" contra los manifestantes violentos.

El exvicepresidente Joe Biden, probable candidato demócrata a la presidencia de Estados Unidos, visitó una zona de protestas en su población natal en Wilmington, Delaware, y habló con algunos manifestantes. También escribió un post en Medium expresando su comprensión a los conserners por la muerte de Floyd.

Al menos 4.400 personas fueron detenidas en los días de protestas, según un conteo de The Associated Press. Los cargos iban desde robos y cortes de autopistas a incumplir toques de queda.

En Salt Lake City, un líder activista condenó la destrucción de la propiedad pero dijo que el duelo por los edificios dañados no debería estar al mismo nivel que el dolor por hombres negros como Floyd.

"Quizá este país recibiera el mensaje de que estamos hartos de que la policía asesine a hombres negros desarmados", dijo Lex Scott, fundador de Black Lives Matter Utah. "Quizá la próxima vez que un policía blanco decida apretar el gatillo, le venga la imagen de ciudades en llamas".

Sin embargo, miles de personas siguieron marchando de forma pacífica en Phoenix, Albuquerque y otras ciudades, y algunos pidieron el final de los incendios, el vandalismo y los robos, afirmando que socavaban sus demandas de justicia y reformas.

En el centro de Atlanta, las autoridades lanzaron gas lacrimógeno para dispersar a cientos de manifestantes. La alcaldesa, Keisha Lance Bottoms, dijo que dos agentes habían sido despedidos y tres relegados a labores administrativas tras la difusión de un video en el que se veía a agentes rodeando un auto el sábado y utilizando pistolas eléctricas contra el hombre y la mujer que iban dentro.

En el centro de Los Ángeles, una camioneta de la policía aceleró hacia varios manifestantes en una calle, derribando a dos personas. Los manifestantes se levantaron y corrieron hacia la vereda. En la cercana Santa Mónica, cerca de una manifestación pacífica, un grupo irrumpió en varias

tienas y robó objetos como zapatillas y sillas plegables. En un restaurante al otro lado de la calle se produjo un incendio.

En Minneapolis, el agente que presionó su rodilla sobre el cuello de Floyd por varios minutos ya fue acusado de asesinato, pero los manifestantes exigen que los otros tres policías involucrados en el caso sean procesados. Los cuatro ya fueron despedidos.

"No hemos acabado", dijo Darnella Wade, organizadora de Black Lives Matter en la vecina ciudad de St. Paul, en donde miles de personas se reunieron pacíficamente frente al Capitolio estatal. "Nos enviaron al ejército y nosotros sólo les pedimos arrestos".

La indignación por el racismo a través de muchas generaciones en un país fundado por esclavistas se sumó a una serie de muertes recientes para avivar el descontento. A eso se añadía la angustia por meses de confinamiento provocado por la pandemia del coronavirus, que ha golpeado de forma desproporcionada a las comunidades de color, no solo en número de infectados, sino también en empleos destruidos y penurias económicas.

La escala de las protestas en todo el país era similar a las manifestaciones históricas del movimiento de los derechos civiles y en contra de la guerra de Vietnam.

Governor Whitmer Rescinds Safer at Home Order, Moves Michigan to Phase Four of the MI Safe Start Plan

Retailers, restaurants will be permitted to open with capacity limits, social distancing

LANSING, Mich., June 1, 2020: Today, Governor Gretchen Whitmer signed Executive Order 2020-110, rescinding her Safer at Home order and moving the entire state to phase four of the MI Safe Start Plan.

The governor's order will allow retailers to reopen on June 4 and restaurants to reopen on June 8, both subject to capacity limits. Day camps for children will likewise be permitted to open on June 8. Effective immediately, groups of 100 or less will be allowed gather outdoors with social distancing. Office work that is not capable of being performed remotely can resume. And in-home services, including housecleaning services, can resume operations.

"The data has shown that we are ready to carefully move our state into the next phase of the MI Safe Start Plan, but we owe it to our brave frontline heroes to get this right," said Governor Whitmer. "While Michiganders are no longer required to stay home, we must all continue to be smart and practice social distancing, and encourage those who meet the criteria to get tested for COVID-19. If we all do our part, our goal is to announce a shift to phase five for the entire state prior to the fourth of July. Stay smart, stay safe, and let's all do our part."

Michiganders must continue to wear facial coverings when in enclosed public spaces and should continue to take

all reasonable precautions to protect themselves, their loved ones, and the community. And they should continue to work from home to the maximum extent possible.

"The governor and I, along with a team of experts, have determined that our state is ready to move into the next phase of the MI Safe Start Plan. Hospitalization numbers are down, our frontline workers have PPE to last them several weeks, and the number of positive cases and deaths are declining," said MDHHS Chief Deputy for Health and Chief Medical Executive Dr. Joneigh Khaldun. "We will continue to monitor the data and work closely with local health departments to ensure Michiganders practice safe social distancing. On behalf of our health care professionals and first responders on the front lines, we must all be smart and be safe."

"As the hardest-hit region in the state, Wayne County and its residents are ready to safely return to greater activity and commerce," said Wayne County Executive Warren C. Evans. "We continue to vigilantly monitor the spread of COVID-19 and will do so to make sure the number of daily cases continues to decline. It's been an extremely difficult three months for all of us, but the social distancing measures we have put in place has slowed the spread of this

disease and saved lives. Today is an important step toward returning to some semblance of normalcy, but it is important for all of us to continue following that safe distancing and work directives outlined in Stage 4 of the MI Safe Start Plan."

"I appreciate Governor Whitmer for her diligence and commitment to reopening the state safely. We look forward to reopening Detroit safely and efficiently," said Detroit Mayor Mike Duggan.

"We know we still have challenges to face, but moving into this next phase acknowledges the huge strides this state has made to slow the spread of this deadly virus," said Flint Mayor Sheldon Neeley. "I appreciate Gov. Whitmer's caution and proactive response throughout this crisis. Her leadership has undoubtedly saved lives."

"The last few months have been very hard for everyone. I applaud the Governor for doing everything she can to keep us safe," said Lansing Mayor Andy Schor. "And now that the curve has flattened and I am very excited that we have moved into phase 4 and can have things start to reopen. Economic issues have been very challenging in Lansing and across the state, but we know it was necessary to save lives. Now we are ready to get back to growing our city here in Lansing and the economy throughout the state!"

Subject to local regulation, gyms and fitness centers may conduct outdoor classes, practices, training sessions, or games, provided that coaches, spectators, and participants maintain six feet of distance from one another during these activities. Outdoor pools can also reopen, with restricted capacity.



Kaptur Statement in response to ongoing unrest sparked by the killing of George Floyd

Washington, D.C., June 1, 2020: Congresswoman Marcy Kaptur (D-OH) released the following statement in response to the ongoing protests sparked by the killing of George Floyd:

"It is our duty as Americans to snuff out all forms of hate and racism. Those protesting peacefully are patriots. Their demonstration is as the Founders envisioned and they deserve respect and admiration for seeking a better America. They will make our country stronger," said Rep. Kaptur.

"To the very small minority of people who have resorted to violence, consider the lasting effects such destruction will have on communities that too often are al-

ready struggling. Whatever your objective, you make harder the lives of so many people. Let the words of the Reverend Martin Luther King, Jr. guide you: 'Darkness cannot drive out darkness; only light can do that. Hate cannot drive out hate; only love can do that.'

"I will continue to support those who are working to create a more just society. I will continue to work with local leaders and advocates to ensure that Northern Ohio leads the way in that fight. And I will continue to fight for the passage of important legislation in Congress, such as the Police Training and Independent Review Act, and efforts to revive the very successful community policing initiatives of previous Administrations.

"I invite people of goodwill from across Northern



Ohio to join me in helping rebuild the torn spirals and burned blocks of our country. Let us rise from this deep tragedy and engage the true spirit of America. Let us do it in George Floyd's memory, and the memory of every victim of racist violence. Let us unite with the grieving family of George Floyd and aspire to fulfill his family's wish – justice and peace."

Toledo Mayor Wade Kapszukiewicz issued the following statement on June 1, 2020

Today, I was joined by Chief George Kral to discuss the events of this weekend and to take the initial steps for our city to move forward and to be better. Toledo had a rough night on Saturday, but when you compare what happened here to what is happening in so many other American cities right now, I know that things could have been a lot worse.

The reason we were able to avoid the worst of what other cities are experiencing is because Toledo has a good Police Department and good citizens. More often than not, we get things right in Toledo – but we know we can be even better.

The peaceful protests of this weekend were welcomed and an important part of our political process. I heard you. I saw you. I joined you.

However, what happened to change the peaceful nature of these events must be examined. Of course I have seen social media reports. I am asking citizens who have opinions about what they saw on Saturday to submit them in writing to my office for review and in-

vestigation. You can submit your first-hand account and photographs or videos to TPDconcerns@toledo.oh.gov or by going to the Engage Toledo app.

As we work to continue to build trust and promote accountability on policing, I announced several reforms that will be implemented to increase the transparency on which healthy police-community relations is based.

I am committed to improvements being made to the Civilian Police Review Board. All current members' terms will expire in the next 30 days. I am seeking resumes of those who wish to be considered for appointment to this board and want to help us make positive changes. Email your interest to TPDconcerns@toledo.oh.gov.

In addition, I announced today that the Internal Affairs Department of Toledo Police will be moved from the Safety Building to a neutral location. This will allow those who want to make a com-

plainter against the police more comfortable in doing so. We are also going to give the public access to the training we offer our officers on sensitivity and diversity and de-escalation tactics.

Finally, I have placed a link on the City of Toledo website that has the Toledo Police Department operations manual, recent community survey, the Bias Free Policing Review, Use of Force continuum, and much more.

Thank you, Toledo, for your care and concern for what is happening in our country right now. Thank you for peacefully using your voices toward a better world for all of us.

El Programa de Consulados Móviles tiene como objetivo principal la prestación de servicios consulares a los mexicanos que residen en poblaciones alejadas de las sedes consulares. Bajo este programa, los connacionales que viven en estas comunidades tienen la facilidad de obtener documentos de importancia, como Pasaportes y Certificados de Matrícula Consular de Alta Seguridad (MCAS).

El pasaporte es un documento de identidad y viaje que identifica a su titular como nacional del país que lo expide y le permite viajar a otros países, siempre y cuando cumpla con los requisitos migratorios y/o de visado del país al que se dirija.

La MCAS es un documento que cumple con fines censales y de protección. Además, tiene la ventaja de ser aceptado por un gran número de instituciones privadas y oficiales como documento de identidad, como prueba de nacionalidad, y como comprobante de domicilio en un distrito consular dado. No obstante, es importante aclarar que la MCAS no comprueba ni pretende sustituir el documento extranjero de legal estancia en un país. En ese sentido, solamente muestra que el portador está domiciliado en el extranjero y registrado ante la representación de México.

Durante los Consulados Móviles también se puede recibir información sobre los diversos servicios que se ofrecen en la representación consular y asesoría de protección preventiva con valiosos consejos sobre qué hacer y a dónde dirigirse en caso de que un connacional se encuentre en una situación de emergencia legal.

"Generalmente nos acompañan abogados, representantes de organizaciones o autoridades para dar alguna asesoría gratuita, mensaje o plática en materia de protección. También nos han acompañado representantes del Departamento del Trabajo para ofrecer orientación", informó Claudio Uribe, nuevo Cónsul del Departamento de Documentación.

Uribe fue Cónsul del Departamento de Protección durante dos años en el Consulado de México en Detroit, y en diciembre del 2019 se realizó una rotación del personal.

El diplomático mexicano comentó que en cuanto se tengan las sedes en donde se llevarán a cabo cada uno de los consulados móviles, se darán a conocer. Asimismo, dijo que durante estas jornadas también se ofrece el servicio de Actas de Nacimiento y permisos OP7 para menores de edad, que son las autorizaciones que otorgan los padres para que un menor pueda obtener su pasaporte, ya sea en otro Consulado o en México.

En algunas ocasiones también se incluye en los Consulados Móviles, el servicio de Registro Civil para registrar a los hijos de padre o madre mexicano que hayan nacido en el extranjero. "Este trámite era algo que hacíamos exclusivamente aquí en la sede, pero ya hemos hecho excepciones para tomar citas en algunos lugares. Todo depende de los aliados que tengamos en cada localidad que visitamos. Es un proceso complejo y requerimos que nos ayuden a recopilar la información previamente, nos la envíen dos o tres semanas antes para que la revisemos y el día que estemos allá puedan ir las familias a concluir el trámite de registro de sus hijos", agregó el entrevistado, quien aseguró que previamente se darán a conocer los lugares en donde ofrecerán este servicio para que los connacionales puedan organizarse y hacer su cita.

Otro de los servicios que se ofrece es el registro de las solicitudes para el trámite de la Credencial para Votar desde el Extranjero del Instituto Nacional Electoral (INE). "Nosotros no emitimos esa credencial, únicamente hacemos la solicitud para enviarla a México y posteriormente se reciba por correo", destacó Uribe.

La credencial para votar es un documento para que los mexicanos que residen fuera de México puedan votar en las elecciones mexicanas desde el extranjero. Es también un documento de identificación oficial reconocido en México. Es importante tener en cuenta que al momento de realizar este trámite, el nombre será separado del padrón electoral para formar parte de la Lista Nominal de Electores Residentes en el Extranjero. Por esta razón, si al momento de celebrarse una elección la persona se encuentra en México, no podrá votar.

Para ser atendido en los Consulados Móviles, es indispensable hacer cita en Mxitel en el 1877 6394835.

Consulado de México en Detroit anuncia nuevos costos en sus servicios

Vigencia 3 años: \$78;

Vigencia 6 años: \$107;

Las personas mayores de 60 años reciben un descuento del 50%.

MATRÍCULA CONSULAR

Vigencia 5 años: \$30.

PODERES

NOTARIALES: \$127 (personas físicas) y \$190 (personas morales);

TESTAMENTOS:

\$323;

COPIAS CERTIFICADAS DE ACTAS DE NACIMIENTO: \$14;

MENAJE DE CASA PARA MEXICANOS:

\$105;

MENAJE DE CASA PARA EXTRANJEROS:

\$140.

Claudio Uribe, Cónsul de Documentación en el Consulado de México en Detroit, dijo que el pasaporte de 1 año se otorga únicamente a menores de edad o en casos de protección. "Son para todos aquellos que no cumplen con los requisitos que la ley señala para obtener un pasaporte ordinario, por ejemplo que tenga un error en el acta de nacimiento o que no cuenten con una identificación y deban viajar a México por una emergencia comprobable o deseen regresar al país. También si se tiene cita pendiente en corte y se muestra el citatorio o bien, para que puedan ser atendidos en un hospital. Son los tres casos generales en donde se otorga este tipo de pasaporte".

Asimismo, destacó que el aumento del costo en los documentos fue poco. "Fueron unos cuantos dólares. El pasaporte de tres años costaba \$74 y aumentó \$4 dólares, el de 6 subió \$6, el que más aumentó fue el de 10 años, antes costaba \$136 y ahora cuesta \$150. Ya tenía varios años que no se actualizaban los precios".



Los pagos se realizan directamente en las oficinas del Consulado el mismo día que se realiza el trámite. El teléfono para hacer citas es el 01 800 900 0778

Los requisitos siguen siendo los mismos. Pasaporte por primera vez:

1. Acta de nacimiento certificada por el Registro Civil, no se aceptan actas enmendadas, enmendadas, alteradas y/o mutiladas. El acta original se devuelve;

2. Identificación oficial con fotografía. Debe tener el nombre completo del interesado tal y como aparece en el acta de nacimiento. Las identificaciones que se aceptan son: Certificado de primaria o secundaria con foto, credencial de elector (INE), cartilla del servicio militar, matrícula consular, título o cedula profesional. Identificación oficial expedida por autoridad mexicana o de Michigan u Ohio;

3. Acta de Matrimonio solo si desea que en su documento aparezca el apellido de casada. Si se casó fuera de México o los Estados Unidos, su acta deberá estar legalizada o apostillarla.

Renovación: Presentar pasaporte anterior en lugar de acta de nacimiento. Si el pasaporte que va a renovar fue expedido con "observaciones", deberá de cumplir con la condición/es señalada/s para poder renovarlo. Los pasaportes expedidos en territorio nacional antes del año 1995 y, pasaportes expedidos en las oficinas consulares antes del año 2006, se hará el trámite como primera vez, por lo tanto, se requieren los originales de todos los documentos que presente.

Pasaporte para menores de edad:

1. Acta de nacimiento;

2. Identificación oficial. Certificado de primaria o secundaria de la SEP, identificación de la escuela o constancia de estudios con foto del menor y sello oficial de la escuela.

En caso de menores

de 6 años: Constancia médica expedida por el pediatra con nombre completo del menor con sello del consultorio o firma del pediatra sobre la foto del menor.

3. Permiso OP7. Tanto para el trámite por primera vez como para la renovación ya sea del pasaporte o de la Matrícula Consular es indispensable que se presenten ambos padres, con identificación oficial con el nombre completo tal cual aparece en el acta de nacimiento del menor. La forma se proporcionará en las oficinas del Consulado. En el caso de que uno o ambos padres no vivan con el menor tramitar autorización en el Consulado o delegación de la SRE que le corresponda.

Requisitos para Matrícula Consular por primera vez para mayores de edad:

1. Acta de nacimiento;

2. Identificación oficial.

3. Comprobante de domicilio, se aceptan recibos de renta, luz, agua, teléfono, cuenta de banco, seguro del auto, correspondencia o comprobantes de paquetería, etc. El recibo deberá estar a su nombre o presentar un comprobante que especifique que el interesado reside y recibe correspondencia en esa dirección.

4. Acta de Matrimonio sola para mujeres casadas.

Renovación: Se requiere matrícula anterior, ya no es necesario presentar acta de nacimiento. Las matrículas expedidas en las oficinas consulares antes del 13 de mayo del 2005, se realizará el trámite como primera vez por lo que se requieren los originales de todos los documentos que presente.

Matrícula Consular para menores de edad:

1. Acta de nacimiento;

2. Identificación oficial;

3. Comprobante de DOMICILIO.

4. Permiso OP7.

What is a coronavirus?

- Coronaviruses are a large family of viruses that are known to cause illness ranging from the common cold to more severe diseases such as Middle East Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS).
- A novel, or new, coronavirus is called nCoV.
- The current new coronavirus is called 2019-nCoV.

What are the symptoms of Coronavirus?

- The most common symptoms are fever, cough, shortness of breath, and breathing difficulties.
- In more severe cases infection can cause pneumonia, severe acute respiratory syndrome, and even death. The period within which the symptoms would appear is 2-14 days.

Where do coronaviruses come from?

- Coronaviruses cause disease in a wide variety of animal species
- Several known coronaviruses are circulating in animals that have not yet infected humans
- A spillover event is when a virus that is circulating in an animal species is found to have been transmitted to human(s)

How can I protect myself from infection?

- Wash your hands with soap and water or an alcohol-based hand rub
- Cover your mouth and nose with a tissue, sleeve or a flexed elbow when coughing or sneezing
- Avoid unprotected close contact with anyone developing cold or flu-like symptoms
- Seek medical care if you have a fever, cough, and/or difficulty breathing
- When visiting live markets, avoid direct unprotected contact with live animals and surfaces in contact with animals
- Cook your food and especially meat thoroughly
- Seek medical care if you have a fever, cough, and difficulty breathing; please reveal your travel or contact history

Is there treatment?

- As of yet, there are no specific treatments for coronaviruses, but symptoms can be treated.

Are antibiotics effective in preventing and treating 2019-nCoV?

- No, antibiotics do not work against viruses. The 2019-nCoV is a virus and, therefore, antibiotics should not be used as a means of prevention or treatment.

Does 2019-nCoV only affect older people, or are younger people also susceptible?

- People of all ages can be infected by the virus. Older people and those with pre-existing medical conditions appear to be more vulnerable to becoming severely ill with the virus

Can pets at home spread the 2019-nCoV?

- At present, there is no evidence that companion animals/pets such as dogs or cats can be infected with the virus. However, it is always a good idea to wash your hands with soap and water after contact with pets.



COVID-19, Police-Related Death Taking Toll on Nation

June 2, 2020: If ever there is to be a summer of discontent, 2020 is quickly shaping up to fill the bill. Already feeling pent-up and frustrated after weeks of coronavirus-related stay-at-home orders, protests filled the streets of Toledo and several other Northwest Ohio communities over the weekend.

The death of George Floyd in Minneapolis while in police custody only added a lit match to a powder keg of emotions across the region and nation. A police officer is accused of killing Floyd by holding his knee on the suspect's neck for several minutes, despite continuous pleas by Floyd and onlookers for the cop to release pressure. An autopsy shows Floyd died from asphyxiation due to constant pressure. Floyd's death, caught on video, has prompted outrage and protests.

As Ohio and Michigan residents seek to adjust their routines yet again with the end of stay-at-home orders by each state's governor, many remain laid off or unemployed, their immediate economic futures uncertain. Floyd's death also punctuated the growing concern over the large proportion of minority deaths from COVID-19 when compared to the white population. The death rates only exacerbate long-time health disparities in minority populations.

Protests in Toledo over the weekend grew to at least Bowling Green and Fostoria by Sunday, largely peaceful in nature. However, there were 22 arrests in the aftermath of a large protest Saturday in downtown Toledo, prompted by a clash with police who used tear gas and rubber bullets to disperse the crowd after the protest ended. Police wore full body armor at the event.

"Officers had rocks, bricks, gas cans, incendiary devices, m80s, fireworks, eggs, and more hurled at them. Many of those objects struck officers and other protesters, causing injury," read a statement posted on TPD's official Facebook page. "Tensions and tempers were high from some people on all sides. It is possible that there were examples of officer misconduct on Saturday - and all formal complaints will be investigated."

Police are asking for the public's help to identify photos that will be posted on social media in

the coming days — people not yet charged for their roles in escalating the violence that led to broken windows at businesses, damage to police cruisers, and injuries to protestors and police.

The coming weeks and months will be difficult, painful, and tough for all people," the TPD post read. "We recognize this and want to move forward working in conjunction with our community to preserve life, enforce the law, provide quality services, reduce the fear of crime, and promote joint problem-solving for safe, secure neighborhoods."

TPD officers demonstrated they meant those words by walking with sign-carrying protestors along the streets of South Toledo Monday evening. The peaceful march went for miles and took place down Hill Ave. to Reynolds Rd. A protestor called it "a breakthrough for our generation."

Michigan's governor announced Monday that state's stay-at-home order would be lifted effective immediately. Ohio has gradually been reopening businesses over the past couple of weeks, as the governor gradually eased a stay-at-home order over the past month. Michigan's approach to reopening businesses and services mirrors Ohio's approach.

Outdoor gatherings of up to 100 people are now permitted in Michigan. Outdoor parks and recreation facilities may be open. Drive-in theaters can reopen. Retailers will be allowed to reopen June 4, followed by bars and restaurants for indoor and outdoor dining June 8. Day camps, libraries, museums, and outdoor public swimming pools can resume operations that same day. Gyms and fitness centers, casinos, and hair and nail salons must remain closed, although Michigan's governor hinted they may reopen by July 4th.

The economic effects of the COVID-19 precautions will be felt for months, if not years to come.

The University of Toledo will host a virtual roundtable discussion on Thursday, June 4, 5:30 p.m., about the death of George Floyd. The free, public event will feature a panel of UT students, faculty and staff. The "Dialogues on Diversity Virtual Town Hall" will include UT Police Chief Jeff Newton, UT law professor Benjamin

Davis, Dr. Monita Mungo, UT assistant professor of sociology, and Nyah Kidd, president of the UT Black Student Union, among others.

"The events of the past week have brought to light the critical role higher education can and must play in facilitating open and honest discussions that empower us as a community and a nation to translate our ideals into actionable change," said Dr. Willie McKether, UT vice president for diversity and inclusion.

The virtual gathering can be accessed on WebEx using the access code 160 282 6992. The meeting password is H5Fu4PQ6D3. Others can join by phone by calling 415.655.0002.

Latino nonprofit organizations continue to focus on children and families in need during COVID-19. The Sofia Quintero Art and Cultural Center recently made and handed out approximately 800 art kits throughout the Old South End, while continuing to serve lunches to kids and senior citizens alike.

The Believe Center is putting a focus on the family with a summer schedule of exercise and activities that will be centered at the new Corbett Athletic Complex at Danny Thomas Park, 2101 Broadway. The evening activities will begin Tuesday, June 9 and will run through mid-August.

A family run will be held Tuesdays and Thursdays, 5 to 7 p.m. Every other Wednesday, 6 to 8 p.m., will feature Family Fitness on the Field, a free, family-friendly outdoor exercise program that features Zumba alongside speed and agility exercises. Friday nights, 6 to 8 p.m., will feature a kickball game pitting one family against another. During the day, STEM on the Field will feature science, technology, engineering and math activities for kids ages 5 to 14 every Wednesday and Friday, 11 a.m. to 1 p.m. At each event, COVID-19-related social distancing and safety protocols will be enforced.

The Believe Center continues to host a free Friday food giveaway, 11 a.m. to 1 p.m., in conjunction with community partners.


